# Introduction

SuiteProjects Pro is a highly configurable system that provides superb project management capabilities for companies and service providers in many different industries. Account administrators are involved in many aspects of the SuiteProjects Pro system. This Administrator Guide helps you as you tackle your account administration duties. They may include:

- Knowing how your company's SuiteProjects Pro account is configured and the options that exist to enhance your account functionality.
- Entering or supervising the entry of key information such as new employees or contracts, and maintaining the information accuracy.
- Modifying form permissions on forms and designating them as required, read-only, or hidden to meet specific company needs. This can assist you in controlling sensitive information using application roles. See [Form Permissions](#) and [Roles Overview](#).
- Answering questions about using the account. Many times you become your company's Help Desk. Many account administrators produce employee guides that address your company's configuration.
- Ensuring compliance with your company processes and policies by maintaining best practices in SuiteProjects Pro.

This document addresses the configuration options that exist in SuiteProjects Pro. While you may already use some of them in your account, others may be something you will consider implementing at a future date for specific needs identified by your employees. You've probably asked yourself "How can I change...?" or "Can I do...?" This document is designed to help you answer some of those questions.

## Configuring SuiteProjects Pro Settings

There are two types of settings that control your account configuration: internal settings and company settings. There are also integration settings. Each is described in more detail as follows.

### Internal Settings

Many internal settings are set by SuiteProjects Pro Professional Services when your company's SuiteProjects Pro account is configured. Later, as you become aware of new functionality through release updates, you can [Creating a Support Case](#) and request that an internal setting be enabled in your account. Generally, these requests relate to new features. When a new feature is enabled, you must log out of your company's SuiteProjects Pro account and then log back in to see the new feature.

### Company Settings

The other type of setting is a company setting. You can configure company settings as well as account-wide settings. To find these settings and settings, go to the Administration application. When you enable these features or make changes to the settings, you do not need to log out and then log back in. The changes display immediately. Company settings are:

- **Global Settings** — Account-wide settings that display under sections of the Administration application. They are explained in detail in [Administration – Global Settings](#).
- **Application Settings** — Application Settings address specific functionality within each application. An application is addressed in each chapter of this guide. You can locate the specific settings associated

with an application and review the relevant forms. Under each of the Application Settings, there is a catch-all group of settings titled Other settings. Many of these settings are already preconfigured in new accounts based on experience and best practice. This guide explains how enabling these settings affect your company's SuiteProjects Pro account.

## Account Integration Settings

SuiteProjects Pro integrations are available for several software programs. If not set up initially when your company's SuiteProjects Pro account is configured, you should contact your SuiteProjects Pro account manager or SuiteProjects Pro Professional Services to discuss implementation. Frequently, you may want assistance in the initial configuration. Integrations include:

- Add-on services such as SuiteProjects Pro OffLine, SuiteProjects Pro Mobile, SuiteProjects Pro Outlook Connector, and SuiteProjects Pro Project Connector.
- NetSuite

SuiteProjects Pro offers a desktop XML API tool titled SuiteProjects Pro Integration Manager. It enables you to import and export from and to CSV text files.

In addition, SuiteProjects Pro Exchange Integration Manager supports exchanging information with Microsoft Exchange. You can export project task assignments, resource bookings, and time off request calendar commitments from SuiteProjects Pro to employees' Microsoft Outlook calendars.

## Multiple Sessions

You may have multiple sessions of SuiteProjects Pro running on the same computer at the same time. This is helpful when you are using multiple applications since it saves data entry time by avoiding switching to different applications within the same instance.

## Terminology

You can customize most terminology in SuiteProjects Pro to meet the unique needs of your company. For example, one company may use the word project to describe work to be accomplished. Another company may call it a case, job, or assignment. Please keep this in mind as you review the contents of this document. For more information about customizing terminology, see [Interface: Terminology in Administration – Global Settings](#).

## Application Overview

SuiteProjects Pro contains various applications, which are designed around specific functional areas such as Projects, Timesheets, Expenses, and Resources. The way these applications operate in your environment is dependent on the business needs of your company. This Administrator Guide steps through the configuration options and provides business and operational processes as well as best practices for the different applications. The applications are described as follows:

**Administration Application** — This is where you control your company's settings and many configuration options. There are two main selections under Administration: Global Settings and Application Settings. Each is described as follows.

- **Global Settings** include the account-wide settings and options. For descriptions of the forms and an explanation of their use, see [Administration – Global Settings](#).

- **Application Settings** include the functional application configuration options as well as data entity creation and maintenance. Each of the chapters in this guide presents an application. Reviewing them will help you gain a better understanding of the applications.

**Home Application** — The Home application is essentially a home base application that is meant to convey critical information to employees such as messages and reminders of pending approvals. It also contains various wizards, which help you quickly update data throughout the account. You can mount reports onto the dashboard for quick access to saved reports. You can enable a graphical reporting dashboard to represent saved reports in forms such as pie charts and line graphs. While this is helpful, not all reports lend themselves to graphical representation. See [Home Application Setup](#).

**Opportunities Application** — The Opportunities application enables you to manage prospective new business for your company with existing customers as well as with new customers and prospects. You are able to create Deals, Estimates, Proposals, To dos, and Events within the application. Many companies use the NetSuite integration for this functionality. See [Opportunities](#) or contact SuiteProjects Pro Support and request information about the NetSuite integration.

**Projects Application** — The Projects application is one of the primary components in SuiteProjects Pro. This is the application where management of your company's projects takes place. The application is flexible and provides several features to address your company's needs. See [Projects](#).

**Resources Application** — The Resources application enables you to schedule resources to projects. It also provides a vehicle to store an employee's skill set, education, industry experience, job roles and location in the SuiteProjects Pro database. You can then search the database to find the right resource. See [Resources](#).

**Invoices Application** — The Invoices application handles financial transactions such as customer charges and invoices. Primarily focused on invoicing your customers, the Invoices application manages the results of running the billing rules that you can set up for projects in the Projects application. See [Invoices](#) and [Projects](#).

**Timesheets Application** — The Timesheets application is where employees record their time against customer or internal projects. See [Timesheets](#).


**Expenses Application** — The Expenses application is where employees may enter expense reports against projects for a specific date or period of time. It also can handle authorizations for employee spending on company expenses. See [Expenses](#).

**Purchases Application** — The Purchases application provides the ability to create a process flow from a purchase request to fulfillment and receipt, and lets you track purchases made within your company. See [Purchases](#).

**Reports Application** — The Reports application provides employees the ability to create and run a wide variety of reports based on your company's account configuration. See [Reports](#).

**Workspaces Application** — The Workspaces application provides employees with an area to store documents and share them with others. It acts as an administrative library. See [Workspaces](#).

**User Menu** — The user menu draws together all user features into a common area. Point to the user menu to access the Help and Support features.

 **Note:** SuiteProjects Pro Support cannot act as an administrator for company specific data-related items such as unlocking employee accounts or resetting passwords. As an account administrator, you perform these tasks for your company.

# SuiteProjects Pro Account Types

The following types of SuiteProjects Pro account are available:

- **Production account** — Your SuiteProjects Pro production account is where you perform your daily business activities. Most users spend most of their time working in the production account.
- **Release preview account** — Your SuiteProjects Pro release preview account is a temporary test account that is running the new version of SuiteProjects Pro software. It is available for a short period before your production account is upgraded to a new SuiteProjects Pro release. Your release preview account is created automatically using a recent copy of your production account data.

You can use the release preview account to:

- Become familiar with the new features and other changes in the upcoming SuiteProjects Pro release.
- Verify that your existing business workflows function as expected before your production account is upgraded to the new SuiteProjects Pro release.

- **Sandbox account** — A SuiteProjects Pro sandbox account is an entirely separate instance of SuiteProjects Pro from your production account where you can develop new processes, customizations and integrations. You can use a sandbox account to test and train your employees in existing integrations and processes without affecting your production account data. The data in the sandbox account is a copy of your production account data. The sandbox account can be refreshed to bring in new data from your production account. Each refresh overwrites the previous sandbox account. You can purchase one or several sandbox accounts to allow for development and testing teams to have their own accounts in which to experiment.

During the upgrade period for a new release of SuiteProjects Pro, sandbox accounts are upgraded to the new version several weeks before your production account is upgraded to the new version. You should use your sandbox account to test new features and other changes in the upcoming SuiteProjects Pro release in addition to testing in your release preview account. Sandbox accounts have fewer limitations than release preview account.

The sign-in page you use to access SuiteProjects Pro is different for each type of account. The address bar of your browser shows a different URL after you sign in, depending on the type of account you signed in to. For more information, see [Your Account URLs](#).

## SuiteProjects Pro Sandbox

A SuiteProjects Pro sandbox account is an entirely separate instance of SuiteProjects Pro from your production account in which you can develop new processes, customizations and integrations. You can use a sandbox account to test and to train your employees in existing integrations and processes without affecting your production account data. The data in the sandbox account is a copy of your production account data at the time the sandbox was created. Each sandbox account can be refreshed to bring in new data from your production account. Each refresh overwrites the previous sandbox account. You can purchase one or several sandbox accounts to allow for development and testing teams to have their own accounts in which to experiment.

Sandbox accounts provide ideal places for:

- Testing customization elements and integrations before deployment.
- Fixing issues with existing customizations.

- Trying out new features.
- Developing training material, and training employees in existing and new business practices in an account identical to your production account.

Actions you take in sandbox accounts have no effect on your SuiteProjects Pro production account. You can feel free to make changes in a sandbox account without altering your production data.




**Important:** SuiteProjects Pro add-on services, API and platform and integration features let you exchange data with external systems. Make sure you connect your SuiteProjects Pro sandbox account only with other systems in a sandbox environment. Connecting your SuiteProjects Pro sandbox account with any systems in a production environment could result in a loss of data integrity.



**Note:** For more information about acquiring one or more sandbox accounts, contact your SuiteProjects Pro account manager. A sandbox account is created shortly after you purchase a license for a sandbox.

## General Guidelines about Sandbox Accounts

Review the following guidelines:

- To distinguish a sandbox account from your production account, look out for the following:
    - The domain part of the URL in the address bar of your browser indicates the type of account. The account-specific domain for a sandbox account is <company-id>.app.sandbox.netsuitesuiteprojectspro.com/, where <company-id> is a unique account identifier which is typically assigned based on the Company ID for your sandbox account.
-  **Note:** OpenAir is now SuiteProjects Pro. As of 5 a.m. Eastern Time (UTC-5) on January 25, 2025, for your sandbox account, and on February 15, 2025, for your production account, service URLs with the netsuitesuiteprojectspro.com domain name replace URLs with the openair.com domain name.

For your sandbox account, the account-specific domain now is <company-id>.app.sandbox.netsuitesuiteprojectspro.com. Any links or bookmarks to sign-in page or account URLs with the openair.com domain name redirect to the SuiteProjects Pro sign-in page, even if you have an active SuiteProjects Pro session in a different browser tab.

- The SuiteProjects Pro UI for your sandbox account includes the following mention immediately below the page header: This is a copy of <source-account>. It was created at <created>, where <source-account> is the Company ID for the account where the data was copied from, and <created> is the date and time in the Eastern Time (UTC-5) time zone when the sandbox account was created or refreshed.
  - The Company ID for your sandbox account is assigned at the time of purchase. You can change the **Company ID** at any time (Administration > Global Settings > Organization > Name & Address).
  - The unique account identifier part of the account-specific domain for your sandbox account is assigned based on the Company ID at the time the account is created. It can be changed upon

request. To change your account-specific domain, contact SuiteProjects Pro Support. The new account identifier <company-id> must be unique and include only allowed URL characters.

- By default, all active employees and guest users accessing your SuiteProjects Pro production account using SuiteProjects Pro credentials (user ID and password) can access the sandbox account using the same user ID and password. To prevent these employees and guest users from accessing the sandbox account, inactivate them in your sandbox account. Action is required to ensure that active employees using single sign-on to access your SuiteProjects Pro production account can access your sandbox account. See [Actions Required after Sandbox Creation or Refresh](#).
- Your sandbox account is an exact copy of the source account at a given date and time. It is not possible to pick and choose what data or configuration settings are copied across from the source account to the target sandbox account. It is not possible to specify the exact time when the source account snapshot should be taken. The snapshot is taken when the sandbox creation task starts, which depends on several factors including account size, server load, and other sandbox refreshes pending in the queue.
- Your sandbox account can be refreshed using your production account data on demand within your license limits. See [Refreshing Sandbox Accounts](#).
- You can enable optional features for your sandbox account in the same way you enable optional features for your production account by contacting SuiteProjects Pro Support. Any features that are enabled on your sandbox account but not on your production account will be cleared when your sandbox account is refreshed.
- Each add-on service license covers both your sandbox and production accounts. If a feature is part of a licensed add-on service that you have purchased for your production account, you can enable it on your sandbox account too.
- Functionality availability in your sandbox account is subject to some limitations. Action may be required to ensure the functionality is available after a sandbox is created or refreshed. ## When a Sandbox Account Expires

Licenses for sandbox accounts have expiration dates. Your sandbox account is canceled when the license for your sandbox expires. Your sandbox account data is deleted from all live and non-live environments six months after the sandbox account cancellation date.

 **Note:** Contact your SuiteProjects Pro account manager to renew your account before it expires.

## Features Available for Testing in a Sandbox

Many SuiteProjects Pro features are available for testing in sandbox accounts. Some features are only available in a limited form in sandbox accounts, and a few behind-the-scenes tasks that run in your production account do not run in your sandbox account. When your sandbox account is created or refreshed, not all features enabled in your production account are enabled in your sandbox account. Some features can be enabled for your sandbox account on request, and other functionality require action on your part before they can be used in your sandbox account. During sandbox creation and refreshes, certain objects are not copied from your production account. For more information, see [Data That is Not Copied from Production to Sandbox](#).

## Data That is Not Copied from Production to Sandbox

When a sandbox account is created or refreshed, the following information is not copied from your production account:

- **Attachments and workspace documents**

The attachment or document files are not copied from your production account to the sandbox account. Only the attachment or document metadata is copied across.

- **Triggers**

Automated tasks running behind-the-scenes on your production account are launched by triggers. Trigger information is not copied across from the production account during sandbox creation or refresh. To test these automated tasks on your sandbox account, you must enable the automated tasks and schedule them again by going to the corresponding form, changing the scheduled event configuration and saving the form. See [Actions Required after Sandbox Creation or Refresh](#).

- **SAML identity provider profiles**

SAML identity provider profiles are not copied from your production account to the sandbox account. You must deploy SAML single sign-on on your sandbox account if required for testing or authentication. See [Actions Required after Sandbox Creation or Refresh](#).

- **Two-factor authentication (2FA) user settings and setup**

The following user information is not copied from your production account to the sandbox account: **Two-factor authentication required** demographic setting, the **2FA required**, **2FA status**, **Complete 2FA setup by** date information shown on the employees list, user 2FA setup (authenticator app) information. You need to enroll users to sign in using 2FA and users will need to repeat the 2FA setup after each sandbox refresh, if required.

- **Reports published using the Business Intelligence Connector feature**

By default, the Business Intelligence Connector feature is never enabled for your sandbox account when the account is created or refreshed. Published reports in your production account are not copied across to the sandbox account. To test access to published report in your sandbox account, you must enable the feature for your sandbox and publish the reports to the Business Intelligence Connector in your sandbox account. See [Actions Required after Sandbox Creation or Refresh](#).

- Note:** Auditing information is copied across from your production account to your sandbox account. This includes audit trail fields, web services log reports, SuiteProjects Pro NetSuite Connector status logs, user scripting logs. Review the following guidelines:
- **Audit trail fields** — The audit trail information recorded for every change to the record includes the internal ID for your company's SuiteProjects Pro account (`db_id`). This `db_id` is different for your production account and your sandbox account. You can use this information to identify the changes that were made in your production account, and those that were made in your sandbox account after it was created or refreshed.
  - **Web services log reports** — The reports show the web services requests made in your production account before the sandbox was created or refreshed and in your sandbox account after it was created or refreshed. Links to view the request and response for web services requests made in your production account do not work when viewing the report in your sandbox account.

## Refreshing Sandbox Accounts

Each of your sandbox accounts can be refreshed from your production account upon your request.

- Note:** The account where the data is copied from is referred to as the source account. The sandbox account that is created or refreshed with a copy of the data from the source account is referred to as the target account.

Typically, the source account is your production account. In some cases, the source account can be another sandbox account. If you hold valid licenses for more than one sandbox accounts, and can provide a business justification to support your request, you can refresh a sandbox account from another sandbox account. You must specify the Company ID for both source and target sandbox accounts.

Review the following guidelines before requesting a refresh:

- Refreshing a sandbox account replaces all configuration settings, all data, all user passwords, and all customizations in the target account with those from the source account. Any changes you made to the target sandbox account before the refresh are overwritten.
- When refreshing a sandbox account, the target sandbox account is deleted and replaced with a copy of the source account. After the refresh starts, all the data previously held in the target sandbox account is lost and cannot be recovered.
- Any features that are enabled on your sandbox account but not on your production account are cleared when your sandbox account is refreshed.
- The sandbox refresh process starts after SuiteProjects Pro Support acknowledges and accepts your request. You cannot access your sandbox account while the sandbox refresh process is under way.
- The company ID and account specific domain for the target account are the same before and after the refresh unless you specify otherwise at the time of requesting the refresh.

- Refreshing a sandbox account can take anything from a few hours up to 72 hours to complete. The delay depends on several factors including account size, server load, and other sandbox refreshes pending in the queue.
- The number of sandbox refreshes is limited to one per month. To increase the limit to one per week, contact your SuiteProjects Pro account manager.
- Functionality availability in your sandbox account is subject to some limitations. Action may be required to ensure the functionality is available after a sandbox is created or refreshed. For more information, see [Features Available for Testing in a Sandbox](#).

### To request a sandbox refresh:

1. Create a support case. See [Creating a Support Case](#).

Enter the following details on the Create a Support Case form:

- In **Step 2. Click here to select the type of case you'd like to create**, select "Ask a question".
- In **Step 3. Select a case severity**, select "C3 — How To / Non Urgent questions".
- In **Step 4. Which Feature does it relate to?**, select "Sandbox Refreshes/Questions" under the category "Non-Product Inquiries".
- In **Step 5. Provide a short summary of your problem/question**, enter "Sandbox account to be refreshed: <sandbox\_id>".

**Note:** Specify the Company ID (<source\_sandbox\_id>) for the source sandbox accounts.


If you want to refresh a sandbox account with data from another sandbox account, provide also the following information:

- The Company ID (<source\_sandbox\_id>) for the source sandbox accounts.
- Business justification.

By default, some functionality running in the source account or target account before the refresh does not run in the target sandbox account after the refresh. You can include a list of the functionality that you want to enable for your target sandbox account when you request the sandbox refresh or you can create a new support case to enable the functionality after your sandbox is refreshed. Further actions may be required to ensure that the functionality is available and operational in your sandbox account after the refresh. For more information, see [Actions Required after Sandbox Creation or Refresh](#).

2. SuiteProjects Pro Support will contact you to acknowledge your request and will proceed with the sandbox refresh.

SuiteProjects Pro Support will contact you again when the sandbox refresh is completed.

 **Warning:** Your refresh request cannot be canceled or otherwise modified in any way after it has been acknowledged and accepted.

You cannot access the target sandbox account while the refresh is under way.

The new sandbox completely replaces the previous sandbox. The new sandbox contains a copy of account data that is a snapshot taken from your chosen source account at the time of the sandbox refresh. All the data previously held in the target sandbox account is lost and cannot be recovered.

If you want to retain any changes made in your sandbox account before the refresh, save these changes outside of the sandbox account so that they are available to be added to the new sandbox after the refresh. Account administrators should formulate a strategy to save any changes made in the previous sandbox and add them to the new sandbox, and inform users of the processes to be used.

### How can I differentiate between my production and sandbox accounts?

To distinguish a sandbox account from your production account, look out for the following:

- The domain part of the URL in the address bar of your browser indicates the type of account. The account-specific domain for a sandbox account is <company-id>.app.sandbox.netsuitesuiteprojectspro.com/, where <company-id> is a unique account identifier which is typically assigned based on the Company ID for your sandbox account.

 **Note:** OpenAir is now SuiteProjects Pro. As of 5 a.m. Eastern Time (UTC-5) on January 25, 2025, for your sandbox account, and on February 15, 2025, for your production account, service URLs with the netsuitesuiteprojectspro.com domain name replace URLs with the openair.com domain name.

For your sandbox account, the account-specific domain now is <company-id>.app.sandbox.netsuitesuiteprojectspro.com. After signing in, you are redirected to an account URL with the netsuitesuiteprojectspro.com domain name. Any links or bookmarks to sign-in page or account URLs with the openair.com domain name redirect to the SuiteProjects Pro sign-in page, even if you have an active SuiteProjects Pro session in a different browser tab.

## About Sandbox Refreshes

The following questions and answers are specific to refreshing your sandbox.

### Can I specify a date and time for the sandbox refresh?

Refreshing a sandbox account involves deleting the sandbox account and creating a new sandbox account. You can specify when you would like the sandbox refresh process to be initiated. However, you cannot specify exactly when the snapshot of your production account will be taken and the creation of your sandbox account will start. Various factors determine when the new sandbox creation will start and when the snapshot of your production account will be taken, including the time it takes to delete the existing sandbox, size of your production account (the amount of data), current loads on the SuiteProjects Pro servers, and the number of customers requesting a new sandbox or a sandbox refresh during the same time window.

### How long does it take for my sandbox to be refreshed?

Refreshing a sandbox account can take anything from a few hours up to 72 hours to complete. Various factors determine how long it takes to refresh your sandbox, including the size of your production account (the amount of data), current loads on the SuiteProjects Pro servers, and the number of customers requesting a new sandbox or a sandbox refresh during the same time window.

### Can I cancel my sandbox refresh request?

It is not possible to cancel a refresh request.

A refresh completely replaces the content of the sandbox account with the content of the production account. After your sandbox account has been refreshed from production, it cannot be restored to its prior state. Before submitting a request to refresh a sandbox account, please ensure that your company is fully notified and ready for the refresh from production. Your refresh request cannot be canceled or otherwise modified in any way after it has been acknowledged and accepted. See [Refreshing Sandbox Accounts](#).

### Is there a limit to the number of sandbox refreshes.

The number of sandbox refreshes is limited to one per month. To increase the limit to one per week, contact your SuiteProjects Pro account manager.

### I have some important data I want to keep in my sandbox. Can my data be saved during the next refresh?

A sandbox is not intended for storage of data. A refresh completely replaces the content of the sandbox account with the content of the production account snapshot. Any data that exists in a sandbox before a refresh is requested is overwritten by the refresh. See [Refreshing Sandbox Accounts](#).

### What happens to my sandbox during a SuiteProjects Pro version upgrade?

All sandbox accounts are upgraded typically three weeks before the production upgrade. Accounts are unavailable during the upgrade, which typically takes several hours.



# SuiteProjects Pro Account Identifiers and URLs

Each SuiteProjects Pro account has the following unique identifiers.

- **Company ID** – This is the unique identifier for your company's SuiteProjects Pro account. Account users enter the company ID on the SuiteProjects Pro sign-in page when signing in. You can change the Company ID in Administration > Global Settings > Organization > Name & Address. - **Account- specific domain name** – Your SuiteProjects Pro account URL includes a unique domain name that is specific to your account. Your account-specific domain name includes a unique account identifier <company-id> which is typically assigned based on the Company ID for your account and identifies the type of account. See [Your Account URLs](#).
- **Database ID (db\_id or Account No)** – This is the unique internal ID for your company's SuiteProjects Pro account. You may need to reference the database ID when contacting SuiteProjects Pro Support or setting up certain NetSuite integration features. See [Finding the Database ID for Your Account](#).

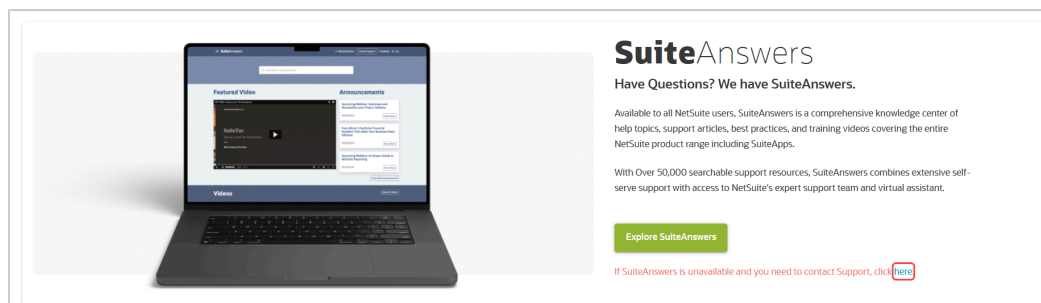

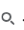

 **Note:** A strict process is in place to verify the identity of the account administrator contacting SuiteProjects Pro Support to unlock the user account or reset a password.


- Before contacting SuiteProjects Pro Support, use self-service help resources such as the SuiteProjects Pro Help Center or Suite Answers for possible answers to your inquiry. You can search on the SuiteAnswers page to find support articles, training videos, help topics, and best practice documents on any subject need help with
- Wherever possible and regardless of your support services subscription, you should call SuiteProjects Pro Support only in case of a critical concern (C1). For all non-critical concerns (C2 to C4), you should submit an online case. For information about the different case severity levels C1 to C4, see [Case Severity Definitions](#).

- The SuiteProjects Pro account type (production, sandbox, preview) and the company ID for the SuiteProjects Pro account where the problem exists.
- A full description of the problem and how the outcome differs from the expected behavior or result.
- Screenshots demonstrating the problematic behavior.
- Detailed steps to reproduce or demonstrate the problem.
- Details of all troubleshooting steps you attempted.
- Any special circumstances that led to the discovery of the problem.
- The date and time when the problem started or when you noticed the problem.
- The exact wording of any error messages returned.
- You should never include any sensitive information such as sign-in credentials, credit card numbers, or personally identifiable information, for example..
- You should contact the person in your company who manages SuiteProjects Pro (account administrator) before reaching out to SuiteProjects Pro Support to report a problem. Any troubleshooting steps must be done by an account administrator in most cases, as users with other roles often do not the necessary permissions and access privileges.

 **Note:** Account administrators can nominate users who are authorized to submit a Support case. To do so, contact SuiteProjects Pro Support.

## Case Severity Definitions

Review the following case severity definitions and always use the appropriate case severity when submitting a case.

Using the appropriate case severity helps SuiteProjects Pro Support prioritize between cases. Otherwise, SuiteProjects Pro Support need to evaluate the true urgency of each case, which slows down the response time to all cases.

- **C1 – Critical / Business Down:** Production use of the service is stopped or so severely impacted that the company cannot reasonably continue business operations.
- **C2 – Urgent:** One or more important functions of the service are unavailable with no acceptable alternative solution. Customer's implementation or production use of the service is continuing but there is a serious impact on business operations.
- **C3 – How-to / Non-urgent Questions:** Important service features are unavailable but an alternative solution is available, or less significant service features are unavailable with no reasonable alternative solution. There is minor loss of business operation functionality or an impact on implementation resources.

 **Note:** Use the case severity C3 - How-to / Non-urgent Questions when submitting a case to request a sandbox refresh.

- **C4 - Enhancement / Non-tech Support:** An incident that has a minimal impact on business operations or basic functionality of the service.

## Case Resolution Overview

Unless our Support team is able to resolve the case, the Support team will log an issue and a with the case. There are two types of issues: defect or enhancement.

- An issue is categorized as a defect when the problem occurs with an existing SuiteProjects Pro feature that does not work as designed.
- An issue is categorized as an enhancement when the issue is a request for additional functionality for an existing feature or for a new feature.

The resolution of customer-reported defects, and the timeframe for resolution is appropriate to the severity of each defect. SuiteProjects Pro defines three levels of defect severity:

- **S1:** The defect blocks one or more core business functions from working. Resolution is a top priority.
- **S2:** The defect is not preventing any core business functions from being operational. Prioritization depends on the business use case and number of customers impacted.
- **S3:** The defect is not a significant hindrance to the business or an alternative solution is available or is not a significant hindrance to the business.

Our Support team communicates significant updates related to the defect resolution with impacted customers. The Support team can also provide further assistance as needed. If you want to request additional information or discuss an issue's severity level, please update your support case for assistance.

## Get Ready for Your SuiteProjects Pro Account Upgrade

SuiteProjects Pro delivers changes to customers in one of three ways:

- Major release – SuiteProjects Pro delivers two major releases each year. All production accounts are upgraded at the same time for all major releases of SuiteProjects Pro. All sandbox accounts are upgraded 3 weeks before the production upgrade.

- E-fix – An e-fix is a scheduled maintenance release used to resolve customer-reported issues that do not require immediate attention but should be fixed prior to a major release. Each e-fix is rolled out to all production and sandbox accounts at the same time.
- Hot push – A hot push is an update that occurs outside of the release schedule to fix critical customer-reported issues that cannot wait for the next scheduled e-fix. A hot push is rolled out to all production and sandbox accounts at the same time.

## OAuth 2.0 Token Based Authentication


SuiteProjects Pro supports OAuth 2.0, a robust authorization framework. This authorization framework enables client applications to use a token to access SuiteProjects Pro through the XML API, SOAP API, or REST API. The application accesses the protected resources on behalf of a user who gave an explicit permission for the access. This method eliminates the need for API integrations to store user credentials.

This feature is available if API Access is enabled for your account. It includes the following elements:

- **Administrators** can register up to 20 integration applications with SuiteProjects Pro and enable or disable these applications in the Administration module. For more information, see [Managing API Integration Applications](#).
- **Administrators** can use web services reports to audit and revoke authorizations granted by SuiteProjects Pro users to integration applications. For more information, see the help topic [Auditing and Managing OAuth 2.0 Authorizations](#) under  [Security](#).
- **Application Developers** can use the OAuth 2.0 authorization code flow to get an access token then use the access token to access your SuiteProjects Pro data using the API. For more information, see the help topic [OAuth 2.0 for Integration Applications Developers](#) (Help topic under API).

 **Note:** SuiteProjects Pro only supports the OAuth 2.0 authorization code grant type.


- **End-users** can give applications explicit permission to access SuiteProjects Pro on their behalf and they can revoke this permission at any time. For more information, see [Authorizing Applications to Access SuiteProjects Pro on Your Behalf](#).

 **Note:** The first time a registered application attempts to access SuiteProjects Pro on their behalf, users must sign in using the same trusted sign-in page they normally use to sign in to SuiteProjects Pro then give the application explicit permission. The OAuth 2.0 feature supports the following user authentication mechanisms:



- Password authentication by SuiteProjects Pro — Users enter their Company ID, User ID and Password on the SuiteProjects Pro sign-in page.
- SAML authentication:
  - Service Provider initiated Single Sign-on — Users enter their sign-in details on your company Single Sign-on form.
  - Identity Provider initiated Single Sign-on — Users must sign in using their Identity Provider Single Sign-on form before the application attempts to access SuiteProjects Pro on their behalf. When the application attempts to access SuiteProjects Pro, the authorization page appears automatically. Users do not need to enter their sign-in details again if the Single Sign-on session has not expired.


## Managing API Integration Applications

Integration applications using OAuth 2.0 to obtain access to your SuiteProjects Pro data must be registered and enabled by an account administrator. To register and manage your integration applications, go to Administration > Global Settings > Account > API Integration Applications.

 **Note:** API Access must be enabled in your account to connect tools and services to SuiteProjects Pro using the API. The Business Intelligence (BI) Connector feature must be enabled in your account to connect tools and services to your published reports using the REST API. The API Integration Application page is not available unless API Access or BI Connector is enabled. To enable API Access or BI Connector in your account, contact SuiteProjects Pro Support or your SuiteProjects Pro account manager.

1. All your registered applications are listed in a grid. Details include the name of the application and the date and time when it was last updated.

2. To register a new application, click **ADD NEW APP**. This button is disabled if you reach the limit of 20 registered applications. See [Adding a New Application](#).
3. To enable or disable an application, click **ENABLE** or **DISABLE** in the top right corner of the corresponding box. See [Enabling, Disabling, or Removing Registered Applications](#)
4. To edit an application configuration, click the edit icon  in the bottom right corner of the corresponding box. See [Application Configuration](#).
5. To remove an application configuration from the list of registered applications, click the delete icon  in the bottom right corner of the corresponding box. See [Enabling, Disabling, or Removing Registered Applications](#).

## Adding a New Application

You can register up to 20 applications. Each application needs a Client ID and Client Secret to obtain access to SuiteProjects Pro using OAuth 2.0. The Client ID and Client Secret are generated by SuiteProjects Pro as part of the registration process and are unique to each application.



**Important:** The Client Secret is a **private** key the application uses to request an authorization code from SuiteProjects Pro. It should not be shared or stored in public code repositories.

The Client Secret is displayed only one time. You will not be able to retrieve it after you close the Application Credentials dialog.

If you misplace the Client Secret, you can edit the application configuration and generate a new Client Secret for the application.

## To register a new application with SuiteProjects Pro:

1. Do one of the following:
  - Go to Administration > Global settings > Account > API Integration Applications, and click **ADD NEW APP**.
  - From any page in SuiteProjects Pro, click the Create button and click API integration application. The Add New Application popup window appears.
2. Enter the following information:
  - **Application name** (Required) — Enter a display name for your application in SuiteProjects Pro. The name must be unique to the application. You will not be able to use a name already used by another registered application.
  - **Description** — Enter a few sentences to tell your employees what the application and how it will help them. Your employees will use this information to decide whether they allow this application to access SuiteProjects Pro on their behalf.
  - **Redirect URI** (Required) — Enter a link users should be redirected to after granting or denying the application permission to access SuiteProjects Pro on their behalf.

## Enabling, Disabling, or Removing Registered Applications

You must enable an application to allow this application to obtain access to SuiteProjects Pro using OAuth 2.0.


You can disable an application to prevent this application from obtaining access to SuiteProjects Pro using OAuth 2.0. If you disable an application, SuiteProjects Pro automatically revokes all permissions given by users for the application to access SuiteProjects Pro on their behalf. Employees will not be able to use the disabled application.

You can remove a disabled application from the list of registered applications. All permissions, authorizations and application credentials associated with the application configuration will be deleted. This action cannot be undone.

### To enable or disable a registered application:

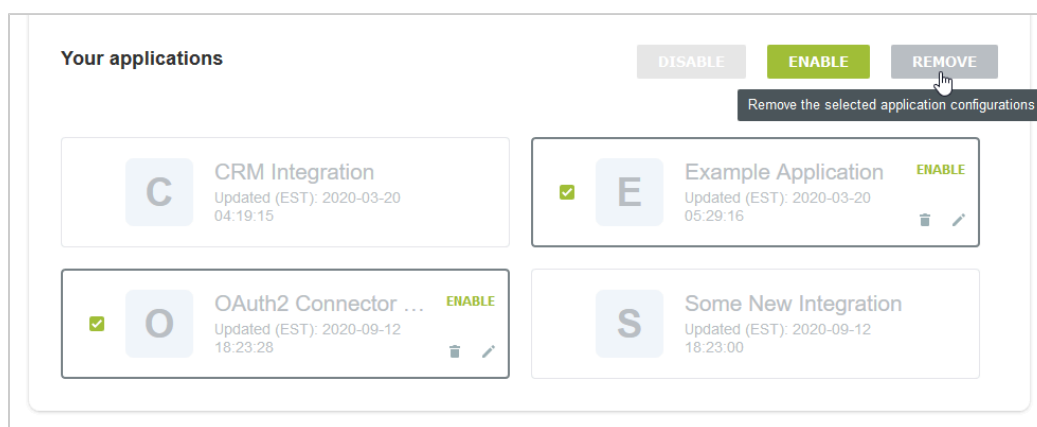
1. Go to Administration > Global settings > Account > API Integration Applications.
2. Click **ENABLE** or **DISABLE** in the top right corner of the corresponding box. A confirmation popup window appears.

### To remove a registered application:

### To enable, disable, or remove multiple applications at the same time:


1. Go to Administration > Global settings > Account > API Integration Applications.
2. Check the box for each application you want to enable, disable, or remove. Notice that you can only select multiple applications if they are either all enabled, or all disabled. After you select the first application, the application that are not available for selection appear in light gray color. Notice also that some of the buttons in the top right corner of the list of registered applications become available and change from light gray color to dark gray or green.



3. Click **ENABLE**, **DISABLE**, or **REMOVE** to perform the corresponding action on all selected applications. A confirmation popup window appears. Click **ENABLE**, **DISABLE**, or **REMOVE** to confirm. Click **Cancel** to cancel the operation and return to the API Integration Applications page.

## Application Configuration

You can view the configuration details of your registered applications, including their unique Client ID from the Application Configuration form. You can change the application name, description or Redirect URI or generate a new Client Secret for the application.

To open the Application Configuration page for a registered application, go to Administration > Global Settings > Account > API Integration Applications and click the edit icon  in the bottom right corner of the corresponding box.

1. The **General** section of the form lists the main application detail:
  - You can change the **Application name**, **Description** and **Redirect URI**.



**Important:** Client applications use the redirect URI when requesting access to SuiteProjects Pro. Ensure you enter the redirect URI supplied by the application developers. If you need to change the redirect URI, disable the application, change the redirect URI and enable the application again.

- You can view when the application was registered under **Created**.

**Note:** All times are given as Eastern Standard Time (EST).

2. You can view the **Client ID** — the unique identifier a client application needs to send to SuiteProjects Pro along with a client secret as part of the OAuth 2.0 authorization code flow.
3. Use the **Tokens Lifetime** section to configure the validity period of the access and refresh tokens:
  - **Access token lifetime** — Select the expiration time of access tokens. Available values go from 5 to 60 minutes in 5-minute increments. The default access token lifetime is 15 minutes.

**Note:** The validity period of access tokens cannot be greater than the session timeout set for your account. If the **Access token lifetime** value is greater than the session timeout value, the session timeout value is used for the access token validity period. The application configuration form shows the current values for the session timeout and access token validity period for reference.

To change the session timeout value, go to Administration > Global settings > Account > Security.

- **Refresh token lifetime** — Select the expiration time of refresh tokens. Available values go from 1 to 31 days in one-day increments. The default access token lifetime is 1 day.

**Note:** Before the SuiteProjects Pro 2021.2 release, you could set the refresh token lifetime to values from 1 to 24 hours in one-hour increments. Values for the refresh token lifetime set before the SuiteProjects Pro 2021.2 release show in days (decimal values) instead of hours

As part of the OAuth 2.0 authorization code flow, authorized applications need to exchange an authorization code for an access token and refresh token to obtain access to SuiteProjects Pro. The access token has a short expiration time. When the access token expires, the client application can use the refresh token to obtain a new access token without user interaction until the refresh token expires or the authorization is revoked.

**Note:** Access tokens normally remain valid for their entire lifetime. However, the access token becomes invalid before it is due to expire if any of the SuiteProjects Pro business rules have changed and the access token is refreshed. Business rule changes may include any changes to your company's SuiteProjects Pro account configuration, or to the access privileges or role permissions of the employee who authorized the client application.

Each refresh token can be used one time only. Refresh in an access token generates a new access token and a new refresh token.

4. To generate a new Client Secret, click **Regenerate Secret** — You may need to generate a new client secret if you misplace or delete the client secret accidentally or if your client secret becomes compromised.

The new client secret will be valid immediately. The old client secret will continue to be valid for 24 hours after you generate a new one. This allows time to update any enabled application with the new client secret.

5. If you made any changes to the configuration details in the General section, the **Save** button is enabled. Click **Save** to save changes and return to the API Integration Applications page or click **Cancel** to close the configuration form without saving.

## Authorizing Applications to Access SuiteProjects Pro on Your Behalf

Integration applications let you connect SuiteProjects Pro with other applications and they extend what you can do with SuiteProjects Pro. Integration applications may use the OAuth 2.0 authorization protocol to gain access to your company's SuiteProjects Pro account.

The first time an application using the OAuth 2.0 protocol attempts to access SuiteProjects Pro on your behalf, you will need to give this application your explicit permission.

To authorize an application, you will typically use the following steps:

1. The application opens a browser and directs you to the same trusted sign-in page you normally use to sign in to SuiteProjects Pro — the SuiteProjects Pro sign-in page or your company Single Sign-on form appears.
2. Enter your sign-in details and click **Log in**.  
An authorization page will appear indicating that the application <application name> would like to access your SuiteProjects Pro data.
3. Read the content of the authorization page attentively. It should describe what the application does and how it will help you. It should also say what the application can do, for example:
  - The application will be able to access all data you have access to.
  - The application will be able to perform all actions permitted by your role and user privileges.



**Important: For Administrators** — Business rules configured for your company's SuiteProjects Pro account are applied when an integration application interacts with your SuiteProjects Pro data through the REST API. However, they are not applied when an integration application interacts with your SuiteProjects Pro data through the SOAP API or XML API — application developers must enforce business rules within their integration application if required. Business rules include SuiteProjects Pro account configuration settings and access control mechanisms, as well as any user scripts deployed on your company's SuiteProjects Pro account.

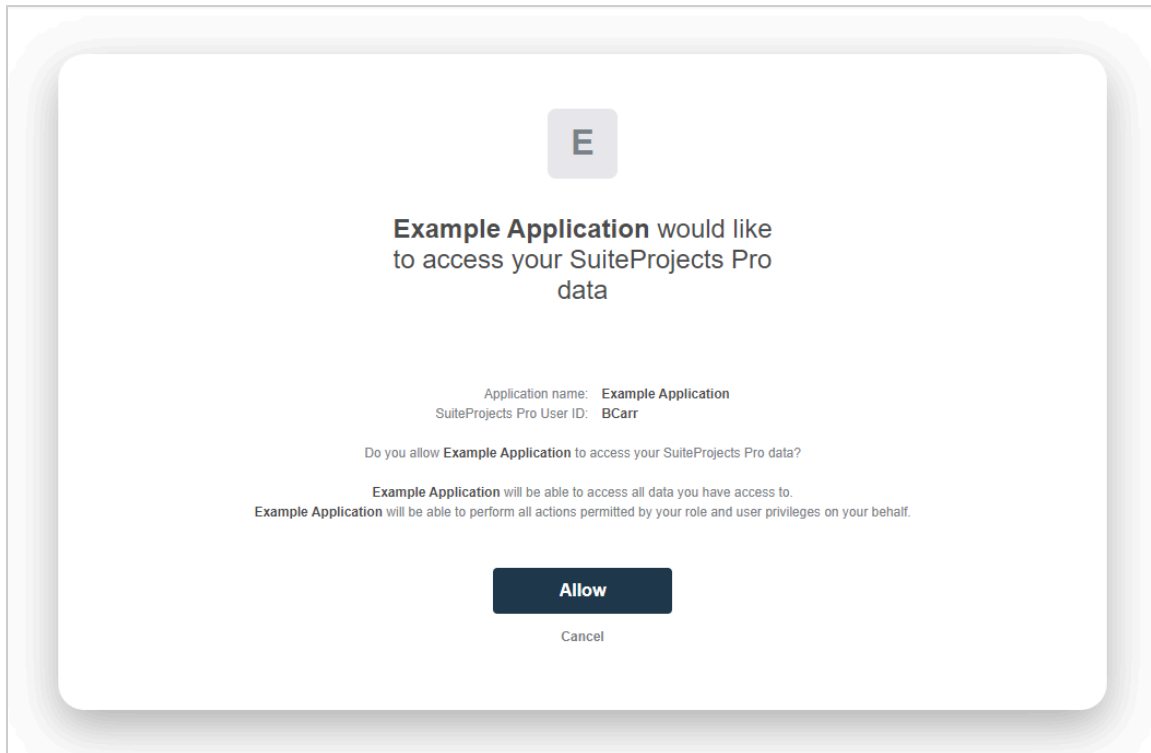
4. Click **ALLOW** to authorize the application or click **CANCEL** if you do not want the application to access SuiteProjects Pro on your behalf.



**Note:** The steps may vary depending on the method you use to sign in to SuiteProjects Pro:

- If you normally enter your company ID, user ID and password on the SuiteProjects Pro sign-in page, or if you enter your company ID on the SuiteProjects Pro sign-in page and then your password on your company single sign-on page, the above steps apply.
- If you normally need to enter all sign-in details on your company single sign-on page to access SuiteProjects Pro without going to the SuiteProjects Pro sign-in page first (Identity Provider initiated Single Sign-on), you must sign in and launch SuiteProjects Pro before the application attempts to access SuiteProjects Pro on your behalf. The authorization page appears automatically. Follow steps 3 and 4 above. You do not need to re-enter your sign-in details.

Integration applications are registered and managed by your account administrator. They need to be enabled on your account before they can attempt to connect to SuiteProjects Pro and request your permission.



**Note:** Integration applications are registered and managed by your account administrator. They need to be enabled on your company's SuiteProjects Pro account before they can attempt to connect to SuiteProjects Pro and request your permission.

Account administrators can disable an application at any time.

- If you have authorized an application and this application is disabled by an administrator, the application will no longer be able to interact with SuiteProjects Pro.
- If an administrator enables this application again, you will need to give this application your explicit permission again before you can continue to work with it in connection with SuiteProjects Pro.

After you authorize an application, it will be able to interact with SuiteProjects Pro on your behalf until you revoke the authorization.

To view the application you have authorized, go to User Menu > Personal Settings > Authorized Applications. All your authorized applications are listed in a grid. Details include the name of the application and the date and time when it was last updated.

**Note:** All times are given as Eastern Standard Time (EST).

To revoke an application, click **REVOKE** in the top right corner of the corresponding box, then click **REVOKE** in the confirmation message. The application no longer shows in the authorized applications list. If a revoked application attempts to access SuiteProjects Pro on your behalf, you will be prompted to give this application your explicit permission again.

## Automatic Backup Service


The Automatic Backup Service (ABS) lets you set up a regular delivery of your account data to an email address or SCP/SFTP server for safeguarding. Your data is compressed as a ZIP file and can be PGP encrypted for additional security. You can use this feature to download all of your data, workspace documents and attachments.

**Note:** The Automatic Backup Service is a licensed add-on and must be purchased separately. To enable the Automatic Backup Service feature, contact your SuiteProjects Pro account manager or SuiteProjects Pro Professional Services.

## Setting up the Automatic Backup Service


When the Automatic Backup Service (ABS) is enabled, go to Administration > Global Settings > Account > Automatic backup service and configure your backup settings.

- **Data to include in the backup** — Select which data will be exported in each backup. You can include the SuiteProjects Pro Data Dictionary, text files (either comma- or tab-delimited) and MySQL import file. You can set the default CHARSET for your MySQL import files to "UTF-8", and include table relationships in the MySQL import file.

 **Note:** If the **Apply relationships** box is checked, the MySQL import file contains statements to support table relationships:

- Change the storage engine to "InnoDB".
- Change foreign key columns to allow null values.
- Set foreign keys to null if the value is 0 (zero).


- **Documents and attachments** — Check the **Document and attachments** box to include them in the backup.
  - By default, the filename of each attachment and workspace document is the system-generated internal ID for the attachment (document). You can append the original names and extensions to documents and attachments in addition to the internal ID.
  - You can use a **Date range filter** to include only documents and attachments created or updated during a specific period. Using a date range filter can be useful to manage the size of the backup file. The form indicates the total file size of selected documents before compression.
- **When do you want the backup to run** — schedule when you would like the backup to run. You can set the schedule to particular days of the week or month, or every day. You can also set the time for the backup to run. You should run the backup in the evening for better performance.
- **How do you want the data sent** — Select how the data should be sent. Options include SCP, SFTP or Email. Emails will not be sent if the files are larger than 60 MB. You can also suspend the service.


 **Important:** Support for the FTPS protocol in the Automatic Backup Service stopped on January 20, 2021.

- **SCP/SFTP settings**
  - **Address** — Enter the IP address or DNS name for your SCP or SFTP connection.
  - **Directory** — Specify a directory to place the exported file in.
  - **User name** — Enter the user name used for your SCP or SFTP connection.
  - **Password** — Enter and verify the password for the SCP or SFTP service.
  - **Status email** — Enter an email address for status emails to be sent to.
  - **Status notification** — Select which events are included in status emails. You can include all events or errors only.
  - **Disable remote file attribute copy** — Try to check this box if you receive setstat errors during the ABS transfer.
  - **Try to resume transfer when it fails** — Check this box to try and resume the transfer in case the connection to the SFTP server is interrupted. This is only available if you choose to send your data using SFTP.

If the SFTP connection is interrupted, SuiteProjects Pro will attempt to retry the scheduled automatic backup transfer twice. After the third unsuccessful attempt, an error is logged and a status notification email is sent to advise that the automatic backup was unsuccessful. The status notification email also indicates if the connection is interrupted but the automatic backup completes successfully on the second or third attempt.

- **Seconds between retry attempts** — Enter the time interval (in seconds) between ABS transfer attempts. The interval can be between 5 seconds (default) and 5 minutes.

 **Note:** After you change the transfer method to SFTP, click **Save** to see the **Try to resume transfer when it fails** box and **Seconds between retry attempts** field.

 **Important:** Support for custom remote ports for SCP or FTPS in the Automatic Backup Service stopped on January 20, 2021.

- **SSH Security Information** — After you set up the ABS and SuiteProjects Pro connects with the SCP or SFTP server, SuiteProjects Pro stores the SSH public keys for all hosts ABS connected to (**Known hosts**). To clear the list, check the **clear list** box.

 **Note:** To replace an existing SSH public key with a new one:

1. Check the **clear list** box.
2. Click **Save**.
3. Click the Tips button then **Test ABS connection settings**. If the connection test is successful, the new SSH public key is added to **Known hosts**.

- **PGP Encryption** — If you want to use PGP encryption, copy and paste the PGP public key in the text box.
- **Other**
  - **Include the audit trail in the text backup** — By default, text files do not include audit trails. Check this box to include the audit trail. This can make the text files difficult to parse. MySQL import files always include the audit trail.
  - **Include all tables in the text and MySQL backups** — By default, the export excludes some tables with typically large datasets such as `assign_by_day`, `booking_by_day`, `schedule_by_day`, and `user_tag_by_day` for example. Check this box to include all tables in text and MySQL backups.
  - **Include status file with backup** — Check this box to include a small status file with data about the transfer. The status file contains the checksum of transferred file(s), file size, and the list of all tables.
  - **Tables to exclude** — You can exclude tables from a MySQL import file here. Enter the list of tables to exclude, separated by commas.

## Exporting All SuiteProjects Pro Attachments

When set up, each export will contain a folder within the main ZIP file containing all attachments, labeled with a numeric attachment ID. Select the “Add original names and extensions to Documents and attachments” option in the “Data to include in the backup” section to add the original attachment filenames to each attachment in addition to the numeric attachment ID.

## FilterSet Settings

Using filter sets lets you specify access privileges to various entities in SuiteProjects Pro such as customers, projects, and employees. You assign filter sets to employees. Based on how filter sets are created, an employee's view and access to the various entity values can be narrow or expanded to a wider and possibly an all-value level. Employees may have more than one filter set assigned to them, but only one may be used at any particular time. Essentially, a filter set is what an employee can see and a role is

what an employee can do within SuiteProjects Pro. For more information about filter sets, see [Filter Sets Overview](#).

To access the Filter Set settings, go to Administration > Global Settings > Account > FilterSet settings.

The following settings control filter set options for all users in your company's SuiteProjects Pro account. Check or clear the corresponding boxes as applicable.

- Require a filter set selection when adding or editing Customers
- Require a filter set selection when adding or editing Projects
- Require a filter set selection when adding or editing Project stages
- Require a filter set selection when adding or editing Services
- Require a filter set selection when adding or editing Employees
- Require a filter set selection when adding or editing Expense items
- Require a filter set selection when adding or editing Time types
- Require a filter set selection when adding or editing Charge stages
- Require a filter set selection when adding or editing Booking types
- The "Access to booked Projects/Customers" filters respect the booking type filter set

**Note:** If a Booking type filter set was created, this option restricts which projects and customers are available to the employee.

## Global Search

**Note:** The Global Search feature was enabled by default for all accounts with the 2024.2 upgrade. To disable the feature in your company's account, contact SuiteProjects Pro Support.

The Global Search feature brings together navigation suggestions, personal shortcuts and modern search in one place.

For more information about using the global search, see the help topic [Getting Started with Global Search](#).

Account administrators can control global search settings and perform maintenance tasks. To do so, go to Administration > Global settings > Account > Global search.

The global search settings page lets account administrators:

- Choose whether to add global search coverage for additional item types in your company's account as and when this coverage becomes available.

**Note:** In SuiteProjects Pro 2024.2, global search coverage is limited to navigation items (main navigation and create menu), customers, projects and employees (resources). These item types are always available using the global search and it is not possible to remove coverage for these object types.


As and when we extend global search coverage to additional item types in future, coverage for each additional object type will be optional. Account administrators will be able to add or remove coverage for these additional object types in your company's account.

- Update the information available for an object type in the global search functionality. To do so, locate this object type and click **Synchronize**.

The data synchronization is queued and progress information (percentage) or the date and time the last synchronization completed is shown on the page.

Object data synchronization may be required when:

- A new navigation item or create action is introduced in your company's account by a new release or by a change in your account configuration. In this case, you must synchronize navigation items before you can search for the newly introduced navigation items and create actions.
- We make changes to the information that you can use to search for objects. This may be the case, if we add additional information you can search objects by, such as the news feed status to search for projects, for example.
- We make changes to the way object data is indexed to improve the search functionality.
- You change your account terminology. In this case, you should synchronize all item types that are impacted by the terminology changes so that these changes are reflected in search results.
- There is a problem with the global search functionality, such as missing results. If this is the case, updating the information may help to resolve the problem.

 **Note:** If global search coverage includes coverage the object type, the global search object data is updated automatically if an object is added, deleted, or if any of the information available for search is modified.


The global search object data is deleted automatically if you disable the Global Search feature for your company's SuiteProjects Pro account. It is updated automatically if you enable the Global Search feature again.

The global search object data for a specific object type is deleted automatically if you disable all access to the application that includes this object type. It is updated automatically if you enable access to the module again.

## Integration: Import/Export

The Integration: Import/Export page contains links for exporting:

- Your company's account data – See [Exporting your Account Data](#).
- The SuiteProjects Pro WSDL definition specific to your account – See the help topic [Account-Specific SuiteProjects Pro WSDL Definition](#).
- XML schema for each business object type supported by the XML API – See the help topic [XML Schema Definitions](#).
- Export charge, invoice, timesheet, or expense report data to a CSV file for batch processing.

 **Important:** You should use the Integration Manager or SuiteProjects Pro API instead to export data for batch processing instead of the batch data export functionality on this page. The Integration Manager and API give you more flexibility over what information your export and how the export CSV file is constructed. For more information, see the help topics [Integration Manager Overview](#) and [API Overview](#).

## Exporting your Account Data

Account administrators and users with the *Export data* role permission can use the following steps to download your company's SuiteProjects Pro account data.




You can export your account data in the following formats:

- Comma- or tab-delimited text files (one CSV file for each table exported).
- MySQL dump file (one single SQL file) for the version of MySQL currently in use by SuiteProjects Pro. You can then import this SQL file into a MySQL database and run queries and reports against it.


### To export your account data:

1. Go to Administration Global Settings > Account > Integration: Import/Export.
2. In the Import/Export page, do one of the following:
  - Click **All data in text format** to export your data as comma- or tab-delimited CSV files.
  - Click **All data in MySQL format** to export your data as a MySQL dump file.

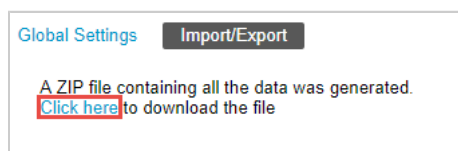
The Export data page appears. If you are exporting your data as a MySQL dump file, the page indicates the version of MySQL currently used by SuiteProjects Pro.

 **Important:** Larger tables, such as `assign_by_day`, `booking_by_day`, `schedule_by_day`, and `user_tag_by_day`, for example, are not available as CSV files using this export functionality. They are only available when exporting data in MySQL format.

3. Under **Choose which tables to exclude**, select any tables to exclude from the data export.

 **Tip:** To include a small number of tables, click **Select all** first to exclude all tables, and then select the tables you want to include.

4. If you are exporting your account data as CSV files (text format), do the following:
  - a. Select the **Text delimiter** for your CSV export files. You can choose comma, tab, or the **List separator for CSV output files** set in your employee record or personal settings.
  - b. Select the **Data layout**. You can choose whether to include column titles for your data in the top row of your export CSV files (`Column titles in first row`), or to include values only and not column titles (`No titles in data`).
  - c. Select a **New line format**. You can choose the line-endings to use for your export CSV files:
    - UNIX – Newline character (ASCII `0x0a`, represented by the `\n` escape sequence in most languages), also referred to as `linefeed (LF)`.
    - Macintosh (Mac Classic, or Mac system prior to macOS) – Single carriage return (ASCII `0x0d`, or `\r`), also referred to as `CR`.
    - Windows – Combination of a carriage return and a newline, also referred to as `CR/LF`.
  - d. Check the **Suppress the audit field data** box if you do not need audit trail information in your export CSV files. Audit trail information can increase the table size significantly and slow down the generation and archiving of export CSV files.
5. Click **Export**.  
SuiteProjects Pro creates a ZIP file containing your export data.
6. Click the **Click here** link to download the ZIP file with your data.



## Licenses

Account administrators can review the number of user licenses purchased and used for your SuiteProjects Pro account by license type. To do so, go to Administration > Global Settings > Account > Licenses.

The Licenses page is a useful reference to track licenses usage for your account.

There are three types of user license for SuiteProjects Pro:

- **Timesheets and Expenses (T&E) Only** – For active users listed under Administration > Global Settings > Users > Employees who do not have a guest role and who have access to any combination of the Account, Expenses, and Timesheets SuiteProjects Pro applications (modules). T&E Only user licenses cannot be used instead of Full or Client (Guest) user licenses.
- **Full** – For active users listed under Administration > Global Settings > Users > Employees with access broader than that of Timesheets and Expenses users or Guest users. Full user licenses may be used instead of Time and Expenses or Client (Guest) user licenses, if these are used up.
- **Client (Guest)** – For active guest users listed under Administration > Global Settings > Users > Guests (users with a guest role). Client (Guest) user licenses cannot be used instead of Full or T&E Only user licenses. For more information about guest users, see [Guest Roles and Guests](#).

For each type of user licenses, the page shows the number of user licenses purchased for your SuiteProjects Pro account under the **Licenses** column, and the number of licenses currently in use under the **Active** column. The page also shows the Total number of licenses purchased and the total number of licenses currently in use.


The number of licenses currently in use corresponds to the number of active users (employee or guest records with the **Active** box checked).

Inactive users do not count toward your license usage, and user licenses are not tied to a specific user. However, you must hold enough user licenses of the appropriate type to cover the number of active users on your account.

The number of active users is shown in red color if it is larger than the number of licenses. SuiteProjects Pro sends license compliance email alerts to account administrators when the number of active users exceeds the number of licenses that may be used for a certain type of users. License compliance email alerts are not sent if the Timesheets and Expenses Only or Guests (Clients) user licenses are exceeded but there are enough Full user licenses to cover the excess, for example.


If the number of active users exceeds the number of licenses, you should:


- Review the list of active employees, including which SuiteProjects Pro applications they have access to, and the list of active guest users on your SuiteProjects Pro account.

 **Tip:** You can use the Employees account-wide tabular (detail) report and add the dimensions Employee ID, Name, Active, Account access, Expenses access, Timesheets access, Opportunities access, Projects access, Resources access, Purchases access, Invoices access, and Workspaces access to review active employee module access. See the help topic [Module Access Overview](#).

- Take any appropriate action to reduce the number of active users.

For example, you can remove any application access other than Account, Expenses, and Timesheets for an employee so that this employee takes up a T&E only user license instead of a full user license. For more information about controlling employee module access, see [Access Control Overview](#).


 **Tip:** You can use the bulk employee change wizard to change the module access settings for several employees at one time. See [Making Changes to Multiple Employee Records at the Same Time](#).

 **Tip:** The All Item Types in Calendar optional feature lets employees see their task assignments and bookings in the calendar even if they do not have access to the Projects and Resources module. See the help topic [All Item Types in Calendar](#).

- Contact your SuiteProjects Pro account manager, to review SuiteProjects Pro licensing or purchase additional user licenses.

Limits are enforced to prevent you from creating or activating users if doing so would exceed the number of user licenses purchased for your account. If no user licenses of the appropriate type are available:

- When adding a new active user or checking the **Active** box on an existing employee or guest record using the SuiteProjects Pro UI, SuiteProjects Pro does not let you save the record if adding or activating the user.

 **Note:** The New employee, or New guest user form shows the number of user licenses available that may be used for the type of user being added, if there are any.

Depending on the default module access settings for new employees, the New employee form shows either the total number of T&E Only and Full user licenses available, or only the number of Full user licenses available. If you have no Full user licenses available, and your default module access for new employees includes modules other than Account, Timesheets and Expenses, for example, to add an active T&E user, you would need to create an inactive user, and remove access to modules other than Account, Timesheets and Expenses for this user, before you check the **Active** box.

- When adding a new user using the API, or when importing a employee record from NetSuite using the NetSuite integration, the employee record is added and the **Active** box is cleared for that employee.

## Optional Features

The Optional Features section contains options that impact general SuiteProjects Pro usage.

To access the Optional features page, go to Administration > Global Settings > Account > Optional features.

You can control the following options from this page:

- **Enable the Vehicle feature:** When enabled, Vehicles display in the list of Application Settings under Invoices Settings and Expenses Settings. When one or more vehicles are set up in SuiteProjects Pro,

a Vehicle drop-down list is available on mileage receipts in the Expenses application and on mileage expense charges you create in the Invoices application. See [Vehicles](#) under Expenses for information about creating a vehicle in SuiteProjects Pro.

- **Only show Customers with projects in the customer:project drop-downs:** In many areas of SuiteProjects Pro, the customer and project field is concatenated into a Customer:Project drop-down menu. Enabling this option populates the drop-down selections with customers that have a projects so you get a consistent Customer:Project value set. When this option is not enabled, customer names without projects also display in the drop-down menus such as Customer X, Customer X:Project Y. Displaying Customers without projects supports a model of recording time and expenses, handling resource allocation, and invoicing at the customer only level.
- **Show the customer name on project drop-downs and pickers:** When writing reports or setting up filter sets, a pick list displays with projects. If this option is enabled, the customer name also displays at the end of the project name in these lists in parenthesis such as Project Y(Customer X). If this option is disabled, only the project name displays.
- **Show the phase name on task drop-downs and pickers:** When handling time recording or resource allocation at the task level, this option enables SuiteProjects Pro to include the phase name in parenthesis after the task name such as Task Y(Phase X). This is helpful if you have tasks with the same name within a project allocated to different phases [that is, "Design (Pilot)", "Design (Production)"]. When this option is disabled, only the task name displays. Therefore, it is important that task names are unique and clear.
- **Group employees by type (i.e., generic/guest) on drop-downs and pickers:** This option provides a sorting or ordering approach to your employee based drop-downs so that different resource types (for example, Regular, Guest, Generic) appear in groups within the menu. When enabled, generics and guests generally appear at the bottom of the menus, with each group ordered alphabetically. When disabled, generics and guests are listed within the regular employee list in alphabetic order with an identifier (generic or guest) after the employee name.
- **Use the service name as the default description:** Throughout SuiteProjects Pro, services are typically used to track categories of labor or accounting allocation information. However, there is no restriction on what a service can be used for within SuiteProjects Pro. Due to its unique handling within SuiteProjects Pro regarding its inclusion on timesheets and invoice charges, your account configuration may include using a service for something unique to your organization. The name of a service may align with how you view information for display on invoices, for example. In this case, instead of entering the description information separately as part of a billing rule or charge creation, you may enable this option to reuse the service name. Enabling this option usually assumes that time is tracked to a task level, and that either the time entry or the task itself holds a service. When this option is disabled, you must manually enter the description field.
- **Hide the Job code on lists and reports unless employee has "View job codes" privilege:** With the ability to use the job code in many report filtering options and to be able to override the job code field name using terminology override, the job code becomes an area that may be used to capture sensitive information related to a person's job category or level. This is information that, more likely than not, should not be available to everyone in the organization. If you have configured SuiteProjects Pro to have sensitive information in this area, you can use this option so that employees who have permission to view job codes may only view the job code value of his/her own record. With this option enabled, the job code field is hidden throughout SuiteProjects Pro such as on reports and in the customized page lists. If this option is disabled, then the job code is available throughout SuiteProjects Pro as a regular field on reports and customize lists which support the field.
- **Allow the message board text to be customized by department:** The Home application has a central Message Board that is used to communicate to account users. In many cases, more than one department in a company may be set up to use the SuiteProjects Pro environment and they can be performing different functions. For example, Sales and Operations may be using timesheet entry but the data entry policies for those two departments may be different. Setting up departments within SuiteProjects Pro lets you allocate employees to a specific department. The Message Board text by department option gives you the ability to set up message board communications to specific groups

of employees. The text is entered in the Departments entity and overrides the general message board content. See [Departments](#). If you have this option selected and no specific department text has been created, the general message board text is visible. If this option is not enabled, the general message board is visible to all employees.

- **Enable additional address lines three and four:** This option expands the Customer and Employee address fields to allow for a 3rd and 4th line, which displays on formatted reports such as invoices or timesheets.
- **Payroll integration (drop-down list):** SuiteProjects Pro enables the integration with the following payroll systems: Ceridian PowerPay, Paychex, ADP-PCT and ADP-NobleStar. This is an optional service providing your company subscribes to the payroll systems.
- **Enable employee tag feature:** The employee tag feature enables the tracking of custom field information in a defined tag field over time. Each tag entry is associated with a timeframe (current or start/end date). As with custom fields, you may define as many tag groups as you need with as many values in each tag group as you need. The enabling of the tag group feature displays a tag link on the Employee accounts for value setting. Tag groups may be used to filter information in reports. See [Tag Groups](#) and [Employee Entity Tag](#).

The main differences between employee-based custom fields and tag groups are:

- Tag group values are tracked over time
- Tag groups may be restricted from viewing within an employee's role in SuiteProjects Pro


Custom fields may also be restricted from viewing within an employee's role. However, this must be done through form permissions and still give employees the ability to view custom field information in reports. Custom fields also do not track values over time. When the field is set or changed, that is the field value for current and historical reporting.


- **Enable target utilization feature:** The target utilization feature enables the tracking of an employee's utilization % target in a defined field over time. Each utilization entry is associated with a timeframe (current or start/end date). The enabling of the target utilization feature displays a Target Utilization link on the Employee accounts for value setting. See [Target Utilization](#).
- **Enable work schedule time ranges:** The overall use of this optional feature is to control resource bookings from a start time point in a day. For example: If a workday is defined as 8:00 a.m. to 4:00 p.m. and an employee is booked to work 100% of the time starting at 10 a.m. for the day, the number of hours would compute to 6 hours of effort. To use this feature, you must set up work schedules in SuiteProjects Pro to have a start/end time definition per day and an optional override at the employee work schedule level on the start/end time of the day. See [Work Schedules](#).
- **Enable distinct work hours per day on work schedule, e.g. 8 hours Monday, 4 hours Tuesday, etc.:** enables work hours to be scheduled for a different number of hours for each work day. When reports use work schedule hours, the hours vary based on the work schedule. For any report where hours are converted to days, the average hours for the week is used for the calculation. When enabled, the work hours per day can be assigned to both work schedules and to individual employees.



**Important:** Varying the work hours per day definition impacts daily billing rules. If the day is defined as 4 hours and an 8 hour workday is entered on timesheets, the billing rules treats this as 2 days of work.

- **Enable multi-week work schedule. Maximum number of weeks:** The multi-week work schedule feature enables using a varying work schedule that spans several weeks. For example, a schedule may be 4 10-hour days, 1 4-hour day in week one and 5 8-hour days in week two. This enables resource managers to know exactly when resources are available based on varying weekly work schedules. Choose Disabled or 2-, 3- or 4 weeks as the duration of the varying schedule.
- **Enable internal debugging information capture during Automatic Backup Service execution:** Useful for SuiteProjects Pro engineers to debug Automatic Backup Service (ABS) problems.

- **Enable QuickViews for bookings, Enable QuickViews for employees, Enable QuickViews for projects, Enable QuickViews for tasks:** Control QuickViews availability for each record type. For more information about QuickViews, see  [User Guide](#).
- **Enable shortcuts:** When enabled, account users can create navigation shortcuts to any page in and outside SuiteProjects Pro from anywhere in SuiteProjects Pro. Users can then spend less time navigating and more time getting things done. For more information about creating and using shortcuts, see the help topic [Shortcuts](#).
- **Maximum number of shortcuts a user can save:** By default, each user can have a maximum of 50 navigation shortcuts at any one time. Enter a number between 1 and 50 to reduce the maximum number of shortcuts allowed.
- **Base used to construct names for downloadable files:** Enter your preferred base name for all download files from your company's SuiteProjects Pro account. The base name must include only alphanumeric characters and underscores, and can include a maximum of 32 characters.

 **Note:** Before 2024.2, the name of all download files from SuiteProjects Pro was `openair.<ext>`, where `<ext>` is the file extension.

With effect from 2024.2:

- The default name for download files is `download.<ext>`.
- You can use this setting to enter your preferred base name for download files. To avoid any disruption to business processes in place, the base name was automatically set to `openair` in all existing production and sandbox accounts as part of the 2024.2 upgrade.

## Performance

SuiteProjects Pro reschedules, deactivates, or skips certain billing, automated revenue recognition and project recalculation for projects with no recent activity to optimize performance. This prevents automated billing and revenue recognition runs being delayed because there are too many of these automated runs scheduled to run at the same time. Project recalculation on completed projects which are still marked as active can also use substantial system resources and impact all SuiteProjects Pro users.

This standard performance feature is always active. To change the configuration settings, go to Administration > Global Settings > Account > Performance. Only account administrators and users with the **Perform company maintenance functions** role permission can view and change the settings on the performance page (or performance console).



**Important:** Review the following guidelines:

- This feature may cause SuiteProjects Pro not to run auto-billing, auto-recognition, and project recalculation for projects which experience long downtime periods between billing milestones or other recalculation points, as these projects can appear to be inactive to SuiteProjects Pro, even when not marked as such.
- You should not disable project recalculation for projects which require further updates to their percent complete status, assignment utilization, or for which dates of tasks may need to be changed.

## Automated Billing and Revenue Recognition

SuiteProjects Pro lets you set billing and revenue recognition to run automatically for each project. For more information about billing and revenue recognition autorun, see [Auto-Billing](#) and [Running Revenue Recognition Automatically](#).

You can configure SuiteProjects Pro to reschedule or deactivate automated billing or automated revenue recognition for a project if no billing or revenue recognition transactions were created in the recent past.

- To configure the performance settings for automated billing, go to Administration > Global Settings > Account > Performance > Auto-bill.
- To configure the performance settings for automated revenue recognition, go to Administration > Global Settings > Account > Performance > Auto-rec.

You can set the following thresholds for both processes:

- **Reschedule action** – Enter the number of days after which the automated process should be rescheduled to run one time every month. The threshold must be between 7 and 180 days. The default threshold is 120 days.

If the automated process was scheduled to run every day, on the 1st and 15th of every month, or on the 15th and last day of the month, and there were no transactions created in that period, SuiteProjects Pro will now run the automated process one time every month.

- **Deactivate action** – Enter the number of days after which the automated process should be deactivated. The threshold must be between 30 and 500 days. The default threshold is 400 days.

If there were no transactions created in that period, the billing or revenue recognition auto-run is deactivated.

By default, these actions apply if transactions exist for the project. To apply these actions to projects with no billing transactions or no revenue recognition transactions, check the **Apply also to projects with no project <transaction type> transactions**.

The form shows the number of impacted projects and updates this number as you change the settings.

The page also includes the list of impacted projects. The list is not updated as you make changes – you must click **Update results** to view the updated project list.



**Important:** This feature may disable auto-billing for template projects, and for new projects that you create from those templates. If you check the **Apply also to projects with no project <transaction type> transactions** box, review your template projects the following day. This setting does not affect projects using the duplicate\_from\_project custom field setting.

## Project Recalculation

You can configure SuiteProjects Pro to skip project recalculations under selected conditions. This allows you to avoid resource-demanding project recalculations which are no longer necessary, and improves overall performance.

To configure the performance settings for project recalculation, go to Administration > Global Settings > Account > Performance > Project recalculation.

Check the boxes for all the conditions that must be met to skip recalculation for a project, and enter the threshold number of days for each condition. The threshold must be between 1 and 500 days. The default threshold is 90 days.



**Note:** If you select more than one condition, SuiteProjects Pro skips recalculation only if the project meets all the selected conditions (AND logical operator).

## Proxy Expirations

The Proxy User feature enables designated user to sign in and act as another SuiteProjects Pro user (the proxied user) without needing to know the proxied user's password. See [User Proxy Overview](#).

You can use proxy expiration to set a validity period when designating a proxy user. This lets you control how long the proxy user can act on behalf of the proxied user. It is useful when delegating tasks to proxy user while an employee is on vacation or on leave.

To enable proxy expiration, go to Administration > Global Settings > Account > Proxy Expirations and set the following options:

- **Proxies have expiration dates** – Check this box to enable proxy expiration.
- **Default proxy expiration** – Select No expiration to have proxy expiration turned off by default or select the default validity period. SuiteProjects Pro uses the default validity period to calculate the default proxy expiration date based on the date the proxy record was created. The expiration date can be changed when setting up each proxy. The proxy expires at midnight (00:00) leading up to the proxy expiration date, in the time zone set for the company's account.

## Security

Security focuses on protecting your SuiteProjects Pro environment from employees trying to access SuiteProjects Pro without proper permission or the sharing or showing of information to others.

Go to Administration > Global Settings > Account > Security. You can control the following features from the Security administration form:


- **Two-Factor Authentication** — Two-factor authentication adds more security to SuiteProjects Pro with an extra verification step during sign-in.
- **Employee Lockout** — Employee lockout is a security feature that ensures employees have an active account and have knowledge of the password to access SuiteProjects Pro.



- **Session Timeout** — The session timeout features ensures users need to re-enter either their passwords or their full credentials after a given period without user interaction.
- **Secured Short URLs** — Control access to the online invoice URL that SuiteProjects Pro generates automatically when an invoice is created.


## Employee Lockout

Employee lockout is a security feature that ensures employees have an active account and have knowledge of the password to access SuiteProjects Pro.

 **Important:** SuiteProjects Pro Support cannot act as an administrator for company specific data-related items such as unlocking employee accounts or resetting passwords. As an account administrator, you perform these tasks for your company.

Account administrators can control the following Employee lockout options. To do so, go to Administration > Global Settings > Account > Security, and use the instructions for each of the following setting on the Security form.


- **Failed logins to allow before locking employee** — Select a value from the dropdown list. This is the number of times an employee can attempt to sign in using an incorrect password.

 **Note:** Locked employees see the same on-screen error message on the SuiteProjects Pro sign-in page whether the employee credentials are invalid or the employee is locked out of SuiteProjects Pro.


By default, SuiteProjects Pro sends a lockout notification email to the employee when the employee exceeds the number of sign-in attempts permitted.

Lockout notification email can be disabled for your account. To stop SuiteProjects Pro sending lockout notification email to employees being locked, contact SuiteProjects Pro Support.

- **Send employee lockout notifications to this email address** — Enter an email address. When a user reaches the maximum number of sign-in attempts and is locked out, an email notification is sent automatically to the address supplied in this field. The email includes the name of the employee so account administrators within your company can follow the appropriate password reset procedure. Typically, administrators unlock the user account and send an email notification to the employee or reset their password reset and notify them verbally or by email. SuiteProjects Pro Support is not allowed to unlock employees — you should include the email address of one of the administrators for your company's SuiteProjects Pro account.


 **Note:** You can specify multiple email addresses separated by semi-colons. However, depending on how long your email addresses are within your company, you may be able to enter only one to three. A better option would be to set up an email distribution list and use this in the notification field. Then your distribution list can be expanded as your list of contact employees grows or modified as your organization changes.

- **Employee log in support email address** — Enter an email address or the alias for an email distribution list. Typically, this should include the email address for your company's Help Desk. If an email address is specified, SuiteProjects Pro Support will direct employees to the email address provided in this field for any access issue such as unlocking employee accounts or resetting passwords.

 **Tip:** Create an email distribution list if you have more than one office location or department using SuiteProjects Pro. Appoint ownership of various general employees to specific employees on this distribution list or allow a primary and backup support structure within your environment.


Users have the following recourse if they forget their password or need help with unlocking their user account:

- Users can click the **Forgot your password or ID?** link on the SuiteProjects Pro sign-in page and enter the email address associated with their user account. If the email address supplied is associated with an active employee record, SuiteProjects Pro sends an email to that address containing the Company ID, the User ID as well as the password hint entered by the user when setting their password. For more information, see the help topic [Signing In Using Your SuiteProjects Pro Sign-In Details](#).
- Users may contact any of their account administrators to request a password reset or to obtain help with unlocking their account. Account administrators can then set a temporary password from the Demographic settings form on the employee record. See [Demographic](#).

 **Note:** Administrators who need help with resetting their password or unlocking their user account should obtain help from other account administrators, or contact SuiteProjects Pro Support if there is only one administrator for the SuiteProjects Pro account.

- If the Password Security Questions optional feature is enabled for your account, users can click the **Reset password or unlock account** link on the SuiteProjects Pro sign-in page and regain access to SuiteProjects Pro by answering a security challenge.

To enable the Password Security Questions feature, contact SuiteProjects Pro Support.

 **Note:** Review the following guidelines:

- If the Password Security Questions feature is not enabled and a user attempts to regain access to SuiteProjects Pro using this method, an error message appears. To specify a custom error message, go to Administration > Global Settings > Account > Security, and enter the custom message in the **Custom error message for password questions** box. You can use this custom message to provide the user some information about opening a ticket with your company's internal help desk, for example.
- If you require answers to the security questions to have a minimum lengths, contact SuiteProjects Pro Support and request to change the minimum number of characters each answer must contain to a specific value.
- System emails are disabled by default on sandbox accounts. The **Forgot your password or ID?** and **Reset password or unlock account** links can therefore only be used for production accounts.

## Session Timeout

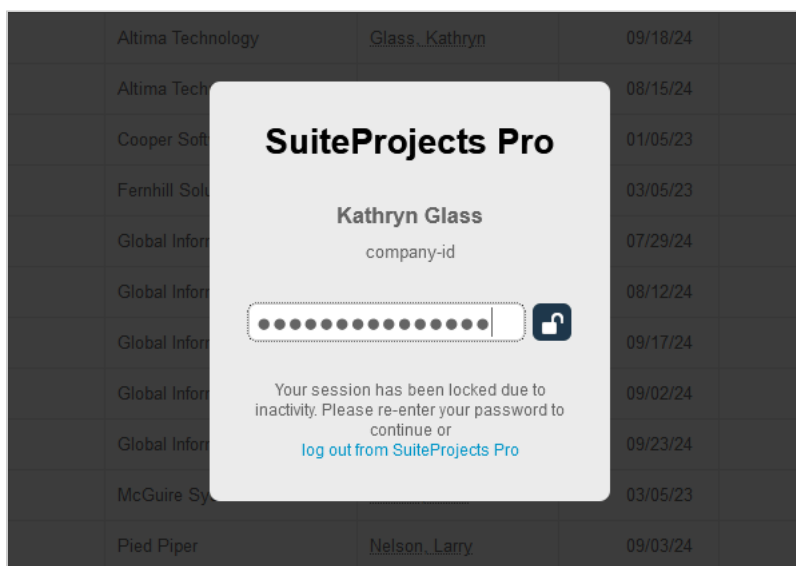
The session timeout features requires users to re-enter either their passwords or their full credentials after a given period without user interaction.

Account administrators can set the **Session timeout** and **Redirect user's page after timeout** periods in Administration > Global Settings > Account > Security Options:

- **Session timeout:** This option controls the time a session may be inactive before the employee is automatically locked out and prompted to re-enter their password. Session timeout avoids SuiteProjects Pro sessions from being used by others on a shared machine. Session timeouts should be set according to the data security policies your company has in place. The default and maximum period for the session timeout is 5 hours.

**Note:** You may have different categories of SuiteProjects Pro users in your company, such as power users who use SuiteProjects Pro all the time, and time and expenses users who use SuiteProjects Pro one time a week or less. You should select a session timeout value that does not inhibit power users. This is generally a 30 minute to 1 hour window.

- **Redirect user's page after timeout:** This option controls the time a session may be locked out before the user is automatically signed out and redirected. The user will be redirected either to the SuiteProjects Pro sign-in page or to the alternate URL configured in Administration > Global Settings > Account > Integration: SAML Single Sign-On, if this feature is enabled on your account. This option can be set to "On timeout" or to a finite period up to a maximum of 6 hours. It should be set according to the data security policies your company has in place.



## Secured Short URLs

SuiteProjects Pro generates a short URL for viewing the invoice online when an invoice is created. By default, anybody with the short URL can view the invoice online without signing in to SuiteProjects Pro.

You can limit access to invoice short URLs generated in future by setting a passcode. When accessing the short URL for an online invoice, users will need to enter the passcode before they can view the invoice.

### To set a passcode for secured short URLs:

1. In SuiteProjects Pro, go to Administration > Global Settings > Account > Security.
2. Enter a **Passcode for secured short URLs**.

3. Click **Save**.

All invoice short URLs generated after you set a passcode will be protected



**Important:** Review the following guidelines:


- An invoice short URL is secured only if **Passcode for secured short URLs** does not have a null value at the time when the invoice is created and the invoice short URL is generated.
- If you are setting a passcode for the first time, short URLs for invoices created before you set the passcode are not secured.
- If you change the passcode, the new password applies to **all** secured short URLs. Users accessing secured short URLs generated with the old password must enter the new password.
- If you clear the **Passcode for secured short URLs**, users accessing secured short URLs can view the invoice online without entering a password. The password prompt does not appear.

## Two-Factor Authentication

Add more security to SuiteProjects Pro with an extra verification step during sign-in.

Two-factor authentication (2FA) adds a second level of security when you sign in to the SuiteProjects Pro user interface. To sign in using 2FA, you must first enter your SuiteProjects Pro user credentials (company ID, user ID and password) and then enter a time-based verification code generated by an authenticator app for each sign-in.

**Note:** Currently, SuiteProjects Pro supports only time-based verification code from an authenticator app as second factor.

The authenticator app must comply with the OATH TOTP standard. OATH stands for the Initiative for Open Authentication. TOTP stands for time-based one-time password.

To enable 2FA for your account, go to Administration > Global Settings > Account > Security, check the **Two-factor authentication** box, and click **Save**.

After you enable 2FA for your account:


- Account administrators can control 2FA settings for the SuiteProjects Pro account and enroll users to sign in using 2FA. See [Managing two-factor authentication in SuiteProjects Pro](#).
- Enrolled users must setup 2FA within a set number of days or sign-ins. For more information, see the help topic [Signing In Using Two-Factor Authentication \(2FA\)](#).

## Managing two-factor authentication in SuiteProjects Pro


After you enable 2FA for your company's SuiteProjects Pro account, you can:

- Control 2FA settings. To do so, go to Administration > Global Settings > Account > Two-factor authentication.

- When you enroll a user to sign-in using 2FA, this user can skip the 2FA setup for a limited number of days and sign-ins. You can control the number of **Days until 2FA setup is required** and the number of **Sign-ins until 2FA setup is required**.
- Check the **Trust devices** box to allow users to add the device they sign in from as a trusted device. This will let the same user sign in to SuiteProjects Pro on the same device without being asked to enter a verification code every time. Each device is trusted for a limited number of days, after which it is removed automatically from the list of trusted devices for your company's SuiteProjects Pro account. You can specify the number of **Days until a trusted device is removed**. A user's trusted devices are removed automatically when the user changes password.

 **Important:** Clearing the **Trust devices** box removes all trusted devices for all users.

- [Enroll or disenroll users to sign in using 2FA.](#)
  - Add the following columns to the employees list for auditing purposes:
    - **2FA required** – The column indicates whether a user is enrolled to sign in using 2FA (Required), not enrolled (Not required), or accessing SuiteProjects Pro using single sign-on (empty value).
    - **2FA status** – The column indicates whether a user has completed the 2FA setup (Setup), not completed it yet (Required), or is not enrolled to sign in using 2FA (empty value).
    - **Complete 2FA setup by** – The column shows the deadline when the user must set up 2FA by.
  - Reset two-factor authentication or remove trusted devices for one user from Administration > Global Settings > Users > Employees > [Select an employee] > Two-factor authentication.
- When you reset 2FA settings for a user, SuiteProjects Pro sends an email notification automatically to inform the user.
- Disable 2FA temporarily for your account. To disable 2FA, go to Administration > Global Settings > Account > Security, clear the **Enable two-factor authentication** box, and click **Save**.

 **Note:** Disabling 2FA temporarily for your account does not remove 2FA setup-related information for users. After you enable 2FA again, users will not need to set up 2FA again.

## Enroll or disenroll users to sign in using 2FA

Use the following steps to enroll or disenroll users to sign in to your company's SuiteProjects Pro account using 2FA.

When you disenroll a user, all 2FA setup-related information for this user is removed. If you enroll that same user again, the user will need to setup 2FA again and will be able to skip 2FA setup up to the number of times and days specified in the two-factor authentication settings for your company's account.

### To enroll or disenroll users to sign in using 2FA:

1. In SuiteProjects Pro, go to Administration > Global Settings > Users > Employees > [Select an employee] > Demographic.
2. Check the **Two-factor authentication required** box to enroll the user. Clear the box to disenroll the user.
3. Click **Save**.
 

After you enroll a user, the demographic form shows "User must complete 2FA setup by <date>" under the **Two-factor authentication required** box.

SuiteProjects Pro sends an email notification automatically to inform the enrolled user of the requirement to setup 2FA.
4. Repeat for each user you want to enroll to sign in using 2FA.

**Note:** Two-factor authentication is not available for users accessing SuiteProjects Pro using single sign-on. Saving the form returns an error if both the **Two-factor authentication required** and `saml_auth` boxes are checked.

You can use the bulk employee change wizard to copy the value of the **Two-factor authentication required** box to other user records in your company's SuiteProjects Pro account. See [Making Changes to Multiple Employee Records at the Same Time](#).

You can use the XML API and SOAP API, or the Integration Manager to modify the value of the **Two-factor authentication required** [`mfa_status`] box for multiple users.

## Custom Fields

SuiteProjects Pro comes with standard fields but you may need to track additional information. You can add custom fields for specific object types to track this additional information.

Custom fields are used for a variety of purposes:

- You can create custom fields to extend standard forms and track additional information.
- You can create custom fields to extend the record data stored by SuiteProjects Pro. You can create custom fields for the user rate per project [`Uprate`] object used for project employee billing and project billing, for example. These custom fields are available through the XML API and SOAP API only. They are not available on any form.
- SuiteProjects Pro also uses custom fields to support additional features and integrations.

**Important:** Do not rename or amend custom fields that support additional features and integrations. Doing so would prevent the feature or integration from working as intended.

With the exception of custom fields for the user rate per project [`Uprate`] object, and unless the custom field is hidden either using the custom field properties or form permissions, custom fields for a record type are available in forms, lists and reports for this record type.

Custom field values for supported object types can be read or set using the SuiteProjects Pro API or user scripting. See the help topic [Custom Fields \(REST API\)](#), [Custom Fields \(SOAP API and XML API\)](#), and [Custom Fields \(user scripting\)](#).

To view the list of custom fields set up for your company's SuiteProjects Pro account, go to Administration > Global Settings > Custom Fields.

For steps to create or modify a custom field, see [Creating and Modifying Custom Fields](#).

## Custom Field Guidelines

Review the following guidelines:

- Each custom field is created for a specific object type. The object type associated with the custom field cannot be changed after the custom field is created. For more information about object types supporting custom fields, see [Record Types and Forms Supporting Custom Fields](#).
- Several types of custom fields let you track different type information. You choose the custom field type when creating each custom fields. The custom field type cannot be changed after the custom field is created. For more information about custom field types, see [Custom Field Types](#).
- A custom field cannot be deleted if it has been used to store information. If you no longer need a custom field, make it unavailable by clearing the **Active** box in the custom field properties form.

- You can create as many custom fields as you need. There is no set limit on the number of custom fields.
- The SuiteProjects Pro software uses the custom field name you define to identify the custom field for operations such as reading and updating custom field values. Like most programmatic names, the custom field name must be unique and follow certain conventions, such as containing only alphanumeric characters and underscores but no spaces.
- Customizations, integrations and additional features may use custom fields. Modifying custom fields supporting customizations, integrations or additional features may prevent them from working as intended.
- Custom fields are grouped in one sequence on forms. You can control the position of the group of custom fields relative to standard fields, and the position of each custom field relative to other custom fields. See [Custom Field Position](#).
- You can control access to custom fields using form permissions, in the same way as you control access to standard fields. See [Form Permissions](#) and [Permission Rules](#).

## Creating and Modifying Custom Fields

You can create a new custom field from anywhere in SuiteProjects Pro.

After you create a custom field, you can view and modify its properties.

If you want to change the position of a new custom field (relative field order) on the properties form for the associated object type, you can only do so after you save the custom field. See [Custom Field Position](#).

You can delete a custom field only if there are no values recorded for this field. If there are values for a custom field, you cannot delete it, but you can clear the **Active** box for this custom field if you no longer need the custom field.



**Important:** Do not rename or amend custom fields that support additional features and integrations. Doing so would prevent the feature or integration from working as intended.

### To create a custom field:

1. Select **Custom fields** in the Create menu.
2. Under **Add a custom field to**, select the object type for which you want to create the custom field. For more information about supported object types, see [Record Types and Forms Supporting Custom Fields](#).
3. Under **Type of field to add**, select the type of field that you want to create. For more information about supported field types, see [Custom Field Types](#).
4. Click **Continue**.

The Custom field properties form appears.



**Note:** After you save the custom field, it is not possible to change the custom field type or the object type that the custom field is associated with.


5. Set up the properties of your custom field. See [Defining Custom Field Properties](#).
6. Click **Save**.

### To view or modify custom field properties, or delete a custom field:

1. Go to Administration > Global Settings > Custom Fields > > [*select a custom field*].  
The Custom field properties form appears.
2. Change the properties of your custom field, as needed. See [Defining Custom Field Properties](#).



3. Do one of the following:
  - Click **Save** to save the changes and return to the custom field list.
  - Click **Cancel** to discard the changes you have made and return to the custom field list.
  - Click **Delete** to delete the custom field, then click **OK** in the confirmation dialog.

 **Note:** The Delete option is available only if there are no values recorded for this custom field.

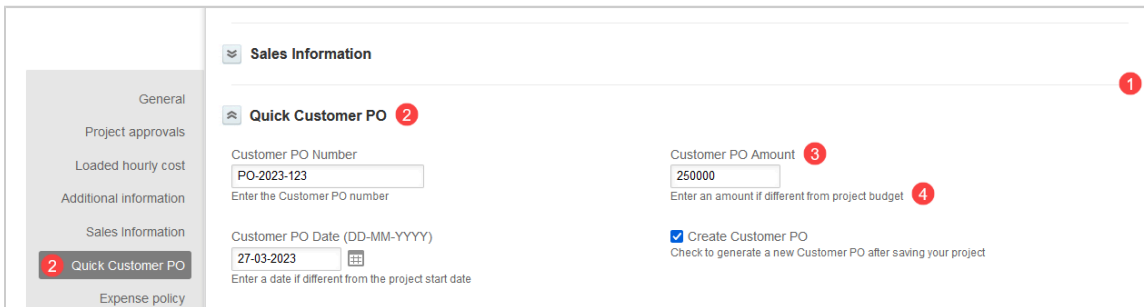
## Defining Custom Field Properties

When creating or modifying a custom field, you define the properties of this custom field on a form. Some of the properties are common to all custom field types, other properties depend on the custom field type.

The following table describes the properties that are common to all custom fields.


You can control how the custom field appears on the relevant form using the following properties:

1. Divider – Divider lines are used to separate different sections of the form or different groups of fields in the same section of the form.
2. Divider text – Form section header can be used for form navigation and for access control.
3. Display name – The label shown in the SuiteProjects Pro UI gives a short description of the information tracked in the custom field. It is required for all custom fields.
4. Hint – If applicable, assistive text can be used to help users track the right information.

<b>Add notes</b>	Check the box to show a text box on forms under the custom field. Users can enter additional notes in this text box.
<b>Divider</b>	Check this box to add a divider line before this custom field on the form. Divider lines are used to separate groups of fields on the form. See <a href="#">Dividers and Sections</a> .
<b>Divider text</b>	<p>If you want to add a custom section to your form and place this custom field in the custom section, enter the form section header as you want it to appear on the form.</p> <ul style="list-style-type: none"> <li>■ Adding a custom section adds a divider line before the custom field even if the <b>Divider</b> box is not checked.</li> <li>■ The custom section also includes the fields immediately after this custom field and before the next form section. ## Custom Field Position

All custom fields are always shown in one sequence. By default, custom fields appear after standard fields at the bottom of the form for the associated object type. You can use form options to change the position of the sequence of custom fields relative to standard fields. You can place custom fields at the top of the form, the bottom of the form, or immediately before one of the standard fields on the form.

After you save a custom field, you can change its position relative to other custom fields on the form for the associated object type at any time.

 **Note:** You must save a new custom field before you can set its relative position. The **Position** dropdown list is not available on the custom field properties form when creating a custom field.

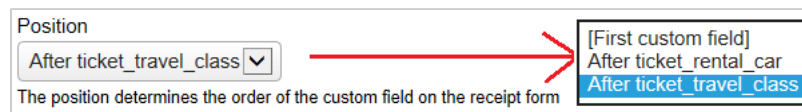
### To change the position of custom fields on a form:

1. Change the position of the sequence of custom fields relative to standard fields. To do so:
  - a. Go to the form.
  - b. Click the Tips utility button and select **Modify form permissions** from the contextual tips menu.  
The form permissions page appears.
  - c. Go to the Form options section.
  - d. Under **Display Custom Fields before form field**, select one of the following options:
    - [Default] – This option places custom fields in a default position, which depends on the form.
    - [Top] – This option places custom fields at the top of the form.
    - <standard field label> – These options places custom field before the standard field. Standard fields are listed in the same order as they appear on the form.

- [Bottom] – This option places custom fields at the bottom of the form.

**Note:** Changing the position of custom fields relative standard fields may place custom fields in standard form sections, and standard fields in custom form sections. See [Dividers and Sections](#).

- e. Click **Save**.
2. Change the position of custom fields relative to other custom fields. To do so:
    - a. Go to Administration > Global Settings > Custom Fields > *[select a custom field]*.  
The Custom field properties form appears.
    - b. Select an option from the **Position** dropdown list. The lists shows positions relative to other custom fields on the form, in the order they currently appear on the form.  
You can set the position as the first custom field on the form, or immediately after another custom field on the form.



- c. Click **Save**.

## Dividers and Sections

You can use a divider line to separate groups of custom fields in the form.

You can also create custom form sections and place custom fields in a custom section. This enables you to:

- Use form navigation to jump to a custom form section.
- Control access to custom form section by role using form permissions. See [Hidden Divider Sections](#).

You can add a divider line and add a section for your custom fields when creating or modifying a custom field.

### To add a divider line or a custom section:

1. Go to Administration > Global Settings > Custom Fields > *[select a custom field]*.  
The Custom field properties form appears.
2. Do one of the following:
  - Check the **Divider** box to add a divider line before this custom field on the form. Unless you also enter a **Divider text**, the divider line separates groups of fields in the same form section.
  - In the **Divider text** box, enter the form section header as you want it to appear on the form. This creates a custom form section and places the custom field as the first field in this custom section.

**Note:** Review the following guidelines:

- Adding a custom section adds a divider line before the custom field to separate different sections even if the **Divider** box is not checked.
- The custom section also includes the fields immediately after this custom field and before the next form section. If custom fields are positioned before a standard field, the custom section may also include this and other standard fields.
- To add multiple custom fields to the same section, set the **Divider text** for the first custom field and leave it blank for the following custom fields.
- Entering the same **Divider text** for two different custom fields creates two section with the same name.


3. Click **Save**.





## Custom Field Types



When creating a custom field, you select the type of field you want to create depending on the information you want to store in the field.

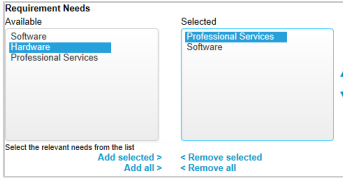
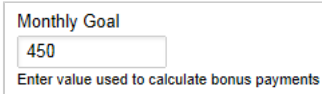
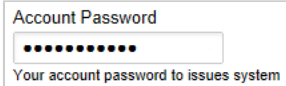
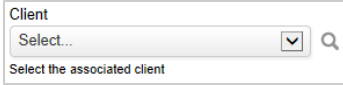
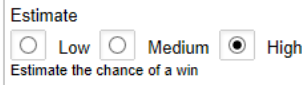
The following table describes all available field types for custom fields. Any character limits mentioned apply to English letters, which require one byte for each letter. If you are using another language, the limit is lower because one character could require up to four bytes. For non-English characters, the limits for the fields vary depending on the characters entered, and the field maximum is lower than the number indicated.

## Tag Field and Value Options

Add a status badge to your entity properties forms and display it on your lists, project status summaries, reports and dashboard portlets.

The tag field lets you select a single tag. It uses the same mechanism as dropdown custom fields but tag field values are shown as badges with specified text and color.

- You can use tag custom fields to draw attention to important information in forms, lists, and reports. For example, you can use this custom field type to define a risk tags for any entity.
- You can control who can see or update tag values using form permissions and form rules.

- You can use the Integration Manager, XML API, SOAP API and user scripting to read, set and modify tag custom fields.

### To create or modify a tag custom field and tag value options:

1. Follow the usual procedure for creating or modifying custom fields.
  - If the Conditional Dropdown Custom Fields optional feature is enabled for your company's SuiteProjects Pro account, the custom field properties form includes a required **Tags** field.

## Contacts

Contacts may be any individual that is associated with a customer and that your company wishes to track.

To view the list of all contacts, go to Administration > Global settings > Customers > Contacts.

To view the list of contacts for a specific customer, go to Administration > Global settings > Customers > Customers > [Select a customer] > Contacts. The tab is available after you create a customer. See [Customers](#).

One special type of contact is the billing contact. Contacts designated as a billing contact are available for association on the project form. You also use them in the invoice process by including contact information in the invoice address section. If the billing contact has an email address, you may also choose to email invoices to the designated billing contact after the invoice has been approved. See [Customer Billing Information](#).

Enter the first and last name in the contact form as well as the associated customer record. All other fields are optional. If you have entered customer address information, you may optionally copy the customer address to the contact by checking the **Copy customer address** box or override the address by typing in the address fields. Although the email address field is an optional field, it is useful to enter since other features allow communication to contacts with email addresses. You can send email messages to contacts specified in reports or an invoice generated for the customer.

## Customer Locations

Create and store customer location attributes at the customer entity level. You can then use these attributes for reporting. Sample customer locations could be by state, by city, by country or any customized list of values.

To view the list of all customer locations, go to Administration > Global settings > Customers > Customer locations.

### To create Customer Locations:

1. Go to Administration > Global Settings > Customers > Customer locations.
2. Select **New Customer location** from the create menu.
3. Enter the location Name along with any Notes, if desired.
4. Click Save.

## Customers

Your company may use the term client or customer. Depending on your company's terminology preferences, different titles may display on these forms. In this manual, we are using customer.

We define customers as those who drive business within your company. You can keep customer information basic or cover all information about the customer, depending on what other systems you may be using to track customer information.

To view the list of all customers, go to Administration > Global settings > Customers > Customers.

### To create a customer:

1. Go to Administration > Global Settings > Customers > Customers.
2. Select **New Customer** from the create menu.  
The New customer form appears.
3. After you save it, the information appears on the Edit demographic information form. To access it, click the Demographic tab.

**Note:** The Customer form asks for two basic pieces of information: Company Name and Nickname. Each is explained as follows.

**Company Name** — is the official corporate name of the customer and is used on reporting and invoices.

**Nickname** — is a shortened version of the company name that is used throughout the SuiteProjects Pro UI to save space on page views. The nickname does not appear on invoices. However, it does appear on formatted application reports such as Timesheets and Expense reports.

You may optionally enter customer address information in the Customer form along with a designated customer location and customer owner. If you enter a customer owner, this resource becomes available for inclusion in the review or approval of items related to the customer project such as timesheets and invoices. Basic customer tracking information for sales such as territory, customer source, business type, and so forth are provided for optional entry if the Opportunities application is enabled in your account. See [Opportunities](#).

**Note:** You should always set up a customer account for your own company. You can use it for the internal tracking of projects.

## Customer Billing Information

A Billing information tab becomes available for a customer after you save the Customer form. Billing information includes Currency, Payment terms, Invoice prefix, Billing code, and a standard invoice approver, which may be left blank if control is desired within the project.

A default set of Payment terms is supplied as standard. However, you may create customized payment terms. See [Payment Terms](#).

The Invoice prefix lets you define a prefix for the customer, which will allow sequential numbering based on the value of the prefix. This provides customer level or ownership level invoice numbering. For example, if a set of customers is uniquely owned by an office or country, you can set an invoice prefix on all of these owned Customers to ensure the invoice numbering is sequential for the country or office. You may also choose an Invoice layout to use with this customer, as well as a specific Billing code if you use Billing codes in your company.

If you are sending invoices to customers by email using SuiteProjects Pro, your customers can view their statements or account status in SuiteProjects Pro, provided you have checked the **Customer can view statements** box on the Edit billing information form. Your company's employees can view statements using Reports > Advanced > Customer statements.

## Frequently Asked Questions (FAQs)

[When would I use billing information at the customer level?](#)

You generally use billing information at the customer level for one or more of the following reasons:

- You would like a specific person to approve all the customer's invoices.
- There is a specified hourly rate you want to use for this customer's billing and you are not using multiple rates by role, job code or service.
- There are particular payment terms for this customer.
- You want to designate a special invoice prefix on all invoices for this customer.
- You want to use a certain invoice layout for this customer.
- There are particular notes you want to display on the invoice or email text.

## How do the settings on the customer billing information form work with project level settings?

If you leave items blank on the project form, the customer billing definitions are used. If invoice text or notes are added at the project level, the customer information and project information are added together on the invoice. The invoice approver is included in the invoice routing regardless of the project level settings.

## Prospects

Prospects are potential customers against which deals are being proposed. Prospects are only used in the Opportunities application and may be converted to customers at a later stage. The information captured for prospects is similar to that of customers without the information regarding billing. The link does not display for prospects.

To view the list of all prospects, go to Administration > Global settings > Customers > Prospects.

### To create a prospect:

1. Go to Administration > Global Settings > Customers > Prospects.
2. Select **New Prospect** from the create menu.

## Customer Display Options

Customer display options control how customers are displayed on forms.

## Show additional fields for search

If you have multiple customers with similar names, additional information may be needed to identify the correct customer record when selecting a customer from a dropdown list or using the Customer search on entity forms.

Use this setting to select which additional fields are shown in the dropdown lists and search results.

By default, the customer dropdown lists on entity forms only include the customer **Name**. When the **Number of entries to display in Customer dropdowns** is set to a finite number in your personal settings, a search tool is also available. By default, the search results only include the customer **Name**.

You can configure SuiteProjects Pro to show up to three additional standard or custom field values separated by a comma on the customer dropdown lists and search result lists if your role allows you to view the information.

The additional field values also show on Customer dropdown lists when using the Redesigned Advanced Filters optional feature.

## Email Settings

Email settings control the handling of email sent by SuiteProjects Pro.

### Forward undeliverable email to this email address

Each employee must have an email address entered on their account, however the email address may be invalid. Any email such as notification or approval requests sent to an invalid email address are forwarded to the email address identified in this field. The account administrator or a distribution list of account administrators should be designated here to handle invalid email addresses. If a value is not entered, then undeliverable email are ignored.

## Set up email return path

By default, the Return-Path header (sometimes referred to as "envelope address") is set to `www@openair.com` by the SuiteProjects Pro email relay server for all email messages originating from SuiteProjects Pro. If you have a DMARC policy for your domain, this results in failing SPF alignment when SuiteProjects Pro sends an email message with a user email address in the From header.

You can set up SuiteProjects Pro to change the Return-Path to a custom value when appropriate, depending on the scenario. If a custom return path is specified for your account and the custom return path domain matches the email header in the From domain, SuiteProjects Pro sets the Return-Path header to this custom return path and tells the SuiteProjects Pro email relay not to modify the Return-Path header.

**Note:** OpenAir is now SuiteProjects Pro. As of 5 a.m. Eastern Time (UTC-5) on January 25, 2025, for your sandbox account, and on February 15, 2025, for your production account, service URLs with the `netsuitesuiteprojectspro.com` domain name replace URLs with the `openair.com` domain name.

The sender for all email originating from SuiteProjects Pro will change from `www@openair.com` to `www@netsuitesuiteprojectspro.com` over a period of time after February 15, 2025. The target date for your company's account will be communicated in advance of the change. If your company's account is configured to send system email from user email addresses, there will be no noticeable changes. However, your IT team will likely need to be make adjustments to spam filter configuration to allow this email through.

## Do not set the From: address to the current employee's email address

Email generated by an employee's account such as a timesheet approval request, displays the employee's return email address by default unless you have selected this option. If you do not want the employee's return email address to show up in email generated by SuiteProjects Pro, the return email address reads: `www@openair.com`. A reason you may want to consider doing this is that some of the less configurable email servers reject email coming from the SuiteProjects Pro domain with your company's email address, incorrectly thinking it is spam email.

Some features in SuiteProjects Pro, such as scheduled reports and alerts, let users specify a custom sender email address for system-generated email. When the **Do not set the From: address to the current employee's email address** box is checked, the custom sender email is ignored and all email is sent from `www@openair.com`.

## Text for time off requests submitted for approval email

The content of the time off request submitted email can be defined here using key field names that can be substituted with field values. The allowed fields are:

- SUBMITTERNAME
- TIMETYPENAME

- STARTDATE
- ENDDATE
- DAILYDETAIL
- TOTALHOURS
- URL
- SCHEDULEREQUESTNAME
- DESCRIPTION
- CATEGORYNAME
- CUSTOMERNAME
- PROJECTNAME
- PROJECTTASKNAME

## Text for booking requests submitted for approval email

Similar to the time off request email, the content of booking request email can also be defined here. To enter the content, type in the desired text and add in the available fields as appropriate (typed in all caps bracketed by "%"). This enables SuiteProjects Pro to substitute the field value for each of these field names.

## Email Templates

The Email templates page shows a list of email templates used for standard email notifications in your company's SuiteProjects Pro account.



**Note:** The Custom Email Notifications optional feature is often enabled for new SuiteProjects Pro accounts as it offers more control and flexibility for email notifications. For more information, see [Notifications](#).

You should enable the Custom Email Notifications feature and disable standard email notifications, if you are still using the latter on your account.

Email templates are only used for standard email notifications. When disabling standard notifications, you should disable email templates for the same record types, if email templates are supported for the record type. See [Disabling Standard Email Notifications and Email Templates](#).

## Creating an Email Template

If you are using standard email notifications, you can create email templates and customize the subject line and body of the email to include the information required.



## To create an email template:

1. Go to Administration > Global settings > Display > Email templates.
2. Click the create button and select **New <object-type> email template**, where <object-type> is the type of object associated with this notification.  
The Email template form appears
3. Enter a **Name** for the email template.
4. Select a **Template type**. The template type options give a short description of the action required or of the event triggering the notification. They vary depended on the type of object associated with the notification.
5. Enter an **Email subject**. Your **Email subject** string is appended to the standard email notification subject line. You can enter a combination of free form text and field value variables. Field value variables are replaced the field value for the associated object when the email notification is triggered .
6. Enter an **Email body**. You can enter a combination of free form text and field values.  
To add a field value variable in the Email subject or body:
  - a. Select a **Field**.  
The code for the field value variable appears in the text box under the **Field** dropdown.
  - b. Copy and paste the code for the field value variable in the Email subject or body.
7. Enter **Notes** to describe the email template and its purpose, if required.
8. Check the **Active** box. You can only have one active template for each object type and template combination. Checking this box deactivates any email templates of the same type for the same object type.
9. Click **Save**.

## Interface: Display

Display options control how various presentation elements are shown your company's SuiteProjects Pro account. You can change these settings at any time.

- Hovering over menu links reveals menu options
- Enable collapsible sections in forms
- Enable dynamically collapsible sections in hierarchy lists
- Open popups as panels instead of windows
- Use on-page panel instead of popup for Time entry notes dialog on timesheet
- Show cost tab and/or form if employee can view any of the loaded cost levels
- Hide the help tab
- Hide the support tab
- Hide the help panel on forms
- Hide the footer tips and toggle link
- Control the data density displayed in list views with selected mode
- Control the data density displayed in timesheet grid with selected mode.

## Interface: Terminology

The Terminology form lets you override standard terms in the SuiteProjects Pro UI with custom terms specific to your company's account.

You can use this form to replace standard terms throughout SuiteProjects Pro with terms that are commonly used in your company. Using terms that your employees are familiar makes it easier for them to adopt SuiteProjects Pro.

1. The Interface: Terminology global settings form shows the **default term**.
2. You can choose one of the **standard alternative terms** available from the dropdown field for each term, or use the default term by selecting "None" from the dropdown options.
3. You can enter a **custom term** in the text field instead of using one of the standard alternative terms.

## Logos: UI, documents

You can set up SuiteProjects Pro to show your company logo on HTML and PDF documents generated by SuiteProjects Pro and your company pictogram in the upper-left corner of the SuiteProjects Pro UI.

You can upload three different logos. Each of these logos serve a different purpose and show in a different location:

- **Company logo for web** – shows in the upper-left corner of HTML documents (reports) such as expense reports, invoices, POs, purchase requests, booking requests, deal booking requests and time off requests.
- **Company logo for PDF** – This logo shows in the upper-left corner of PDF documents (reports) such as expense reports, invoices, POs, purchase requests, booking requests, deal booking requests and time off requests.
- **Company logo for page banner** – This logo (pictogram) shows on the upper-left corner in the SuiteProjects Pro UI.

## Navigation

To upload or change your company logos, go to Administration > Global settings > Display > Logos: UI, documents.

For each of the three company logos:

- Click **Browse** and select a GIF, JPG or PNG file from your computer to upload or change the logo. Uploading a new logo for one of the three location replaces any existing logo for this location after you save the form.

**Note:** Other file types such as BMP, EPS and SVG, for example, are not supported and cannot be uploaded.

You can use invoice layouts to use different logos for invoices (see [Invoice Layouts](#)).

- Check the **Remove "<filename.ext>"** box to remove the current logo. This setting is available only if a logo exists and shows the filename and extension of the uploaded file (<filename.ext>).

For the company logo on PDF documents:

- Check the **Display PDF logo on first page only** box to show the logo on the first page of PDF documents but not on subsequent pages, thereby creating more space for content from page 2 onward. Clear the box to show the logo on all pages.
- Check the **Display PDF logo full size** to show the full-size logo and ignore the top margin set up for your reports. Clear the box to resize (if necessary) and fit the logo within the report top margin. If you are showing the full-size logo, the height of the logo should be 100 pixels or less to avoid using too much header or page space. If the logos shows too large in your PDF documents, clear the **Display PDF logo full size** box or upload a smaller version of your company logo.

By default, the company pictogram on the page banner links to the SuiteProjects Pro product information page (<https://www.netsuite.com/portal/products/professional-services-automation/suiteprojects-pro.shtml>) when clicked. You can specify the URL of the page that should open when clicking the company pictogram. To do so, enter the URL in the **URL for company logo** box.

**Note:** The company logo for the page banner should have a width between 24 and 200 pixels and a height of 44px. SuiteProjects Pro resizes the logo to fit these dimensions, if larger. The height of your logo should be 44 pixels or more, and the logo aspect ratio should be between 24:44 and 200:44.

All changes take effect after you save the form. Changes are discarded if you leave the form without clicking **Save**.

## Print Settings

The Print settings page lets you select the default page format for PDF documents generated by SuiteProjects Pro for your company's account. The preferred page format can then be set **for** individual users on the employee demographic form (Administration > Global settings > Users > Employees > [Select an employee] > Demographic), or **by** users in their personal settings. See the help topic [Personal Settings](#).

## Navigation

The Print settings page includes the following setting: **Page size for generating PDF pages**. Select either Letter (8.5" x 11") or A4 (approx. 8.25" x 11.75" or 21 cm x 29.5cm).

You can configure other settings for PDF documents, such as margins and font size, or example, in the application settings controlling each type of document.

## Regional Settings

The Regional settings page lets you select the default regional settings for users across your company's account.

Regional settings can then be set **for** individual users on the employee demographic form (Administration > Global settings > Users > Employees > [Select an employee] > Demographic), or **by** users in their personal settings. See the help topic [Personal Settings](#).

## Navigation

Regional settings determine how SuiteProjects Pro shows some type of values in the UI and in reports. For example, the North American or the European date format can be used for dates.

The Regional settings page includes the following settings:

- **Date format** – Select the required date format for dates shown in the UI and in reports.



**Important:** If your company operates and uses SuiteProjects Pro at a global level, you should set up reports using relative date values such as This Month or Last Quarter whenever possible. Reports using custom date values may not work as expected when shared and run by employees using a date format that is different to the date format used by the report owner. If a report configured to show information for dates starting 6/1/24 onwards using a MM/DD/YY date format is shared with an employee who uses a European date format such as DD/MM/YY, for example, the report shows information for dates starting January 6th, 2024 instead of June 1st, 2024 when run by this employee.

- **Number format** – Select the number format with decimal and thousands separators that are used as standard by your company headquarters.
- **List separator for CSV output files** – Select your company's preferred CSV delimiter. A CSV delimiter, or field separator, is a character that separates values in a row of a CSV file. Some common delimiters include: comma (,), colon (:), pipe (|), semicolon (;), tab (\t), and tilde (~). The default delimiter for CSV files in SuiteProjects Pro is a comma – it is a commonly used in countries like the US, UK, and Australia. In Some European countries, the semicolon is commonly used because the comma is used as decimal separator for numerical values. You should use the same CSV delimiter as in other application, such as Microsoft Excel, for example, into which you import data that you downloaded from SuiteProjects Pro.

## Time Settings

The Time settings page lets you select the default time settings for users across your company's account.

Time settings can then be set **for** individual users according to their location on the employee demographic form (Administration > Global settings > Users > Employees > [Select an employee] > Demographic), or **by** users in their personal settings. See the help topic [Personal Settings](#).

## Navigation

Administration > Global settings > Display > Time settings

The Time settings page includes the following settings:

- **Time zone** – Select the time zone for your main company location. Time and date time values, such as created and last modified date and time, for example, are converted to the preferred time zone when shown on the UI and in reports, unless otherwise specified.
- **Use 24-hour clock for time entry and display** – Check this box to show time values in the UI and in reports using the 24-hour clock convention as used by the international standard [ISO 8601](#). When checked, 10:36 p.m. shows as 22:36, for example.
- **Week starts (default)** – Select the first day of the week to be used in your company's SuiteProjects Pro account. This is an important default that defines the first day in a 7-day week for weekly reporting and display of information. This is the only period used in reporting or for data display that uses an arbitrary start and end. Other reporting periods, such as daily, monthly, semi-monthly, and annual have a universal start and end date."
- **Shift bi-weekly time period by one week** – Check this box to start the first item created for the next time period one week later than the next available date. This is helpful when changing from a weekly to a bi-weekly time tracking process in your company.

## Billing Rates


SuiteProjects Pro lets you select what determines hourly Billing Rates. This is a global setting that controls all billing rates in SuiteProjects Pro. Therefore, you cannot choose Service for one customer and Project billing rules for another.

## Navigation


Administration > Global Settings > Jobs, Rates > Billing Rates

The options are:

- **Service** — This selection determines the billing rate to the customer based on the various kinds of services performed. These rates apply to all Customers.

 **Note:** Your company may use the term Service or Activity. Depending on your company's terminology preferences, one or the other displays in selections on this form.

- **Service / Customer** — This selection is similar to the Service type noted above as the rate is based on the various kinds of services performed. The difference is that with this option, the Service rates dialog appears on the Customers form and lets you designate the billing rates for the kinds of services performed specifically for this customer. This is useful if you have preferred Customers for which you discount your services.
- **Employee** — Choosing the Employee option selects the billing rate entered in the employee's Demographic record for the billing rate.
- **Employee / Project** — This setting enables the Employee billing rate tab. The Employee billing rates link displays. By selecting this link, you are able to set billing rates by employee for this particular project.

 **Note:** The Employee billing rates link is not available through the Projects application, only through the Administration application.

- **Customer / Project** — This setting enables the Billing information tab. If you create a new or edit an existing customer, you can then set a specific rate to be charged on all projects for this customer. The Employee billing rates link displays. This is useful if you charge a blended rate for all work done for a customer.
- **Project billing rules** — Selecting this option provides you with the most flexibility in billing the customer. You can create billing rules for every project based on the terms of the particular contract or statement of work. You can use hourly billing rates, fixed fee, and receipt based billings.



**Important:** You should use Project billing rules. Changing to another method from Billing Rules hides Billing Rules in SuiteProjects Pro and may create confusion among your employees who do billing.

## Cost Centers

Cost centers function as a reporting and accounting tool to track costs related to expense receipts and employee time entries. You can associate cost centers with the following entities: Customers, Projects, Tasks, Services, Time types, Expense Items, and Employees.

To view the list of all cost centers, go to Administration > Global settings > Job, rates > Cost centers > Cost centers.

### To create Cost centers:

1. Go to Administration > Global Settings > Jobs, Rates > Cost Centers.
2. Select **New Cost center** from the create menu.
3. Enter the **Name** and **Notes**. The Active cost center box is checked by default.
4. Click **Save**.

## Receipt rules

Receipt rules determine which receipts within expense reports are assigned to the cost center.

To view and change receipt rules, go to Administration > Global settings > Job, rates > Cost centers > Receipt rules.

Receipt rules can be set by customer, project, task, expense items, and employee. You can select multiple options. When an employee creates and saves an expense report, the associated expense item is checked against the receipt rule selections. If a receipt matches a selected item that is associated with a cost center, the cost center is assigned to the receipt. If no item is found, then no cost center is assigned.

There are multiple selections in case there is not one uniform way that costs are associated to a cost center, that is, you can select a project and then an employee. In the majority of instances, the expense receipt is stamped with a cost as derived from its associated project. In the absence of a cost center on a project, SuiteProjects Pro looks for the cost center associated to the employee, if applicable, to stamp the expense receipt. The same applies to time entries.

## Time Entry Rules

Time entry rules determine which time entries are assigned to the cost center.

To view and change receipt rules, go to Administration > Global settings > Job, rates > Cost centers > Time entry rules.

Time entry rules can be set by Customer, Project, Task, Expense Items, and Employee. You can select multiple options. When an employee creates and saves a timesheet, the associated time entry items are checked against the time entry rule selections. If a time entry matches a selected item that is associated with a cost center, the cost center is assigned to the cost, which is determined by multiplying the time entry by the employee's associated cost. If no item is found, then no cost center is assigned.

When an item is selected, a Cost center field is added to the form for that entity. You need to associate each item you selected with its appropriate cost center by editing these entities individually. For example,

if you create a Employee cost center called US Employees, and have Employee for Receipt Rules, you then need to go to each employee in the US Group and add them to the US Group cost center on the Employee Demographic record.

## Job Codes

Job codes classify employees into general job positions defined by your company. Job codes are not necessarily job titles at the company. They are normally used as a type of employee that you bill out to a customer. You can give job codes a generic cost for calculating estimated margins without named resources. You can also give job codes a bill rate within a rate card. For example, you may create a Project Manager, Consultant, and Engineer job code. Generic resources may be associated with a job code to inherit rates for forecasting purposes. See [Rate Cards](#).

To view the list of all job codes, go to Administration > Global settings > Job, rates > Job codes > Job codes.

### To create Job codes:

1. Go to Administration > Global Settings > Job, rates > Job codes.
2. Select **New Job code** from the create menu.
3. Enter the Job code name and Loaded cost per hour (used to calculate project costs for analysis), select Currency, and associate with a Generic resource.
4. Add Notes, if desired.
5. Click Save.

You can set time entry rules and charge rules to determine how a job code is assigned to a time entry or a charge, respectively.

To view and change time entry rules, go to Administration > Global settings > Job, rates > Job codes > Time entry rules.

To view and change charge rules, go to Administration > Global settings > Job, rates > Job codes > Charge rules.

## Rate Cards

Use rate cards to define bill rates for a group of job codes. You can use rate cards to determine billing rates in Project Billing Rules as well as Project estimating based on job codes. You can create multiple rate cards, which is helpful if you negotiate different bill rates per job code, per customer. For example, for Customer ABC, a project manager bills at \$150 per hour; however, for Customer XYZ, a project manager bills at \$140 per hour. In this example, you would have two rate cards for each billing arrangement.

To view the list of rate cards, go to Administration > Global Settings > Job, Rates > Rate Cards > Rate Cards.

To view the list of rates set in all your rate cards, go to Administration > Global Settings > Job, Rates > Rate Cards > Rates.

### To create Rate cards:

1. Go to Administration > Global Settings > Jobs, Rates > Rate Cards.
2. Select **New Rate card** from the **Create Button**.



3. Enter the rate card Name.
4. In the Rates section, select the Job code from the drop-down list (job codes must be set up), the Rate (per hour) to be charged, and the Currency. See [Job Codes](#).
5. Add Notes for additional description, if desired.
6. Click Save.

## Accounting Dates

SuiteProjects Pro lets you control accounting dates for a variety of transactions. You can associate accounting dates with timesheets, time entries, expense reports, receipts, invoices, revenue containers, and recognition transactions as well as with reports drawing from these accounting dates. The ability to maintain separate accounting dates can be particularly helpful when the original transaction date of an entity must be independent from the financial accounting date, as signified by a financial report or general ledger application.

Accounting dates can be populated automatically at a particular time, such as transaction creation, and with a particular date.

 **Note:** This is not equivalent to accounting period functionality as seen in a financial system. This feature permits transactions to be tagged with an additional date value to keep reporting consistent within a particular accounting period. [Discuss this feature with SuiteProjects Pro Professional Services](#) before deciding on whether this functionality is applicable in your account.

To enable accounting date functionality, [Creating a Support Case](#) and request that the following switch for accounting periods be enabled: Enable the accounting period feature to manage transaction dating.

### To set up Accounting dates:

1. Go to Administration > Global Settings > Organization > Accounting Dates.

The selections available in the drop-down lists for the Accounting date configuration vary according to the entity that is being set up. For each entity, select an event and then select an associated accounting date. For example:

- Timesheet events include: Timesheet created, Timesheet submitted, and Timesheet approved.
- Timesheet Accounting Dates include: Timesheet start date, Date timesheet is created, Date timesheet is submitted, Date timesheet is Approved, Custom date, and Custom Accounting period.

The drop-down values are similar to the above for time entries, expense reports, receipts, and invoices. These drop-down values are the events in SuiteProjects Pro that trigger the stamping on an accounting date onto the transactions. For example, when a Timesheet is submitted, the time entry is stamped with an accounting date of today's date.

After you select the settings and save the form, the accounting dates for the associated transactions are populated automatically according to the accounting date event and the chosen date. Any accounting date can be manually updated by editing the individual transaction and over-writing the accounting date.



**Note:** The automatic population of accounting date for charges and revenue recognition transactions can be set up within the billing and revenue recognition rules. See [Accounting Periods](#).

## Accounting Periods

The accounting period functionality lets you associate separate accounting dates with most transactions as well as with reports drawing from these accounting dates. The ability to maintain separate accounting dates can be particularly helpful when the original transaction date of an entity must be independent from the date, as signified by a financial report or general ledger application.

Review the following examples:

- Charges on an invoice dated July 5th need to be associated with the month of June in the general ledger since the charges were incurred in this month. In this example, the invoice transaction date would be 07/05/12, however, the invoice accounting date might be 06/01/12.
- A receipt incurred in March needs to be posted to the financial system in June. In this example, the receipt transaction date might be 03/17/12, while the receipt's accounting date might be 06/01/12.

The accounting period functionality lets you associate an additional independent accounting date with a transaction. You can then configure reports to leverage the accounting dates, rather than the original transaction dates. The accounting date functionality is enabled with the accounting period functionality.

To enable this functionality, [Creating a Support Case](#) and request that the following switch be enabled: Enable the accounting period feature to manage transaction dating (Support - Check with Sales before enabling). After you have activated the accounting period functionality, the following transactions have an acct\_date field available:

- Invoices
- Charges
- Expense reports
- Receipts
- Timesheets
- Time entries

- Revenue recognition transactions
- Agreements
- Customer PO's
- Fulfillments
- Purchase items
- Purchase Orders

### To create an Accounting period:

1. Go to Administration > Global Setting > Organization > Accounting periods.
2. Select **New Accounting period** from the **Create Button**.
3. Name the accounting period (Ex: P1 November 2012).
4. Select the start and end date for this period (Ex: 11/01/12 and 11/15/12).
5. Select the Transaction date for this period. This is the date that displays in the accounting date field when a transaction is created and associated manually or automatically with this Accounting Period.
6. Add any relevant notes to the Notes field that may be helpful. (For example, you might type, "This is the first of two accounting periods in November 2012.")
7. Check the **Active** box, unless the accounting period does not need to be active at the moment. (Inactive accounting periods do not show up in drop-down lists for association with transactions).
8. Check the **Current accounting period** box to which the accounting period should be referenced if and when the current accounting period is selected in any billing or revenue recognition rules setups.
9. Click Save.


### To auto-populate Accounting Dates charges through Project Billing rules:

1. Go to Projects and select a project. Go to Billing > Billing rules.
2. Drill into the billing rules. Under the Accounting date setup, **How to get the accounting date field**. Select either of the following
  - **Use the accounting date specified below**  
If this is selected, the **Accounting date** field must be populated with a specific transaction date.
  - **Use the accounting period specified below**  
If this is selected, the Accounting period drop-down listed below must be populated with a specific accounting period, or more commonly, the dynamic current accounting period selection. If you select the current accounting period, the accounting period that has the **Current accounting period** box checked is used.
3. Click Save.  
The next time the billing rule is run, charges generated have the Accounting date populated according to the Accounting Period setup within the rule.

### To update the Accounting Dates on charges:

1. Go to Projects and select a project. Go to Billing > Billing rules.
2. To update the accounting date one charge at a time, drill into a charge and manually update the accounting date field.

3. To update the accounting date on charges in bulk, go to the open charges tab within the Invoices application. Select the check boxes next to the charges that need to be updated, click the run-an-action icon, select **Change the Accounting Date to** and select the appropriate accounting period.
4. Click OK.

 **Note:** Access to the accounting dates is controlled by an employee's application role and can be hidden on forms using form permissions. See [Form Permissions](#).

### To auto-populate Accounting Dates on Revenue Recognition Transactions through Revenue Recognition rules:

1. Go to Projects and select a project. Go to Recognition > Recognition rules.
2. Drill into the revenue recognition rules. Under the Accounting date setup, designate How to get the accounting date field. Select either:
  - Use the accounting date specified below  
If this is selected, the **Accounting date** field must be populated immediately below with a specific transaction date.
  - Use the accounting period specified below  
If this is selected, the Accounting period drop-down immediately below must be populated with a specific accounting period, or more commonly, the dynamic Current accounting period selection. If the current accounting period selection is picked, the accounting period that has the **Current accounting period** box checked is used.
3. Click Save.  
The next time revenue recognition is run, these updated rules create revenue recognition transactions that have the Accounting date populated according to the Accounting Period setup within the rule.

### To update the Accounting Dates on revenue recognition transactions:

1. Go to Projects and select a project. Go to Recognition > Recognition rules.
2. To update the accounting date on one revenue recognition transaction, drill into a revenue recognition transaction and manually update the accounting date field.
3. To update the accounting date on revenue recognition dates in bulk across a project, drill into a project and go to the revenue recognition transactions tab. Select the check boxes next to the charges that need to be updated, click the run-an-action icon, select **Change the Accounting Date to** and select the appropriate accounting period. Click OK.

## Updating Accounting Dates Automatically

You can update an accounting date manually, or arrange to have the accounting date automatically populated at a particular time. See [Accounting Dates](#).

This applies to the following:

- Timesheets
- Time entries
- Expense reports
- Receipts
- Invoices


- Revenue containers
- Recognition transactions

## Approval Options

You can configure SuiteProjects Pro to require approval for certain type of transactions before these transactions can be processed. Some transaction approvals are available as standard when the transaction type is enabled, other transaction approvals are optional. To control most optional transaction approvals, go to Administration > Global Settings > Organization > Approval Options.

- To enable employee- or customer-level approval routing for a type of transaction, check the **Enable approvals for <transaction\_type>** box.
- To enable project-level approval routing for a type of transaction, check the **Enable project approvals for <transaction\_type>** box.
- SuiteProjects Pro lets you designate specific employees on the project record (**Project approver 1**, **Project approver 2**, and **Project approver 3**) to approve transactions for this project as part of an approval process. When this functionality is enabled, you can create approval processes and route approvals to the designated project approvers using the metavalues [Project approver 1], [Project approver 2], [Project approver 3].

To enable this functionality, check the **Enable additional project specific approvers** box.

 **Note:** SuiteProjects Pro skips the approval level and the transaction is approved automatically at this approval level if:

- A [Project approver <n>] metavalue is included in an approval process at the user level.
- The project approver is not specified on the project properties form.

- To include the time when the transaction was submitted, approved or rejected in the approval history for the transaction record, check the **Display the time on the approval history** box.

The following table lists the transaction record types for which employee-, customer-, or project-level approval routing is available. Optional transactions approvals are indicated with a check mark. Transaction approvals available as standard with the transaction type, are indicated with the mention "Standard".

**Note:** To enable project-level approvals for bookings, contact SuiteProjects Pro Support. This is only available if the booking request functionality is not enabled for your account.

## Currencies

SuiteProjects Pro supports multiple currencies.

All SuiteProjects Pro accounts include the capability to create expense receipts in any of the supported currencies even if all your business transactions are done in the default currency for your account. Account administrators can:

- Set the default currency for the account.
- View the list of supported currencies, including the market exchange rates for these currencies (updated daily). See [Viewing Exchange Rates](#).
- Override market exchange rates with company exchange rates. See [Setting Company Exchange Rates](#).

If your business uses more than one currency for transactions, you can enable the Multicurrency feature. The Multicurrency feature provides support for transactions in currencies other than your default currency. For example, the feature lets you reimburse employees expenses, invoice customers, recognize revenue, and run reports in multiple currencies. After you enable the feature, you can:

- Set the different currencies your company uses for transactions. See [Enabling Multiple Currencies](#)
- Set a **Currency** for all relevant entity records and work with multiple currencies in SuiteProjects Pro.
- Download historical currency cross rates as a CSV file.

Additional optional features also give you access to advanced multicurrency functionality, for example:

- The ability to modify historical currency cross rates.

**Note:** This feature requires the Edit Exchange Cross rates optional feature to be enabled for your account, in addition to the Multicurrency feature.

- The ability to define arbitrary custom currencies for reporting purposes.

**Note:** This feature requires the User-Defined Reporting Currencies optional feature to be enabled for your account.


To enable the Multicurrency feature and discuss advanced multicurrency functionality, contact your SuiteProjects Pro account manager or SuiteProjects Pro Professional Services. You cannot disable the feature after you create transactions and records that rely upon it.

## Viewing Exchange Rates

To view the exchange rates for all supported currencies, go to Administration > Global settings > Organization > Currencies > View exchange rates.

The Exchange rates list includes the following information for each available currency:

- **Currency** — The name of the currency.
- **Symbol** — The three-letter currency code as per the [ISO 4217](#) code list.
- **Market rate** — Current market value of the currency against the selected base currency. To select the foreign exchange rate base currency, go to Administration > Global settings > Organization > Currencies > Set exchange rates.

 **Note:** Market foreign exchange rates are updated daily using a data feed from [Xignite](#) around 3:00 a.m. Eastern Time (UTC - 5).

To find the exact foreign exchange rates update schedule for your account, export your SuiteProjects Pro data and include the alert table. The table shows all alert triggers configured for your account. Look for `trigger_hour` and `trigger_minute` values in the row with the type value `multi_currency`.

- **Company rate** — SuiteProjects Pro lets you override the market foreign exchange rate value with a company rate. The company rate is used for all transactions and reports if it is set. The market rate is used otherwise. See [Setting Company Exchange Rates](#).

## Setting Company Exchange Rates

SuiteProjects Pro lets you override the market foreign exchange rate value with a company rate for each currency. The company rate is used for all transactions and reports if it is set. The market rate is used otherwise.


To change the base currency for foreign exchange rates or enter company exchange rates, go to Administration > Global settings > Organization > Currencies > Set exchange rates.

- To change the base currency for foreign exchange rates, select a currency from the **Base exchange rates on** dropdown list.
- To set a company exchange rate for a currency, locate the currency on the form and enter the exchange rate value against the selected base currency in the box next to the currency name and code.
- Click **Save** to save any changes made on the Set exchange rates form.

After you set a company exchange rate, it appears on the Exchange rate list. See [Viewing Exchange Rates](#)

## Enabling Multiple Currencies

If your business uses more than one currency for transactions, you can configure SuiteProjects Pro to support transactions in currencies other than your default currency. For example, the feature lets you reimburse employees expenses, invoice customers, recognize revenue, and run reports in multiple currencies. After you enable multiple currencies, you can set a **Currency** for all relevant entity records, include monetary fields for each configured currency in reports, and work with multiple currencies in SuiteProjects Pro.

 **Note:** The Multicurrency feature is not required to create expense receipts in any of the system-supported currencies. If all your business transactions are done in the default currency for your account, you do not need to enable the Multicurrency feature. You cannot disable the feature after you create transactions and records that rely upon it.

### To enable multiple currencies:

1. Contact your SuiteProjects Pro account manager or SuiteProjects Pro Professional Services and request the Multicurrency feature.
2. Go to Administration > Global Settings > Organization > Currencies > Multi-currency.
3. Select the currencies your company conducts business transactions in. The first currency you select at the top of the form is your default currency. To add more rows, click the [Add rows] dropdown and select the number of rows you need to add.
4. Click **Save**.

## Departments

Departments function as groupings of employees based on distinct criteria. The criteria can be defined based on your company's requirements. You can also use Departments to grant group access privileges and create customized approval procedures.

### To create Departments:


1. Go to Administration > Global Settings > Organization > Departments.




2. Select **New Department** from the **Create Button**.
3. Type the Department name.
4. Add Notes as applicable.
5. Click Save.

After the Department is created and saved, additional options display. They include:

- **Assigned employees** — The Assigned employees option is where you can now assign employees to the department. A employee can only belong to one department. Employees available to be assigned display in the Available Items area. If an employee is not listed in the Available Items, then they have already been assigned to another department. You must unassign the employee from the old department before you can assign them to the new department. After all employees are assigned in the Selected Items area, save the form.
- **Edit** — After employees are assigned, you can Edit the Department form and add the Department head if applicable. The Department head must be an active employee and must be a member of the department.

 **Note:** Click the link to Modify the form permissions to display a message area. If departmental dashboards are active in your account, you can enter messages or notifications that are posted on the departmental dashboard when employees sign in to SuiteProjects Pro. Only members of the department are able to view these messages.

- **Approvals** — Approvals allow you to set each employee's approver by function. The functions listed include: Timesheets Approver, Expenses Approver, Authorizations Approver, Proposal Approver, Purchase Request Approver, and PO Approver, provided these functions are enabled in your company's SuiteProjects Pro account. You can assign mass approvers to the department head, to a generic such as Manager or to an approval process. You can also choose named approvers by employee by function. After approvers have been assigned, save the form.

 **Note:** Approvers can also be assigned at the Employee level when a Employee is created or modified.

## Hierarchy

Hierarchies are used to create hierarchal classification trees with employees, customers, and projects. A employee, project, and customer can only belong to one node at any particular moment within a hierarchy, but can belong to multiple hierarchies at one time if multiple hierarchies exist for a record. A employee project, and customer can also be moved between nodes with a hierarchy.

Hierarchies are used for subtotaling and filtering within Summary reports. For example, you may create a customer hierarchy based on geographical location that associates each customer with an office location such as a city. You could also create a two level hierarchy: city and state. Each level may have multiple nodes. The state level can have Texas, Georgia, and Washington. Or, at the city level you could have Seattle, Austin, Dallas, and Atlanta. Each city level node has a parent node such as a state. By assigning customers to a city, they are automatically also associated with the state.

### To create Hierarchies:

1. Go to Administration > Global Settings > Organization > Hierarchies. Select **New Hierarchy** from the **Create Button**.
2. Enter the Hierarchy name and select the Type. Associate the hierarchy with either Employee, Project, or Customer.

3. Add Notes about this hierarchy, if desired.
4. The **Active** box is checked by default.
5. Check the **Show this Hierarchy when editing objects of this type** to make the field visible on the entity form.
6. Check the **Require a hierarchy selection when editing objects of this type** to make this field required.
7. You can duplicate levels and nodes of another hierarchy if this feature has been enable for your account. However, the nodes will be empty.
8. Save the form. The **Enable this hierarchy as a column in entity lists** box becomes available. Check this box to add the hierarchy to customized lists of data.

After you create a Hierarchy, then you create corresponding Levels and Nodes. When the hierarchy form has been saved, links to the Levels, Nodes and Entity (Customers, Projects or Employees) display on the Edit hierarchy form.

### To create Levels:

1. Click on Levels link. Select New > Level.
2. Enter the Hierarchy level name. If this level is the topmost level, then no Parent is required. For all other levels below the topmost level, a parent is required.

**Note:** There can be only one topmost level for each hierarchy. If you do not select a parent for a level, SuiteProjects Pro automatically places it as the topmost level and it becomes the parent of the previously topmost level.

3. Add Notes about this hierarchy, if desired.
4. Click Save.

You create Nodes in a similar manner to Levels, as described above. You cannot create Nodes until you have created Levels.

### To create Nodes:

1. Click on Nodes link. Select New > Node.
2. Enter the Hierarchy node name and select the Parent the level to which it belongs.

**Note:** There can be multiple Nodes at each level. When you create your Nodes, you can assign customers, projects, and employees to the nodes.

3. Click Save.

You are able to see a list of entities associated with the hierarchy. If a Project hierarchy is created:

- On the Edit hierarchy form, check the **Use to determine filter set access for projects** box if you want to use it in filter sets. This feature lets an employee have project access based on placement within a project hierarchy. See [Filter Set Access Control](#).
- On the Edit project form, specify the node of the hierarchy in which the project belongs.
- On the Employee Demographic form, select which group of projects the employee has the right to use by picking the appropriate node or level of the hierarchy.

Note: Customers, projects, or employees can only belong to one node in each hierarchy. Therefore, it is useful to assign them to the most specific node. When you run reports, the employee, customer, or project are automatically rolled-up into the higher level parent nodes.

## Name & Address

The Name and Address link displays the Company information form. This is where you enter company information such as name, address, phone number as contracted with SuiteProjects Pro for billing purposes. The key field here is the Company ID, which is required to identify your company's instance during sign-in. The Company ID may be changed if, for example, your company undergoes a name change.

### To create or edit Company information:


1. Go to Administration > Global Settings > Organization > Name & Address.

**Note:** All active users of your company's SuiteProjects Pro account receive an email if the Company ID field is changed. This is a critical piece of information for accessing SuiteProjects Pro. If changes are made to the other company information fields, no email notifications are sent to SuiteProjects Pro users.

## Projects

The Project form requires only a few fields to create a project: Project Name, Customer, and Start date. However, it lets you capture pertinent project information such as the following.

- **Project name** — The project name should be descriptive but short to preserve space on page displays and on reports.
- **Project owner** — The Project Owner drop-down can be set to the resource responsible for the information accuracy tracked on the project. This field setting has special use related to approval processes and reporting filters.
- **Project stage** — Remember, project stages must have been previously defined to be available for selection here. See [Project Stages](#).
- **Start date** — The Start date is defaulted to today's date and, in most cases, signifies when the project is estimated to start.
- **Budget hours** — Indicates the effort estimated to complete the project activity. When budget hours is set, the budget alert feature within the projects application may be used to notify project owners when work expended on a project is within a defined threshold of the project budget.
- **Budget money** — The Budget money is where the contract value is typically entered. It is in the same currency set on the project.
- **Currency** — The currency displayed is the default currency for your account, but may be overridden to be any currency defined in your account. The billing rule currency defaults to the currency set on the project.
- **Billing code** — The Billing code is a free-text 2 digit field that may be used in the Invoices application for batch creation of invoice per billing code. Values set in the billing code field are not defined in SuiteProjects Pro and should be set according to policy within your company, if used.
- **Invoice layout** — The Invoice Layout dropdown displays if you have defined invoice layouts in the invoices application. The default value is Default invoice layout, which is also set within the Invoice application options. Overriding the invoice layout value will define which invoice layout should be used when an invoice is generated for the project.
- **Agreements or customer POs** — If there are Agreements and Customer POs for the selected customer, an agreement and customer PO field is available allowing you to associate these entities with the project. Associating an Agreement or Customer PO with the project permits these items to be available for inclusion on billing rules, which will provide automatic balance tracking.

 **Note:** You can also create and edit project information in the Projects application. See [Projects](#).

## Tag Groups

The Tag group functionality lets you create specific subgroupings of items such as a subgroup of employees. This is useful if you need to report on a group of items that is a subset or may cross several values in a particular entity. For example, using the Department may be too large of a group for your particular need and the tag group is able to pare down the selection. Or, you may want to classify the Consultants role into their area of expertise to report on the utilization for each of these subgroupings. For example, Financials or CRM consultants may cross organizational department and boundaries.

The difference between a tag group versus a custom field is that the tag group lets you track the changes in historical values. A custom field only shows and reports on the current value, whereas an employee's change in tag group values are represented throughout any time range in reporting.

### To create Tag groups:

1. Go to Administration > Global Settings > Tag group.
2. Select **New Tag group** from the create menu.
3. Select Entity type. This is always Employee.
4. Enter the Name of the tag group and choose whether you would like this tag group to be searchable in the Resources application.
5. Enter Tag group attributes for this group. For example, if you decide to have a tag group for city, attributes may be values such as Chicago, New York, Dallas, and San Francisco.
6. Check the **Active** box to indicate which attributes are active.
7. Click Save.

## Tax Locations

Multiple tax locations can be established to handle sophisticated tax requirements. Tax locations allow for complex tax requirements.

Tax locations include:

- US federal and states taxes
- GST Goods and Services Tax (Canada, Australia)
- VAT (Europe, and other countries)
- PST (Provincial Sales Tax - Canada)
- HST (Harmonized Sales Tax - Canada)

### To create Tax Locations:

1. Go to Administration > Global Settings > Organization > Tax Locations.
2. Select **New Tax location** from the **Create Button**.
3. Enter the Tax location name.
4. Select Tax rates for the type of tax and enter percentage amounts.
5. Type the Accounting code for each tax rate.
6. Type Optional terminology that displays on POs.

7. Add Notes, if desired.
8. Check the **Include GST in PST calculation** box if you want the GST to be added to the total before the PST percentage is applied.
9. Click Save.

After creating Tax locations, a Tax Location drop-down list is available within the following entities: Projects, Customers, and Employees.

To apply the taxes to an invoice, you must associate the appropriate Tax Location with the project.

When setting up an expense billing rule, the GST and HST tax amounts can be backed out if they are not application to be billed back to the customer.

## Frequently Asked Questions (FAQs)

There are several tax options here such as Federal, State, and GST. How do I know which ones to set up?

This can be simple or complex depending on where your company and customers are located. We suggest contacting your company's Tax Accounting or Finance Department for guidance on which tax rate options should be set up in SuiteProjects Pro.

Even if I have the proper tax rates set up in SuiteProjects Pro, how can I make sure that they are applied properly on the invoices?

As mentioned above, taxation action items can be complex. Invoicing Customers should be controlled by your company's Accounting or Billing department. Taxation details are usually contained in the contract or statement of work with the customer.

## Tax Options

Tax Options provide the ability to select and create various taxation scenarios. These are available in the Invoices and Expenses applications.

### To create or edit Tax options:

1. Go to Administration > Global Settings > Organization > Tax Options.
2. Select the Tax calculation method. Three main methods exist for tax calculation.
  - **Tax locations** — allow the creation of individual tax settings, which consider taxation on a geographic basis. See [Tax Locations](#).
  - **Tax rate by expense item and service** — permits the tax settings, which are based on individual expense items and services, to be applied when generating customer billings. See [Expense Items](#) in Expenses Settings and [Expense Items](#) and [Service](#) in Invoices Settings.
  - **Federal/State tax by project and vendor** — permits the entry of a tax location/rate directly on a project or vendor, which will be applied to customer billings.
3. Check the **Enable tax locations on receipts** box.
4. Click **Save**.

**Enable tax locations on receipts** — By default, taxes may be handled on invoices and taxable information will be computed based on associated services with timesheet hours, that is, the service is set up as taxable.

Expense Items and Products may also be set up as taxable. The tax calculation is applied based on the tax location set on the project, which is passed to the invoice, or set directly on the invoice. Optionally, receipts within an expense report may have unique taxes related to the location of where the expense was incurred. Select this option to display the tax location field on receipts for the entry of specific tax handling.


Other considerations when selecting this option are as follows:

- When you rebill expenses, do you remove the tax amount of the location where the expense was incurred and apply a standard tax rate, an option on the expense billing rule?
- Do you apply taxes in addition to the taxes captured for the receipt?
- Do you pass taxes directly through to the customer?

## Work Schedules

Work Schedules define the work week within your company. You may create multiple calendars to define different work weeks. For example, you might define part-time schedules or work week hour variations might need to be addressed in different regions of your company. See [Creating and Editing Company Work Schedules](#).

If work schedule time ranges are enabled, you can define start times for each day of the week. See [Optional Features](#).

 **Note:** You need to enable work schedule time ranges and ensure that employees work schedules include start times to create bookings with start and end times for these employees, see [Frequently Asked Questions \(FAQs\)](#) under the Resources chapter.

You can also enter schedule exceptions for each work schedules. Work schedule exceptions can be created for public holidays, closure periods recognized or any other days, part-days or periods recognized by your company as non-working time. For each exception, enter a description, for example the name of the holiday, the start and end dates of the exception, and enter 0 hours for the work day definition.

Company work schedules can be associated with individual employees by setting the employee's **Schedule** link to the desired company schedule. Employees associated with the work schedule are not available for work on the days specified in the work schedule exceptions. If you have selected timesheet options to display schedule exceptions on the timesheet, then the company holidays entered on the work schedule are displayed on the employee's timesheet based on the schedule associated with the employee's account.

There are various configurations available on work schedules that allow for options such as a flexible-time schedule. Contact SuiteProjects Pro Support or SuiteProjects Pro Professional Services to discuss these options.

## Creating and Editing Company Work Schedules

You may create multiple calendars to define different work weeks.

### To create or edit work schedules:

1. Go to Administration > Global Settings > Organization > Work schedules.
2. Do one of the following:
  - Select a work schedule to edit it.
  - Click the **Create** button then **New work schedule**.

The work schedule form appears.

3. If you are creating a new schedule, enter a **Company work schedule name**.
4. Check the **Make this the default company work schedule** box if you want this work schedule to be associated to all new employees by default.
5. Check the boxes for each working day of the week according to your company's work schedule.
6. Enter the **Work hours per day for this company work schedule**.
7. If work schedule time ranges are enabled for your account, you can define different set of **Daily work hours**. For each set:
  - a. Enter either a **Default start time** or a start time for each working day of the week. The end time is set based on the number of hours for that day.
  - b. Enter a **Description**.
  - c. To make this set the default daily work hours for employees associated with the company work schedule, check the **Default** box.
8. Add any exceptions to the company work schedule. Exceptions can be used to enter public holidays and any period of company closure for example. These exceptions apply to all employee schedules associated with the company work schedule.
9. Click **Save**.

## Frequently Asked Questions (FAQs)

### How do I input my company holidays into the work schedule?

Company holidays and other days where all employees will not be working are entered under the Exceptions to Account workschedule work schedule section of the Work Schedule form. Remember, you can have multiple work schedules based on different countries, regions, states, etc. For each work schedule, enter the Description, which is the holiday name, Start date, End date, Hours to work per day (enter 0 if full day off, or other value depending on the situation), and select a Reason (time type) if these exist in your environment.

**Note:** Always add the next year's holidays after the current year's entries. This will keep all calendars consistent with the appropriate exception data.

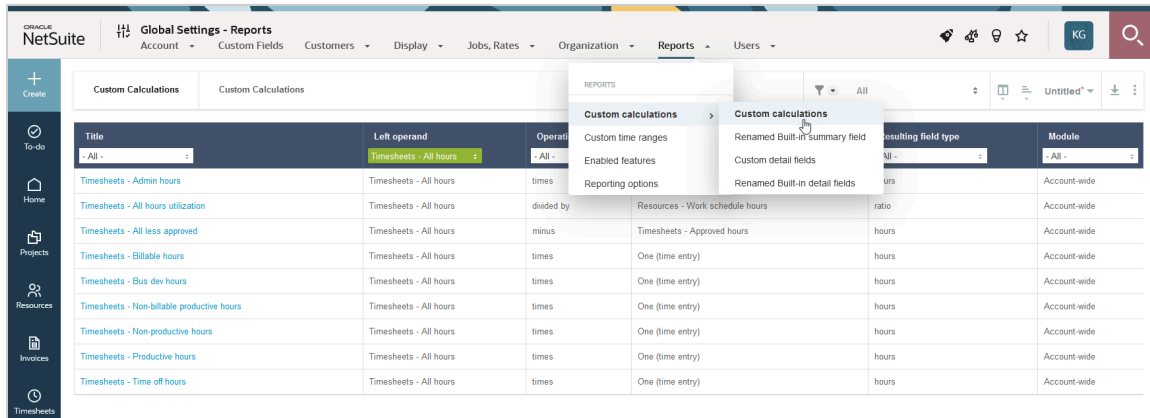

## Custom Calculations Overview

SuiteProjects Pro comes with several standard value fields, but you may find that there are other values you would like to track such as fields related to projects, employees, resources, and expenses to name a

few. Or, there may be some standard value fields that you would like to rename for reporting purposes, using your company's terminology. SuiteProjects Pro addresses your needs by allowing you to create custom calculated fields and renamed built-in fields.



### To access Calculated Fields:

1. Go to Administration > Global Settings > Reports > Custom Calculations. Select the type of calculated field link you want to use.
2. To view or modify an existing calculated field, select the appropriate field link under the Title column.
3. To add a new calculated field, select New and one of the options available in the drop-down list.

## Custom Calculations

The Custom calculations option lets you define additional value fields for specific objects. Custom calculated field values are only displayed in Summary reports. When selecting what type of custom calculated field to make, the drop-down selection under the New menu corresponds to the type of summary report the calculation will be found in after it is made. For example, if you select an Account-wide project custom calculation, the resulting calculation can be found when you create a report from the account-wide projects section of summary reports. You are also able to use custom detail fields as constants in Custom calculations.


Calculated fields allow you to take two value fields and apply an operation on one from the other such as Expenses Approved minus Expenses Submitted. When a custom calculated field is created and associated with an object, it cannot be changed to another object. See [Custom Calculations Overview](#).

When you create custom calculations, you need to decide on the main value you want to use in the custom calculation. For example, do you want to use money values related to Invoices or hours related to Timesheets, or both? This decision helps you determine whether you are choosing an Account-wide custom calculation or a application-specific custom calculation. The Account-wide selection provides the most flexibility in creating custom calculations. The entity determines where the value is stored in SuiteProjects Pro.



## To create a Custom calculation:

1. Go to Administration > Global Settings > Reports > Custom Calculations.
2. Select the custom calculation type from the **Create Button**.  
The New custom calculation form displays.
3. Next, decide on the Left operand, Operation and Right operand. Operation values include: plus, minus, times and divided by.
4. The Title is the name you provide for the custom calculated field. The custom calculated field title is automatically prepended with the entity name (for example, Employee - Invoiced hours).

 **Note:** The **Do not automatically prepend module name to title in account-wide report** box is only available when selecting Account-wide custom calculations. When checked, the entity name does not appear in the name of the custom field when selecting it as a value in the Summary reports.

5. A description may be added.
6. An **Active custom calculation** box is available.
7. Click Save.

## Custom Detail Fields

The Custom detail fields option lets you define additional value fields for specific objects. You can display Custom detail field values in Detail reports.

Custom detail fields allow you to create a new value field from standard value fields within a particular application. When a custom detail field is created and associated with an object, it cannot be changed to another object. You can bring custom detail fields in as separate columns in summary reports.

You need to select the entity value you want to use from the New drop-down list. For example, are you creating a custom field based on the Project stage or Booking? The entity determines where the value is stored in SuiteProjects Pro.

## To create a Custom detail field:

1. Go to Administration > Global Settings > Reports > Custom Calculations.
2. Click the Custom detail fields link.
3. Select the new custom detail field type from the **Create Button**.  
The New custom detail field form displays.
4. Next, choose the Function. Function choices include: AVERAGE, CONCATENATION, CONSTANT, DATE\_DIFF, DIFFERENCE and SUM. Not all function types are available for the various application entities. For example, if the entity is a text field, your function choices are limited to CONCATENATION and DATE\_DIFF.
5. The Title is the name you provide for the custom detail field.
6. Depending on the application entity chosen and the function, the form varies:
  - If the function is AVERAGE, an Available numeric area displays where you can select the numeric values to be used in the average and move them to the Selected numeric area.
  - If the CONCATENATION function is selected, a Text template area displays. You are able to add straight text and use standard field values. To select standard field values, choose the appropriate value from the Field drop-down list. Then copy and paste the value shown in the

text box below the drop-down list into the Text template. It may be something like the following:  
%%approval\_history%%

- If the CONSTANT function is selected, you need to enter the value of the constant. The other argument for the constant function is the Resulting field type. Choices include: hours, days, quantity, and ratio. The constant custom detail fields can be used in custom calculations and in summary reports. This functionality is currently limited to transaction fields, such as Project billing transactions or Time entries.
- If the DATE\_DIFF function is chosen, the arguments area displays Date 1 minus Date 2. Both date fields are drop-down lists with the date fields available for the entity selected.
- If the function chosen is DIFFERENCE, the arguments area displays Minuend minus Subtrahend. The minuend and subtrahend fields are drop-down lists that contain the numeric data values for the entity selected.
- If the function is SUM, an available numeric area displays where you can select the numeric values to be used in the sum and move them to the Selected numeric area.

## Renamed Built-In Detail Fields

SuiteProjects Pro gives you the capability to Rename built-in detail fields for reporting purposes, using your company's terminology. You can also bring these Renamed built-in detail fields in as columns on summary reports.

### To create a Renamed built-in detail fields:

1. Go to Administration > Global Settings > Reports > Custom Calculations.
2. Click the Renamed Built-in detail fields link.
3. Select the standard field that you want to rename from the **Create Button**.  
The Rename built-in detail field form displays.
4. The Built-in title drop-down list provides a list of fields available to be renamed that are associated with the entity chosen.
5. After choosing the Built-in title field, enter the new Customized title. For example, Project owner may now be called Project Manager.
6. Under Summary Reports detailing options, if desired, check the **Suppress Optional 'Summary Report' suffix** box.
7. Click Save.

## Renamed Built-In Summary Fields

SuiteProjects Pro lets you rename built-in summary fields for reporting purposes, using your company's terminology. You can use these Renamed built-in summary fields in Summary reports.

### To create a Rename built-in summary fields:

1. Go to Administration > Global Settings > Reports > Custom Calculations.
2. Click Renamed Built-in summary fields.
3. Select the summary field that you want to rename from the **Create Button**.
4. The Built-in title drop-down provides a list of fields available to be renamed that are associated with the entity chosen. After choosing the Built-in title field, you enter the new Customized title. For example, you can change Project billing hours to Billed Hours.

5. Check the **Do not automatically prepend application name to title in account-wide reports** box if you don't want the application name prepended to the title. If you do not check this box, the calculated field displays in the value selection in summary reports with the application name before it. For example, it could read Timesheets - [NAME OF CALCULATION].
6. Click Save.

## Custom Time Ranges

SuiteProjects Pro lets you create custom time ranges to use in Summary reports and in Advanced resource reports and Invoice-Income received reports. Each report has a period field that sets the time range for the report. SuiteProjects Pro comes with built-in time periods such as Weekly, Monthly, Annual, etc. Custom time ranges allow for custom periods to be created based on specific company needs (such as a 4-4-5 calendar). When created, they are available for use in time period specific reports. A typical use of custom time ranges is if you report upon a fiscal monthly period that does not coincide with calendar months.

### To create Custom time ranges:


1. Go to Administration > Global Settings > Reports > Custom Time Ranges.
2. Select **New Custom time range** from the **Create Button**.
3. Enter the Custom time range name.
4. Next, add Time period names and Time period start dates. You must have at least two periods and dates, because the last date you enter is only used to calculate the end date of the previous period. The end date of each period is set to one day before the start date of the next period. If you do not name each time period, the name defaults to the start and end dates.
5. If you need to add more periods and dates, click Add Rows and select the number of rows to add.
6. Click Save.

## Enabled features

The Enabled features page lists features which can be enabled or disabled by account administrators for each SuiteProjects Pro application or by SuiteProjects Pro Support at the account level.

To view the enabled features list, go to Administration > Global Settings > Reports > Enabled features.

The listed features can be one of the following types:

- **Application** — Application settings are controlled by account administrators in the Administration module (Administration > Application Settings > [Select an Application] > Other Settings). These features are described in this guide. See the chapters describing each application.
- **Internal** — Internal settings control the optional features which can be enabled for your account by SuiteProjects Pro Support. These features are described in  [Optional Features](#).

The view includes the following information for every listed feature:

- **Name** of the feature — To learn more about the feature, click the feature name. The SuiteProjects Pro Help Center opens in a new browser window or tab and takes you directly to the relevant help topic.
- The release date when the feature was **Introduced**.
- The **Area** indicates which application the feature relates to or whether it is global feature.

- Whether the feature is **Enabled in account** (green square icon) or **Disabled in account** (red square icon). To learn more about requesting an optional feature to be enabled for your account, click **Disabled in account**. For Application settings, this link points to the help topic describing the feature.

**Note:** Some optional features shown as **Enabled in account** require additional Administration settings. Click the feature name or refer to [Optional Features](#) for more information.

- The feature **Type** — Application or Internal.

**Note:** You must be an administrator or have the **View Enabled Features** role permission to access the enabled features list. You must be an administrator or have the **View Help Center** role permission to click the links and access help topics describing the features.

**Attachment File Drag and Drop**

This feature lets you add attachments to projects, expense reports and receipts using file drag and drop. After you enable this feature, a new user interface for attachments appears on the project, expense report, and receipt properties forms. Like with the default attachment user interface, you can either attach multiple files from your computer or attach a single workspace document.

To add one or multiple files from your computer as attachments, drag the files to the **file attachments** box. The attached files appear in the **file attachments** box and include information about the file (file name, size, date and time uploaded, uploaded by).

**Note:** The date and time uploaded follows the preferred date format and time zone in your personal settings.

You can also drag a folder from your computer to attach all the files contained in the folder.

After the files are attached the following options are available:

- The number of attachments is indicated in the top right corner of the **file attachments** box.
- To download a single attachment, click the download icon.
- To download all attachments as a Zip archive, click the download icon in the top right corner of the **file attachments** box.
- To manage the current attachments, click the edit icon.
- To delete an attachment, click the delete icon.
- To delete all attachments, click the delete icon in the top right corner of the **file attachments** box.

**Note:** When you create a new project, expense report, or receipt, you can add attachments before you save the form. If you leave the form without saving the changes, the attachments will be saved in OpenAir as unassigned attachments. For more information, see [Unassigned Attachments](#). If you add attachments using file drag and drop to an existing project, expense report, or receipt, the attachments will be associated with the project, expense report, or receipt even if you do not save the form. ## Reporting Options

Reporting options settings provide system-wide controls on the appearance of reports and functions available in the Reports application. The Reports application also contains an Options tab which has other settings that affect the appearance of reports.

To view and modify the reporting options, go to Administration > Global Settings > Reports > Reporting Options.

The page includes the following settings:

- **Summary report forex conversions (multicurrency) determination observe the 'date to use' value:** Check this box to determine the historical foreign currency exchange rate to use in summary reports according to the **date to use** selected in dropdown list in the report properties.
- **Summary report user loaded cost determination observe the 'date to use' value:** Check this box to determine the historical loaded cost values to use in summary reports according to the **date to use** selected in dropdown list in the report properties.
- **Show projected billing values in summary reports. Calculated as hours times employee's default billing rate:** Projects-projected billing fields if multi-currency are available in Summary reports. The hours used in the computation of the field are determined by the charge projection feature activated within the Project Application Options tab. The charge projection feature by default uses the defined hours as virtual timesheets and forecasts financials based on existing billing rules on the project. When you check this box, it overrides the charge projection feature value by using the employee's hourly billing rate value instead of any rate defined on billing rules.
- **Show date and timestamp on reports:** Checking this option displays a Generated on date timestamp at the bottom of each report.
- **Show filter set on downloaded reports:** If you are using Filter sets to limit or narrow access to various data values, that is, a set of customers or employees, this option displays the filter set on the report to clarify the content presented.
- **Enable date range detailing:** Selecting this option enables new date ranges available within custom detail calculations using the Date\_Diff function. When enabled, the Date\_Diff function can use date ranges such as Today, Last week, and This Month. For example, a custom detail calculation field called Days to Completion would be calculated as Calculated finish date minus Today.
- **Hide the 'Drill down' reports tab:** Drill down reports allow reporting with hierarchies and a drill down capability into the various levels of the defined hierarchy. If you are not using hierarchies, you should hide the drill down tab since no additional capabilities are available to report employees.
- **Disable the FTE forecast summary report values which use job code-specific FTE generics:** The FTE forecast summary report calculates amounts based on the loaded cost for the Job code. If a generic resource is selected on the job code, costs are calculated on projects that have a generic resource assigned using the work schedule. Choosing this option prevents these costs from being calculated for generic resources and possibly skewing the data presented in the report.
- **In historical utilization calculations, the task type for filtering, subtotaling and detailing is sourced from the project's task instead of the timesheet's task:** When calculating historical utilization, by default the Task type value is taken from the timesheet. If this option is selected, the current task type value from the task is used in the calculation instead of that from the timesheet.
- **Enable Purchase date filters on summary reports:** Selecting this option provides several date filters to be available for Purchases data in the Summary reports form.
- **Enable Invoices date filters on summary reports:** Selecting this option provides several date filters to be available for Invoices data in the Summary reports form.
- **Enable Timesheets date filters on summary reports:** Selecting this option provides several date filters to be available for Timesheets data in the Summary reports form.


- **Enable Expense reports date filters on summary reports:** Selecting this option provides several date filters to be available for Expense report data in the Summary reports form.
- **Enable custom field date filters on summary reports:** Selecting this option provides a date filter for Custom date fields that you have created for your company to be available in the Summary reports form.
- **Enable custom field date filters on detail reports:** Selecting this option provides a date filter for Custom date fields that you have created for your company to be available in the Detail reports form.

## Users

You can add and manage SuiteProjects Pro users and set up access control in the Administration > Global Settings > Users section.

Access to data and functionality in the SuiteProjects Pro UI and add-on services is controlled at 3 levels:

- **Filter Sets** — A filter set is a defined access configuration that can be assigned to users. It controls what data –what projects or employees, for example– an employee can access. You should set up filter sets at a generic level and use the same filter sets for several employees based on what records these employees need to access to perform their job. Filter sets may overlay with roles to provide a matrix of capabilities for the employee. See [Filter Sets Overview](#).
- **Roles** — A role is a defined access configuration that can be assigned to users. It controls access to functionality, primarily. You should set up roles at a generic level and use the same filter sets for several employees based on what these employees need to do to perform their job. Roles may overlay with filter sets to provide a matrix of capabilities for the employee. See [Roles Overview](#).

 **Note:** Form permissions can be used to restrict the form data users can view or modify according to their role. Account administrators can define specific field access on most forms in SuiteProjects Pro to further refine the matrix of capabilities determined by the employee's role and the applied filter set. See [Form Permissions](#).

- **User Privileges** — Capabilities may also be defined at the user-level on the employee record. See [Employees Overview](#).

This includes the ability to:

- Access certain modules within the SuiteProjects Pro UI or use certain add-on services. Application and exchange access control let you set up generic roles and then control access to specific modules. For example, the employee's role may grant the ability to create invoices, but may not have access to the Invoices module, which effectively cancels out the role permission to create invoices.
- Perform certain actions or have access to information that should generally be available to designated employees. For example, permission to unapprove or unexport transaction records is controlled at the employee level on the Employee Demographic form rather than being granted by role. These permissions are sensitive and may impact data integrity in SuiteProjects Pro and third-party software you integrate with SuiteProjects Pro.

Users can fall into two broad categories:

- **Employees** — Your company employees, as well as the external consultants and subcontractors who deliver services on behalf of your company.
- **Guest Roles and Guests** — Guests are customers who are able to sign in to SuiteProjects Pro and view the application data that is associated with them. See [Guest Roles and Guests](#).

Employee locations allow you to store location attributes at the employee entity level, for reporting or segmentation purposes. Sample employee locations could be by state, by city, by country, or any customized list of values. See [Employee Locations](#).

## Filter Sets Overview

Filter sets define what data the employee has permission to view or update. The following entities are identified within the filter sets: Customers, Projects, Services, Employees, Expense Items, Charge stages, and Project stages. Roles and Filter Sets may overlay to provide a feature/data matrix of capabilities for the employee. By setting up appropriate Filter Sets, an administrator can provide multiple roles with access to the same record but can customize what users can see or do in those records.

Two filter sets are predefined for new accounts:

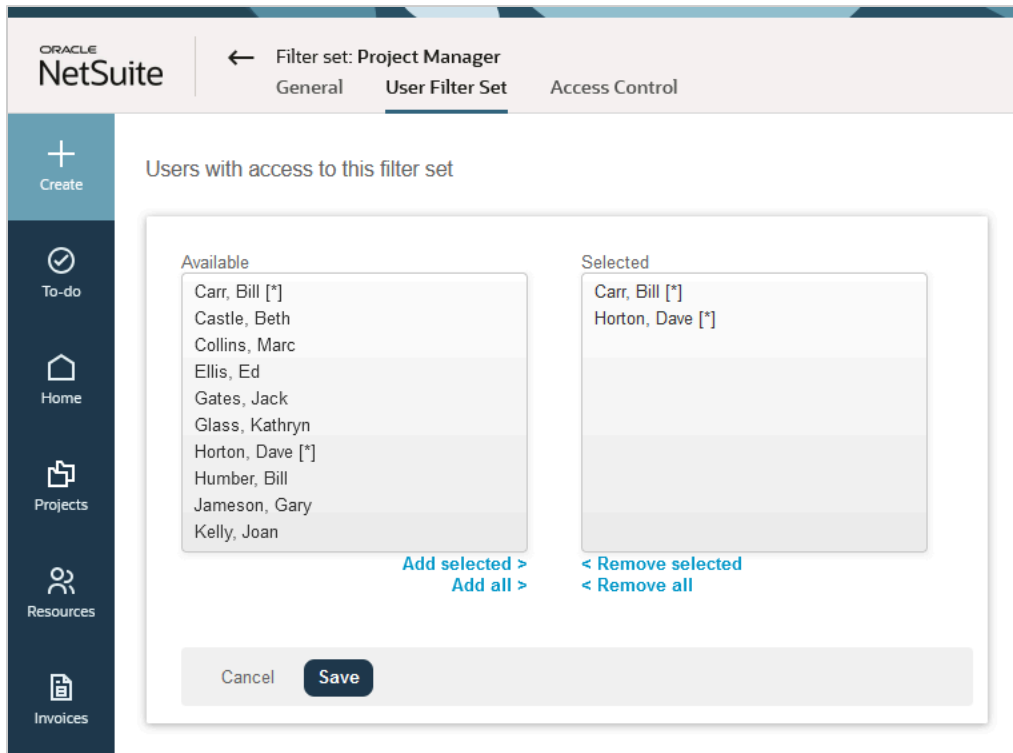
- All access — allows access to all data in your company's SuiteProjects Pro account
- Booked/Assigned — the default configuration of this filter set limits Employees access to the authenticated user only, and limits Project access to either Projects that are owned by the user or Projects that the user has been booked or assigned to.

### To create filter sets:

1. Go to Administration > Global Settings > Users > Filter Sets.
2. Click the Create button and select **New Filter set**. The New Filter Set form appears.
3. Enter the filter set name, Notes and check the Make this the default filter set for new and imported employees (if applicable).
4. Click Save.
5. After the filter set has been created and saved, additional options become available on the form, including the following links:
  - **General** — the Name and Notes about the filter set.
  - **Employee filter set** — identifies who has this filter set assigned to them in the filter set link of the employee record. See [Employee Filter Set](#).
  - **Access Control**— identifies what types of data employees with this filter set can view. See [Filter Set Access Control](#).

## Employee Filter Set

After the filter set has been created, you can choose which employees will have this filter set available to be added to their employee record. It is added to the Filter sets link within the employee record. Employees with an asterisk (\*) after their name cannot be removed from the assignment as this is their primary and only filter set. Employees must have at least one filter set assigned to their employee record. Employees with more than one filter set can switch filter sets to view different types of data.



## Filter Set Access Control

Access Control defines the level of access that is granted to the assigned employees. Access Control can be set for the following entities: Customers, Projects, Project stages, Services, Employees, Expense Items, Charge stages, and Booking types. The filter sets provide the access relationship of those entities to a specific employee through discrete selections or with a meta value relationship description. For example, employees may have access to Project XYZ or to all projects they directly own.

### To view or modify the Access Control for a filter set:

1. Go to Administration > Global Settings > Users > Filter Sets.



2. Click a Filter set name to display the Filter set form.
3. Click the **Access Control** link.
4. To modify Access Control, click the Access control type you would like to modify for this filter set.
5. Include or exclude items by adding or removing the items from the Available or Selected areas, respectively.
6. Click **Save**.

## Customer/Project/Project Stages

Filter sets can limit the view of customers, projects and project stages. For example, you could set a project manager filter set to be able to access only owned projects, booked projects, or assigned projects as well as only projects in a certain project stage.

## Expense Items/Booking Types/Charge Stages

Filter Sets can limit the view of Expense Items, Booking Types and Charge Stages. For example, you could prevent an employee from accessing the Miscellaneous Expenses item or the Overage charge stage by modifying the filter sets.

## Employees/Services/Time Types

Filter sets can limit the view of employees, services, and time types. For example, you could set an employee filter set to be able to access only their own timesheets or choose only internal time types on their timesheet.

## Filter Sets Options at the Employee Level

## Switching Filter Sets

If an employee has been assigned more than one filter set, the employee can select which filter set is currently active by using either of the following paths, depending on their Employee setup configuration.

### To select a filter set as active:


1. Go to User Menu > Change filter set to display the list of available filter sets. Click **Choose** on one of the rows to set that filter set as your active filter set for the current session.
2. Go to Employees and select the Employee ID. On the Employee Demographic form, scroll down the Primary filter set field and select the desired value.

 **Note:** This is only available if the Employee has been assigned more than one filter set.

## Primary Filter Sets Application Overrides

### To assign multiple filter sets at the Employee level:

1. Go to Employees and select the Employee ID. On the Employee Demographic form, scroll down the Filter set module overrides. Use the create or edit link to add or remove filter sets for the employee record.

 **Note:** If you are using the Filter set module overrides, changing the primary/active filter set does not impact the application overrides, unless the override setting is Active filter set.

## Frequently Asked Questions (FAQs)

### Why would an employee have more than one filter set assigned to them?

There may be instances where an employee is playing two or more role in the company. For example, a manager may be primarily responsible for the Eastern Region. But due to a vacancy in the company, they may also need to take over the responsibility for the Central Region. Using filter sets would allow the manager to view each of the regions individually. Remember that filter sets determine what data the employee has access to in your company's SuiteProjects Pro account.

Administrators and users with a "All Access" filter set can experience slow performance in accounts with large amounts of data, especially when loading lists. Assigning multiple filter sets allows these users to change the active filter set to view only the data they need. Lists will load quicker if the filter set combination returns significantly less data than the "All Access" option.

### Can I delete a filter set?

You cannot delete a filter set if there are employees assigned to it. To delete a filter set, you must remove all assigned employees first. You can run a detail report for the filter set which can show what employees are assigned to it. You can delete the filter set when no employees are assigned to it.

When considering the Access Control in filter sets, you should consider using the meta value relationships as much as possible. The values provided in employee and project access are the discrete lists of all the employees and projects in your company's SuiteProjects Pro account, which can be cumbersome to manage.

For example, employee access for managers would typically need to see their direct reports. If you assign the meta value **[Access to Managed Employees]**, it automatically lets the employee see all direct reports who have that employee as their manager in your company's SuiteProjects Pro account.

## Roles Overview

Roles define what an employee can do in your company's SuiteProjects Pro account. The role setup designates what rights and privileges are available to employees with a specific role. This includes what applications the employee can access as well as whether they can view, modify, or create various records. For example, you may create a Project Manager role which lets project managers modify projects but does not allow them to change the project stage.

Employees are assigned the default role when created. An employee must have a role assigned to them and can be assigned to only one role. You can change the employee's role at any time in the Employee Demographic form.

You can create or edit and grant or revoke rights and privileges for general and application-based entities and items. There are separate sections for General Settings, My Account, Workspaces, Opportunities, Resources, Projects, Timesheets, Expenses, Purchases, Invoices, Integration, Proxy restrictions, and Scripting. See [Role Permissions](#).

You can also create Guest roles to give customers a restricted access to SuiteProjects Pro and enable to view only relevant project information. See [Guest Roles and Guests](#)

## Predefined Roles

There are two predefined Roles within the application:

- **Administrator role** — cannot be modified. The Administrator's primary SuiteProjects Pro usage is maintaining your account configuration, adjusting for company needs, data audits, report creation, release management, process enforcement, and general administration.
- **Employee role** — can be modified as needed. Typically, the Employee role has few rights and privileges.

## Typical Custom Roles

Here are some examples of typical roles that you may want to create:

**Employee (default)** — Primary SuiteProjects Pro usage is time and expense entry. There is no edit or create capability on any other object.

**Project manager** — Primary SuiteProjects Pro usage is budget and schedule management of projects. This may include project creation, financial review (no create-edit access to financial data), and resource management permissions (submit booking requests, create bookings, etc.).

**Finance** — Primary SuiteProjects Pro usage is invoicing and billing-revenue financial management of projects. It also may include project setup and customer setup.

**Human Resources** — Primary SuiteProjects Pro usage is employee maintenance as well as vacation and sick time (HR benefits) reporting. Typically, employees with this role can also create and edit employees as well as view all timesheets and expense reports.

**Project Administrator** — Primary SuiteProjects Pro usage is project setup, including billing and recognition rules, and customer creation. This role does not usually have invoicing capability or the ability to create or edit financial information regarding billing and revenue.

**Resource Manager** — Primary SuiteProjects Pro usage is for resource bookings and the management of resource schedules. This may also include project and task assignments within the Projects application.

**Super User** — Primary SuiteProjects Pro usage is managing localized account configuration items such as invoice layouts, employee maintenance, and company calendars. This role has limited impact to global account configuration changes, although shares some account administration responsibilities.

### To create a new role:

1. Go to Administration > Global Settings > Users > Roles.
2. Click the **Create Button** and select **New Role**. The New Role form appears.
3. Enter the Role name.
4. Check the **Make this the default role for new and imported employees** box to assign this role to all new and imported employees by default.
5. Check the boxes for all permissions you want to grant employees with this role. The role form contains sections covering the permissions for the different functional areas and applications in SuiteProjects Pro. See [Role Permissions](#).

### To edit an existing role:

1. Go to Administration > Global Settings > Users > Roles.
2. Click the role you want to edit. The Edit Role form appears.
3. Check the **Make this the default role for new and imported employees** box to assign this role to all new and imported employees by default.
4. Check the boxes for all permissions you want to grant employees with this role. The role form contains sections covering the permissions for the different functional areas and applications in SuiteProjects Pro. See [Role Permissions](#).


### To assign a role to an employee:

1. Go to Administration > Global Settings > Users > Employees.
2. Click on the Employee ID for the employee whose role you want to change. The Employee Demographic form opens.

3. Click on the **Role** dropdown at the top of the form, next to the Employee ID, and select the employee's role.
4. Click **Save**.



**Tip:** You can use the bulk employee change wizard to copy the Role to other user records in your company's SuiteProjects Pro account.

## Role Permissions

The role form contains sections covering the permissions for the functional areas and applications in SuiteProjects Pro.

### Roles – General Settings

The General Settings section lets you specify general role permissions. For example: View Customers, View and modify Customers, and View and Modify Customers (except name). In this example, by selecting View and Modify Customers, View Customers is included and does NOT need to be checked. You can select the check boxes to turn options **on** or **off** based on the role requirements.

Most of the following options include either simply View or View and modify: Customers, Customer locations, Prospects, Contacts, Projects, Employees, Generic employees, Departments, Attribute sets, Roles, Services, Service 1 lines, Payroll types, Expense items, Vehicles, Approval processes, Vendors, Employee costs, Loaded costs, Generic employee costs, Employee job codes, Generic resource job codes, Filter sets, Custom time ranges, Account-wide reports, Employee login detail report, Auto-billing rules, Hierarchies, Tax locations, Job codes, Rate cards, Cost centers, External IDs, Snap shots, Calendars for others, Audit trails, Internal IDs, Dashboard graphs, Email templates, Calculated fields, Built in summary fields, Tag groups, Target utilization, Download lists, Download reports.

Also within the General Settings section are the following role options:

- **View and modify existing employees** — lets employees with this role view and update existing employees. This is useful for roles that may need to modify employees but who should not have the ability to create new employees.
- **See billing rates and budget amounts** — This is useful for project managers or others so that they are aware of project financial information.
- **Customize forms and Customize lists** — Customize forms option permits employees to modify certain forms within the application such as Receipts or the Timesheet. You, as the account administrator, are generally the employee who customizes forms, although some companies also use a super employee account. Customize lists permits employees to change the order and selection of fields in the list (for example, Projects or Employees).
- **Restrict data viewed on reports** — Share saved reports with other employees, Specify report usage designations, and Specify report filter sets.
- **Download lists and reports into Microsoft Excel or PDF files** — Download lists and Download reports.
- **Employee Unlock** — Allow employees to unlock the account of other employees who have failed the security requirements set for your company's SuiteProjects Pro account. Many companies restrict this option to you, the account administrator, and to a backup employee for times when you are unavailable.

- **View and modify all list views** — Enables users to access and manage all list layouts in an account from the Administration module or from within lists. This role permission is available only if the Custom List Layouts feature is enabled for your account. To enable this feature contact SuiteProjects Pro Support.
- **Change owner on list views** — Enables users to change the owner for list layouts they have access to. This role permission is available only if the Custom List Layouts feature is enabled for your account. To enable this feature contact SuiteProjects Pro Support.

## Roles – My Account

Options in the My Account section relate to Administration > Global Settings. You can select the check boxes to turn options **on** or **off** based on the role requirements. You should not grant most of these options to roles other than the account administrator role.

The View and Modify options include: Dashboard, Company demographics, Company schedules, Company logos, Company settings, Terminology, Custom fields, Currency rates, Base currencies, My charges, Automated back-up service, Company status on dashboard, and Employee status on dashboard.

Also within the My Account section are the following role options:

- **Exchange information** — Import Customers from outside sources as well as Export data to other applications including Microsoft Excel.
- **Use of the following wizards** — Bulk employee change wizard, Expense report attachment wizard, American Express receipt import wizard, and Bulk task change wizard. The wizards allow you to make bulk changes to certain aspects of related records. For example, if you were going to change the department across a large set of employees, you would use the Bulk employee change wizard.
- **Administration** — Perform company maintenance functions and Create own proxies.

## Roles – Expenses

Options in the Expenses section relate to the Expenses application. You can select the check boxes to turn options **on** or **off** based on the role requirements. Most of the following options include either simply View or View and modify: Expense report alerts, Payment types, Expense reports, expense report layout, expense grid, reports, authorizations, and expense report reimbursements.

Also within the Expenses section are the following role options:

- **Create charges from approved expense reports** — This option permits charges to be created after an expense report has been approved. You must have enabled the following internal switch: Automatically bill expense items assigned to a customer when an Expense report is approved. To enable this internal switch, [Creating a Support Case](#).
- **Book approved authorizations** — This option permits employees to book (that is, create a financial transaction) for the item when the authorization is approved.
- **Allow employee to delete (individually or in bulk) open, submitted or rejected envelopes** — This option permits employees to delete any open, submitted or rejected expense reports either individually or in bulk. This features requires the following internal switch to be enabled: Administrators can delete employees envelope. To enable this internal switch, [Creating a Support Case](#).


## Roles – Timesheets

Options in the Timesheets section relate to the Timesheet application. You can select the check boxes to turn options **on** or **off** based on the role requirements. Most of the following options include either simply

View or View and modify: Time types, Timesheet alerts, Ceridian payroll integration, Approved timesheets, Archived timesheets, Time off requests, Timebills from approved timesheets, Timesheet layout and rules, Reports, Adjust approved timesheets, Leave accrual transactions, Accrual rules, Run leave accrual, and View the time entry tab.

Also within the Timesheets section are the following role options:

- **Create charges from approved timesheets** — This option permits charges to be created after a timesheet has been approved. You must have enabled the following internal switch: Automatically bill time assigned to a customer when a timesheet is approved. To enable this internal switch, [Creating a Support Case](#).

 **Note:** Most customers use Billing Rules to generate charges. If you use Billing Rules, this role permission is not applicable.

- **Run leave accrual** — This option permits employees to run the leave accrual and update leave balances. You should restrict access to this option to account administrators and run leave accrual at a specified day and time.
- **Allow employee to delete (individually or in bulk) open, submitted or rejected timesheets** — This option permits employees to delete any open, submitted or rejected timesheets either individually or in bulk. This features requires the following internal switch to be enabled: Administrators can delete employees timesheets. To enable this internal switch, [Creating a Support Case](#).

## Roles – Projects

Options in the Projects section relate to the Projects application. You can select the check boxes to turn options **on** or **off** based on the role requirements. Most of the following options include either simply View or View and modify: Dashboards, Project locations, Tasks and Phases, Task types, Gantt chart layout, Reports, Project analysis, Project overview, Recognition rules, Transfers, Task cost and Billing projections, Project stages, Assignment groups, Project pricing, Baselines, Booking grid, Project alerts, Issues, Issue statuses, Issue severities, Issue sources, Issue stages, Budgets, and Unlock projects (locked by SuiteProjects Pro Project Connector).

Also within the Projects section are the following role options:

- Hide the profitability section in the project overview.
- Create and modify project billing rules and Run project billing. You should restrict access to these options to roles of employees who control the financial aspects of projects.
- Change the project stage of a project. This option can be useful when the employee who manages a project is not the one to change the stage of the project.
- Enable the advanced booking worksheet functionality.

## Roles – Workspaces

The options in the Workspace section relate to the Workspace application. You can select the check boxes to turn options **on** or **off** based on the role requirements. The options include: create, view, and modify workspaces, view account storage usage, view and modify document categories; copy, move and download documents; view reports; and view and modify workspace alerts.

## Roles – Invoices

Options in the Invoices section relate to the Invoices application. You can select the check boxes to turn options **on** or **off** based on the role requirements. Most of the following options include either simply

View or View and modify: Charges, Invoices, Invoice payments, Invoice layouts, Reports, Charge stages, Agreements, and Customer POs, and Change the customer PO of a charge.

Also within the Invoices section are the following role options:

- **Change the charge stage of a charge** — This option permits employees to change the charge stage of a previously created charge (timebill). You should restrict this option to those personnel with billing responsibilities.
- **Change the agreement of a charge and Change the customer PO of a charge** — This option permits employees to adjust the agreement or customer PO on a charge. You should restrict this option to those personnel with billing responsibilities.

## Roles – Resources

Options in the Resources section relate to the Resources application. You can select the check boxes to turn options **on** or **off** based on the role requirements. Most of the following options include either simply View or View and modify: Skills, Booking types, Industries, Job roles, Locations, Education, Custom profiles (1-35), Profiles, Bookings, Booking grid, Booking requests, Deal booking requests, Customer engagement history, Reports, Resource options, Optional resource detail in Custom search and quick search, and Resource alerts.

Also within the Resources section are the following role options:

- **Enable profile worksheet** — This option permits employees to modify a profile. When enabled, a **Worksheet** link displays in the Resources application for any resource that the employee has access to through their Filter Sets.
- **Create bookings** and **Customize the form used to create multiple bookings** — These options allow employees to schedule a resource on a project. You should restrict this option to those in a resource or project management function within your company to avoid resource scheduling conflicts. SuiteProjects Pro lets you book multiple resources at the same time as well as customize this form to meet your needs.
- **Create booking requests** and **Create deal booking requests** — These options allow employees to request resource bookings for projects or on deals in the Opportunities application is available.
- **Customize the Custom Search form** — This option permits employees to customize the Custom Search form to include or exclude skills, education, custom profiles in the custom search. See [Search - Resources Application](#) and [Custom Search](#).

## Roles – Purchases

Options in the Purchases section relate to the Purchases application. You can select the check boxes to turn options **on** or **off** based on the role requirements. Most of the following options include either simply View or View and modify: Manufacturers, Purchasers, Carriers, Accounts payable locations, Receiving locations, Products, Shipping terms, Payment terms, Purchase requests, POs, Quick PO items, Fulfillments, PO layout, Reports, Reduce purchase item quantity payable, and F.O.B. locations.

Also within the Purchases section are the following role options:

- **Create POs** — This option permits employees to create purchase orders directly without having to submit a purchase order request.
- **Create and modify non-PO purchase items** — This option permits an employee to create or modify purchase items that have not been previously identified as products on purchase orders.
- **Create fulfillments** — This option permits employees to record fulfillments against purchase orders.



- **Can reduce purchase item quantity payable** — This option permits employees to adjust the quantity to be paid on a PO.

## Roles – Opportunities

Options in the Opportunities section relate to the Opportunities application. You can select the check boxes to turn options **on** or **off** based on the role requirements. Most of the following options include either simply View or View and modify: Create, view, and modify Deals; Estimates; Proposals; To Dos; Events; Territories; Employee locations; Business types; Customer sources; Customer sizes; Templates; Proposal layout; Reports; and Deal stages.

Also within the Opportunities section are the following role options:

- **Assignments** — Assign to dos to all employees, Assign events to all employees, and Assign deals to all employees
- **Create charges from accepted proposals** — This option permits employees to convert charges to time entries when a customer or prospect has accepted the proposal. If this is a Prospect, the prospect must be converted to a customer for the charges to be billable.
- Change the deal stage of a deal

## Roles – Proxy Restrictions

Options in the Proxy Restrictions relate to proxy permissions. You can select the check boxes to turn options **on** or **off** based on the role requirements. Proxy permissions allow an employee to proxy or, in other words, log-in as another employee and perform actions as that employee. SuiteProjects Pro can distinguish between a direct sign-in and a sign-in done by proxy. In addition, SuiteProjects Pro can distinguish the actions performed directly within a particular account and one done by a proxy.

Proxy restrictions under the **Roles settings** restrict what a proxied-in employee can do. Examples of proxy restrictions include: A proxy employee cannot approve timesheets, A proxy employee cannot approve their own timesheets, A proxy employee cannot approve booking requests, or A proxy employee cannot approve invoices.

## Roles - Integration

Options in the Integration section relate to the QuickBooks integration functionality in the SuiteProjects Pro Integration Manager, which is no longer supported.



**Important:** As announced in the October 8, 2022 SuiteProjects Pro Release Notes and through Proactive Feature Change Notification (PFCN), support for the QuickBooks integration functionality in SuiteProjects Pro Integration Manager ended with the SuiteProjects Pro 2023.1 Release on April 15, 2023. Previous versions of SuiteProjects Pro Integration Manager, including any shortcuts created using Integration Manager 6.6 or earlier version, can no longer be used to exchange information between SuiteProjects Pro and QuickBooks.

There are a variety of integrations with SuiteProjects Pro. Employees can download some of them from the SuiteProjects Pro UI under Add-on services. As an account administrator, you provide an employee with Exchange Access. See [Employee Access Control Settings](#).

Other integrations are enabled through an internal switch. You may need to discuss integration availability with your SuiteProjects Pro account manager or SuiteProjects Pro Professional Services. As an account administrator, when an integration is enabled, you generally provide employees access to it. You may want to speak with SuiteProjects Pro Professional Services to understand other integration options and how to implement them in your company's account. See [Account](#).

## Guest Roles and Guests

You can provide guest access to your customers if you want to share some project information with them such as project Gantt charts, project outlines, or invoices, for example. Guests are customers who are able to sign in to SuiteProjects Pro and view the application data that is associated with them.

Guests are stored as employees [users] in the SuiteProjects Pro database. The Demographic form for guests is similar to the Demographic form for employees — many of the fields and settings are the same. However, guests must be assigned a guest role. You will need to create a guest role before you can add a guest user. You must also select the appropriate Customer in the **Employee is this Customer** dropdown when adding a guest user.


Guest role settings include the following: Guest can view Project Gantt charts, Guest can view Project outlines, Guest can view task details in Gantt/outline views, Guest can view Invoices, Guest can view Workspaces, and Guest can customize lists.

### To create a guest role:

1. Go to Administration > Global Settings > Users > Guest Roles.
2. Click the **Create Button** and select **New Guest role**. The New Guest Role form appears.
3. Enter the **Role** name. Check the boxes for all permissions you want to grant guest users with this role.
4. Enter any **Notes**, if desired.
5. Click **Save**.

### To add a guest user:

1. Go to Administration > Global Settings > Users > Guests.
2. Click the **Create Button** and select **New Guest**. The New Guest form appears.
3. Enter the Employee ID. Select a role and a customer from the **Role** and **Employee is this Customer** dropdowns, respectively.
4. Enter and confirm a password for the user. Check the **Force a password change** box to ensure the guest user changes password when signing in to SuiteProjects Pro for the first time.
5. Click **Save**.
6. Go to the **Filter sets** tab.
7. Select any applicable filter sets.
8. Click **Save**.

 **Note:** You need to create at least one guest role before you can add a guest user. You will not be able to save the New Guest form if you are not able to assign a role to the user.

## Employee Locations

Employee locations allow you to store location attributes at the employee entity level. These attributes can then be reported on. Sample employee locations could be by state, by city, by country, or any customized list of values.

## To create Employee locations:

1. Go to Administration > Global Settings > Users > Employee Locations.
2. Select **New Employee location** from the **Create Button**.
3. Enter the **Name** of the employee location along with any **Notes**, if applicable.
4. Check the **Active employee location** box.
5. Click **Save**.

## Employees Overview

A user is an individual who has access to your company's SuiteProjects Pro account.

- Generally, most users are employees, but third party consultants, partners, and customers can also be users.

**Note:** You can also create guest records for your customers with access limited to this company's projects, invoices, or workspaces. Guest records are a special kind of employee records. See [Guest Roles and Guests](#).

- Users need to be set up in SuiteProjects Pro through the creation of employee records. For users to have access to SuiteProjects Pro, their records must include a user ID, and a password, and the user must be marked as active.
- Users can be granted access to specific modules within the SuiteProjects Pro user interface as well as specific add-on services.
- Users can be granted access to specific functionality and data in SuiteProjects Pro.

To view the list of employees, go to Administration > Global Settings > Users > Employees.

To view an employee record, go to Administration > Global Settings > Users > Employees > [Select an employee].

To add an employee, click the Create button, then click **New Employee**.

The New Employee form contains several sections including employee demographic information and user settings. After you save the New employee form, the following employee information and settings tabs become available.


- The Demographic tab lets you enter demographic information for employees and set permissions and options at the user level. See [Demographic](#).

- The Demographic, AccessControl, Filter Sets, and Proxy tabs let you control what functionality the employee has access to. See [Employee Access Control Settings](#).
- The Schedule, Leave Accrual, Loaded Cost, Employee, Entity Tag, and Target Utilization tabs let you set information that supports SuiteProjects Pro functionality. See [Employee Time, Cost and Category Settings](#).

## Demographic


The Employee Demographic form holds much information about employees. After a new employee is set up and you return to this form, it is titled Edit employee demographic information.

When setting up an employee, the first item that is presented after selecting the create option is the Demographic form. A lot of information is recorded on this form although most of this information is not required by default.


 **Note:** Form permissions are available on this form, so any field may be made to be required, read-only, or hidden if desired. See [Form Permissions](#).

The first part of the demographic form requests general information about the employee per your organization:

- **Employee ID** — Must be unique and is used by the employee to sign in to SuiteProjects Pro. Many clients use the first part of the company email address as the sign-in userid.
- **Role** — Provides permissions within SuiteProjects Pro (the Role must be defined prior to setting on employee record).
- **Active employee** — This checkbox controls the activation of the employee account. If the box is unchecked, the employee does not appear in the drop-down lists populated with employee names and is unable to sign in to SuiteProjects Pro.
- **Name elements** — First and Last name are required. Middle and title are optional. The first and last name entered are displayed in all employee drop-down lists in 'last name, first name' order.
- **Address information** — Optional. Address information entered may be displayed on expense reports.
- **Email address** — Required. SuiteProjects Pro communicates to users by email with alerts, reminders, and informational messages.
- **Password** — Required. When setting up a new employee, you should leave the hint area blank.

 **Note:** The employee can be set to change the password upon initial sign-in. This is helpful during the set up of new employees.

- **Manager** — For the manager to be available in the drop-down list, an employee record must first be created for this manager. The manager is frequently involved in item approvals such as timesheets and expense reports.

 **Note:** The manager must be defined as an active employee to set this field. The drop-down is populated based on active employees.

- **Cost center** — Must be defined prior to setting on the employee record. See [Cost Centers](#).
- **Job code** — Must be defined prior to setting on the employee record. See [Job Codes](#).
- **Department** — Must be set up prior to setting on the employee record. See [Departments](#).

## Employees Demographics – Approver

A series of Approvals display for the approval process, depending on which items have been activated. See [Approval Options](#). Approvals may be set to dynamic values, specific individuals, or a defined approval process.

- Dynamic values include [Self approver], [Manager], [Manager's manager], [Account owner], and [Project owner]. Each dynamic value is substituted with the corresponding employee when an item goes through the approval process.

**Note:** Account owner and Project owner may not resolve themselves to a specific named resource and may cause auto-approvals, which are not desired. These two settings are more appropriate for Project approval setups. If project level approvals are enabled for the account, SuiteProjects Pro always checks the project level for approval, AND then references the employee record setting of approval.

- The second type of approval setting is a named resource. Select the resource from the drop-down list, which contains all active employees.

**Note:** This may involve more administration to keep the relevant approvers current. If a named employee is desired, an approval process containing the single employee is recommended for a single location in case the named employee changes positions within the company or leaves the company.

- The last type of approval setting is an Approval process. The approval process object permits the definition of one or more employees. It also controls the routing of an item's approval for concurrent review/approval, auto-approval based on a defined limits. Approval processes allow for maintenance of approval routing changes by capturing the routing in one place that is referenced among many employees and projects. When a change is made, the next time an item goes through the approval process, it will follow the new routing definition. Approval Processes must exist prior to being selected on the employee record. See [Approval Options](#) and the approval processes associated with the Timesheets, Expenses, Invoices, Purchases, and Resources applications.

**Note:** Check the **Save as the default approvers** box to use the approvers defined in this employee record as the default for new employee record that you create. You should use form permissions to allow only account administrators to check this box. Avoid having defaults reset by other roles.

## Employee Demographics – Custom Fields

You may create any number and type of custom fields to appear on the Employee Demographic form. The entry of this information is dictated based upon your company's configuration and may also be controlled through the form permissions of the Employee Demographic form. See [Custom Fields](#).

## Employee Demographics – Filters Hierarchy

There are two places on the Employee Demographic form that reference Filter Sets: Primary filter sets, with optional application overrides if you have this feature activated, and the Filter set field at the bottom of the form.

**Note:** The difference between the settings is that one is used for granting a data view to the employee and the other is used to group the employee into the correct data view. These values may be the same or different depending on your filter set structure.

**Primary Filter Set** — defines what the employee can see in SuiteProjects Pro. There is an optional application overrides feature, activated by SuiteProjects Pro Support upon request, that lets you restrict

data views based on which application the employee is in. The optional override is useful for controlling items such as projects available for timesheet entry and resource booking reviews, while allowing a general view in other applications.

**Filter set** — The Filter set value normally found at the bottom of the form is what you use to place an employee into a data view. Depending on your account configuration, the filter set may need to be a required field to ensure correct placement of employees into data views. The Filter set and the Primary Filter Set values may not match as the employee may be allowed to see a restricted data view but need to be defined to a larger data view.

Examples of Primary vs. Filter set settings are:

- Data views are set up geographically for regional data views. The employee's Primary Filter Set is restricted to a Self view while the Filter set setting is the region with which the employee is associated such as USA. This same example applies to department viewing if you want a unique department view, functional organization viewing, and so forth.
- One or more employee Hierarchies may also be defined to organize the employees for reporting purposes. The Hierarchies must exist prior to being selected on the employee record. The hierarchy's primary purpose is to allow roll-up reporting according to a specific structure. See [Hierarchy](#).
- There is also the ability to limit Project level access to employee. If you have created Project hierarchies in your account and have the project level access feature activated, you are able to limit an employee's view by setting a project level access based on the defined project hierarchy. By selecting the project hierarchy and the specific node within that hierarchy, the employee's filter set has the ability to include projects in their data view within those defined hierarchy nodes. Contact SuiteProjects Pro Support if you would like to have the project level access by hierarchy feature activated.

## Frequently Asked Questions (FAQs)

[What are the differences between an employee's Primary filter set and the Filter set \(shown at the bottom of the form\) in the Employee Demographic form?](#)

The Primary filter set is the data view access this employee has in SuiteProjects Pro. Adding the employee to a Filter Set at the bottom of the employee form adds them to the view of other employees with that Filter Set as their Primary, and causes the employee name to display in the Access > Employee Access section of that Filter Set.

## Attachments

When you create an employee record, you can add attachments to the employee record, provided the attachments functionality has been enabled in your account. Attachments can include a wide variety of documents such as the following: employment forms, client recommendations, and emails.

### To add or edit attachments:

1. Select the Browse button to add a new attachment.
2. Click on the Manage current attachment link to download, replace, or delete an existing attachment.

## Employee Access Control Settings

All users must be assigned one and only one role and at least one filter set. You can also set rights and privileges for users on an individual basis when creating or editing user records for your company's employees, subcontractors or guests.

This section gives an overview of the available settings relevant to configuring access control. Go to Administration > Global Settings > Users > Employees > [select an Employee] to review the available settings. For example:

- **User Access Removal** — Only employees marked as active employees have access to SuiteProjects Pro. See [User Access Removal](#).
- **Application Options** — Options in the **Demographic** tab control certain user privileges for the different SuiteProjects Pro applications. See [Application Options Overview](#).
- **Application Access** — The **Access Control** tab can be used to control user access to specific applications. See [Access Control Overview](#).
- **Filter Hierarchy** — The **Primary Filter Set** and **Filter set** fields on the Demographic form as well as the **Filter sets** tab define what the user can see in SuiteProjects Pro. See [Filters Hierarchy Overview](#).
- **User Proxy** — User proxy enables an authorized employee to use SuiteProjects Pro as another employee with no knowledge of that other employee's password. See [User Proxy Overview](#).

## User Access Removal

Only employees marked as active employees have access to SuiteProjects Pro. To remove access to SuiteProjects Pro for a particular user, either temporarily or indefinitely, clear the Active employee box on the Demographic form for this employee.

## Application Options Overview

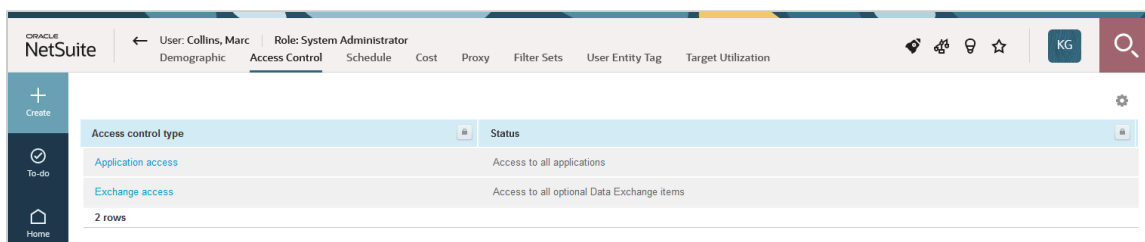
Certain user privileges can be granted or revoked from the Employee Demographic form. Scroll through the Employee Demographic form to review the options available.

In particular, you may enable users to un-approve or un-export items within SuiteProjects Pro such as timesheets, expense reports, invoices, booking requests, project recognition transactions, and proposals. If the item follows the approval process functionality, an additional setting in the Demographic form lets you grant un-approve as well as un-export permission to an employee for the item. These permissions are controlled at the employee level only on the Employee Demographic form. They cannot be granted to a role.

**Note:** These settings control approval and data export capabilities. They are sensitive and are used to support integration in many cases.

## Access Control Overview

Access Control settings are available in the employee record for existing employees. When adding a new employee, the access control tab becomes available after the Employee Demographic form has been saved.



There are two main access control settings:

- **Application access** lets you control which modules (applications) are available to the employee from the main navigation menu.

You should grant access to application on a needs basis. For example, if an employee does not have responsibility for invoicing or permissions to view invoicing data, remove Invoices from their application access. This helps minimize confusion for users.

Application access determines which type of user license is taken up by the employee. An employee with any combination of Account, Timesheets and Expenses application access takes up a Timesheets and Expenses (T&E) only license. An employee with any other application access takes up a Full user license. For more information, see [Licenses](#).

Granting application access does not automatically grant feature permission. This is controlled by the role assigned to the employee. See [Role Permissions](#).

Check the **Default set of applications for new employees** to grant the same application access for the new employee records you create.

**Note:** Default application access typically includes Account and Timesheets. You should not grant application access other than Account, Timesheets and Expenses to avoid taking up Full user licenses unnecessarily.

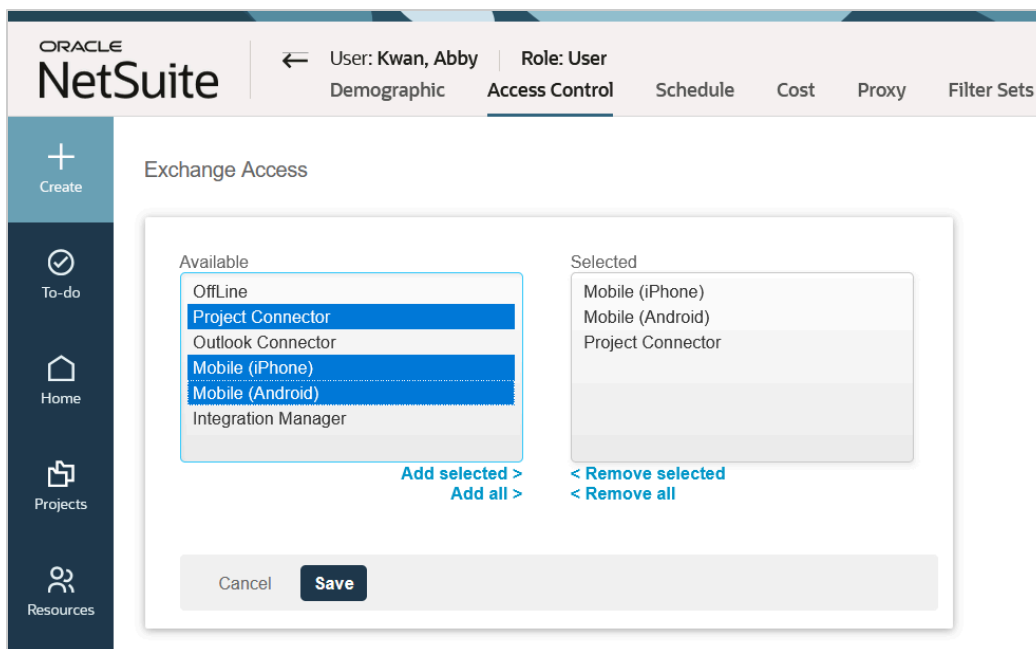
**Tip:** The All Item Types in Calendar optional feature lets employees see their task assignments and bookings in the calendar even if they do not have access to the Projects and Resources module. See the help topic [All Item Types in Calendar](#).

- **Exchange access** lets you control which Add-on services the employee is allowed to download and use. An employee must have exchange access for the add-on service to be able to work with SuiteProjects Pro data using the application.



**Note:** Removing access to an add-on service application does not eliminate the ability to download the application. The mention “Not approved for download” appears above the download link if the user has not been granted access to that application. All add-on service applications require authentication to connect with SuiteProjects Pro. Authentication fails if the employee does not have the appropriate exchange access.



## Filters Hierarchy Overview

Assigned filter sets determine what data users have access to. All users must be assigned at least one filter set — their primary filter set. Other filter sets can be assigned to the employee. Any filter sets may be used to override the primary filter set for a given application. You can also include an employee into the employee access definition of certain filter sets — users with any of these filter sets assigned would then have access to this particular employee.

**Important:** When assigning filter sets to an employee, you should assign only the filter sets that show the data the employee need to access in the course of their current work. If the employee's responsibilities change over time you should change the filter sets assigned to this employee accordingly.

The following settings are available on the employee record:

- **Filter Sets tab** — Use the **Filter sets** tab to assign multiple filter sets to the employee. To do so:
  1. Go to Administration > Global Settings > Users > Employees > [Select an employee] > Filter Sets.
  2. Select filter sets from the **Available Filter sets** list and click **Add selected**.
  3. Click **Save**.

Users only have one of their assigned filter sets active at a given time and can switch between assigned filter sets to access different types of data.

**Tip:** When the All Access filter set is assigned to an employee, you should assign multiple filter sets and include filter sets that return significantly less data when viewing transaction lists such as a booking list, for example. This enables the employee to change filter set and limit the amount of records on lists to speed up loading times and improve the performance of lists.

**Note:** You can also assign filter sets to employees when creating or editing filter sets. See [Filter Sets Overview](#).

- Primary Filter Set** — All users must be assigned at least one filter set — their primary filter set. This is set to the default filter set when creating or importing users. You can select a primary filter using a dropdown in the top section of the Employee Demographic form. If the primary filter set was not already assigned to the user, it is added to the list of assigned filter sets on the **Filter Sets** tab.

- Filter set modules overrides** — This optional application overrides feature allows you to grant or restrict access to data depending on the SuiteProjects Pro application the employee is using. Contact SuiteProjects Pro Support to enable this feature.

The optional override may be used to control items such as projects available when users fill a timesheet or review resource booking, for example, while allowing a general view in other applications.

When the feature is enabled, an additional setting becomes available on the Employee Demographic form next to **Primary filter set**. Click the **Create** link to define filter set overrides. Any of the available filter sets can be selected for each application. Changing the primary filter set or changing the active filter set does not impact the application overrides, unless the override setting is **[Active filter set]**.

- Filter set** — You can include an employee into the employee access definition of certain filter sets if the filter set restricts employee access. Users with any of these filter sets assigned would then have access to this particular employee. Use the **Filter set** setting, normally found in the Display Options section at the bottom of the Employee Demographic form to ensure the employee is included in the employee access definition of selected filter sets. Depending on your configuration, this setting may need to be a required field.

## Project level access

An optional feature enables to restrict project access according to a defined project hierarchy. With this feature enabled, the **Use to determine filter set access for projects** box becomes available on the Edit hierarchy form. If you check this box, a **Project level access** section becomes available on the Employee Demographic form and you can assign a node in that project hierarchy to the user. You can restrict access to project information relevant to the assigned project hierarchy by creating a filter set

and configuring project access to **[Access to Projects in my hierarchy node]**. Contact SuiteProjects Pro Support and ask for the following feature to be enabled: **Enable ability to define project hierarchy for filter sets**.

For more information about configuring and using hierarchies, see  [Administrator Guide](#) under Global Settings > Company > Hierarchy.

## User Proxy Overview

User proxy enables an authorized employee to use SuiteProjects Pro as another employee with no knowledge of the other employee's password. If users are granted the right to proxy in as other users, they can click **Log in as** from the **User Menu** menu and select an employee from a list of available proxies to sign in on their behalf. A new instance of SuiteProjects Pro opens allowing the employee to perform a function for the proxied employee.

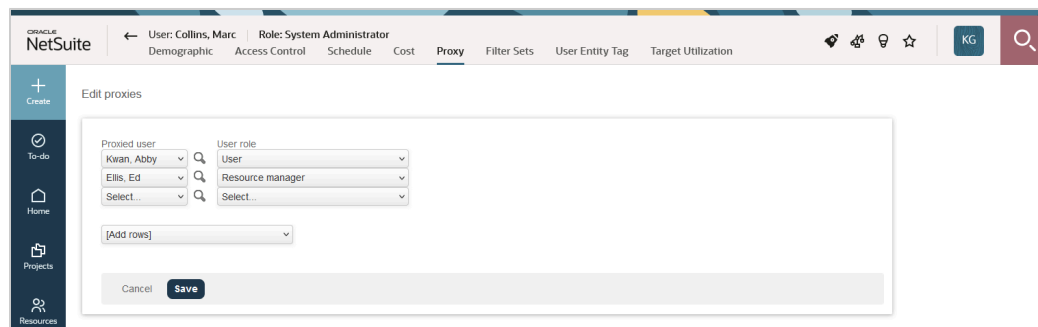
Users with the role permission **Create own proxies** enabled are permitted to designate proxies who will be able to sign in and perform a function on their behalf. **Proxy restrictions** may also be set for the role.

The role permissions a user will have when proxying in as another employee is specified in the proxy configuration.

The user proxy feature is helpful for delegating certain processes when employees are out of the office or do not have access to SuiteProjects Pro. However, it can have security implications. Account administrator should exercise control over users ability to proxy and set expiration dates for user proxies to ensure that proxying rights are granted only when required and to authorized users only.


### To enable an employee to proxy in as another employee:

1. Go to Administration > Global Settings > Users > Employees and click the Employee ID of the employee you want to grant the proxying rights to.
2. Click the **Proxy** tab.
3. Select the **Proxied employee** and **User role**. This will determine the role permissions the user will have when proxying in as the proxied employee. Use the role assigned to the proxied employee on their Demographic form to ensure the proxying user has the same permissions as the proxied employee.
4. Set an **Expiration date** if required by the Proxy Expirations configuration settings. This ensures the proxy expires automatically on the specified date. See [Enabling Proxy Expirations](#).
5. Click **Save**.



Users with the role permission **Create own proxies** enabled are permitted to designate proxies who will be able to sign in and perform a function on their behalf.

If the Proxy Approver Notifications feature is enabled for your company's SuiteProjects Pro account, and if the designated proxy employees can approve transactions on their behalf, proxy approvers receive notification email messages about transactions awaiting the proxied employee's approval. See the help topic [Proxy Approver Notifications](#).

 **Note:** Account administrators cannot create their own proxies for security reasons. It is not possible for any employees to sign in on behalf of an employee with an account administrator role.

### To enable another employee to proxy in as oneself:


1. Go to the **User Menu** menu and click **Proxies**.
2. Select a user who may proxy.
3. Click **Save**.

### Enabling Proxy Expirations

After the proxy expiration is activated you will be able to set expiration date when editing user proxies.

### To enable expiration dates for proxies:

1. Go to Administration > Global Settings > Account > Proxy Expirations.
2. Check the **Proxies have expiration dates** checkbox.
3. Select a **Default proxy expiration** period from the dropdown options.
4. Click **Save**

 **Tip:** You can configure SuiteProjects Pro to send an email notification whenever an item is submitted or approved by a proxy. For example, you can go to Administration > Application Settings > Timesheets and configure SuiteProjects Pro to notify the **[Approver]** whenever a timesheet **Was approved by proxy**.

## Employee Time, Cost and Category Settings


SuiteProjects Pro lets you enter information related to the employee's time and cost on the employee record. An optional feature lets you categorize employees. After you save the employees form, the following tabs are available on the employee record.

### Schedule

The Schedule link displays within the employee record after the Employee Demographic form has been saved. By default each employee has the company work schedule set. You can use the associated work schedule for your employees or you can define a work schedule specific to a particular employee. For more information about company work schedules see [Work Schedules](#).

If work schedule time ranges are enabled, you can define start times for each day of the week. See [Optional Features](#).

 **Note:** You need to enable work schedule time ranges and ensure that employees work schedules include start times to create bookings with start and end times for these employees, see [Frequently Asked Questions \(FAQs\)](#) under the Resources chapter.

For new employees to the company, you should enter a schedule exception for a system start date to the day before work begins to ensure utilization reporting is accurately recorded. When the employee

leaves the company, you should enter a schedule exception for the day after departure to a future date approximately five years into the future to ensure correct utilization reporting.

### To define a work schedule specific to an employee:

1. Go to Administration > Global Settings > Users > Employees > [select an employee] > Schedule.
2. Choose the **Use this employee-specific work schedule** under the Work schedule for <employee's name> section.
3. Check the boxes for each day of the week the employee is available.
4. Enter the **Work hours per day for this employee**.
5. If work schedule time ranges are enabled for your account:
  - a. Under the Daily work hours section, enter either a **Default start time** or a start time for each day of the week the employee is available. The end time is set based on the number of hours for that day.

- b. (Optional) Enter a **Description**.
6. Add any exceptions to <employee's name> work schedule.
7. Click **Save**.

## Frequently Asked Questions (FAQs)

What is the difference between an employee's schedule and the company Work Schedule, set up under Global Settings > Work schedules?

The company Work Schedule is the baseline work schedule for the specific regions/areas within your company. The default work schedule displays in each employee's demographic until it is changed. An employee's schedule, on the other hand, is unique to that particular employee. You can accommodate a variety of situations with this feature. For example, you may have an employee (a part-time employee) that works from 9:00 a.m. - 1:00 p.m. each day or an employee that works 4 days per week (Monday - Thursday) for 10 hours per day.

## Cost

The Cost link displays within the employee record after the Employee Demographic form is saved. Employee cost should be a fully loaded cost, ideally normalized for job code bands and thus obscuring specific salary information. Cost information may be restricted by role and by removing the view form permissions on the role assigned to the employee. There is a "current" cost value and additional rows so that historical costs may be captured for individual employees and is automatically utilized in reporting. Historical costs may be tracked in multiple currencies. This is helpful if resources moved between geographies and were subsequently paid out in different currencies.

You must enable the three levels of costs for your account by contacting SuiteProjects Pro Support. Request that the following internal switches be enabled: Show cost tab or form if employee can view any of the loaded cost levels and Available loaded costs (Support - Check with Sales before enabling). You can control access to view each level of cost by the role settings.

## Leave Accrual

Leave accrual rules establish the framework for employees to accrue and draw down time. Select the leave accrual rules that apply to the employee.

### To add or remove leave accrual rules:

1. Go to Administration > Global settings > Users > Employees > [Select an employee] > Leave accrual.

2. Select the **Leave accrual rule** from the drop-down list.
3. Enter leave accrual rule information such as **Start Date** and **End Date**.
4. Select the leave accrual rule number to **Transfer Balance To** that applies to this rule.

**Note:** You can transfer leave balances from one rule to another rule. This is useful if an employee has multiple leave accrual rules and some have end dates applied. When setting up leave accrual transfers, be sure to consider the timing of leave accrual in the rules.

5. Click **Save**.

You can use the leave accrual summary advanced report to review leave accrual, draw-down and available leave balances by employee and by period, along with other details like department, manager and employee cost center. To run this report, go to Reports > Advanced > Timesheets > Leave accrual summary.

If the leave accrual feature is enabled, you can create leave accrual transactions manually to adjust the leave accrual balance. For more information, see [Leave Accrual Balance and Transactions](#).

## Employee Entity Tag

The Employee entity tag link displays within the employee record after the Employee Demographic form is saved and the employee tag feature is enabled.



Tag groups are defined with specific attribute values. When tag groups have been established, the Employee entity tag may be modified for each employee. See [Tag Groups](#).

The Employee entity tag provides a custom field with historical data tracking ability. The viewing of tag groups and attributes can be controlled by role permissions. This permits the tracking of sensitive information, such as HR data, and can restrict data access by the employee's role. When you have applied a Tag group entity tag to an employee, you can customize the Employees list to display the tag group value.

### To enable the Employee entity tag feature:

1. Go to Administration > Global Settings > Account > Optional features.
2. Check the **Enable employee tag feature** box.
3. Click **Save**.

### Frequently Asked Questions (FAQs)

#### How would I use the Employee Entity Tag?

The Employee entity tag feature lets you specify particular attributes to an employee. Although different from the standard fields on the demographic, these attributes can also be reported on. To use the Employee entity tag, you must have created Tag groups and the Attributes within them. See [Tag Groups](#) for instructions on how to create Tag Groups. Tag group values can be added to the Employees list.

### Target Utilization

The Target utilization link displays within the employee record after the Employee Demographic form is saved and the Target utilization feature is enabled. Target utilization is defined as the utilization expected from an employee for capacity planning purposes. After a target utilization has been set, various values become available for reporting including Target utilization, Base target hours, and others. Target utilization will be available in both utilization reporting as well as capacity reporting. Historical utilization reports may also be created.

### To enable the Target Utilization feature:

1. Go to Administration > Global Settings > Account > Optional features.
2. Check the **Enable target utilization feature** box.
3. Click **Save**.

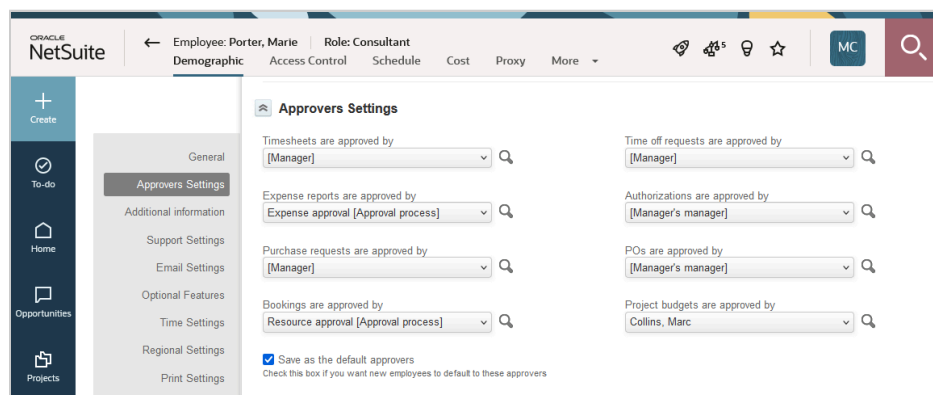

## Approval Routing

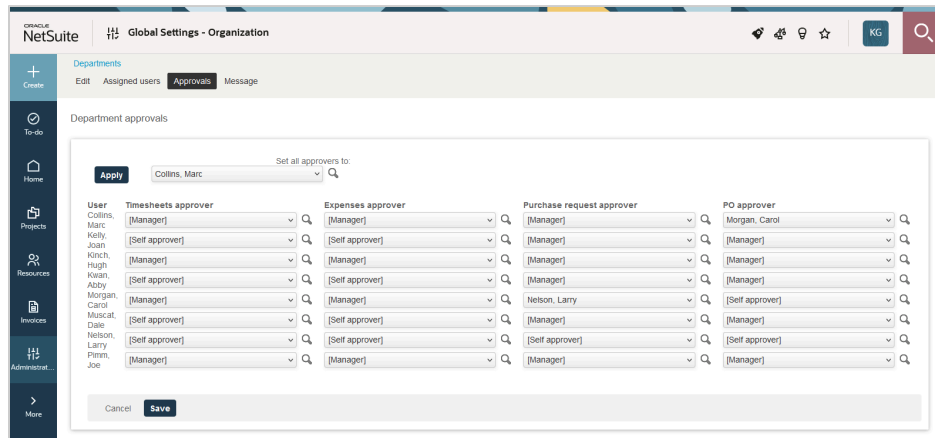
You can configure SuiteProjects Pro to require approval for certain type of transactions before these transactions can be processed. See [Transaction Types Supporting Approvals](#).

You can select who approves transactions depending on the type of transaction at 3 different levels:

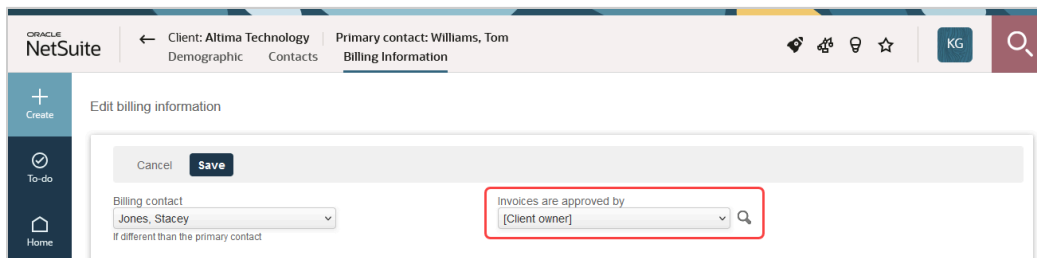
- Employee-level approval routing — You can control who approves transactions submitted by an employee on:
  - The employee record. To do so, go to Administration > Users > Employees > *[Select an employee]* > Demographic and scroll to the Approval settings section.



- The department record. To do so, go to Administration > Organization > Departments > *[Select a department]* > Approvals.



- Customer-level approval routing — If invoices approvals are enabled, you can control who approves invoices for each customer on the customer record. To do so, go to Administration > Global Settings > Customers > [Select a customer] > Billing Information.



- Project-level approval routing — You can control who approves transactions associated with each project on the project record. You can also designate up to three employees (**Project approver 1**, **Project approver 2**, and **Project approver 3**) to approve transactions for the project as part of an approval process. To do so, go to Projects > Projects > [Select a project] > Properties and scroll to the Project approvals section.

For more information about approval processes, see [Approval Processes](#).

**Important:** The project-level approval routing functionality is optional. To enable project-level approval options, go to Administration > Global Settings > Organization > Approval Options. See [Transaction Types Supporting Approvals](#) and [Approval Options](#).

When project level approvals are enabled and set for the project associated with the transaction to be approved, transactions submitted for approval are routed according to both project level and employee level approval settings. Transactions submitted for approval are routed according to the project level approval settings first, and routed according to the employee level settings after the project level approvals are obtained.


For each transaction type, select the appropriate approval routing from the dropdown list. Approval can be routed to:

- A named employee.
- A dynamic value (metavalue) — The approval is routed to an employee determined automatically based on the project or the employee associated with the transaction to be approved.
  - [Self approver] — Transactions are approved automatically when submitted.
  - [Manager] — Approvals are routed to the manager of the employee who owns the transaction to be approved.
  - [Manager's manager] — Approvals are routed to the manager of the manager of the employee who owns the transaction to be approved.

Metavalues at project-level also include:

- [Project owner] — Approvals are routed to the employee who owns the project associated with the transaction to be approved.
- [Customer owner] — Approvals are routed to the employee who owns the customer whose project is associated with the transaction to be approved.
- An approval process — Approval processes let you define multiple levels of approval required before transactions can be processed. For each level of approval, you can set the approver to a named employee or a dynamic value, set an alternative approver to avoid self-approval, and configure automatic escalation to ensure that transactions progress through the approval process. See [Approval Processes](#).

## Approval Processes

Approval processes let you define multiple levels of approval required before transactions can be processed. For each level of approval, you can set the approver to a named employee or a dynamic value, set an alternative approver to avoid self-approval, and configure automatic escalation to ensure that transactions progress through the approval process.

You can create any number of approval processes to meet your business requirements. See [Creating an Approval Process](#).

You can modify an existing approval process only if there are no records or transactions progressing through this approval process. Changes to the approval process will apply to the relevant records or transactions submitted after you modify the approval process. See [Modifying an Approval Process](#).

## Creating an Approval Process

SuiteProjects Pro lets you create multilevel approval processes to meet your business requirements.

### To create an approval process:

1. Go to Administration > Application Settings > [Select an application] > Approval processes.

**Note:** You can access the full list of approval processes defined for your account list from any of the Expenses, Invoices, Opportunities, Purchases, Resources, and Timesheets application settings. The same approval process may be used for different transaction types across different SuiteProjects Pro modules.

2. Click the Create button then **New approval process**.

The approval process entity form appears.

3. Enter a descriptive name for the **Approval process**. Descriptive names are helpful when you manage a large number of approval processes.
4. Define the process using the rows available. You can use the **[Add Rows]** dropdown to add more rows if required.

For each row:

- a. Select a **Sequence Number**. The sequence number indicates the level of approval (the order in which the record or transaction is routed for approval). Multiple rows can have the same sequence number.
- b. Select an **Approver**. This can be a named employee or a dynamic value (metavalue) such as [Project owner] or [Manager].
- c. (Optional) **If approver is equal to submitter, send to** — Select an alternative approver in case the selected approver is the same as the employee who submitted the record or transaction for approval, if self-approvals are not authorised.

**Note:** You can also set an alternative approver for the entire approval process (step 5). Setting an alternative approver for the entire approval process is equivalent to setting the same alternative approver for each row.

- d. (Optional) Set up **Auto-approve rules**. You can configure SuiteProjects Pro to approve the record or transaction automatically when they match certain criteria. To do so:
  - i. Click **Create**.  
The Auto-approve rules form appears.

- ii. Check the box for each rule you want to apply, and select the field (if applicable), the comparison operator, and the value.
  - iii. Click **OK**.
- e. (Optional) Check the **Can not edit** box to prevent the approver from modifying the record or transaction before approving it, if your account is configured to allow approvers.
  - f. **Assign after** — This field is available only if two or more rows in the approval process have the same sequence number. You can use this field to escalate the approval automatically if the record or transaction is not approved or declined within the specified number of days after submission. SuiteProjects Pro will route record or transaction automatically to the approver on this row if the previous approver with the same sequence number does not approve or reject the record or transaction. The previous approver can still approve or decline the record or transaction after the approval is escalated.

**Note:** The number of days specified in the **Assign after** field is always relative to the initial submission for approval. It is not relative to the previous escalation.

5. (Optional) **If approver is equal to submitter, send to** — Select an alternative approver in case any of the selected approvers is the same as the employee who submitted the record or transaction for approval, if self-approvals are not authorised.

**Note:** You can also set alternative approvers for each row (step 4c). Setting an alternative approver for the entire approval process is equivalent to setting the same alternative approver for each row.

6. (Optional) Check the **A sequence number requires only one approval** box if you have multiple approvers at the same approval level (with the same sequence number) but require only one of them to approve the record or transaction before it is routed to the next level.
7. Click **Save**.

## Modifying an Approval Process

SuiteProjects Pro lets you modify an existing approval process. Changes to the approval process will apply to the relevant records or transactions submitted after you modify the approval process.





**Important:** By default, SuiteProjects Pro does not permit an approval process to be modified if there are one or more transactions progressing through this approval process. Modifying an approval processes while some transactions are still awaiting approvals may cause problems with progressing approval for these transactions.

### To modify an approval process:

1. Go to Administration > Application Settings > [Select an application] > Approval processes > [Select an approval process].



**Note:** You can access the full list of approval processes defined for your account from any of the Expenses, Invoices, Opportunities, Purchases, Resources, and Timesheets application settings. The same approval process may be used for different record or transaction type across different SuiteProjects Pro modules.


2. Make any changes as required following the same steps as for creating an approval process. See [Creating an Approval Process](#).
3. Click **Save**.

## Customization Center

The customization center in the Administration module provides a single location to set form permissions and create custom fields for all record types supporting these features.

The customization center lets you:

- Customize forms from one location, without having to go to each form to access form permissions for the form.
- Make changes across multiple forms.
- Validate settings made between related forms.

Customization of your SuiteProjects Pro account extends beyond the settings available in the customization center. User scripting lets you customize the SuiteProjects Pro functionality to meet your business requirements. For example, you can use the customization center to show messages on forms at all time (see [Form message](#)) or depending on certain conditions (see [Permission Rules](#)), but you can also show confirmation, warning and error messages on forms using form scripts. See the help topics [NSOA.form.confirmation\(message\)](#) and [NSOA.form.error\(field, message\)](#) under  [User Scripting](#).

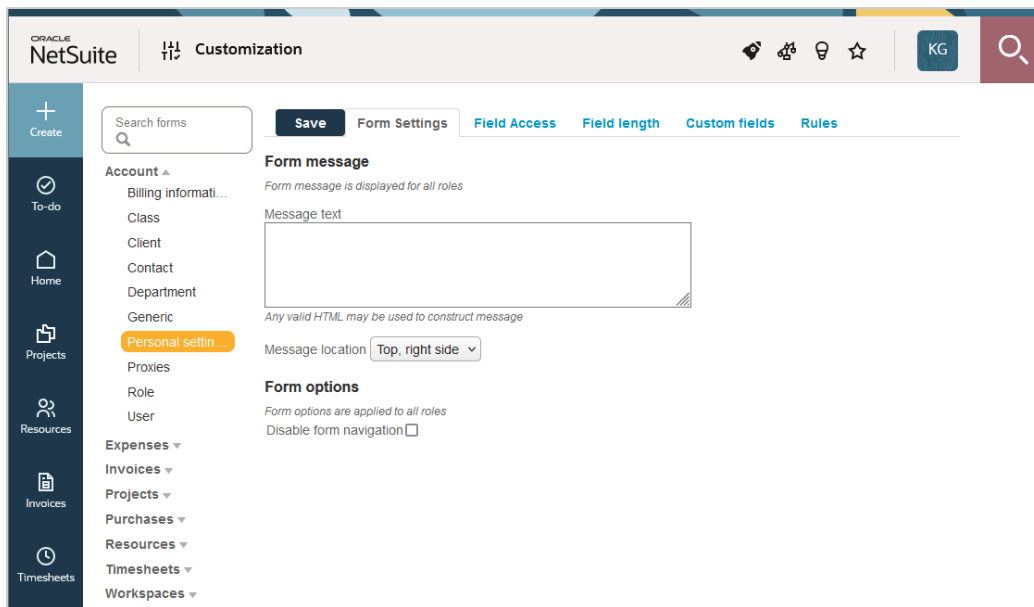
## Viewing or Setting Form Permissions in the Customization Center

You can set form permissions and create custom fields for all record types from the customization center.

### To view or set form permissions in the customization center:

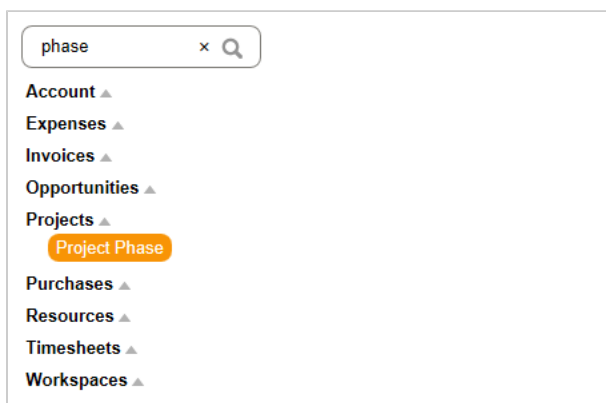
1. Go to Administration > Customization.

The Customization pages shows the list of SuiteProjects Pro modules (applications). You can click the caret next to each module name to expand the list of forms in each module. Each form is referenced by the corresponding record type.



2. Enter part of the record type for which you want to view or set form permissions in the search box. The lists of available forms under each module are expanded and filtered as you type. Matching strings are highlighted in bold in the filtered list.

**Note:** Some record types have different sets of form permissions depending on whether you are adding a new record or modifying an existing record. In this case, the list shows both sets under <record type> [New] for form permissions applicable when adding new records and <record type> [Edit] for form permissions applicable when modifying existing records. There are two sets of form permissions for timesheets, for example: Timesheet [New] and Timesheet [Edit].



3. Click the record type to view or edit the permission settings for this form. The page shows the following tabs:
  - **Form Settings** — The Form Settings tab includes the following form permissions form sections:
    - **Form options** — Control general form display options. See [Form options](#).
    - **Form message** — Add a custom message to the form. See [Form message](#).
  - **Field Access** — The Field Access tab includes the following form permissions form sections:

- ▣ **General permissions** — Control users' ability to save and delete records. See [General Permissions](#).
- ▣ **Field settings** — Control users' permission rights for each field on the form. See [Field Settings](#).
- ▣ **Hidden divider sections** — Control users access to specific groups of fields. See [Hidden Divider Sections](#).
- **Field Length** — The Field Length tab shows the Text field length section of the form permissions form and lets you control the maximum length of text fields on a form. See [Text Field Length](#).

- **Custom Fields** — The Custom Fields tab lists the existing custom fields for the record type, and lets you create new custom fields. For more information about custom fields, see [Custom Fields](#).
- **Rules** — The Rules tab shows the Permission rules section of the form permissions form and lets you control users' permission right dynamically when certain conditions are met. See [Permission Rules](#).

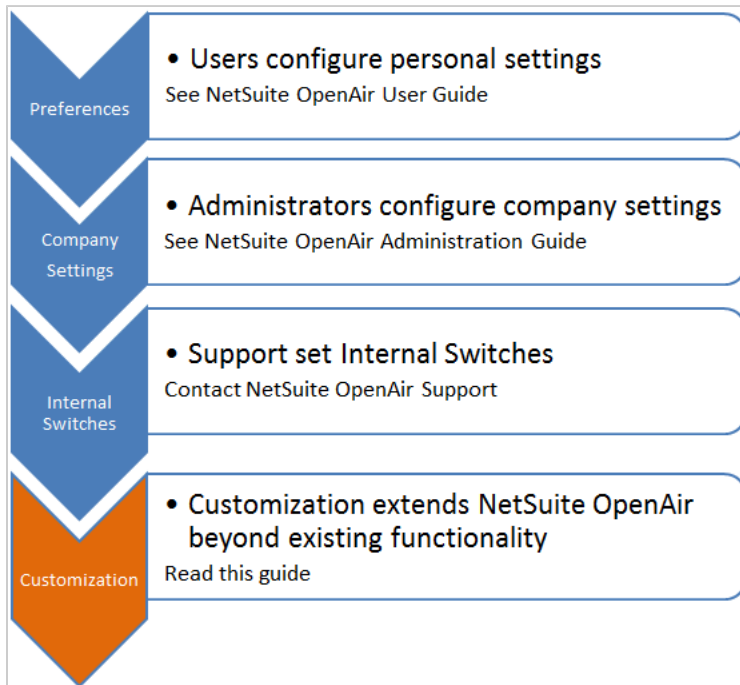

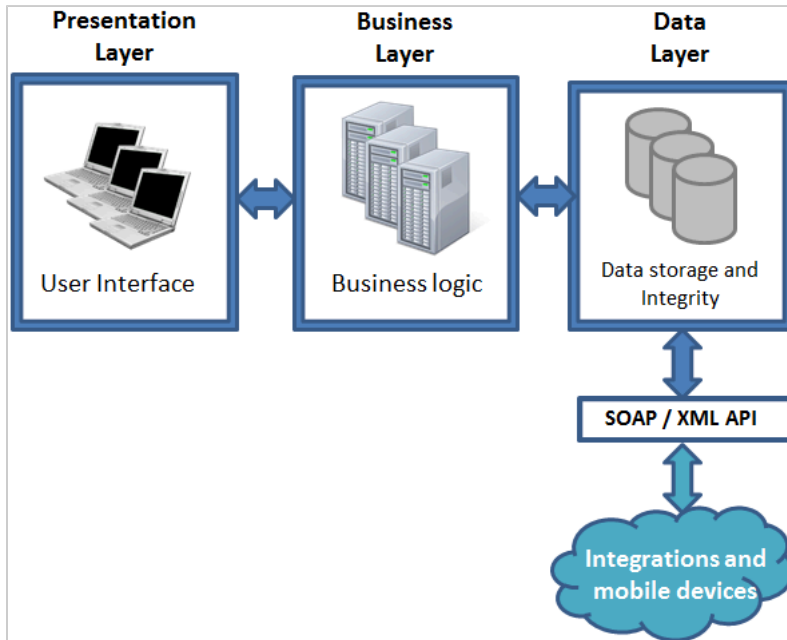
SuiteProjects Pro is a highly configurable system.

- Users can set personal settings to tailor SuiteProjects Pro according to the way they prefer to work. See [User Guide](#).
- Administrators configure the company settings to tailor SuiteProjects Pro according to their company business processes. See help topics in this guide.
- SuiteProjects Pro Professional Services set internal settings during the initial configuration for your company's SuiteProjects Pro account. To take advantage of additional functionality as your business requirements evolve or as new features become available, you can submit a case to SuiteProjects Pro Support and request for optional features controlled by internal settings to be enabled. See [Optional Features](#).

Customization is one component of the SuiteProjects Pro platform. It lets account administrators customize SuiteProjects Pro to better meet the unique needs of your business. It includes:

- [Custom Fields](#)
- [Form Permissions](#)
- [Notifications](#)
- [Approval Routing](#)
- User scripting — See [User Scripting](#).

An application system such as SuiteProjects Pro consists of three logical layers (presentation layer, business logic layer, and data layer), and application programming interfaces (API) that lets you integrate SuiteProjects Pro with add-on services, and other software applications in your infrastructure.



## Presentation Layer

Users interact with SuiteProjects Pro through forms and fields. You can extend these forms by creating [Custom Fields](#) and then define how users can interact with the fields by setting [Form Permissions](#). Custom fields have a data component (Entity) and user interface component (Form), see [Record Types and Forms Supporting Custom Fields](#).

Custom fields are displayed together as a block on a form. You can organize the custom fields using [Dividers and Sections](#) and positioned them as required on the form. See [Custom Field Position](#).

Custom messages can be displayed to assist and enforce the user in following your business processes. See [Form message](#) and [Permission Rules](#).

## Business Layer

You can extend and create business rules through [Form Permissions](#), [Notifications](#), and [Approval Routing](#).

The [Custom Fields](#) you create can be added into your business rules.

## Data Layer

You can create [Custom Fields](#) to track additional information.

Custom fields have a data component (entity or record type) and user interface component (form), see [Record Types and Forms Supporting Custom Fields](#). To create a data component with no user interface component, check the **Hide on data entry forms** box for the custom field. See [Defining Custom Field Properties](#).

The custom fields you create are available through the API. SuiteProjects Pro also uses custom fields to support additional features and integrations.

## SOAP and XML API

SuiteProjects Pro API provides programmatic access to your SuiteProjects Pro account data and business processes without using the SuiteProjects Pro UI. You can use the API to perform operations and integrate SuiteProjects Pro with other applications.

SuiteProjects Pro API includes the following component APIs:

- XML API – The XML API interfaces with the data layer in SuiteProjects Pro and provides the most comprehensive programmatic access to your SuiteProjects Pro data.
- SOAP API – The SOAP API uses SOAP-based web services, and serves as a wrapper around the XML API, providing the same or similar functionality.
- REST API – The REST API interfaces with the business layer in SuiteProjects Pro. This ensures that business rules configured for your SuiteProjects Pro account are applied when an integration application interacts with your SuiteProjects Pro data through the REST API. However, the REST API is limited in scope compared to the XML API and SOAP API and currently provides access to selected SuiteProjects Pro object types only. For more information about

## Custom List Layouts

This topic describes the elements of the Custom List Layouts optional feature that can be configured and controlled by account administrators.

For general information about using list layouts [Personalized List Layouts](#) under [User Guide](#).

## Access Control

To enable the Custom List Layouts feature for your company's account, contact SuiteProjects Pro Support.

After you enable the feature, the following controls become available:

- Role permission **View and modify all list views** – Account administrators and users with this role permission can:
  - View for all list layouts in your company's account. That is, all list layouts owned by all users of your company's account, including list layouts that have not been shared as public.
  - Perform the following actions on any list layouts in your company's account.
    - Delete list layouts.
    - Set or unset list layouts as public list layouts – Public list layouts are custom list layouts that are available to all users of your company's account.
    - Set or unset a list layout as the default list layout for new users.
    - Transfer ownership of a list layout from one user to another.

For more information about roles and role permissions, see [Roles Overview](#).

- User privilege **Create public list views** (Administration > Global Settings > Users > Employees > [Select an employee] > Demographic, Optional features section of the form) – Users with this user privilege can set or unset list layouts as public list layouts, even if they do not have the **View and modify all list views** role permission.

## List Layout Administration

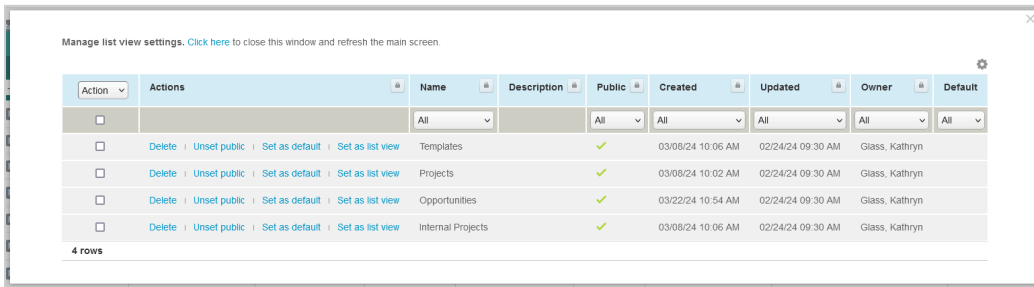
Account administrators and users with the **View and modify all list views** role permission can:

- Check the **Set this list view as default for new users** box when saving a list layout to set it as the default list layout for new users.

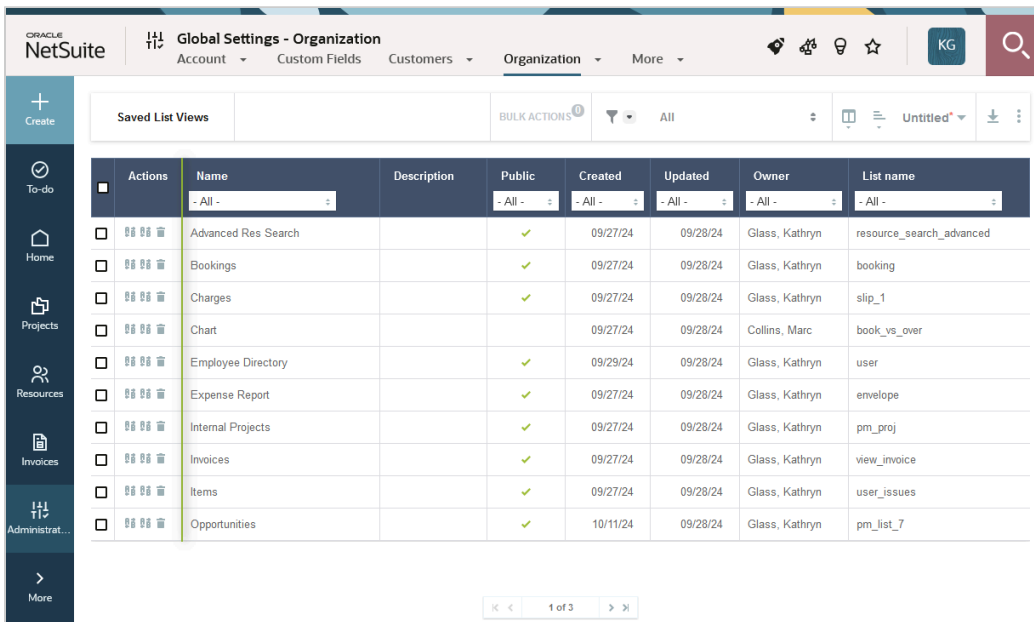
**Note:** Users can personalize the default list layout. If a user changes any list layout properties, these changes will continue to apply the next time this user goes to the list. If you modify a default or public list layout, these changes will not apply for existing users unless they switch to a different list layout and switch back to it again.

The default layout is applied to the list for all users currently using the system default layout ("Untitled") or using a previous default layout that was deleted or made private. In this case, users lose any unsaved changes to the system default layout or previous default layout.

- View and manage the list of all list layouts in your company's account for **a specific object type**. To do so, go to the list for that object type, and click **Manage list view settings** from the list layout menu.



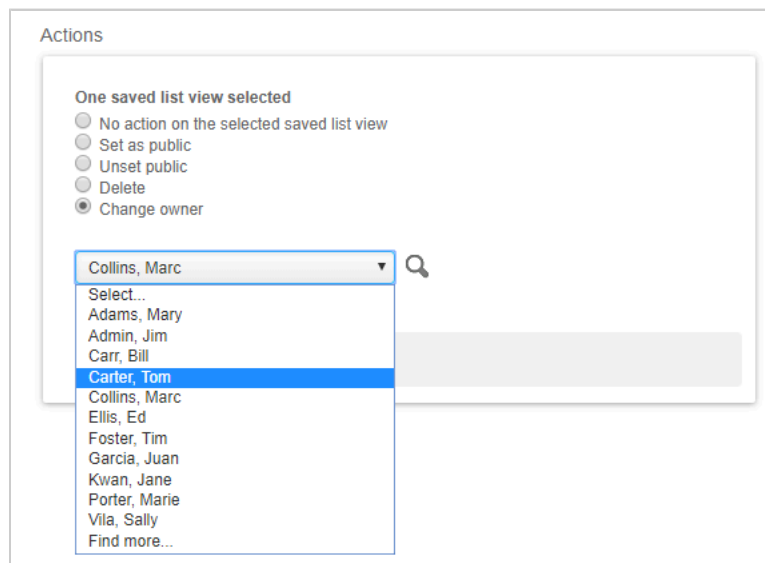
- View and manage the list of all list layouts in your company's account for **all object types**. To do so, go to Administration > Global Settings > Organization > Saved List Views.



- From either the Manage list view settings or Saved list views lists, you can perform the following actions. These actions are available both from the **Actions column** and as bulk actions, unless otherwise specified.
  - **Set as public** and **Unset public** – Public list layouts are custom list layouts that are available to all users of your company's account.

**Note:** Users without the **View and modify all list views** role permission but with the **Create public list views** user privilege can set and unset public layout they own as public.

- **Set as default** and **Unset default**— A default list layout is applied for new users and for all users currently using the system default layout ("Untitled") or using a previous default layout that was deleted or made private. This action is only available from the **Actions** column. It can only be performed for one list layout at a time.
- **Delete**
- **Change owner** – Transfer ownership of list layouts from one user to another. Only the current owner can save changes to a list layout. Only the current owner and account administrators can use a list layout unless it is a public list layout. Transferring ownership may be useful if the list layout owner leaves the company and you want to make changes to the list layout or to let another employee use it without making the list layout public. This action is only available as a bulk action. After you choose the **Change owner** action, select the new owner for the selected list layouts and click **OK**.



## Deleted Attachment Recovery

Recover deleted files, including receipt photos, résumés or CVs, or other attachments, to a specified workspace or to their original location, or download the files to your PC.

After you enable this feature, you can:

- Restore a deleted attachment to its original attachment, or to a specific workspace.
- Download deleted attachments.

To enable this feature, contact SuiteProjects Pro Support.



**Note:** Records deleted 180 days or more ago are not generally available for recovery. Record retention periods may change in the future. For more information about deleted record retention, see [Data Deletion](#).

Recovered files count against your account's file storage limit.

### To recover a deleted file to its original location:

1. Go to Administration > Global Settings > Account and click **Restore deleted document/folders**.

**Note:** The original location must still exist to recover a deleted file to it. You cannot recover a deleted file to a deleted record.

2. In the **Run an Action** column, select the checkbox next to the file or files you want to recover.
3. In the **Run an Action** dropdown list, select **Restore files to original records**.
4. A dialog appears showing the status of the recovered files. Click the **Click here** link to close the window and refresh the list of deleted files.

### To recover a deleted file to a workspace:

1. Go to Administration > Global Settings > Account and click **Restore deleted document/folders**.
2. In the **Run an Action** column, select the checkbox next to the file or files you want to recover.
3. In the **Run an Action** dropdown list, select **Restore deleted files**.  
Alternatively, you can click the **Undelete** button in the **Commands** column.
4. In the Actions dialog, select a Workspace to recover the deleted files to and click **OK**.
5. A dialog appears showing the status of the recovered files. Click the **Click here** link to close the window and refresh the list of deleted files.

### To download a deleted file to your PC:

1. Go to Administration > Global Settings > Account and click **Restore deleted document/folders**.
2. In the **Run an Action** column, select the checkbox next to the file or files you want to recover.
3. In the **Run an Action** dropdown list, select **Download**.  
Alternatively, you can click the **Download** button in the **Commands** column.
4. Select a location to save the file to and save the file.

## Form Default values

You can configure SuiteProjects Pro to populate fields with default values when you create a record of either of the following types:

- Projects
- Tasks
- Timesheets
- Receipts
- Bookings

- Milestones
- Billing rules – Time billing rule
- Revenue Recognition rules
  - Percent complete rule
  - As billed rule
  - Expenses rule
  - Fixed amount on date or milestone rule
  - Fixed amount on percent complete rule
  - Incurred vs. forecast rule
  - Time project billing rule

Values can be set for specific roles, so the role of each employee would dictate which values are defaulted. If the defaults apply globally, they may be applied to all roles. Defaults can be set for a variety of fields, including custom fields.

### To set form default values:

1. Create a new form which supports form default values (see list above).
2. Click the link to **Set default form values** from the **Tips Button**.  
A copy of the form appears.
3. Select a role or accept the default of All.
4. Complete all fields for which default values are desired.
5. Click Save.

Use caution in setting default form values. You should not set default values for fields that are often changed during data entry. Setting too many default values can result in data entry errors because employees may forget to change key input data.

## Form Permissions

You can use Form Permissions to control users' access and permission rights according to their role. You can control several elements of the form.

Some of the form permissions settings can be used for access control:

- **General permissions** — Control users' ability to save and delete records. See [General Permissions](#).
- **Field settings** — Control users' permission rights for each field on the form. See [Field Settings](#).
- **Hidden divider sections** — Control users access to specific groups of fields. See [Hidden Divider Sections](#).
- **Permission rules** — Control users' permission right dynamically when certain conditions are met. See [Permission Rules](#).

Other settings control usability, input validation and display options:

- **Field order** — Control the order fields appear on the form if the record type supports this feature. See [Field Order](#).
- **Text field length** — Control the maximum length of text fields on a form. See [Text Field Length](#).
- **Form options** — Control general form display options. See [Form options](#).

- **Form message** — Add a custom message to the form. See [Form message](#).

There are two ways to access form permissions:

- Go to a record form, such as the Project Properties form, for example, click the Tips button, and click **Modify the form permissions**.

The following page appears. Scroll down or use the quick links on the left-hand side to configure the permission settings for this form.

- Go to Administration > Customization.

The following page appears. You can select a form on the left-hand side, then click on the **Field Access** tab to set the general permissions, field settings and hidden divider sections and on the **Rules** tab to set the permission rules.

**Note:** Form permission settings apply throughout the SuiteProjects Pro web application as well as the SuiteProjects Pro Mobile applications and the SuiteProjects Pro OffLine desktop application.

## Field Settings

Field settings allow you to set users permission rights for each field on the form and for each role. On the form permission page, each row corresponds to a field and each column corresponds to a role. You can select the permission rights given to a specific role over a specific field by selecting one of the following dropdown options:

- **REQ** — Required on form. Employee must enter a value.
- **RO** — Read Only on form. Entry is not allowed.
- **Hide** — Hide from form. Field does not display on form.
- **R-RO** — Read Only for system required fields.
- **R-Hide** — Hide from form for system required fields.

Field Settings are universal for the entity associated with the form.

**Note:** Field settings and switches override Permission Rules. If field settings or switch-based **field is required** options are used to control a set of fields, you cannot control those fields using permission rules.

The "Ready for Recognition" box on Projects> Tasks (Pending/ Completed/ All) does not support form permissions as standard. To enable form permission support for the "Ready for Recognition" box, contact SuiteProjects Pro Support.

## Hidden Divider Sections

## Permission Rules


**Note:** Form permission rules are available only if the feature is enabled on your account. Contact SuiteProjects Pro Support and ask for the following feature: **Form Permission Rules.**

Permission rules control permission rights dynamically when certain conditions are met. You can create new rules or edit existing rules and select the access permission for selected fields when one or all the conditions defined are met. The conditions can apply to any of the standard and custom fields on the entity form or to the user role. You can choose the access permission applicable to selected field from the following dropdown options.


- **Show** — Displays selected fields when the conditions are met.
- **Hide** — Hides selected fields when the conditions are met.
- **Read Only** — Marks selected fields as Read Only so that users cannot edit them when the conditions are met.
- **Required** — Marks the selected fields as required when the conditions are met.
- **Hide and Clear** — Hides the selected fields and clears any values in them when the conditions are met.
- **Limit values** — Allows you to limit which values are available to select in a field when the conditions are met. Selecting this rule displays the **Limit values** pick lists.
- **Hide buttons** — Hides selected buttons, such as "Save", "Delete" or "Cancel", when the conditions are met.

**To create permission rules:**

1. Access the **Create a new rule** form using either of the following methods:
  - Go to Administration > Customization, select an entity form, click the **Rules** tab and click the **Create** link.
  - Go to an "Edit entity" form (for example, the Project Properties form), click the **Modify the form permissions** link from the Tips menu, scroll down to **Permission rules** and click the **Create** link.
2. Enter a rule name.
3. Define the conditions for the rule. Multiple conditions may be required to create the rule.

 **Note:** Standard fields, custom fields, and employee roles are options within the conditions.

4. Click **Perform action** and select one of the dropdown options.
5. Select the fields or the button the action will apply to. Multiple fields or buttons may be selected.
6. If you selected the **Limit values** action, for each field selected:
  - a. Click one of the selected fields.
  - b. Select the values using the **Limit values** pick list to restrict the values displayed for this field.
7. Set a **Custom message** and the **Severity of custom message** as required. The severity setting determines the color scheme for the message to be displayed at the top of the form.
8. Click **Save**.

 **Note:** Field settings and switches override Permission Rules. If field settings or switch-based **field is required** options are used to control a set of fields, you cannot control those fields using permission rules. However, those fields can be included in any of the rule conditions.

## Field Order

You can create different form layout, and change the order in which standard and custom fields and standard and custom section dividers appear for each form layout, and apply the form layout to selected user roles. Depending on their role, users will see a different form layout when they view, add or modify a record, for record types that support this feature.

**Note:** You can also set the position of custom fields to appear after any standard or custom field or add a custom form section when creating or modifying custom fields. See [Custom Field Position](#) and [Custom Field Position](#).

### To create a form layout and assign it to specific roles

1. Access the **Field order** form using either of the following methods:

- Go to Administration > Customization, select an entity form, click the **Field order** tab.
  - Go to a record form (for example, the Project Properties form), click the **Modify the form permissions** link from the Tips menu, and scroll down to **Field order**.
2. Click **Create**.

**Note:** To modify an existing layout, click **Edit** next to the layout name.

3. Enter a **Name** for the custom layout.
4. In the **Field order** list, click the field or section divider you want to move, and use the arrows pointing up or down to move the field or section divider up or down.

You can move multiple fields and section dividers at the same time. To do so, hold Ctrl or Shift and click the fields and section dividers you want to select, then use the arrows to move the fields and section dividers.

5. Under Assigned to roles, select the roles you want to assign this form layout to.
6. Click **Save**.

## Text Field Length

This feature shows you the list of fields that can have a maximum character length set, and lets you to set the maximum lengths. If you leave a field blank then the maximum database length for the field is applied.

**Note:** If you specify a maximum length greater than the length allowed in the database then your maximum value will be ignored and the database maximum for the field applied.

The new text field length maximum is applied when creating a new form and modifying an existing form.

**Note:** If you have an existing value that is longer than the new **Text field length** then the existing length of the value will be treated as the maximum length while the form is being modified.

**Note:** The Text field length sections settings are only available if the feature is enabled on your account. Contact SuiteProjects Pro Support and ask for the following feature: **Maximum Text Field Length Form Permission Settings**.

## Form options

The following form level permissions can be set:

- **Display "Save & create another" button at top** — Select this option to display the **SAVE & CREATE ANOTHER** button when create a new entity.

**Note:** This behavior can be overridden by the **Add "Save & create another" button to the top right of forms** company switch under Administration > Global Settings > [Display] Interface : Display.

- **Display Custom Fields before form field** — This option determines where on the form the custom fields will be positioned in relation to the standard form fields. The **[Default]** setting will place the custom fields at the bottom of the form. You can also select **[Top]** or specify a field to position the custom fields after.
- **Disable divider before Custom Fields** — This option will disable the displaying of the divider.
- **Fields which maintain value on "Save & create another"** — This option allows you to select the fields that will be copied forward when using the "Save & create another" feature.

## Notifications

Account administrator can control the email notification messages that SuiteProjects Pro sends automatically to inform users about certain record events.

The Custom Email Notifications optional feature lets account administrators configure when and to whom SuiteProjects Pro sends email notification messages, as well as the message content. Custom email

notifications let you set up separate notification email for a supported record type and event combination. You can set up SuiteProjects Pro to send notification email every time the event occurs for a record of that type, or when the event occurs and the record meets specified conditions.

For example, you can set up notifications to inform users when a transaction is submitted and awaiting the user's approval, when a transaction is approved or rejected, or when a transaction is submitted or approved by proxy. You can also set up notifications to inform users when a booking is created, modified, or deleted and meet criteria such as a specific booking type or Customer: Project, or when the project stage is set to a certain value on a new or existing project.

Account administrators can:

- Enable custom email notifications for selected SuiteProjects Pro modules (applications) only. When enabled for a module, a Notifications list becomes available in the application settings for that module. See [Enabling Custom Email Notifications](#).
- Go to Administration > Application Settings > [Select a module] > Notifications, and add custom notifications for supported types of records and supported events on these records. See [Setting Up Custom Email Notifications](#).

**Note:** The Custom Email Notifications optional feature is often enabled for new SuiteProjects Pro accounts as it offers more control and flexibility for email notifications.

You should enable the Custom Email Notifications feature and disable standard email notifications and email templates, if you are still using the latter on your account.

When the Custom Email Notifications optional feature is not enabled, SuiteProjects Pro sends standard email notifications when transactions are submitted or approved. SuiteProjects Pro also sends email notifications for other record events. Account administrators can:

- Create email templates for standard email notifications. See [Email Templates](#).
- Disable standard email notifications and email templates. See [Disabling Standard Email Notifications and Email Templates](#).

## Enabling Custom Email Notifications

You can enable custom email notifications for selected SuiteProjects Pro modules (applications) only.

To enable custom email notifications, contact SuiteProjects Pro Support, request the Custom Email Notifications optional feature, and specify for which modules you want to enable custom email notifications.

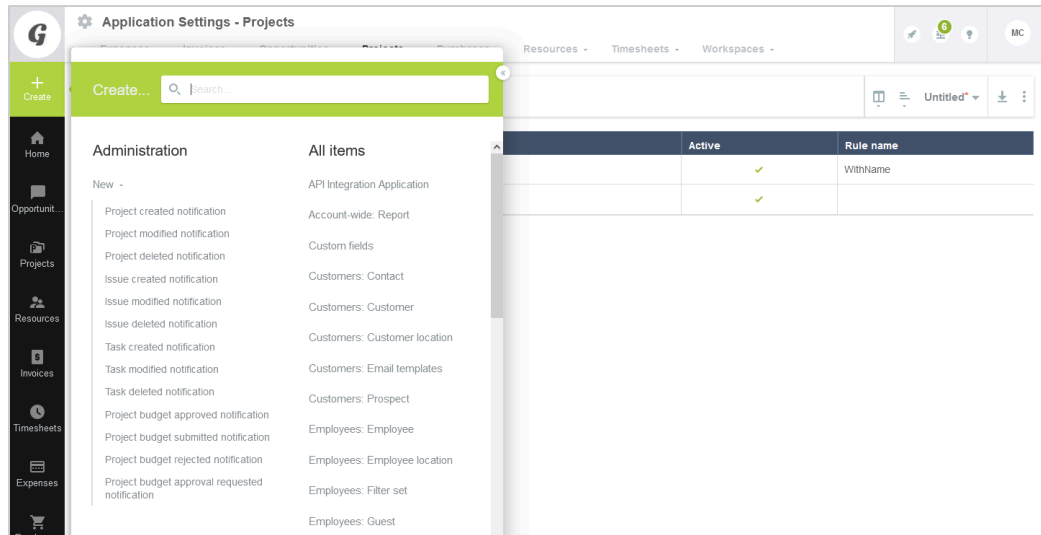
## Setting Up Custom Email Notifications

After you enable custom email notifications for a module, a Notifications list becomes available in the application settings for that module. You can review and modify existing custom email notifications or you can add new ones.

### To set up custom email notifications:

1. Go to Administration > Application Settings > [Select a module] > Notifications.

The list of notifications set up for record types associated with the selected module appears.




2. Do one of the following:
- To modify an existing notification, click <record type> <event> (for example, Project created) under the Event column.
  - To add a new notification, click the Create button, then click the option corresponding to the record type and the event you would like to set up notifications for. The Create menu options also include the record type and the event for record types in the module: <record type> <event> notification (for example, Project deleted notification).

The Notification form appears.



3. (Optional) Enter a **Rule name**.
4. Under **Send a Notification** select when the notification should be sent.

<b>1</b>	<p>Click the dropdown field under <b>Send a Notification ...</b> and select one of the available options. You can set up the notification to be sent: only To do so,</p> <ul style="list-style-type: none"> <li>■ Every time the event occurs for every record of this type — To do so, select <b>When any &lt;record type&gt; is &lt;event&gt;</b>.</li> <li>■ When one or multiple conditions are met — To do so: <ul style="list-style-type: none"> <li>□ Select <b>When all of these conditions are met</b> if you want to send a notification when the event occurs and the record meets all specified conditions (AND logical operator).</li> <li>□ Select <b>When one of these conditions is met</b> if you want to send a notification when the event occurs and the record meets at least one of the specified conditions (OR logical operator).</li> </ul> </li> </ul> <p>If you select either of the latter two options, the form shows additional fields to let you define the conditions.</p>
<b>2</b>	Click the dropdown box further left in the condition row to select a field.
<b>3</b>	Click the middle dropdown box to select a comparison operator from the available options.

- 5 Click **Add row** to add a new condition.  
Click the Delete row icon  next to a row to delete that condition.

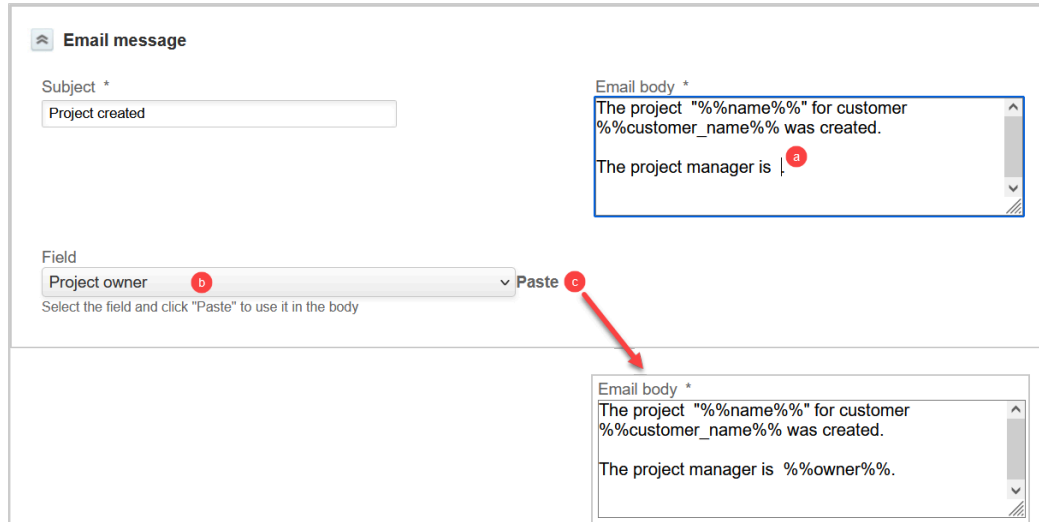
5. Under **Notify**, select who should receive the notifications. Do one of the following:
- Select one or multiple named employees.
  - Select one or multiple dynamic values (metavalues) to send notifications to an employee determined automatically depending on the record information, or who created or modified the record. For example, if you select the metavalue [Customer owner], notifications are sent to the employee who owns the customer associated with the record, or if you select the metavalue [Submitter's manager], notifications are sent to the manager of the employee who submitted the transaction record for approval.
  - Enter one or multiple **External email addresses**, separated by a comma, to send notifications to recipients who do not have a user record in your company's SuiteProjects Pro account.
6. **For email with multiple recipients**, select whether to send one single email with all recipients in the To line, or send separate email messages to each recipient for the same notification.
7. Under **Email message**, enter a **Subject** line.
8. Enter the text to include in the **Email body**.

You can insert field variables in the body of the notification email. Field variables will be replaced by current field values on the record when the notification email about that record is sent. To insert field variables:

- a. Place your cursor where you want to insert the value in the **Email body** text.
- b. Select the **Field** from the dropdown list.
- c. Click **Paste**.

The field variable appears at the cursor location in the **Email body** text.

**Note:** The notation for field variables is the database name for the field between double percent characters. If you know the name of the field in the SuiteProjects Pro database (<field\_name>), you can enter field variables directly in the text using the following notation: %%<field\_name>%.



9. Under **Other**, check the **Active notification** box to enable the notification. SuiteProjects Pro sends the custom email notification only if this box is checked. You can clear this box at any time if you want to disable the custom email notification.
10. For approval requested notifications, check the **Do not send if auto-approved** box if you do not want to send approval requested email notification when the transaction is approved automatically. If the **<Transaction > approved by** is set to the metavalue [Self approver], for example, you may not want to send approval requested notifications.



## Disabling Standard Email Notifications and Email Templates

Standard email notifications and email templates can be disabled for selected types of records. To do so, contact SuiteProjects Pro Support, and specify which standard functionality you want disabled, and for which record types.

The following table lists the functionality you can disable, and the record types the functionality applies to.

**Note:** You should disable standard email notifications and email templates for the same modules and record types as you enable custom email notifications for. See [Enabling Custom Email Notifications](#).

Email templates are only used for standard email notifications. When disabling standard notifications, you should disable email templates for the same record types, if email templates are supported for the record type.

Standard email notification options for several project-related events are controlled on the project properties form. Use form permissions to control access to the Notifications form section or to individual options within that section. See [Form Permissions](#).

## Data Deletion

Users with appropriate role permissions can delete transactions or records using the SuiteProjects Pro web application or SuiteProjects Pro API.

**Note:** Only transactions or records which are not associated with another transaction or a child record can be deleted, unless those associated transactions or records themselves have been deleted.

A deleted transaction or record cannot be recovered. A new transaction or a record needs to be created to replace the deleted one.

API Access is a licensed add-on and must be purchased separately. To enable API Access for your account, contact your SuiteProjects Pro account manager or SuiteProjects Pro Professional Services.

When a user deletes a record in SuiteProjects Pro, the record is flagged as deleted. The record is not removed immediately from the SuiteProjects Pro database.

Deleted records are retained in the SuiteProjects Pro database for a minimum of 180 days. Older deleted records, that is, records marked as deleted and last updated 180 or more days ago, are removed permanently from the database according to a routine schedule.

- Starting February 24, 2024 on sandbox accounts, and March 9, 2024 on production accounts, the removal process will run every week on the weekend. Each deleted record will remain available in the SuiteProjects Pro database for a minimum of 180 days and up to one to two weeks after this minimum retention period.
- Previously, the removal process ran two times a year during major SuiteProjects Pro release windows. Each deleted record remained available in the SuiteProjects Pro database for a minimum of 180 days and up to one year after the record was marked as deleted.

Deleted records cannot be removed permanently or modified by your company's account administrators during the retention period.

Account administrators may request the expedited purge of specific records flagged as deleted for regulatory compliance. See the help topic [Requesting Purge of Deleted Records or Audit Trail Data](#).

Following the expiration or termination of the SuiteProjects Pro Service, data is deleted from all live and non-live environments after six months of the account cancellation date. See also [Data Control](#).

# Timesheets


The Timesheets application provides employees with a place to keep track of the time worked on projects. This is also where managers approve employee timesheets. An employee must have an active employee license to enter time in the application. All employees fill out time against a project, and when approved, you can run billing rules to capture time worked and can invoice customers. Timesheets are classified by default as open, submitted, approved, rejected, or archived.

In addition, you can configure the Timesheets application to support the following.

- Employees can create time off requests. See [Other Settings](#) and the company switch to enable time off requests.
- Managers can reject a line item entry on a timesheet. To enable this feature, [Creating a Support Case](#) and request the following switch be enabled: Enable line item rejection of time entries.
- Administrators can create timesheet rules and the approval process. See [Timesheet Rules](#) and [Approval Routing](#).
- Administrators can manage the layout of timesheet reports and time off requests. See [Timesheet Report Layout](#) and [Time Off Request Layout](#).
- Administrators can create alerts to notify employees their timesheet is late, notify managers that their approval of timesheets is overdue, and alert employees that a timesheet has not been saved. See [Alerts](#).
- Administrators can create notifications for a variety of timesheets and time off request events. To enable this feature, [Creating a Support Case](#) and request the following switch be enabled: Enable administration of notifications in the following application settings: (Timesheets).
- Administrators and employees with the proper role permissions can track leave accrual balances. See [Run Leave Accruals](#).

## Timesheets

The Timesheets application is where employees record their time against customer or internal projects. Employees can enter time against Customers, Customer : Project, and other combinations such as Tasks and Services. There are several other additional data elements that may be required based on your company's configuration such as Time types or Payroll types.

## Creating, Editing, and Deleting Timesheets



New timesheets can be created from anywhere in SuiteProjects Pro.

### Creating a New Timesheet

1. Click the **Create** button in the upper-left corner of the screen and select **Timesheets (New...)** or **Timesheets (New clone...)**.
  - Selecting **New...** creates a completely new timesheet.
  - Selecting **New clone...** creates a new timesheet which is a copy of an already-existing timesheet.


2. If you selected **New...**, set the timesheet starting date, add notes, allow timesheet overlapping, and add attachments to your timesheet.

If you selected **New clone...**, set the timesheet starting date, the timesheet to duplicate, and choose how to populate the hours cells. As with **New...**, you can add notes and attachments to the timesheet.

3. Click the **Save** button. Your new timesheet appears.
4. Fill in the Customer: Project, task, and hours worked for each day.
  - You can add a description and notes for each task by clicking the Note/Description  icon next to each hours cell.
  - Clicking the  icon pins the timesheet hours cells so that if your window is re-sized or there is a long list of days, as many cells as possible stay visible on-screen.
5. When finished, click either **Save** to save the report or **Save & submit** to save the timesheet AND submit it for approval.




## Editing an Existing Timesheet

1. Go to Timesheets > Timesheets. A list of your existing timesheets appears.

 **Note:** Your role may prevent you from editing timesheets which do not belong to you.

2. Click on the timesheet name of the timesheet you would like to edit. The timesheet appears.
3. Make your changes to the timesheet.
4. When finished, click either **Save** to save the report or **Save & submit** to save the timesheet AND submit it for approval.

Each time sheet has several tabs which allow you to edit the timesheet.

- Under **Edit** you can change the Customer or Project, Task, and Hours for each day, and add Descriptions and Notes to each hours cell.
  - Click the  icon next to a row to create a copy of that row.
  - Click the  next to a row to delete that row. A small dialog appears asking you to confirm the deletion.
  - Click the  to search for Customers or Projects.
- Under **Hours remaining**, you can see the number of hours left for each task you entered time for. The **System estimate (hrs)** field shows how many hours are left based on the initial number of hours set for the task. If you think the task will take more or less time than the initial estimate, you can adjust it in the **Hours remaining** field for each task.
- Under **Report**, you can see a tabular layout of your timesheet which can be printed, saved as a PDF, or downloaded as a CSV or HTML file.
- Under **Properties**, you can edit the timesheet's accounting date, default time type, default customer or project, and default task. You can also add notes or attachments.
- Under **Submit/Approve**, you can see the Approval history for the timesheet, along with any notes for each approval stage.

## Editing a Rejected Timesheet

1. If your timesheet approver rejects a timesheet or individual time entries in a timesheet, the timesheet or time entries are returned to you. To find them, go to Timesheets > Timesheets > Rejected.




2. Click the timesheet or time entries you would like to edit. A detailed report of the rejected timesheet or time entries appears.
3. Click the **Edit** tab. The timesheet edit tab appears.
4. Make your changes to the timesheet or time entries, and click **Save** or **Save & Submit**.
  - If you click Save, the timesheet is only saved, but not submitted.
  - If you click Save & Submit, the timesheet is saved and submitted to your approver.

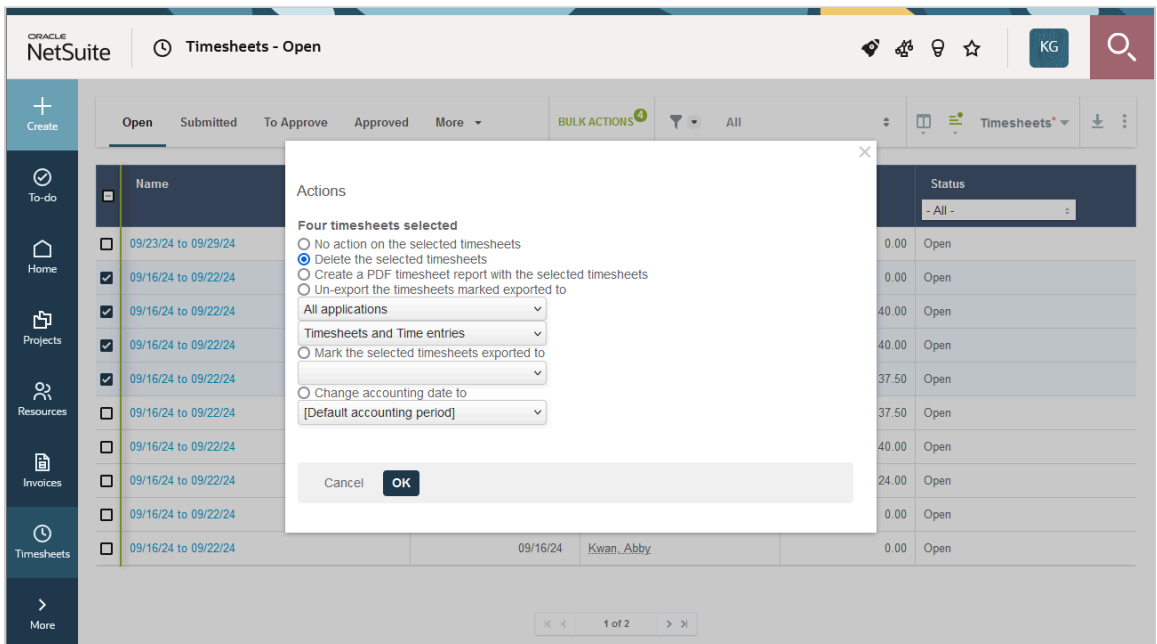
### Deleting a Timesheet

1. Go to Timesheets > Timesheets and click on the name of the timesheet which you want to delete. Your timesheet will open.
2. Click on **Properties**. In the Properties tab, click **Delete**.
3. A popup window will open asking you to confirm the deletion. Click **OK**. Your timesheet will be deleted and you will be taken to the Timesheets list.

### Bulk Deleting Timesheets

1. Go to Timesheets > Timesheets and select all the timesheets you want to delete by clicking the checkboxes next to them.
2. Click the Run an action icon  at the top of the Run an action column. A popup window opens.
3. Select **Delete the selected timesheets** and click **OK**.
4. A dialog appears showing confirming the number of timesheets deleted. Click the **Click** here link to close the window and return to the Timesheets list.

**Note:** Only administrators and users with the **Allow employee to delete (individually or in bulk) open, submitted or rejected timesheets** can run a bulk delete action on timesheets. To enable this feature, [Creating a Support Case](#) and request that the following internal switch be enabled in your account: Administrators can delete employees timesheets.



## Service

Services are specific economic activities that you offer to customers that you use to invoice them. A Service can be set up to bill at an hourly rate; a set amount per day, or week, or month; or may be set as a flat rate. Services are available in the Timesheets, Projects (tasks, billing rules, and recognition rules), Invoices, and Opportunity applications.

If your company's SuiteProjects Pro account is set up to report time against a Customer only or Customer : Project, you may choose to have Services specified to identify the unique service being delivered. When reporting time against a Customer : Project and Tasks, tasks may be set up with a service to be inherited by the time entry directly. You may opt to allow the employee to override the service by entering it on the timesheet.

**Note:** The name of this form is based on your company's terminology. Most companies use services or activities, but other terms are used. You can review and modify your company's terminology definitions in Global Settings. See [Interface: Terminology](#).

### To create a Service:

1. Go to Administration > Application Settings > Timesheets > Services.
2. Select **New Service** from the **Create Button**.
3. Enter the Service name.
4. Under Billing rates, select the Currency if you are using multi-currency in your environment. Choose how you would like to charge for this service: Hourly rate, Other rate (specified amount per time period), or Flat rate (for the entire service-fixed fee).

**Note:** You do not have to complete the billing rates section unless you have chosen to get billing rate from either Services or Services-Customer. See [Billing Rates](#).

5. Optionally, you may choose a cost center for the service if your company has enabled using Cost Centers and has chosen Services as a Selected Item. See [Cost Centers](#).
6. You may also enter text to be used on proposals in the Opportunities application, if desired.
7. Check the **Taxable service** box if tax may be charged to the customers for this service. The tax rate used is based on [Tax Options](#) as well as [Invoice layout - Display, summary](#).

## Time Types

You have the ability to create Time types to be used in the Timesheets application. Time types offer a way to segregate and categorize timesheet entries and can be determined by the employee when entering the time. Some common values are: Regular Time, Overtime, and Personal Time. You can also use time types to determine billable or non-billable travel, paid time off, or other time entry classifications that may affect billing or reporting.

This feature is useful when you have projects where you may need to identify the hours spent in the standard workday (for example, 8 hours in the U.S.) and hours spent above the standard workday, due to a different billing rate or a contractual limit that can be charged to the customer. Time types are useful for reporting on employee activities and utilization components.

### To create a Time Type:

1. Go to Administration > Application Settings > Timesheets > Time types.

2. Select **New Time type** from the **Create Button**.
3. Enter the Time type name.
4. Check the **Allowed in schedules** box if this time type is an option to use when entering time off requests and schedule exceptions.
5. Check the **A task is not required for this time type** box if this time type enables employees to enter time without designating a task as they might normally be required to do.
6. Notes may be added to describe this time type, if desired.



**Note:** There is a feature available to limit time types based on the Project selected for a time entry. To enable this feature, [Creating a Support Case](#) and request that the following switch be enabled: Allow time types to be limited by the project (mutually exclusive with the feature that allow time types to be limited by the task ).

## Timesheet Report Layout

The Timesheet report layout is what you would see if a timesheet were exported and printed as a PDF file, and the format displays on the approval tab for the timesheet approver. You tailor the Timesheet report layout to meet your company's needs. Select the Date format and Grid style. Select the particular fields that you would like to display on the timesheet report by choosing the field from the drop-down list in the related column. You may choose to add text or HTML at the top or end of the timesheet report. You can also configure Adobe Acrobat PDF settings.

### To access and modify the Timesheet report layout:

1. Go to Administration > Application Settings > Timesheets > Timesheet report layout.
2. Check the following boxes as applicable:
  - Show gap hour summary by task – When checked, the timesheet report pulls in the computed gap hours (planned – worked) as tracked by tasks on the project.
  - Hide the time entry notes on the printable view – The printed version of the timesheet report is the same as in the SuiteProjects Pro UI unless you chose to hide the time entry notes. You may want to select this option for printed versions to send to customers for physical signoff.
  - Show the approval history – You should check this box. The approval history is the audit trail of who has reviewed the timesheet and what action was taken.
  - Show the overlapping status of the timesheet in the header – Available if your account configuration allows overlapping timesheets.
3. Finally, choose the Adobe Acrobat PDF settings you would like to use in your environment for clear printing.

## Timesheet Rules

Timesheet rules are a way of putting policy around timesheet submissions. There are several Submission rules you can activate. These are:

- Minimum number of hours required on the timesheet
- Maximum number of hours allowed on the timesheet
- Minimum number of hours per day required on the timesheet


- Maximum number of hours per day allowed on the timesheet
- Minimum leave accrual balance, and Exclude weekends from the daily rules

The first four of these require you to select whether to choose fixed hours or a percentage of the work schedule as the base for the rule. Selecting the percentage of the work schedule is helpful when you are establishing a policy that spans full-time and part-time employees.

You also need to specify the value for the item as well as the Action (Warn or Error) when the rule is violated. For the Minimum leave accrual balance, you need to select the minimum value and the Action to be sent to the employee.

Other options include:

- **Require a time entry every day, independent of workschedule** — enables you to require employees to enter time on Saturday and Sunday, for example.
- **Exclude weekends from the daily rules** — permits weekends on timesheets to pass through timesheet validation without triggering an exception for either the minimum number of hours per day required on the timesheet or maximum number of hours per day allowed on the timesheet rules.
- **Exclude hours associated with cost centers from the daily rules** — If you are using the timesheet rules to monitor minimum and maximum hours per day and cost centers are used to classify employees, this option lets you filter the timesheet daily rule for only those cost centers where the rules apply. For example, you may want to not apply the rules to the sales cost center.
- **Exclude days with no hours from the daily rules** — permits blank days (that is, days with no hours) on timesheets to pass through timesheet validation without triggering an exception for either the minimum number of hours per day required on the timesheet or maximum number of hours per day allowed on the timesheet rules.
- **Require project selection for the following time types** — permits time types to control whether a project is required for timesheet submission. For example, you may have a time type called internal that, when selected, will not require a project selection for time entry. Recording time at the time type level only will not provide a service or task breakdown; therefore, a high level single time type value will have limited reporting capabilities. A good example of a time type that would be useful on its own would be bench time. Please note that this feature is only applicable if you do not require a project selection on all time entries, and it is not commonly used.

 **Note:** The timesheet rules applied in your company's account do not run until the timesheet is submitted for review. Up until the point of submission, timesheet entries saved on a timesheet are not checked against the rule. Therefore, employees may think they have a valid timesheet while it is still in the open timesheet stage.

### To create or modify the Timesheet Rules:

1. Go to Administration > Application Settings > Timesheets > Timesheet rules.
2. The Messages area provides a standard message to the employee when time entries for leave exceed the minimum balance specified in the Minimum leave accrual balance in the section above. Fields identified with %% are standard SuiteProjects Pro fields. Additional fields may be added by looking up the field format. Email templates provide an user unterface to help interpret the field format. See [Email Templates](#).
3. An option to Create a new timesheet when a timesheet is submitted is also available. The options accompanying this feature are the same provided to employees when they choose to copy a timesheet. You should select the option most aligned with your business. For example, Clear the hours is a popular selection.
4. Another option controls whether an alert for rejected timesheets is included in the late timesheet alert notifications.

## Payroll Types

SuiteProjects Pro offers the capability of creating Payroll types for use in the Timesheet application. This is an additional attribute that can be input on the time entry. The general use is to determine regular or overtime work when time types are used for a different purpose. Payroll types have more limited functionality in the rest of SuiteProjects Pro than time types.

### To create a Payroll Type:

1. Go to Administration > Timesheets Settings > Payroll types.
2. Select **New Payroll type** from the **Create Button**.
3. Enter the Payroll type name and any Notes describing the use of this payroll type.

## Time Off Request Layout

You can tailor the Time Off Request report viewed by approvers to meet your company's needs. You are able to select the prefix of all generated time off requests and starting time off request number. **SR-** is the default prefix and starting number defaults to 1.

### To access and modify the Time off request layout:

1. Go to Administration > Application Settings > Timesheets > Time off request layout.
2. Select the Grid style using the drop-down list as well as the Date format.
3. Select the desired check boxes that determine whether to include a description on time off request, signature line on the time off request, and if you would like to show the time off request approval history.
4. Add notes in the header or footer besides the notes on the time off request, if desired.
5. Choose the particular fields that you would like to display on the time off request from the Available Columns and move them to the Selected Columns.
6. Finally, choose the Adobe Acrobat PDF settings you would like to use.

**Note:** To filter the number of time types, projects or tasks that an employee sees for a time off request, use the filters for **Limit lists that appear on form**. This prevents employees from seeing the complete list of projects and tasks they would see when entering a timesheet.

## Add a Save & Submit Button on Time Off Requests

When this feature is enabled, a "Save & Submit" button is added to time off request forms. This button allows users to submit a time off request as soon as they save it. The form retains the "Save" button, which saves a time off request without submitting it.

To enable this feature, go to Administration > Application Settings > Timesheets > Other Settings and select the "Enable the "Save and Submit" button on timesheets and time off requests" setting.


## Leave Accrual Rules

Leave accruals rules provide a structure around how time off such as vacation and personal time off, for example, is handled. First, you set up Leave accrual rules to document each type of time off accrual your


company recognizes, and then you associate them to individual employees that receive that benefit within the company.

### To create a Leave accrual rule:

1. Go to Administration > Application Settings > Timesheets > Leave accrual rules.
2. Select **New Leave accrual rule** from the **Create Button**.  
The New leave accrual rule form appears.
3. In the Accrual section, select the Period, Hours per period, Accrual timing, and the maximum Cap (hours) for the accrual. Each time the rule is executed, the period is referenced to determine if the hours per period should be added to the accrual amount, which results in a Leave Accrual Transaction to be generated. When the Cap of hours has been reached, the rule does not create any more transactions for that defined period.
4. Next, choose one of the **Lose accrued time** options. Enter the Grace period (days), Delay loss accrual (days), and Carry over (hours). Check the **Apply only to grace period** box to only have the carry over hours applied to the grace period, if required.

 **Note:** When the rules are executed, the lose accrued time option is considered, which creates drawn-down transactions to zero the balance of any accrual that are past the deadline for use. For example, if 40 hours remains in the employee's account and the lose accrued time option is December 31, then on January 1 the rule creates a negative 40 hours draw-down transaction to expire the accrued time balance. The Grace period and Delay loss accrual options provide another level of definition related to your time off policy since the lose accrued time options are limited. If your company observes a carryover option, then the rule can be configured with this number of hours (days) for carry over which may also be limited only to those hours (days) carried over into the grace period.

5. For employees that start during a mid-accrual period such as a mid-month hire or mid-year hire, checking the **Include partial accruals** box lets the rule automatically calculate a prorated amount of accrual based on hire timing.
6. Check the **Consider the exact number of days in a month for partial accruals** box to base calculations for partial accruals on the exact number of days in any particular month.
  - If this option is selected, the partial transactions and prorated accrual calculation considers the exact number of days in each month (for example 31 days in January, 28 in February).
  - If this option is not selected, the partial and prorated accrual calculation is based on an average 30-day month.
  - This setting requires the **Include partial accruals** box to be checked.

 **Important:** It is important to set the "Apply after" date to exclude old transactions. In most cases the date should be set to the day that the option is being activated, so that it doesn't affect anything in the past.

7. Check the **Create transactions for employees only during dates where they are assigned to the rule** box to create closed accrual leave periods.

Closed accrual leave periods can be created to prevent leave accrual transactions from being drawn-down against a closed period.

- All the accruals/draw-downs will only be created against this leave accrual rule if created during the duration a leave accrual rule is associated with an employee.
- Transactions created after the rule ends for an employee will be created against the next leave accrual rule its balance transfer progression. If this is the last leave accrual rule in a transfer progression for an employee, the setting is ignored.

**Note:** If the box is not checked, draw-down transactions can be created against this leave accrual rule during the grace period, instead of against the next applicable accrual leave rule. If the **Allow transfer of negative accrual balances** is not checked, these draw-down transactions are never transferred to the new accrual leave rule and lost accrued time may be higher than expected in the new accrual leave rule.

**Important:** It is important to set the “Apply after” date to exclude old transactions. In most cases the date should be set to the day that the option is being activated, so that it doesn’t affect anything in the past.

8. Check the **Allow transfers of negative leave accrual balances** box to enable the transfer of negative balances to the next accrual rule.

**Important:** It is important to set the “Apply after” date to exclude old transactions. In most cases the date should be set to the day that the option is being activated, so that it doesn’t affect anything in the past.

9. From the Draw-down section, select how entered time is applied against the leave accrual: by Time type, Service, Project, or Task. These items are typically associated with a Time off or PTO project that has been set up within the Projects application. Choose when the draw down is generated, either when the leave accrual is run or when a timesheet is approved.

**Draw-down**

An approved time entry that matches all of the filter conditions will generate a draw-down.

Time type	> Create	Generate the draw-down when

Modify draw-downs when an approved timesheet is changed  
Draw-downs will be deleted if a timesheet is un-approved.

**Note:** As an account administrator, you can set Leave accrual rules to run on a schedule or run them manually.

10. Check the **Modify draw-downs when an approved timesheet is changed** box if you want any changes to approved timesheets to be reflected in the draw-downs, or to delete the draw-down if the timesheet is unapproved.

**Note:** If you select the **A timesheet is approved** option, draw-down transactions are created immediately upon timesheet approval. As timesheets may be unapproved for corrections, review the Timesheets Settings > Other settings to determine whether the leave accrual transactions will auto-adjust or require manual interaction for corrections based on timesheet changes. See [Other Settings](#).

11. Enter any Notes if required. Check the **Exclude inactive employees** box to apply the rule only to active employees when running leave accrual.
12. Click Save.

**To associate rules to an employee:**

1. Go to Administration > Global Settings > Users > Employees. Select a Employee ID.
2. Click on the Leave accrual link. See [Leave Accrual](#).

- For each applicable rule, select the rule and enter the Start Date and End Date into the leave accrual row. When the rules are run, employees with the defined rules will have their accruals and draw-downs adjusted per the rule definitions. Each rule is named and includes the following:
  - Accrual definition
  - Draw-down definition

**Note:** Editing existing leave accrual rules may affect existing historical balances of your employees. If you need to change your policies, you should contact SuiteProjects Pro Support or SuiteProjects Pro Professional Services for assistance.

## Run Leave Accruals

The Run leave accrual form provides you, the account administrator, with the ability to run the defined Leave Accrual rules on demand or have them scheduled to be run on a regular basis. When you set up the leave accrual rules, you determine how running leave accruals impacts leave accrual balances. Draw-down transactions are created by the run leave accruals action if the rules have defined this as the method to create the transactions. Otherwise, approved timesheets automatically create the transactions so draw-downs and balances are current.

### To Run leave accruals:

- Go to Administration > Application Settings > Timesheets and select the link to Run leave accruals. The Run leave accrual form provides the ability to run defined Leave Accrual rules on demand or have them scheduled to be run on a regular basis.

## Leave Accrual Balance and Transactions

The Leave Accrual feature lets:

- All users view their leave accrual balance.
  - From the Home page, by clicking the **Current leave accrual balances** link in **My status** widget.



- From the timesheet grid of an open timesheet, by clicking the **Current leave accrual balances** link in the contextual tips menu.
  - From Timesheets > Leave accrual > Current balance.
  - Account administrators can use role permission to control who can:
    - View the user's own leave accrual transactions.
    - View leave accrual transactions (the user's own and those of other users).
    - View and modify leave accrual transactions (the user's own and those of other users).
- Users with any of these permissions can access accrual leave transactions from Timesheets > Leave accrual > All transactions.
- Account administrators can view and modify leave accrual transactions.

To enable this feature, go to Administration > Application Settings > Timesheets > Other settings and check the **Enable the leave accrual** feature box. See [Other Settings](#).

Leave accruals provide a method of tracking and maintaining employees' time off. Time can be accrued or earned as a specific type of time off which may then be drawn down when taken or used by the employee. You can enter leave accrual transactions manually or set up SuiteProjects Pro to calculate time-off entitlement and draw-downs automatically for employees using leave accrual rules. See [Leave Accrual Rules](#).

Although manual leave accrual transactions are allowed, the key to a successful implementation of the Leave Accrual feature is the setting up of rules, which are then applied to employees. The rules control the accrual amounts and draw-down specifics depending on the rule setup for Time Type, Service, Project, or Task. However, you may need to modify leave accrual transactions if the transactions was created against the wrong leave accrual rule because of an incorrect leave accrual set up, for example. You may also need to create a leave accrual transaction manually to adjust the leave accrual balance.

### To create a leave accrual transaction:

1. Go to Timesheets > Leave accrual > All transactions.
2. Select **New transaction** from the **Create Button**.
3. Choose the transaction **Type**, either Accrual or Draw-down.
4. Enter the **Date** and **Hours** for the transaction.
5. Select the **Employee** for which this leave accrual transaction applies and the **Leave accrual rule**. If you have not previously created rules, see [Leave Accrual Rules](#).
6. Add **Notes** as desired.
7. Click **Save**.

## Alerts


This functionality lets you send automated email reminders to ensure that company policies are followed, time is entered and submitted on time, and approvals are completed. Multiple alerts of each type can be set up to meet varying business needs. Refer to the following types of alerts.

- **Timesheet alerts** — can be configured by administrators to alert employees about late timesheets, overdue approvals or unsaved time entries.
- **Late timesheet alerts** — are used to notify employees when timesheets meeting certain criteria are late. To ensure accuracy and timeliness in billing, most companies find it critical to get timesheets in on time. Late timesheet alerts are the most commonly used alerts.

- **Overdue approval alerts** — are useful for managers who must approve time, but who may not be regular users of SuiteProjects Pro. An overdue approval alert can remind those employees who do not sign in regularly that there are timesheets waiting for their approval.
- **Unsaved time entry alerts** — are most often used in companies where time must be entered on a daily basis. These alerts can be used to remind employees on a periodic basis that time entry is due.

### To create a timesheet alert:

1. Go to Administration > Application Settings > Timesheets > Alerts.
2. Select the type of alert you want to create from **Create Button**. The corresponding alert form will open.
3. Name the alert.
4. Under Alert runs on, select the day and time when the Alert should run.
5. Under Rule, define the appropriate selection rules for why the employees would receive an alert and which employees will receive alerts.
6. Use Email notification, define the email sender, subject and text, and decide whether to copy other employees on the alert email.

 **Note:** Depending on your account configuration, sending system-generated email from a custom address may not be permitted. When this is the case, a note under the text box advises you so, and email is sent from [www@openair.com](mailto:www@openair.com). See also [Email Settings](#).

7. Add notes, as desired. These notes do not appear anywhere in the alert; they are for informational purposes, such as remembering why the alert was created.
8. Select Active alert to make this alert active.
9. Click Save.

## Other Settings

The Timesheet application has many configurable parts including add-on functionality and interaction with how you are performing your resource and project management. Many timesheet options depend on whether other features are activated.

### To access the Timesheet Other settings:

1. Go to Administration > Application Settings > Timesheets > Other settings.

**Timesheet Duration:** Timesheet entry is defaulted to a single time period for submission (as selected from the drop-down list). This duration can be overridden on the Employee Demographic form if you have different offices or departments that adhere to different time policies. To enable the override on an employee basis, [Creating a Support Case](#) and request the following switch be enabled: Allow the Timesheet duration to be set at the employee level.

**Location of the "Save" button on the grid:** When your employees have created a timesheet, the timesheet displays allowing data entry. Employees have the ability to save in-progress timesheets and edit them later before completing submission. You have the ability to place where the save button appears on the timesheet. This setting cannot be overridden by an employee preference although employees do have the ability to add additional save buttons to the top right of the forms.

**Number of rows to display in timesheets notes fields:** Each time entry cell has a blue dot next to it which, when selected, displays a pop-up window that includes a description and a notes field. The number of rows selected for this option reflects the number of lines displayed in the notes area of the pop-up

window. This is not a data entry restriction value, only a display value before you must scroll down should the employee have entered more information than can be displayed.

**Width of the hourly cells on a timesheet:** The time entry cells within a timesheet must be at least 2 digits wide to accommodate a time entry. Depending on how many digits you expect to be entered on a regular basis, you may want to increase the value to 3 or 4.

**Show the time type drop-down on the main worksheet:** Time types are used to identify types of time entries such as leave time, holiday, billable, shift work, etc. If your company has decided to use time types, then this feature should be activated to capture the time type value during timesheet entry. If your time types are limited to use within an employee's work schedule (such as holiday or outages), then it may not be necessary to display the field on timesheet entry as the work schedule would handle tracking of the time type value. See [Time Types](#).

**Hide the time type drop-down in the popup window:** The notes option next to each time entry cell displays a time type drop-down menu unless this option is selected. There is no dependency with the time type being viewable on the timesheet.

**Show the customer/project drop-down on the main worksheet:** When selected, the employee can enter time against a specific Customer : Project combination (or customer only if the options to view customer only in drop-downs has been selected). The list of projects displayed is controlled by project viewing options such as all projects, specific projects, assignments, ownership, and bookings.

**Show the customer/project and the task drop-down on the main worksheet:** When selected, an additional field for task is displayed along with the Customer : Project drop-down list. The list of tasks displayed is controlled by project assignment and booking options.

**Show the service drop-down on the main worksheet:** Services are specific activities that you offer to customers which may be used to invoice your customers or used for finance account allocation. In some accounts, they are called activities. If your company has decided to use services, there are many areas in SuiteProjects Pro where the services value can be set as a default for timesheets. See [Service](#).

Activating this feature supplies another field containing the service values on the timesheet, which give control to the employee for selecting the proper value. The ownership of the field setting should be reviewed according to how the Service field is used. If it is used to perform billing or allocations to financial accounts, you may prefer to have the field setting controlled by the project setup process and not overridden by the end-employee.

**Show the payroll type drop-down on the main worksheet:** If your company has decided to use payroll types, activate this feature to allow entry by the employee on timesheets. If not enabled, and your account uses payroll types, they display in a list in the Notes pop-up window. See [Payroll Types](#).

**Show the Project job code drop-down on the main worksheet:** Job codes classify employees into general job positions defined by your company. See [Job Codes](#).

**Show time remaining estimate input on the main worksheet:** When selected, the **System estimate (hrs)** field shows the latest estimated hours value for the task, minus the hours entered against it in the timesheet.

**Require a time type on time entries:** If you have implemented time types and displayed them for entry on the timesheet, this option lets you make this field required for all employees. This requires you to define a complete set of time types so that a valid value is always able to be selected for any type of time entry. This option is dependent on the **Show the time type drop-down on the main worksheet** option being selected. If the show time type option is not active, this option has no impact.

**Require a customer/project on time entries:** If you have displayed Customer : Project (and possibly customers only depending on the show customer name option) for entry on the timesheet, this option will allow you to make this field required for all employees. This option is dependent on the **Show the customer/project drop-down on the main worksheet** option being active. If the show customer/project option is not active, this option has no impact.

**Require a service on time entries:** If you have implemented Services and displayed them for entry on the timesheet, this option lets you make this field required for all employees. This option requires you to define a complete set of services so that a valid value is always available to be selected for any type of time entry. See [Service](#).

**Require a description on time entries:** The description field is an additional field to the notes field that is available for each time entry cell by selecting the dot next it. Setting this option requires the entry of a description for each entry on a timesheet.



**Important:** This impacts the time it takes to enter data should employees be required to enter multiple time entries for projects across multiple days of work.

**Require a payroll type on time entries:** If you have implemented payroll types and displayed them for entry on the timesheet, this option lets you make this field required for all employees. This will require you to define a complete set of payroll types so that a valid value is always available to be selected for any type of time entry. See [Payroll Types](#).

**Require a task on time entries:** If you display a task for entry on the timesheet, this option lets you make this field required for all employees.

**Show only customers and projects with open tasks assigned to the employee:** Tasks have an open/closed flag to provide Project Managers control over completed or in-progress service on a project. Depending on how you are assigned or allocated to projects and tasks for time entry, the activation of this option shows only Customer : Project with open tasks available for time entry.

**Show only customers and projects with open tasks booked to the employee:** Tasks have an open/closed flag to provide Project Managers control over completed or in progress service on a project. Depending on how you are booked to projects and tasks for time entry, the activation of this option shows only Customer : Project with open tasks that you are booked for available for time entry. If this option is not enabled, then any Customer : Project with tasks booked to you for time entry is displayed including those with all closed tasks. This, in turn, enables the entry of time against closed project tasks.



**Important:** If the Access All Tasks optional feature is enabled for your account, employees have access to, and can enter time against all tasks in the project if they are booked to an open task in this project. See the help topic [Access All Tasks](#).

**Display schedule exception information from the associated company work schedule of the timesheet employee:** This option lets you display any schedule exceptions within the timesheet. These are most often company holidays on the company work schedule. The display is handled by highlighting the date column title in the timesheet and adding a footnote indicator, which is defined in the contextual tips menu. The footnote definition is taken from the description field of the schedule exception.

**Display schedule exception information from the work schedule and associated company work schedule of the timesheet employee:** This option lets you display any schedule exceptions within the timesheet. These are most often company holidays on the company work schedule. Other exceptions noted in the employee's personal calendar, such as vacation or leave time, are displayed as well. The exception information is derived from any schedule exceptions input on the company workschedule associated to the employee record, as well as any exceptions input on the employee's personal work schedule directly on the employee record. The display is handled by highlighting the date column title in the timesheet and adding a footnote indicator, which is defined in the Tips area of the SuiteProjects Pro page. The footnote definition is taken from the description field of the schedule exception.

**Allow an approver to edit a submitted timesheet:** When timesheet approvals are used, timesheets are submitted for review by a defined employee or set of employees (approval process) who can then approve or reject the timesheet. To avoid time delays introduced by having a reviewer reject a timesheet then the owner fixing and resubmitting the timesheet, activating this option gives the reviewer the ability to edit the timesheet entries directly before continuing with the approval.

**Hide the description field:** The description field is available for each time entry cell by selecting the dot next to it. Setting this option hides the description field from the pop-up window when the dot is selected, but still displays notes and any other field settings that have been configured. If this option is set, it overrides the "Require a description on time entries" setting.

**Remove blank timesheet rows:** This option will remove blank (empty) timesheet rows from the display and the Timesheet report.

**Preserve row ordering:** Activating this option keeps the time entry rows in the order in which they were entered on the timesheet and does not resort them in alphabetic customer or project order.

**Enable the "Hours remaining" on tasks estimating feature:** Hours remaining are only available if you are assigning employees to individual tasks with an estimate of planned hours/days for each employee on the task. Without this level of project/task information, the hours remaining feature is unable to allocate hours to individuals on timesheet review. When this feature is activated, a new link displays within the timesheet called Hours Remaining. Selecting this link displays to the employee the remaining hours for the task and provides the ability to change the hours remaining value. This adjusts the remaining and estimated hours of the project task within the project plan. There is no impact on the planned hours. Tasks must be displayed on the timesheet for this option to work.

**Require "Hours remaining" estimates for all tasks:** Hours remaining are only available if you are assigning employees to individual tasks with an estimate of planned hours/days for each employee on the task. Without this level of project/task information, the hours remaining feature is not able to allocate hours to individuals on timesheet review. When this option is activated, a new link displays within the timesheet called Hours Remaining. Selecting this link displays to the employee the remaining hours for the task and provides the ability to change the hours remaining value. This value is required for each task identified on the timesheet. Any changes adjust the remaining and estimated hours for the task within the project. There is no impact on the planned hours. The **Enable the Hours remaining** option must be activated and tasks displayed on the timesheet for this option to be available.

**Use the system estimate if "hours remaining" are not entered:** Hours remaining are only available if you are assigning employees to individual tasks with an estimate of planned hours/days for each employee on the task. Without this level of project/task information, the hours remaining feature is not able to allocate hours to individuals on timesheet review. When this option is activated, a new link displays within the timesheet called Hours Remaining. Selecting this link displays to the employee the remaining hours for the task as estimated by SuiteProjects Pro (or the value entered by the Project Manager). A timesheet employee may enter a new value or choose to leave the field blank. A blank entry uses the system estimated value (or the value entered by the Project Manager) of the hours remaining for time entry on the task. This adjusts the remaining and estimated hours within the project task on the project. There is no impact on the planned hours. The Enable hours remaining option must be activated and tasks displayed on the timesheet for this option to be available.

**Get the service from the task if not selected:** This option is dependent on the display of the Service field on the timesheet main. If you have not made this field required, employees may optionally leave the field blank. When activated, this feature ensures every time entry has a Service by obtaining the value from the task if the employee does not override the value in the timesheet. If this option is not activated, then "blank" Service values can be entered against the task. Tasks must be enabled on Projects for this option to be available.

**Always get the service from the task:** If your company uses the Services functionality but does not allow employees to override the value on the timesheets, use this option to ensure the timesheet entry obtains the appropriate service from the project task. Tasks must be enabled on Projects for this option to be available. You should ensure that services are required on tasks if this setting is enabled.

**Do not allow timesheet submission if time is booked to an inactive option:** Employees entering time against Customer : Project (or Customers, and possibly at the task level), are provided a drop-down list of these items based on the timesheet options, such as displaying only Customer : Project with open tasks. This option prevents the submission of a timesheet if the employee was able to view a Customer :

Project task when the timesheet was created, but later the Customer : Project was inactivated before the timesheet is completed and submitted. If this option was not selected and the Customer : Project has been inactivate during the span between timesheet creation and submission, time is allowed to be entered against an inactive project since the timesheet was already in progress.

**Do not allow timesheet submission if time is booked to a closed task:** Employees entering time against Customer : Projects (or Customers, and possibly at the task level), are provided a drop-down list of these items based on the timesheet options, such as displaying only Customer : Projects with open tasks. This option prevents the submission of a timesheet if the employee was able to view a Customer : Project task when the timesheet was created, but later the Task was closed before the timesheet was completed and submitted. If this option is inactive, time is allowed to be entered against closed tasks provided the task was open when the timesheet was created.

**Do not allow timesheet submission if time is not booked to a task:** This option prevents a timesheet submission if a time entry is not recorded to a task on a project. You should enable this option if you are tracking time to the task level.

**Enable the time type default when creating a new timesheet:** When creating a Timesheet, the timesheet form asks for basic information such as the period date. This option provides the employee a default Time type field, which pre-populates all timesheet rows with the selected time type value. This option is useful when the option to enter time types on the timesheet has been activated.

**Enable the customer:project default when creating a new timesheet:** When creating a timesheet, the form asks for basic information such as the timesheet start date. This option also provides the employee a default Customer : Project field, which pre-populates all timesheet rows with the selected Customer : Project value. It is useful when the option to enter Customer : Project on the timesheet has been activated.

**Enable the service default when creating a new timesheet:** When creating a timesheet, the timesheet form asks for basic information such as the timesheet start date. This option also provides the employee a default service field, which pre-populates all timesheet rows with the selected service value. This option is useful if the option to select a service on the timesheet has been activated. See [Service](#).

**Enable the payroll type default when creating a new timesheet:** When creating a timesheet, the timesheet form asks for basic information such as the timesheet start date. This option also provides the employee a default payroll type field, which pre-populates all timesheet rows with the selected payroll type value. This option is useful if the option to enter payroll types on the timesheet main grid has been activated. See [Payroll Types](#).

**Enable time off requests:** The time off request feature enables the submission of schedule changes such as vacation, training, leave time, etc. Several options exist that allow the time off request feature to be used as an employee scheduling tool, a leave time tracking tool, and so forth. Activation of this feature displays another tab within the Timesheet application called Schedule Requests, which can be created and submitted/approved through an approval process. Time off requests interact with timesheets, a employees work schedule, and resource booking according to the various options selected within the Settings form.

**Require a time type on time off requests:** If you have implemented time types and activated time off requests in your environment, this option lets you make this field required for all employees. This requires you to define a complete set of time types so that a valid value is always able for selection on any type of time entry.

**Require a customer/project on time off requests:** If you have implemented project-based time tracking and activated time off requests, this option lets you make Customer : Project selection required for all employees. Such a Customer : Project selection is typically something like [Company Name] : PTO project.

**On time off requests, show only customers and projects with open tasks assigned to the employee:** This option, when time off requests are active, prevents an employee from entering a time

off request against a project that has closed tasks. For employees to see projects with open tasks, the employee must be assigned to either the task or the project depending on the assignment options active in your account.

**On time off requests, show only customers and projects with open tasks booked to the employee:**

This option, when time off requests are active, prevents an employee from entering a time off request against a project that has closed tasks. For employees to see projects with open tasks, the employee must be booked to either the task or the project depending on the assignment options active in your account.

**Require a service on time off requests:** If you have implemented services and activated the time off request function, you may require an employee to select a service. The service value entered in the time off request overrides the timesheet default value for the project/task (set within the task) if you include the time off request on your timesheet. If you allow employees to override the service on the timesheet, then the default value displays from the time off request included on the timesheet.

**Require a task on time off requests:** If you have implemented project-based time tracking and activated time off requests, this option lets you make the Task within a Customer : Project selection required for all employees. This option is helpful for time tracking where you are including a variety of choices within a single project (for example, time off categories such as vacation, jury duty, sick time, and family leave).

**Hide the related time off request entry information on the timesheet:** If your process is to have employee enter their time directly within timesheets regardless of the service or pre-approval of time (time off requests), then time off requests can be hidden from timesheets.

**Do not allow time off request submission if time is booked to an inactive option:** Similar to the “show only open assigned tasks on time off requests” feature, this option lets you stop time off request entry against any tasks or projects have been closed while the time off request was being created. You should check this box if you have enabled the open assigned task option.

**Allow an approver to edit a submitted time off request:** When time off request approvals are used, time off requests are submitted for review by a defined employee who then approves or rejects the time off request. To avoid time delays introduced by having the reviewer reject a time off request and then the owner fixing and resubmitting the time off request, activating this option gives the reviewer the ability to edit the time off request entries directly before continuing with an approval. The approver of the time off request is set on the employee record.

**Automatically create schedule exceptions when a time off request is approved:** Schedule exceptions are entries in the employee's personal work schedule or calendar that identify special work schedule situations such as holidays or vacation. Allowing an approved time off request to create an exception automatically adjusts the employee's calendar to remove time off request dates from available hours in the work schedule. Selection of this option impacts how utilization is computed if you have selected Work schedule hours as the denominator in the utilization calculation.



**Note:** This is mutually exclusive with the following switch: Automatically create bookings when a time off request is approved.

**Allow modification and deletion of schedule exceptions created automatically from an approved time off request:** Schedule exceptions are entries in the employee's personal work schedule or calendar that identify special work schedule situations such as holidays or vacation. Allowing the schedule exceptions within the employees calendar to be modified enables adjustments to the employee's available hours. This may impact how utilization is computed if you have selected Work schedule hours as the denominator in the utilization calculation.

**Automatically create bookings when a time off request is approved:** If you are using bookings in the [Resources](#) application to manage your resource allocations and available hours, an approved time off request may create bookings automatically to allocate the employee to the identified Customer : Project (and Task if required in your environment). If this is not selected, then approved time off requests create an exception to the employee's calendar instead of a booking.

**Note:** This is mutually exclusive with the following switch: Automatically create schedule exceptions when a time off request is approved.

**When creating a timesheet, automatically create time entries for bookings:** If you are managing resource allocation with bookings, then you may choose to have employee timesheets prepopulated with the booking hours. This provides information to the employee of expected work for the defined timesheet period. The entry can be modified to reflect the effort performed. When using this option, ensure you are educating your staff on validating the booking entry and not to simply save the prepopulated timesheet.

The feature can also be used to update time entries every time the timesheet is accessed with data from bookings of selected types. To set how time entries are created or updated based on bookings, go to Administration > Application Settings > Timesheets > Timesheet rules.

**When creating a timesheet, automatically create time entries for approved time off requests:** Time off requests that capture time against a Customer : Project (and Task if required in your environment) can be automatically inserted into an employee's timesheet to allow quicker timesheet entry. The time off request appears as the timesheet is created. The values of the time off request hours may be modified prior to timesheet submission. If the timesheet already exists, this option does not add the time off request into the timesheet automatically - a manual entry is required on the timesheet.

**When automatically creating time entries for approved time off requests when creating a timesheet, get missing values from the time off request:** Time off requests that capture time against a Customer : Project (and Task if required in your environment) can be automatically inserted into an employee's timesheet to allow quicker timesheet entry. The time off request appears when the timesheet is created. The values of the time off request hours may be modified prior to timesheet submission.

**Allow time off requests with time entries on approved timesheets to be un-approved:** The correction of a time off request can still be performed if this option is enabled and the time off request has already been added to timesheets. Without this option, modifying the time off request is disabled if you have allowed the time off request to be included in a timesheet.

**Do not allow editing of the timesheet name:** Check this box to disable editing of the default timesheet name.

- When checked:
  - SuiteProjects Pro generates a standard timesheet name when the timesheet is created ("Timesheet 06/03/12 to 06/10/12", for example) and the name cannot be changed.
  - In timesheet lists, column filter and sorting options for the **Name** column, and advanced filter criteria based on the timesheet **Name** are not available as of October 23, 2024. Saved list layouts



or saved filters including filtering or sorting by the timesheet Name can still be used but the filtering or sorting by **Name** is ignored.

- Otherwise (when cleared):
  - Users can set the name of a new timesheet and modify the name of open timesheets they can modify.
  - In timesheet lists, column filter and sorting options for the **Name** column, and advanced filter criteria based on the timesheet **Name** is available.

**Disable overlapping timesheets:** The necessity for overlapping timesheets is typically driven by the need to enter either a correcting timesheet to move hours between projects or to enter two timesheets within a particular week (For example, your company is on a monthly accounting calendar but you have weekly timesheet submissions. You can create two timesheets for the timesheet period, one ending on the last day of the calendar month and the other beginning on the first day of the next calendar month). Disabling timesheet overlapping ensures unique timesheets for each timesheet period.

**Remember the last used "New timesheet" form settings:** This option enables the quick setup of new timesheets by copying or remembering the last default entries in the Create timesheet form.

**Allow empty timesheets:** The use of this option is helpful if you require timesheets to be submitted for every timesheet period, without exception. Subcontractors, who may not have time for the period, would have an empty timesheet submitted.

**Allow zero-hour entries on timesheets:** The difference between this option and the empty timesheet option is this permits the employee to capture notes on a time entry, but does not require the entry of hours to keep the notes in the time entry.

**Sort timesheets alphabetically by customer and project:** As time entries are entered on the timesheet and submitted, the Customer : Project entries are sorted alphabetically within each day instead of the order they are entered.

**Enable the "Save and Submit" button on timesheets:** On the timesheet, the Save button appears to save in-progress timesheets. To submit timesheets, you are required to select the Submit/Approve link. This submits the timesheet for approval. Selecting this option provides a Save and Submit button to appear on the timesheet and reduces the submit action to a single click.

**Enable start and end time entry on timesheets:** Check this box to let employees specify the times of the day when they worked on a particular project. When checked:

- Check **Enable start and end time entry on timesheets** box on the employee demographic form to enable the functionality for an employee.
- Check the **Require start and end times in time entries** box on the employee demographic form if your company requires that the employee specifies start and end times for each time entry. If you check this box, use form permissions to restrict the employee from clearing the **Enable start and end time entry on timesheets** box in their Personal Settings.
- When the functionality is enabled for an employee:
  - You can click the Notes icon and enter a start time and end time for each time entry.



**Note:** The Start and End Time feature lets employees enter a start time and end time for each time entry. It can be used to log start and end time for a portion of the day when the employee worked on a particular project or task.

This is different from the Day Time Card feature which lets employees enter a time card for a full working day with a start time, end time and break start and end times, without providing a breakdown of time worked on each project in the day.

- Users can add a start time column and end time column to the time entry list.



**Important:** You should not check the **Enable start and end time entry on timesheets** box when the feature **Use Days Instead of Hours for All Time Entries** is enabled.

After you enable **Enable start and end time entry on timesheets**, when users enter a start time and end time, the duration is calculated in hours and not converted to days.

**Enable the leave accrual feature:** Leave accrual is a feature focused on tracking leave balances such as vacation and sick time. The feature can track a leave accrual based on the rule setup according to your company policies. For example, a vacation balance may be refilled one time a year or accrued each month at a certain rate per the employee's seniority in the company. A leave balance draw-down is based on time entries against the specific projects or tasks. For example, taking vacation or sick leave adjusts the leave balance.

**On time off requests, display current leave accrual balance to managers for approval:** When the leave accrual feature is enabled, this option displays the submitter's balance on the approval form. This is useful to ensure the employee's request is in compliance with company policy.

**Display the last update date and time below the timesheet worksheet:** Activation of this feature displays timestamp information about the last update performed on the timesheet in the tips area of the timesheet.

**Do not auto-populate description field on time entries from time off requests:** This selection prevents the Description field as entered on the Time off request from populating the Description field on the Timesheet entry. This option is normally selected to allow the employee to enter their own specific descriptions. This is only applicable if time entries are automatically created from approved time off requests.

**Do not auto-populate description field on time entries from bookings:** This selection prevents the Description field as entered on the Booking from populating the Description field on the Timesheet entry. This option is normally selected to allow the employee to enter their own specific descriptions. This is only applicable if time entries are automatically created from bookings.

**Do not auto-populate notes field on time entries from bookings:** This selection prevents the Notes field as entered on the Booking from populating the Notes field on the Timesheet entry. This option is normally selected to allow the employee to enter their own specific notes. This is only applicable if time entries are automatically created from bookings.

**Display all weeks for timesheets containing multiple weeks:** Activation of this feature enables users to work with all the weeks of a multi-week timesheet in the same grid view.

## Frequently Asked Questions (FAQs)

How would I know whether I should have Services set up for my company?

If your company provides standard types of services to customer, you may want to create services in your account. With services, you are able to use these in invoicing by charging a specific rate or a fixed fee. They can also be used for providing a standard description of the work being performed. See [Service](#).

Why would I use Services on timesheets?

This permits the employee to select the specific services they are performing for a customer. These can be used on the invoice. As a caution, enabling services as a selection on the timesheet puts the control of the value in the employee's hands as they would choose the value from a drop-down list. Many companies have the Accounting or Billing Departments control use of the services.

### What benefits are there for using the Leave Accrual functionality?

The Leave Accrual functionality provides a way of tracking employees' time-off for vacations and sick days, etc. A employee's balance can be augmented automatically through Leave accrual rules or manually. The balance is also drawn-down through timesheet entries based upon the rule settings by using Time type, Service, Project, or Task, and manually as well. Employees and management are able to monitor the leave accrual balance providing a real-time view into the status of the account. The balance is visible on the timesheet worksheet, leave accrual edit form and on the employee's Dashboard. The balance can also be reviewed on Employee Detail and Advanced reports. You may also review projected leave accrual balances, which are based on the current balance from previous accruals and draw-downs, future accruals and approved time off requests.

### What are ways to restrict entry of time types?

Work schedule, filter sets, and disable entry on forms.

### When should a time type be used?


When differentiating time for the same project (and possibly task), a time type is required. Examples include: using time types for anything that can impact payroll (overtime, shift work, etc.), impacts financial information (billable vs. non-billable time), or impacts HR leave tracking (for example, vacation, holiday, leave time). Your company may choose one or more ways to use time types. A best practice is to define a specific use for the time type then determine whether control of its use should be given to the employee entering timesheet data.

# Expenses

The Expenses application captures expense reports and accompanying receipts. It also enables authorizations of anticipated expenses. Depending on a company's needs, employees can enter expenses for a week or any duration. They are prompted to enter a start date, description, and notes. As is the case with all fields on all forms, you can mark the description and notes fields as required. Employees also have the option of saving an attachment to an expense report such as a scanned receipt or a receipt within the expense report.

## Expenses

The Expenses application permits the entry of incurred business expenses by employees as well as the ability to receive pre-approval of future expenses using Authorizations, if this feature has been enabled. The entry of expenses by employees themselves or on their behalf by the company lets Accounts Payable process and track reimbursements. Employees may enter expense reports against projects for a specific date or period of time, depending on your account configuration.

An additional option available to employees is the ability to use an expense worksheet for multiple receipts and adjust the order of the fields that display on the form. Go to Expenses > Expense reports and select the Worksheet link. To customize this worksheet, go to the bottom of the form and click the customize link. Worksheet layout options allow employees to streamline the entry of multiple receipts within a single form.

Administrators and users with the **Allow user to delete (individually or in bulk) open, submitted or rejected envelopes** role permission can delete either one or multiple expense reports at a time, if this

feature has been enabled. When an expense report is deleted, all associated expense items, including any receipts and attachments, are also deleted.

## Expense Items

Expense Items are receipts, tickets, statements or other items that contain costs incurred by an employee and are entered into expense reports according to your company's policies and procedures. The expense items are classifications or categories of these costs. Some examples are: Airfare, Lodging, Mileage, and Business Meals. Several common expense items are predefined in SuiteProjects Pro, but you can modify these and create new items to meet your company's needs.

Expenses entered on expense reports may be rebilled to customers through billing rules and recognized as revenue according to your company's policies. Therefore, expense items also appear under the Invoices application.

### To create an Expense Item:

1. Go to Administration > Application Settings > Expenses > Expense Items.
2. Select **New Expense item** from the **Create Button**.
3. Enter the Expense item name and select the Type of expense item, either regular or mileage. A regular receipt is the default receipt form when a new expense report is created. A mileage receipt is a slightly modified form allowing for mileage rates.  
Note: The following provides further explanation.
  - Mileage expense items may also be set as a regular receipt type since the form provides the ability to enter a price per unit, or in this case, \$\$ per Mile. If you are not using the Vehicle feature that requires the mileage receipt type, you may opt to set up all expense items to the regular receipt type and avoid end-employee confusion.
  - Each expense item may have a standard price or the field may be left blank for the employee to enter the price on the receipt form itself. Any time a price, rate, or other financial information is stated in SuiteProjects Pro, you also have the ability to set the currency value if multi-currency is enabled.
  - A Unit Measure indicates the unit for the price and can be any unit you want.
  - A Per Diem box is available to classify this type of expense and it must follow a particular per diem policy.
4. The next section in the form relates to Receipt policy, which controls actions based on the individual receipt and expense item entered into an expense report. You are able to enter parameters for the receipt and select whether to require notes or approval based on the settings. You can also set limits for allowing per diem expense item in expense reports.
5. Under the Other section, you may enter text to be used on proposals in the Opportunities application.
6. Check the Taxable expense item box if tax may be charged to the customer for this expense item. A tax location may optionally be entered by the employee per receipt if this setting is activated. See [Tax Locations](#) and [Tax Options](#).
7. If you would like the expense item price to be required on the receipt, check the box. If your cost center rules for receipts include expense item cost center values, then you need to optionally set the cost center on expense items as well. The cost center field only displays if you have configured the cost center Receipt rules to involve expense items. See [Cost Centers](#).
8. There is an option to control viewing of expense items using Filter Sets. Expense items are one of the data access control objects within a filter set definition. See [Filter Sets Overview](#).

## Expense Report Layout

You can tailor the Expense report layout to meet your company's needs. Since this report form may be routed for review and approval internally, the layout should clearly communicate the expenses that have been incurred. You are able to select the Date format, Starting tracking number, and Grid style. These settings determine the numbering of created Expense reports and the basic style of the expense report.

### To access and modify the Expense report layout:

1. Go to Administration > Application Settings > Expenses > Expense report layout.
2. If you check the **Show the exp report approval history** box, the approval history is displayed to a reviewer at the bottom of the page.
3. If you check the **Show the authorization history** box, the authorization history is displayed to a reviewer at the bottom of the page.
4. If you check the **Show a daily summary by expense item** box, an additional section on the expense report displays summarizing the expense items per day.
5. If you check the **Show link to expense report attachments** box, a link to expense report attachments displays. Reviewers can view or download information.
6. If you check the **Show link to expense report receipt attachments** box, a link to expense report receipt attachments displays. Reviewers can view or download information.
7. If you check the **Show the billable/non-billable totals in the daily summary** box, a split of billable and non-billable expenses are displayed within the daily summary area. This feature makes use of the Billable receipt radio buttons on individual receipts. To enable this feature, [Creating a Support Case](#) and request that SuiteProjects Pro Support enable: Use a radio button to force selection of billable or non-billable on receipts.
8. Enter the Maximum date columns per row in the daily summary. The default is 80. This forces wrapping of the daily summary columns.
9. The last option is to display an overlapping status on the expense report header. This option is only available if your setup has specified expense report durations such as weekly or monthly and you have not disabled overlapping expense reports.
10. Select Receipt order: By date or By reference number.
11. Enter additional employee display information as desired. Select Employee fields > Create. Additional information may include employee cost center or address.
12. Enter notes to display at the end of the expense report, if desired.
13. Select the fields that you would like to display on the Expense report using the drop-down list for each column. The order you set the fields determines the order in which the fields are displayed as columns on the expense report.



**Tip:** If your employees are entering Foreign Currency Receipts, it is helpful to include the original Foreign Currency fields for approvers to use when they are reviewing receipt submission.



**Note:** Configuring text wrap for column headers is not currently supported. However, where column headers contain space-separated multiple words, text wrapping should apply to column headers in the print or PDF version of the expense report.

14. Select the Adobe Acrobat PDF settings you would like to use in your environment. You should print out of a sample Expense Report when the PDF settings are in place to ensure the page layout and margins are set correctly.

## Vehicles

If the Vehicles feature is enabled for your account, you can define vehicles in the Expenses and Invoices application settings.

To enable the Vehicle feature, go to Administration > Global Settings > Optional Features and check the **Enable the Vehicle feature** box.

After one or more vehicles have been set up, the Vehicle drop-down list is available on mileage receipts in the Expenses application and on mileage expense charges you create in the Invoices application.

**Note:** If you have created mileage expense items as regular receipts, the vehicle drop down list is not available. Vehicle designation is only available on mileage receipts. So if your company has a preference to indicate company car usage, for example, the mileage expense item must be created under a mileage receipt type.

### To enter a Vehicle:

1. Go to Administration > Application Settings > Expenses > Vehicles.
2. Select **New Vehicle** from the **Create Button**.
3. Enter the Vehicle name. This could be a name such as Bill White's Ford Taurus, a company vehicle number, or a license plate/tag number.
4. Select the Fuel type and Ownership from the drop-down lists.
5. Enter the Engine size, if known.
6. Click Save.

## Vendors

Vendors are optional in the Expenses application settings. They are primarily used for vendor management and reporting. When a receipt is entered into an expense report, a vendor can be selected. Vendors are also used in the Purchases application.

To enable vendors in the Expenses application, go to Administration > Application Settings > Expenses > Other settings and clear **Hide the Vendor field on receipts** box.

Setting the vendor on receipts is useful for tracking spending at particular vendors to obtain discounts on services or products. Vendors play a much more important role if you use the Purchases application. See [Vendors](#).

### To create a Vendor:

1. Go to Administration > Application Settings > Expenses > Vendors.
2. Select **New Vendor** from the **Create Button**.
3. Enter the Vendor name and the demographic information, if known. The remaining fields on the Vendor form are optional if vendors are only being used within the Expenses application. The address information is used primarily in the Purchases application.

## Payment Types

If the Payment Types feature is enabled for your account, you can define payment types in the Expenses and Invoices application settings. This functionality lets you select a payment type such as Cash, Credit Card, or Check on a receipt in the Expenses application or on an expense charge in the Invoices application.

Payment types are primarily used by your Accounts Payable or Accounting group to indicate how items were paid for by employees as this may determine the categorization of expenses in the accounting system. An example is a company credit card, which indicates the Accounting organization may need to issue a payment to the credit card company instead of the employee, depending on your company's policy regarding use of the credit card. Several common payment types are predefined in SuiteProjects Pro, but you can modify these and create new items per your company's needs.

### To enable Payment types:

1. Go to Administration > Application Settings > Expenses > Other settings and select the switch to **Require a payment type selection on receipts**.

### To create a Payment type:

1. Go to Administration > Application Settings > Expenses > Payment types.
2. Select **New Payment type** from the **Create Button**.
3. Enter the Payment type name.
4. Check the **Active payment type** box.
5. If you want to set this payment type as the default payment type on new receipts, check **Default payment type** box.
6. (Optional) Enter any **Notes** regarding this payment type.
7. (Optional) Select the Default receipt status from the drop-down list. Values are: None, Reimbursable, and Non-reimbursable. The Company credit card example noted above may be set up as a default receipt status of Non-reimbursable if your company pays the company credit cards centrally through your Accounting department.

### To create a Payment type custom field:


1. Go to Administration > Global Settings > Custom Fields.
2. Select **New Custom field** from the **Create Button**.
3. Select Payment Type using the Add a custom field to drop-down list.
4. Under the Type of field to add drop-down, select the type of custom field desired, and click Continue.
5. Enter the Field name and Display name, complete any other necessary fields.
6. Click Save.

## Authorizations

Authorizations request advance approval of future expenses. Employees create an authorization, enter future expenses, and request approval. To use this feature, you must enable expense authorizations.

To enable Expense authorizations, go to Administration > Application Settings > Expenses > Other settings and check the **Enable expense authorizations** box.



 **Note:** Authorizations do not prevent any expense entry.

## Authorization Numbering

When the authorization feature is enabled, a tab displays in the Expenses application for Authorization numbering. In addition, a link for the Authorization numbering form displays under Expenses Settings. Use it to designate an authorization starting number.

### To request an Authorization:


1. Go to Expenses and select **Authorizations New** from the **Create Button**.
2. Type Authorization name/destination.
3. Select currency and type description.
4. Select Customer : Project.
5. Enter dates.
6. Type advance required.
7. Provide any additional information and click **Save**.

## Alerts

The Overdue approval alert functionality lets you send an automatic email reminder to ensure that expense reports are approved in a timely manner.

### To create an Overdue approval alert:

1. Go to Administration > Application Settings > Expenses > Alerts.
2. Select **New Overdue approval alert** from the **Create Button**. The Overdue approval alert form displays.
3. Name the alert.
4. Under Alert runs on, select the day and time when the Alert should run.
5. Under Rule, define the appropriate selection rules for why the employees would receive an email alert.
6. Check the box to specify Employees/Departments in filter and click Create to identify departments and employees to specify who receives an email alert.
7. Use the Email notification section to define the email sender, subject and text, and decide whether to copy other employees on the alert email.

 **Note:** Depending on your account configuration, sending system-generated email from a custom address may not be permitted. When this is the case, a note under the text box advises you so, and email is sent from [www@openair.com](mailto:www@openair.com). See also [Email Settings](#).

8. Add notes, as desired. These notes do not appear anywhere in the alert; they are for informational purposes, such as remembering why the alert was created.
9. Select Active alert to make this alert active.
10. Click Save.

## Other Settings

The Expenses application has many configurable parts including add-on functionality and interaction with how you are performing your resource and project management.

### To access the Expenses Other settings:

1. Go to Administration > Application Settings > Expenses > Other settings.

**Allow an approver to edit a submitted expense report:** When expense report approvals are used, expense reports are submitted for review by a defined employee who then approves or rejects the expense report. To avoid time delays introduced by having the reviewer reject an expense report then the owner fixing and resubmitting the expense report activating this option gives the reviewer the ability to edit the expense report receipts directly before continuing with an approval.

**Require a customer selection on receipts:** If you have displayed Customers : Projects (and possibly Customers only depending on the show customer name option) for entry on the receipt form or expense worksheet, this option lets you make this field required for all employees.

**Require an expense item selection on receipts:** This option requires employees to always select an expense item instead of submitting expenses against a project without an expense item. Expense items must be configured and at least one expense item must be active. If no expense items exist or all are inactive, then this option has no impact. See [Expense Items](#).

**Require a payment type selection on receipts:** This option requires employees to always select a payment type before saving a receipt. Payment types must be configured and at least one payment type must be active. If no payment types exist or all are inactive, then this option has no impact. See [Payment Types](#).

**The 'Company paid' payment type is always non-reimbursable:** The Company paid payment type has special treatment with this option. Payment type and Reimbursable drop-down lists may be displayed on a receipt with each value set independently. Activating this option ensures the selection of the Company Paid payment type sets the Reimbursable value to Non-reimbursable.



**Important:** To use this feature, you must create a payment type exactly named "Company paid".

**Hide the payment type drop-down on receipts:** The payment type field is available on each receipt. Setting this option hides the field from data entry.

**Enable expense authorizations:** The expense authorization feature lets employees request approval for an anticipated expense. When activated, another tab displays in the Expenses application named Authorization. Employees may create and submit expense authorizations citing the anticipated expense and expected amount. The authorization can then be submitted and reviewed through a defined expense authorization approval process. When approved, an expense authorization may then be included on an expense report to show pre-authorization of the expense.

**Allow an approver to edit a submitted expense authorization:** When expense authorization approvals are used, expense authorizations are submitted for review by a defined employee who then approves or rejects the expense authorization. To avoid time delays introduced by having the reviewer reject an expense authorization then the owner fixing and resubmitting, activating this option gives the reviewer the ability to edit the expense authorization entries directly before continuing with an approval.

**Hide the "Advanced required" field on expense authorizations:** The Advanced required field is available on each authorization to allow employees to note that a cash advance is required to complete the expense purchase. Setting this option hides the field from data entry.

**Hide the "Reimbursable/Non-reimbursable" drop-down on receipts:** The Reimbursable/Non-reimbursable field is available on each receipt. Setting this option hides the field from data entry. If you display the payment type on expense receipts, you may want to include this field as well or allow the payment type of handle the designation of reimbursable/non-reimbursable.

**Hide the "Expense item location" field on receipts:** The Expense item location text field is available on each receipt to allow employees to note the location of the expense such as the destination of an airline ticket to complete the receipt entry. Setting this option hides the field from data entry.

**Hide the "Vendor" field on receipts:** The Vendor field is available on each receipt to allow employees to note what vendor will be supplying the specific expense item. Setting this option hides the field from data entry. Vendors must exist in your company's SuiteProjects Pro account and have at least one active if Vendor is displayed on receipt. See [Vendors](#).

**Hide the "Cash advance" field on expense reports:** The Cash advance field is available on each receipt to allow employees to note the amount of a cash advance provided by the company for the specific expense item. Setting this option hides the field from data entry. If authorizations are used and the 'Advanced required' field is displayed on the authorization, including this field on the receipt permits a process check within accounting.

**Allow receipts to be associated with tasks:** In addition to submitting an expense against a Customer : Project, you may allow employees to enter receipts against a specific task. This is useful if you are tracking deliverables and the cost involved in completing the deliverable such as postage and reproduction costs. If you select this option, a task drop-down list displays on each receipt.

**Require a task selection on receipts:** If you have selected the option to allow tasks to be associated with a receipt, then this option lets you make the task drop-down selection required instead of optional.

**Make the exp report tracking number read-only:** Expense report numbering starts at 1 with an increment of one for each new expense report. The expense report number may be edited unless this option is selected, thereby making the field read-only.

**Allow non-billable receipts:** The receipt form includes a **Billable** box if this option is selected. This lets employees note that the receipt billable or not.

**Do not default receipts to the current date:** The date field on receipts defaults to the current date unless this option is selected. When this option is selected, the date field is left blank and is a required field for entry before a receipt form can be completed.

**Show only customers and projects with open tasks assigned to the employee:** Tasks have an open/closed flag to provide project managers control over completed or in-progress service on a project. Depending on how you are assigned or allocated to projects and tasks for expense entry, the activation of this option shows you only a Customer : Project with open tasks available to you for expense entry.

**Show only customers and projects with open tasks booked to the employee:** Tasks have an open/closed flag to provide Project Managers control over completed or in progress service on a project. Depending on how you are booked to projects and tasks for expense entry, the activation of this option shows only Customer : Project with open tasks that you are booked for available for expense entry. If this option is not enabled, then any Customer : Project with tasks booked to you for expense entry is displayed including those with all closed tasks. This, in turn, permits the entry of expenses against closed project tasks.



**Important:** If the Access All Tasks optional feature is enabled for your account, employees have access to, and can enter expenses against all tasks in the project if they are booked to an open task in this project. See the help topic [Access All Tasks](#).

**Do not auto-populate description field on receipts:** The description field on receipts is an additional text field to the notes field. By default, it displays the name of the selected expense item or is blank if you do not require an expense item on the receipt. Selecting this option keeps the description field blank regardless of the expense item selected.

**Enable line item rejections of receipts:** If you have enabled expense report approvals, the expense report is submitted and reviewed/approved using the expense report approval process. By default, all receipts are included in an expense report rejection. Activation of this option enables each receipt to be individually rejected if necessary to expedite the expense approval. Rejected receipts are removed from the approved expense report and placed into a newly created expense report entitled Rejected receipts from xxxx where xxxx is the expense report name of the original expense report. The newly created expense report must be submitted by the expense report owner for re-review after correcting the issue which caused the rejection.

**Enable the missing paper receipt feature:** When you enable this feature, a **Missing paper receipt** box is available on the receipt form or worksheet. This feature is useful to Accounts Payable if you submit receipts with the expense report and a reconciliation effort is done against the receipts entered on the expense report.

**Always display the "Save and create another" button on receipts:** A Save button is displayed at the bottom of the receipt form. Selection of this option also displays a 'Save and create another' button next to the save button, which enables quick creation of receipts.

**Minimum amount required to submit an expense report:** Expense reports by default can be submitted for any amount. If your policies require a minimum, enter the amount in this field. The default currency for your company's SuiteProjects Pro account is used to define the currency type of this amount field, for example, USD.

**Foreign currency receipt type:** This field setting lets you designate how exchange rates are used on Foreign Currency receipts.

**Foreign current receipt markup (%):** Entry of a value in this field applies a markup to Foreign Currency receipts. The percentage value to enter is an integer value, for example, enter 5 for 5 percent. Markups are useful if you are using a non-modifiable Foreign Currency receipt type setting, but your account wishes to reimburse or bill a higher amount to cover conversion costs.

**Default to expense worksheet when viewing an expense report:** The expense worksheet is an alternate way to enter receipts into an expense report. When you select this option, the expense worksheet appears when you go to an existing expense report, instead of the receipts form.

**Default expense worksheet quantity to 1 for new receipts:** The quantity field is left blank for entry on the expense worksheet. When this option is selected, the quantity field is populated with a default value of 1, which lets employees tab over the field if this quantity is valid for the receipt row being entered. This saves time on data entry.

**Add receipt custom fields to expense worksheet:** If you have created custom fields for receipts, you may also have these fields display on the expense worksheet for data entry. The custom fields are not automatically included in the expense worksheet unless this checkbox is selected.

**Enable the "Save and Submit" button on expense worksheet:** A Save and Submit button appears on the bottom of the expense worksheet.

**Lock expense worksheet columns during horizontal scroll:** Locks the columns on the expense worksheet to allow horizontal scrolling to keep left-most data visible. The numbers in the drop-down list relate to column numbers, for example, Number 2 relates to column 2 on the expense worksheet.

**Expenses are paid by:** A specific employee may be designated in this field. That employee will receive an email when any expense report in the system is fully approved.

## Expense Attachment Deletion Wizard

You can use the Expense report attachment deletion wizard to delete expense attachments from SuiteProjects Pro and free some of your account storage space. The wizard lets you delete files attached

to expense reports and to receipts within these expense reports. To access the wizard go to Home > Home and click **Expense report attachment deletion wizard** in the Wizards portlet.

You need to specify:

- A date range — Attachments will be deleted only if the expense report date is within the specified date range.
- An expense report status — You can choose to delete expense attachments for reimbursed expense reports only or approved expense reports only.





**Important:** After you delete an attachment from SuiteProjects Pro, it cannot be recovered. Only delete attachments if you have downloaded them using the Automatic Backing Service, and if you are confident that you no longer need to match an expense with that attachment.

The Projects module holds the project plan, the work breakdown structure, personnel assignments, financial information including billing and recognition rules, and reports. Customers enter and maintain specific project plan information and outline the work breakdown structure in detail. They can categorize projects into different project stages such as Statement of Work, Internal, Templates, Proposed, Active, In Progress, and Closed or Complete. Remember, all terminology can be customized to meet the unique needs of your company.

## Projects — Introduction

The Projects application is one of the primary components in SuiteProjects Pro. This is the application where you manage your company's projects. There are several configuration settings and data elements

associated with the Projects application. The features and flexibility within this application are probably greater than any other application in SuiteProjects Pro.

Within the Projects application there are additional options to configure application-specific items such as the task worksheet within projects and the automated running of billing or recognition rules.

You are also able to evaluate the status of projects using Earned Value Management (EVM) metrics, and to determine if the project is profitable or unprofitable, and whether it is on schedule, behind schedule, or ahead of schedule. To use these metrics, you must have designated a cost for each resource, have a project plan established, and have the resources' time entered by project as time is incurred.

## Project Status Summary (PSS)

Use Project Status Summaries to produce project status pages that summarize important project progress data. The project status summary can be customized and can be populated with information critical to your company internally or your customers externally.

There are three ways to go to the Project Status Summaries:

- Point to any element which opens a project QuickView and click **Status summary**.
- In any project QuickView, click the  icon in the upper right corner.
- Go to Projects > Projects and select a project. In the Project Dashboard, click the  icon next to the project name.

## Using Project Status Summaries

Each Project Status report can contain a header with basic information about the project. The default project header can be modified or deleted.

## Editing Project Status Summary Layouts


### To edit the Project Status Summary layout:


1. Click the **Options**  icon and click **Edit**.
  - To add a new portlet, click the **Add new portlet**  icon and select the type of portlet to add. Enter a Label and Description for the portlet. You can also select if the portlet is visible in Customer View.

If the portlet is a dynamic portlet, you can select up to three fields to sort individual portlet cards by. Drag the fields to change their order, or click the **Remove**  icon to remove the field from the portlet. Click the **Ascending order**  or **Descending order**  icon to set the sorting order.






 **Tip:** You should set a sorting order for the content of dynamic portlets; without a set order, portlet cards are ordered randomly.


Click **Apply** to add the portlet to the Project Status Summary.

 **Note:** Some portlets require that you have the correct account settings or roles before they can be added to a Project Status Summary. If you are unable to add a desired portlet to your Project Status Summary, confirm with SuiteProjects Pro Support that you have all of the required features or roles to add the portlet. For example, to add the “Bookings” and “Task Assignments” portlets, the “Enable approvals for Bookings” and “Enable Task Assignment Lists” features must be set for your account by SuiteProjects Pro Support.

- To add a field to a portlet, click the Add item  icon within the portlet and select the field to add. Enter a title for the field, or leave it blank to use the default title. Select an optional footnote for the field (footnotes can contain information from a data source or custom text which you enter yourself). You can also select if the field is visible in Customer View, and limit the field to particular roles. Click **Apply** to add the field to the portlet.
- To place an item in a portlet card header in a dynamic portlet card, drag the item from the card body to the card header.

 **Note:** You can place multiple fields in a portlet card header.

- To move a portlet, drag it to a new location in the Project Status Summary.
- To edit an existing portlet, click the **Edit portlet**  icon at the top of the portlet.
- To make a portlet visible or to hide a portlet in Customer View, click the **Hidden**  or **Visible**  icon at the top of the portlet. Alternatively, click the Edit portlet icon and select or clear the **Visible in Customer View** option.
- To delete a portlet, click the **Delete this portlet**  icon.
- To add filters to a portlet, click the **Define how cards are filtered**  icon. Click the **Add Condition** button to create conditions to filter by. Click **Apply** to apply the filter.

 **Tip:** You should use filters in dynamic portlets to get the most targeted data.

## Project Status News Feed

Add, update, and display project status messages to keep project stakeholders informed.

When this feature is enabled:

- Project record headers and project QuickViews show a news feed icon . Click this icon to open the project status news feed, where you can add status updates to your project or read existing updates.

- You can add the **News feed — Status** column to your lists.
  - The **News feed — Status** column shows the project status as a color coded text badge, if there are any status updates for the project and if a project status is set in the latest status update.
  - Click the status to open the project status news feed from the projects list and view the latest status update details. You can sort and filter your data by status using the list sort and filtering options.

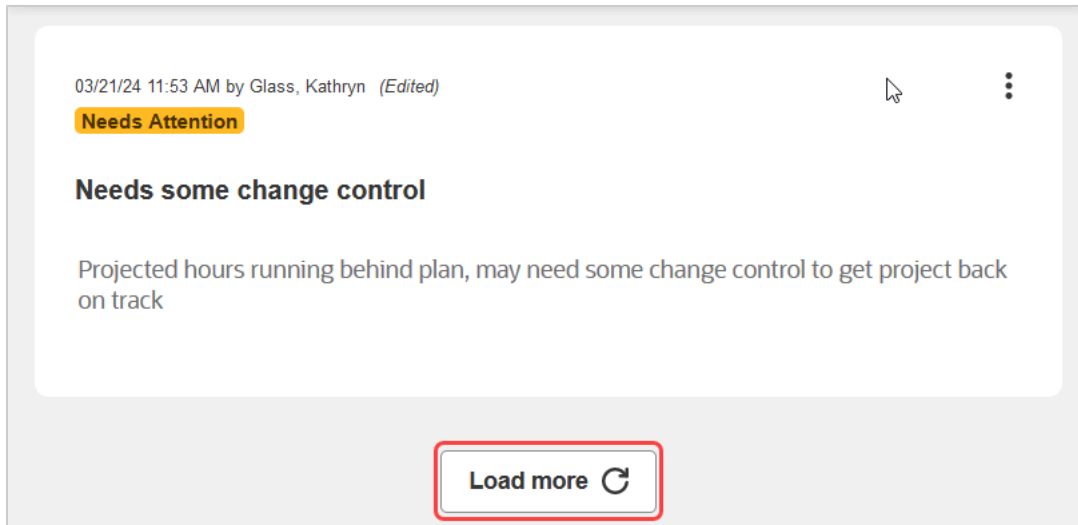

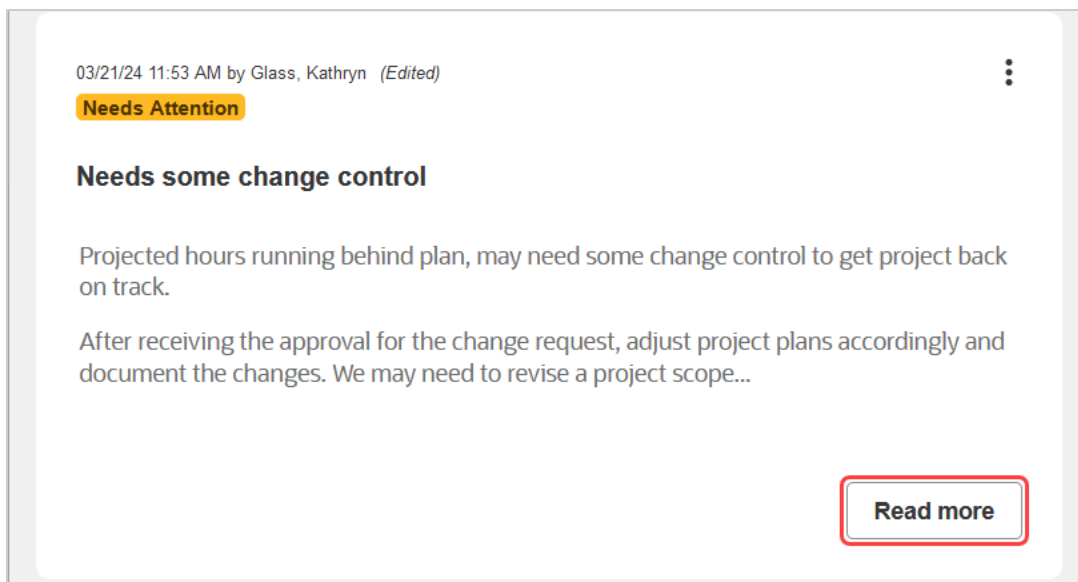

- **View and modify project status news feed on any project** – Users with this role can see the project status news feed and add, edit, or delete messages in it.


 **Note:** Project owners can add, view, modify or delete news feed messages for the projects they own even if they do not have this permission.


 **Note:** To enable the Project Status News Feed feature, contact SuiteProjects Pro Support.




## Adding a Project Status Update

If the Project Status News Feed feature is enabled for your account and you have the relevant role permissions, you can add status updates for your projects.

### To add a project status update:

1. Go to Projects > Projects > *[Select a project]*.
2. Click the news feed icon .

3. Click the  icon in the top right corner of the project status news feed panel. The New Status Update window appears.
4. (Optional) Enter a **Title** for the status update. The title is limited to 125 characters.
5. Select a **Status** from predefined options.
6. Enter the **Status message**. The main text box uses a rich text editor with the following functionality:

- Add emphasis to text using bold **B**, italic *I*, or underlined U character styles
- Format text as a bullet list  or a numbered list 
- Insert a link 

You can insert a link to:

- A URL – Select URL from the dropdown and enter a URL, then click the green tick mark. The URL must not include the `openair.com` or `netsuitesuiteprojectspro.com` domain. When clicked, the URL will open in a new browser tab.
- An Email address – Select Email from the dropdown and enter an email address, then click the green tick mark. You can also enter a subject line and a message body. When clicked, a new email will open in the user's default application for mailto links. The email is prepopulated with the email address, subject line and message body.

You can also select an existing link in the status message and edit it or remove the link (unlink).

At the bottom right of the form are two buttons: 'Discard' and 'Save & Publish'.

7. Click **Save & Publish** to publish your status update, or **Discard** to cancel and return to the project status news feed panel.

## Editing a Project Status Update

If you have the relevant role permission, you can edit project status updates at any time.


**To edit a project status update:**

1. Point to the upper right corner of the status update you want to edit and click the options icon  which appears.
2. Click **Edit**.  
The Edit status update window appears.
3. Make the necessary changes, and click **Save & Publish**.

## Deleting a Project Status Update

If you have the relevant role permission, you can delete project status updates at any time.

### To delete a project status update:

1. Point to the upper right corner of the status update you want to delete and click the options icon  which appears.
2. Click **Delete**.  
A confirmation dialog appears.
3. Click **OK**.

## Updating the Project Status News feed using the SOAP API, XML API or User Scripting

You can customize the project status news feed using the SOAP API and XML API. The APIs support reading, adding, modifying, upserting, and deleting news feed entries. For more information, see [Newsfeed](#), [NewsfeedMessage](#) and [Project](#).

You can also use the user scripting features to generate status updates automatically by script using data from SuiteProjects Pro or external applications and share information from project status news feed entries. For more information, see the help topic [User Scripting](#).

## Outline, Gantt, and Task Detail Views

The Outline and Gantt views lets you oversee your project visually, and provides you with a drag-and-drop functionality to reorder tasks or create dependencies between tasks. All of your project's phases, tasks, and milestones are visible in these views. It is possible to use inline editing to change phase, milestone, or task names; predecessors; IDs; or start and end dates. You can edit selected tasks or phases in the Task Detail view.

The Outline, Gantt, and Task Detail views can be found at Projects > Projects and clicking on a project name. If you have **QuickViews for Projects** enabled, you can point to a project name and select **Outline** or **Gantt** under Quick navigation > Project. If you have a large monitor, it is possible to view all three views on the same page.

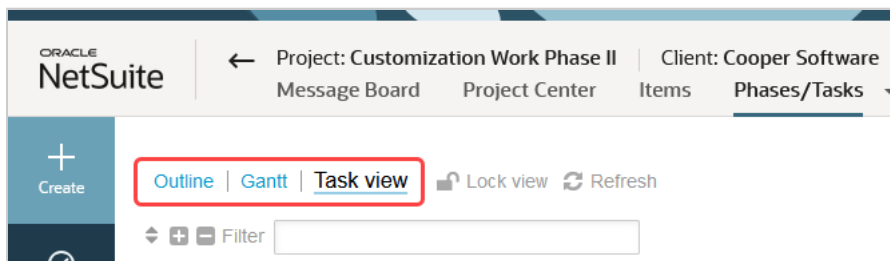
To enable these features, contact SuiteProjects Pro Support and request the **Enable Inline editing, Drag-n-Drop, enhanced Gantt layout in project outline view** switch.



**Warning:** If using the Outline, Gantt, and Task Detail Views, the **Gantt chart reordering sorts task IDs** switch must be disabled.

**Note:** Guest users can be given access to a project's Gantt chart without being given access to task details. When creating a guest role, there is a separate option **Guest can view task details in the Gantt/outline views**. If unchecked, the guest user will see the Gantt chart, but not the links to task details.

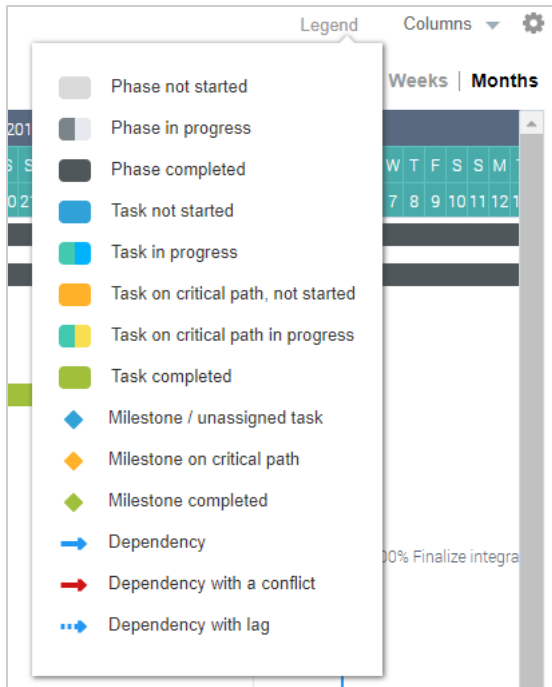
## Navigating Between and Using Outline, Gantt, and Task Detail Views



When you have selected a particular project and chosen phase/task view, you can quickly switch between Outline view, Gantt view, and Task detail view using the navigation pane with the corresponding links.

**Tip:** Clicking on a phase, task, or resource in Outline view highlights it in grey. This highlighted record stays highlighted and in focus whenever you switch views. Furthermore, if Outline and Task Views are displayed together, you can use the up and down arrow keys on your keyboard to scroll through each task form.

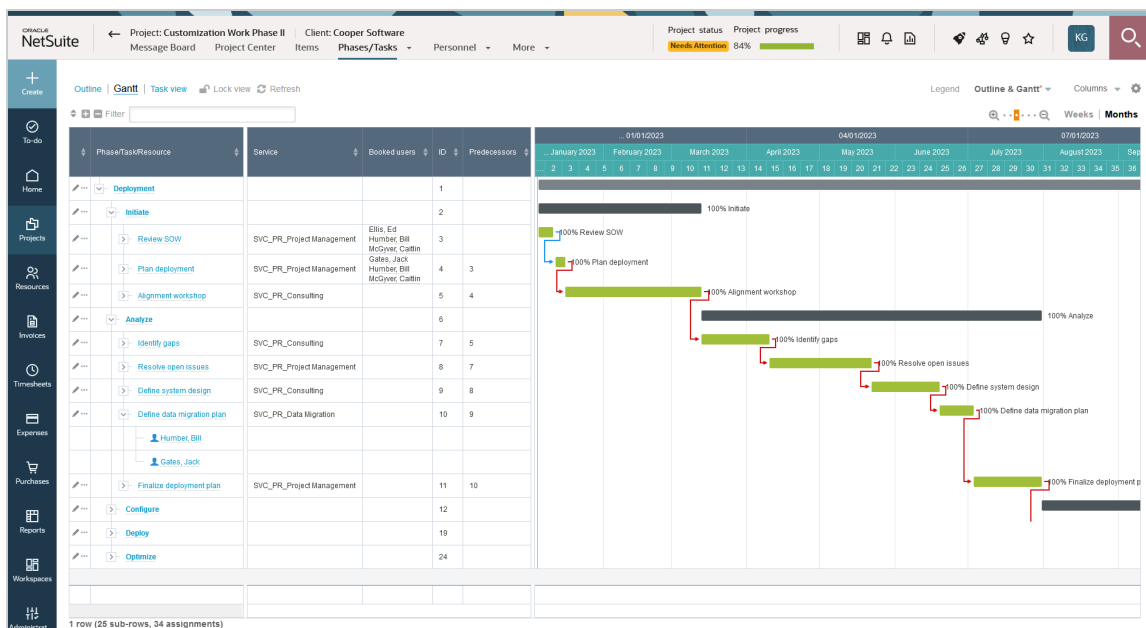
Point to **Legend** in the upper right to open a window describing the various colors and symbols used in Gantt View.







By default, Phases appear grey on the Gantt chart, tasks are light blue, and tasks on the critical path are orange. If you change the duration of a critical path task, it will alter the end date of the project.

Click the Cog icon to open a menu which lets you Customize the list, download list data, or use Task View with Outline View or with Gantt View.

## Customizing Outline and Gantt Views









- You can change the zoom level in Gantt views by clicking the Zoom in or Zoom out icons in the upper right of the Gantt chart.

- You can change the scale to display either Weeks or Months.
- Columns in Outline View can be resized by dragging the column headers' edges.
- The results in each Outline View field can also be sorted. Clicking a column heading makes it the Primary sort criteria. Each time you click a new column heading, it becomes the primary sort criteria and the previous primary becomes the secondary. Clicking a third time sets a new primary, secondary, and tertiary sort field. The Primary sort criteria is indicated by a large green arrow next to the name, the Secondary sort criteria includes a smaller green arrow, and the Tertiary sort criteria uses the smallest green arrow. To sort by the default criteria, click the **Clear sort** icon .
- Click the Expand All  or Collapse All  icon to show or hide Phases, Tasks, and Resources in Outline view.
- Use the Filter to search and display phases, tasks, milestone, and resources with particular text strings in them. For example, if you type "Gate" into the filter field and hit **Enter**, Outline and Gantt views will display projects with names such as "Gate installation" or resources like "Gates, Jack."
- Data in Outline and Gantt Views can be refreshed by clicking the Refresh icon .

## Resource Icons in Outline and Gantt View


Your Outline and Gantt view may include icons next to users assigned to particular tasks. The icons are:

-  **User, Jane** — Active resource currently assigned to the project.
-  **User, Jane** — Inactive resource who is currently assigned to the project. When a resource is inactive, they cannot sign in to your company's SuiteProjects Pro account. These users cannot enter time, expenses, etc.
-  **Analyst [Generic]** — Active generic resource. Use generic resources when you know the type of resource needed but not the specific individual. Generic resources cannot record time or expenses and can only be used for forecasting.
-  **Analyst [Generic]** — Inactive generic resource.
-  **All employees [Assignment group]** — Active assignment group. Assignment groups are useful when there are tasks which need to be assigned to a large number of employees, such as for internal or administrative tasks. The hours set for an assignment group can either be split evenly among the group or kept the same across each employee in the group. Another potential use is for maintaining a group of interchangeable employees with similar skills for use in project tasks.
-  **All employees [Assignment group]** — Inactive assignment group.

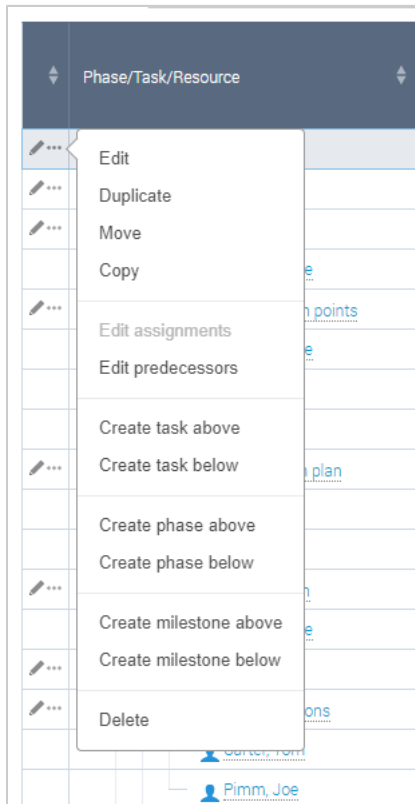
## Creating a Phase, Task, or Milestone in Outline or Gantt View

There are two methods to create a phase, task, or milestone from the Outline or Gantt view.

### To create a phase, task, or milestone in the Outline or Gantt view:

1. Do one of the following:
  - If there is at least one phase, task, or milestone in the Outline or Gantt view, click the more actions icon  on a phase, task, or milestone row, then click an option to create a phase, task, or milestone above or below that row.

**Note:** This method lets you create a phase, task, or milestone without leaving the Outline or Gantt view. You can also use this method to duplicate a phase, task, or milestone, or to move or copy it to another project.



- Otherwise, click the **Create** button, then click **Phase, Task**, or **Milestone** under Task/Phase.

**Note:** This method opens a form and navigates you away from the Outline or Gantt view. To create a phase, task, or milestone without leaving the Outline or Gantt view, use the previous method.

## Editing a Phase or Task in Outline or Gantt View

You can edit phases and tasks and continue working as data is saved and updated in the Outline and Gantt chart. Editing a task and further actions are available when you right-click a task. Phases, tasks, and milestones can be reordered or moved from phase to phase in Outline View by dragging them where you would like. A green check mark indicates valid locations to move the phase, task, or milestone.

## To edit a phase or task:

1. Click the ellipsis icon next to a phase, task, or milestone to open a context sensitive menu from which you can edit phases and tasks and continue working as data is saved and updated in the Outline and Gantt chart. Phases, tasks, and milestones can be reordered or moved from phase to phase in Outline View by dragging them where you would like. A green check mark indicates valid locations to move the phase, task, or milestone.
2. Click the Edit icon next to a phase, task, or milestone to open and edit it in Task view.

Clicking **Edit** in the context menu opens a standard form allowing attributes to be changed. Calculated dates in Outline view can be overridden; hard dates which you enter inline in the Outline or in the task forms are highlighted with green diamonds.

**Note:** Most inline changes are saved immediately, however, if for some reason it is taking longer to save, or if the save is having issues completing, the unsaved changes will be highlighted in purple.

If the **Enable user level outline view** switch is enabled, you can get detailed values for each Assigned To field in both Outline and Gantt views. This information provides an extended overview and understanding of the project and task assignments on a per user basis.

**Tip:** Phases and tasks are stored in the same database table: **project\_task**. The difference is that for a phase, the **is\_a\_phase** field is set to 1 and the **start\_date**, **planned\_hours**, and **percent\_complete** fields do not apply because they are computed from the child tasks.

## Changing Assignments in Outline, Gantt, and Task Detail Views

To modify task assignments click the **Edit assignments** in the context menu or the edit icon . When the option is selected, a standard configuration dialog appears on the right side of the page and details

can be edited according to the current account configuration. After clicking the **OK** button, changes are reflected in the Outline/Gantt view.

## Duplicating and Copying a Task in Outline, Gantt, and Task Detail Views

### To duplicate, copy or move a task:

1. Click the ellipsis icon  $\dots$  next to the task and select **Duplicate** to duplicate a task within the currently selected project.
2. Click the ellipsis icon  $\dots$  next to the task and select **Copy**

to copy a task to a different project. After creating a copy, you can also click **Save and Create another** to make multiple duplicates or copies.

**Note:** Checking **Copy associated billing rules and recognition rules** lets you carry over the corresponding details with the duplicate or copy.

3. Click the ellipsis icon  $\dots$  next to the task and select **Move** to move a task to another project without copying it.

**Note:** Copying and moving tasks can also include subtasks.

## Direct Inline Editing in Outline, Gantt, and Task Detail Views

Inline editing lets you make changes to a field simply by clicking the value in the field itself and entering the new value. Changes are automatically saved when you click outside the active editing area or by pressing the **Enter** key.

The following items can be edited in this way:

- Phase, milestone, or task name
- ID
- Predecessor
- Start date
- End date
- Notes

**Note:** The field for Predecessor edits follows the following syntax: [Predecessor's ID] [Predecessor Type][lag #].

For example, 5ss-1 indicates that the predecessor is ID 5, has a Start-to-Start type, and a lag of -1 days.

You can indicate multiple predecessors by separating them with a semi-colon (;), for example: 5ss-1;6fs5.

You can disable editing in Outline and Gantt Views by clicking the Lock icon .

## Making Changes in Gantt View


Gantt view provides visibility into a project's progress, coupled with the ability to easily modify tasks and phases.

You can also make changes directly in Gantt view with drag-and-drop functionality. For example, to set a finish-to-start dependency between tasks, drag the dependency from one task to the other. The system recalculates planned hours and utilization. Moving or extending a task in Gantt view automatically creates a fixed start and end date for it, rather than a calculated one.

## Marking Tasks as “Non-billable” and Excluding From Project Budgets

Non-billable tasks can be excluded from billing plans and budgets.

### To exclude non-billable tasks from billing in project budgets:

1. Go to Projects > Projects and select a project.
2. Click the Edit  icon next to the task to make non-billable. The Task properties open.
3. Select “Non-billable task” in the Task properties.
4. Click **Save**.

When viewing your budget in Actuals, the Budget Grid, or Compare View, non-billable tasks are marked with grey icons. The Profitability, Billing Rate, and Total billing for these tasks will always be “-”. These tasks will not enter into billing calculations.

## Booking Worksheet Display

The Booking worksheet is displayed as a link within a project if you select the Booking grid within the project stage. See [Project Stages](#). The options allow formatting of the worksheet for easier use by allowing employee names to be repeated on the right side of the worksheet for reference only and to space rows for easier viewing.

### To access and modify the Booking worksheet display:

1. Go to Administration > Application Settings > Projects > Booking worksheet display.
2. Check or clear the required setting.
3. Click Save.

## Advanced Booking Worksheet

The Advanced Booking Worksheet is a more streamlined, detailed, and visually-appealing worksheet for creating and managing bookings. The worksheet has the following features:

- Bookings appear under each resource.
- Bookings that cannot be edited because of their approval status show in light grey color.
- See resource utilization at a glance. Green, yellow, and red color-coded cells highlight underutilized, fully utilized, and overutilized resources.
- Point to a resource's name to open a resource QuickView.
- Display and edit booking information in daily, weekly, monthly, or many other more time periods.
- Drill down to greater levels of detail.
- Filter the worksheet by department, job code, project, or skills.



- Column and row totals showing total number of hours or percentages across all visible resources and all visible time periods.
- Resource utilization subtotals showing total number of hours or percentages for both the filtered set and all resource bookings when filters are applied.

**Note:** If the ability to edit bookings of a certain type is restricted by role, users whose role is selected in Administration > Application Settings > Resources > Booking Types > [Booking Type] > Restrict booking editing by role will not be able to see bookings of that type in the Advanced Booking Worksheet.

1. Contact SuiteProjects Pro Support and request the “Advanced Booking Worksheet” feature.
2. Confirm that you have enabled the Resource Planner feature. If not, contact SuiteProjects Pro Support and request the “Resource Planner” feature.
3. Assign role permissions for non-administrators who will use the Advanced Booking Worksheet. The necessary role permissions are:
  - View and modify bookings
  - View resource planner

### To open the Advanced Booking Worksheet:

1. After the required features are enabled, go to Resources > Bookings > Worksheet.

## Using the Advanced Booking Worksheet

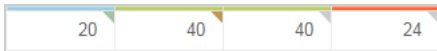
The Booking Worksheet appears as a table with each resource listed in the leftmost column. Point to a resource name to open a QuickView window with various booking-related actions you can perform. You can expand each resource's worksheet rows by clicking the **+** icon next to their name, or collapse the details by clicking the **-** icon.

The Bookings column shows the total number of visible bookings for a resource or per each worksheet row. To see which bookings are visible in the row and their status, click the worksheet row's bookings cell link.

Each period cell contains a colored bar along the top to indicate the resource's utilization. The colored utilization bars use the same color scheme as in the Booking Planner.

**Note:** Utilization over 100% is always colored red.



In addition, period cells may contain a triangular icon with more information.

- Green icon – Cell includes a note
- Yellow icon – Cell includes multiple consolidated bookings
- Grey icon – There is one booking with no note

**Note:** Consolidated booking by day totals in each cell are hard-coded. Multiple bookings may be totaled in each period cell, and bookings may be reconfigured or created when any change is submitted.

Click the triangular icon to open a dialog with details about the bookings within that period cell. Point to the booking name in the dialog to open a booking QuickView. Click the edit icon in the dialog to add or edit a note for the booking.

Select a date range to display using the date selector at the top of the worksheet. You can also choose to display and enter bookings per time period as a percentage of utilization or number of hours.



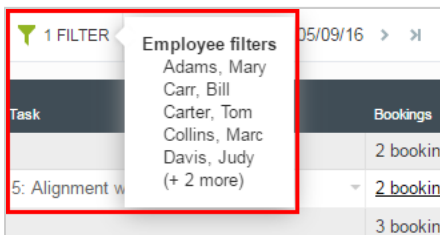
Resource utilization subtotals are visible for both the filtered set and all resource bookings when filters are applied in the advanced booking worksheet.

When filters are applied, resource utilization subtotals show two values :

- The value for all resource bookings, without any filters applied, shown in bold.
- The value for the current set of resource bookings, with the filters applied, if different from the value for all resource bookings, is shown immediately underneath the subtotal for all resource bookings.

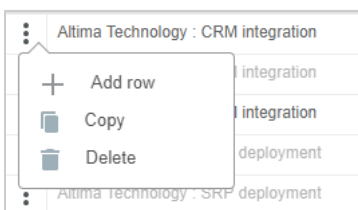
A filter indicator at the top of the worksheet shows how many filters you currently have applied. Click the indicator to open a tooltip with a description of the filters.




The worksheet respects switch settings which prevent you from editing period cells which contain submitted bookings.

You can edit settings for the Booking Worksheet by clicking the icon.

The icon contains a menu from which you can add, copy, or delete worksheet rows.




### To add worksheet rows in the Advanced Booking Worksheet:


1. Click the  icon and click "Add row".

**Note:** If a resource was booked but did not appear on the worksheet because an applied filter hid them, their name will appear in the "Add resource" list. When you add these resources, define the worksheet row, save the changes, and refresh the page, they will be immediately filtered out from the worksheet.

### To copy worksheet rows in the Advanced Booking Worksheet:

1. Click the  icon next to the row to copy, and click "Copy".


### To delete worksheet rows in the Advanced Booking Worksheet:

1. Click the  icon next to the row to copy, and click "Delete".

### To edit worksheet rows in the Advanced Booking Worksheet:

1. Click the cells which you would like to change and enter or select your changes. For example, click a booking type cell to change the booking type from "Open" to "Pending" for that booking.
2. To change a worksheet row's Customer and Project, click a customer and project in the Customer : Project column to open a drop-down list where you can select different projects. Use the "Find more..." option to perform a search for a specific customer or project.

### To customize columns in the Advanced Booking Worksheet:

1. Go to the Advanced Booking Worksheet and click the  icon in the upper right corner of the worksheet. The "Booking worksheet settings" appears.
2. Select which columns you want to display in the "All" tab of the "Columns" section.
3. Clear selected columns in the "All" or "Selected" tab of the "Columns" section by clicking the name of the column.

**Note:** Columns which are currently being displayed in the Advanced Booking Worksheet are highlighted green and appear with a check mark next to them.

4. Reorder columns by clicking and dragging the "Drag to reorder item"  icon at the right side of the column name
5. Click **Save**.

The booking details column can be hidden by clearing the "Show booking details column" option under "Options" in the "Booking worksheet settings" page.

### To Lock Toolbars, Headers, and Columns in the Advanced Booking Worksheet:

1. Go to Projects > Bookings > Worksheet.
2. Click the Column Lock icon at the top of the column which you want to keep in view when scrolling.

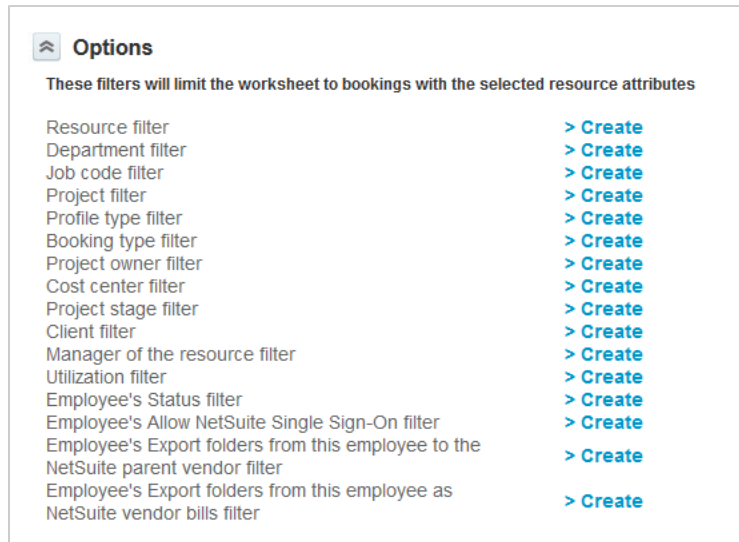
### To save changes and submit visible Open bookings to the next approval workflow status in the Advanced Booking Worksheet:

1. Click **Save** to save all modified data on the page, or click **Save and submit** to submit all visible Open bookings to the next booking approval workflow status.

**Important:** In some cases, the data displayed on the Advanced Booking Worksheet after you save your changes may not show the changes made. This is because SuiteProjects Pro is still recalculating the resource utilization for the resources shown on the worksheet. A warning message appears after you save your changes to confirm that your changes have been saved but that the recalculation is still in progress. To view the updated booking worksheet data, allow some time before reloading the page. To view the last on-screen "booking(s) saved" or "recalculation pending" notification, click the Tips button then click **Review last notification**.

### To set filters in Advanced Booking Worksheet:

1. Go to Resources > Bookings > Worksheet and click the Settings icon .
2. Click the > **Create** link next to the filters you want to set.



3. Select the filter settings and click **OK**.

The utilization filter lets you filter for resources with more or less than a certain utilization percentage in any of the visible booking periods. For example, select **More than 80%** and **Less than 30%** to list only those resources with more than 80% utilization or less than 30% utilization in any of the booking periods in the selected date range.

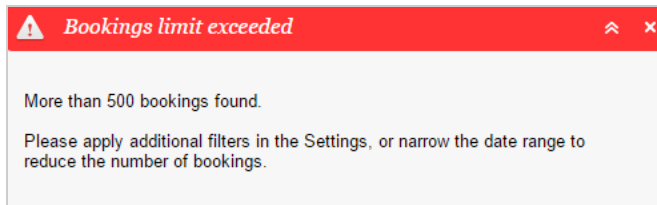

## Advanced Booking Worksheet Optional Functionality and Settings

The following optional features modify the default Advanced Booking Worksheet functionality:

- Detailed booking groups** — When this feature is enabled, bookings grouped under a single row have the same values for all fields except the note, start date and end date fields, even if the columns are not shown on the worksheet. By default bookings grouped under the same worksheet row have the same values in the visible worksheet columns but may have different values in the hidden columns. See [Optional Features](#).
- Restrict utilization calculation to resources impacted by changes** — With this feature enabled, the utilization is recalculated only for the resources that are impacted by these changes instead of all shown resources. Labels indicate when the calculation is in progress, completed or if changes have been made by another user. See [Optional Features](#).
- Require a job code** — When this feature is enabled, a job code is required when you create or modify a booking using the Advanced Booking Worksheet. See [Optional Features](#).

- **Maximum number of bookings displayed** — By default, the Advanced Booking Worksheet displays up to 500 bookings. A warning appears when you reach the maximum number of bookings that can be displayed. You can use the date range and filters to reduce the number of bookings.



To change the maximum number of bookings displayed, contact SuiteProjects Pro Support and request to increase the maximum number of bookings to 1,000, 1,500, or 2,000. Note there is always a trade off between the number of items shown and the page performance.

## Charge Projections

Charge projection options provide financial forecasting. Report values in summary reports named "Projected xxx" are populated based on the charge projection settings. Charge projections are based on information from the project details and the billing rules set for the project.

The process your company uses to allocate resources to a project determine the charge projection settings for your account. Accurate resource allocation provides reliable financial forecasting. If you are not using the Resources application, then the booked hours options do not display in the charge projection selections.

You can run charge projections for a specific time frame by defining a start and end date. Any Projected xxx values prior to the start date of projections are zero. Charge projections may be run for both billing or billing and recognition by selecting the Create recognition projections option. You can also run projections on a relative date range such as from Today forward X number of days.

To view and modify charge projection settings, go to Administration > Application Settings > Projects > Charge projections.

This topic describes the different sections of the administration form for charge projections.

**Note:** The following features affect charge projections settings. To enable these features, contact SuiteProjects Pro Support.

- **Allow charge projections to be run for individual projects** — adds a **Run charge projections** link to the Tips section on each project Properties form. Charge projections will be run using the criteria set in Administration > Projects Settings > Charge Projections.
- **Do not used booked or assigned hours before today when running charge projections using approved/worked and booked/assigned** — ignores booked/assigned hours in the past regardless of whether time has been entered on a timesheet for approved/worked charge projections.
- **Exclude Project from Charge Projections** – When enabled, you can control whether to exclude a project from charge and revenue projections from the project properties form. See the help topic [Exclude Project from Charge Projections](#)

## Status

The Status section of the Charge projections form shows when the last global and project charge and recognition projections were run, or if they are currently running. See also [Run charge projections](#).


## Settings

In the Settings section, you can control which type(s) of time are used to calculate charge projections. Choose one of the following options:

- **Assigned hours** – hours from project or task assignments for each user is assigned to the project.
- **Booked hours** – hours from resource bookings to the project for each user b to the project.
- **Approved hours** – hours recorded against the project from approved timesheets.
- **Worked hours** – hours recorded against the project from all timesheets.
- **Approved and booked hours** – hours recorded against the project from approved timesheets + booked hours after the end date of the latest approved timesheet for each user. If no approved hours exist, only booked hours are used.

To take into account booked hours after the latest approved time entry instead of after the end date of the latest approved timesheet for each user, check the **Use the last day with approved time as the break date for Approved and booked** box.



 **Note:** Latest approved timesheet refers to the approved timesheet with the latest timesheet period end date.

If you check the **Use the last day with approved time as the break date for Approved and booked** box, you can override this behavior on a per-resource level by creating a custom checkbox field for the employee record with the name `use_timesheet_date_for_revrec`. If the `use_timesheet_date_for_revrec` box is checked, booked hours after the end date of the latest approved timesheet for this user are used in charge projections even if **Use the last day with approved time as the break date for Approved and booked** box is checked in the charge projection settings.

- **Approved and assigned hours** – hours recorded against the project from approved timesheets + assigned hours after the end date of the latest approved timesheet for each user. If no approved hours exist, only assigned hours are used.
- **Worked and booked hours** – hours recorded against the project from all timesheets + booked hours after the date of the latest time entry against the project for each user. If no hours were recorded in timesheets against the project, only booked hours are used.
- **Worked and assigned hours** – hours recorded against the project from all timesheets + assigned hours after the date of the latest time entry against the project for each user. If no hours were recorded in timesheets against the project, only booked hours are used.



**Important:** There are two different ways of allocating resource time to a project in SuiteProjects Pro:

- Task or project assignments – Assigned hours are entered on the task or project properties form in the Projects application.
- Bookings – Booked hours are entered either directly on the bookings form or using other tools like the booking worksheet or the project center, for example, in the Projects or Resources applications
- If charge projections are based on assigned or booked hours, either task assignments or bookings are taken into consideration when calculating charge projections but not both .

## Projections filter

You can limit global charge projections to project in selected project stages and limit the process to currently active projects. By default, inactive projects are excluded from projections, so no values are generated for them when these are run.

To run projections for inactive projects, check the **Include inactive projects** box in the **Projections filter** form.

To run projections only for projects in selected project stages, click > **Create** or > **Edit**, and select the project stages.

**Note:** Setting filters for global charge projections can reduce the number of generated entries and improve performance. The projections filter only applies when global projections run. It is ignored when projections are generated for a single project in the project properties form.

## Date range

Project charge projections are flexible. You can define an absolute date range by entering specific start and end dates or define a relative date range by selecting a start date and entering a duration in days. Projections are then generated for the range you specified.

The default display includes specific **Start** and **End** dates. To select a relative range, click the **relative** link in the Date range description. This changes the entry fields to **Start** and **Duration**. Then, select your start time and enter the exact number of days in the Duration field. To return to an absolute range display, click the **absolute** link in the Date range description.

**Note:** Setting a date range for global charge projections can reduce the number of generated entries and improve performance. Longer date ranges increase the amount of data which must be processed, which increase the length of time it takes to run projections.

The date range only applies when global projections run. It is ignored when projections are generated for a single project in the project properties form.

**Date range** Absolute Date Range (default) Click this link to select a relative date range

Projections will be generated for the specified range. You can use a **relative** or an **absolute** range

Select the Start and End dates

Start Duration (days)

Select the Start date and type the duration in days

## Run charge projections

In this section of the Charge Projections form, you can choose to manually run a charge projection now or activate forecasting by setting up automatic charge projections. Whenever projections are run, data on hours and money which would be generated from billing or recognition rules are updated based on current bookings, assignments, timesheet hours, billing rules, and recognition rules.

**Important:** Billing rules are required to create charge projections. Ensure you have created billing rules for Customers : Projects.


### To run global charge projections manually:

1. Select **Run charge projections now** and click **Save**.

By default, selecting **Run charge projections now** generates global charge projections for all projects.

### To run charge projections manually for a specific project:

1. Open the project you want a charge projection for.
2. Go to the project's **Properties** section and click the **Tips** utility button.
3. Select **Generate charge projections for this project**.

 **Note:** Project-specific charge projections cannot be created while global projections are running.

### To set projections to run automatically:

1. Select **Automatically run the charge projections**.
2. Select the day, hour, and minute when the charge projection should run. All times are in U.S. Eastern Time.
3. Click **Save**.

It is important to run the charge projections and refresh the form to make sure that the projections completed before using the corresponding forecasting reports. To check when charge projections were last run, go to Administration > Application Settings > Projects > Charge Projections > Status (see [Status](#)). If a charge projection is currently running, "Global charge projections and recognition projections are **currently running**" will appear in the **Status** section of the Charge projections form.

## Charge Projections Reporting

### Charge Projections Summary Reports

When you have set up billing rules and charge projections options, you can use their corresponding reporting values in summary reports. Examples of commonly-used summary reports for charges based on current settings include:

- [Account-wide] — Projects
- [Account-wide] — Company
- [Account-wide] — Customers

To set up the time range used in the reports, configure the **Period size**, **Number of periods**, and **Date fields**.

Then, choose the corresponding fields which should be calculated in the report. The following are examples of common fields in this type of report:

- Projects — Projected cost [loaded cost type] [rules] — takes hours from charge projections which were generated using billing rules, with the corresponding loaded cost type applied. Field type: money
- Projects — Projected billable hours [rules] — hours from charge projections which were generated using billing rules. Field type: hours
- Projects — Projected billing [rules] — money from charge projections which were generated using billing rules. Field type: money
- Projects — Projected billing margin cost [loaded cost type] [rules] — money from charge projections minus the hours from charge projections times the hourly loaded cost. Field type: money

## Charge Projections Detail Reports

In addition to the Charge Projections Summary Reporting, you can use an additional detail report: Projects — Charge projections. This report is for projected charges based on a project's billing rules. You could use this report to get projections per transaction and filter it depending on the information you need.

You can set your desired date range, and set up conversions on different bases in **Forex conversions and User loaded cost determination** (click the Settings tab if using the Report Manager and Editor optional feature). Any report value which requires a foreign exchange conversion will use that date as the

exchange rate date. This date will also dictate the date used for the currency conversion of user-loaded costs for any cost reporting value.

## Billing

You can set up detailed billing rules on a project-specific basis. After you have created a billing rule and run it, SuiteProjects Pro creates charges based on the rule which can then be used in invoices.

## Types of Billing Rules

There are five types of billing rules:

- **Time billing rule** — These rules are applied to your employees' time entries which are associated with a project. Only approved time entries are used by this rule.
- **Expense item billing rule** — These rules are applied to approved receipts associated with a project.
- **Fixed fee on date or milestone** — Use these rules to create a fixed fee or repeating fixed fee for a project. This rule is useful for charging monthly flat rates to customers for work on a specific project.
- **Fixed fee on % complete** — Use these rules to bill a certain amount when a project, project phase, or project task reaches a set percentage of completion.
- **Purchase item billing rule** — Use these rules to bill purchases made through the Purchases module.


## Billing Rule Forms

Use the Billing Rule form to set the parameters for your billing rules. Each billing rule type has its own form:

### Time Billing Rule Fields

- **Currency** — If your account uses multi-currency, use this list to select the currency you want the billing rule to be run with.
- **Date range** — If needed, enter a start and end date for the time when the billing rule will be in effect. If milestones have been created for the project, you can also select one of these milestones rather than a date.

- **Billing rates** — You can get billing rates from one of four places:
  - **Employees** — If you select Employees from the menu, you can override your employees' assigned billing rates for their timesheet time entries associated with a project. Select the employee from the lists, and enter the new billing rates. If you need more rows, select the number of rows from the "[Add rows]" list.
  - **Rate cards** — If you select Rate cards, you can choose to apply any rate card by selecting it from the "Rate card" list.

 **Note:** If the rate card does not include a rate for a specific employee, that employee's default billing rate is used.

- **Services** — If you select Services, you can override default service rates by selecting the service from the lists provided and entering the new billing rates. If you need more rows, select the number of rows from the "[Add rows]" list.
- **Job codes** — If you select Job codes, you can override default rates by job code by selecting the job code from the lists provided and entering the new billing rates. If you need more rows, select the number of rows from the "[Add rows]" list.

The page refreshes when changing from one Billing rate option to another.

You can type a Billing rate multiplier to apply to Employee or Service rates which have not been overridden by the settings above.

- **Daily rate multiplier** — Use these fields to enter rate multipliers which apply to specific days of the week. This setting affects all rates, including overridden ones.
- **Rounding rules** — For employees' timesheet time entries which are associated with the project, you can round up the number of hours for billing purposes.

For example, if you bill by the day or half-day only, you could set up rules so that any time entries that are less than 4 hours are rounded up to 4 hours, and any time entries that are between 4 and 8 hours are rounded up to 8 hours.

For example, to bill by day or half-day, the rounding rules could be set up as follows:

1. **Hours >** is set to 0, **Hours <=** field is set to 4, **Round to** field is set to 4.
2. **Hours >** field is set to 4, **Hours <=** field is set to 8, **Round to** field is set to 8.

Rounding is done on the daily total of hours for the project in question only.

- **Billing rule filters** — Use these filters to limit the billing rule to certain employees, time types, or services. To create a filter for a particular item, click on its ">Create" button. In the popup window, select the items you want from the "Available items" list, click "Add Selected >", and click OK.
- **Rule Cap** — Set a cap to limit the total amount billed by the billing rule. Caps for time billing rules can be set by hours or by money.

You can also set whether a cap prompts you to adjust time entries to fit under the cap or prevent billing of time entries which exceed the cap:

- **Adjust time entries to fit under the cap** — If selected, when billings by money or hours exceed the cap, the billing run will give you the option to create charges only up until the cap is reached, based on the dates or order of the time entries. If this option is not selected, and billings exceed the cap, no billing will be generated.

The cap limits the total amount billed by the rule. The next time you run billing, the cap will account for any existing charges created with this rule when it calculates whether time entries can be billed.

For example, if you set the cap to \$6,000 and select this option, and the first set of charges created in the rule total \$5,000, the next time you run project billing, you will only have the option to create charges for time entries up to a total of \$1,000. If billing is later run and the next set of charges add up to \$1,500, a total of \$1,000 would be billed.

If the option was not selected, nothing would be billed. In either case, any remaining receipts, purchases, and time entries over the cap would not be billable.

When running billing with this option selected, the Description column will say "Adjusted for cap" for transactions which have not been fully billed.

- **Do not bill time entries that exceed the cap** — This rule affects billing when sequential billing rules exist. If selected, when the cap is reached, no further billing takes place. If this option is not selected, transactions exceeding the cap will pass to successive billing rules, if they exist, for further processing.


This option should not be used if, for example, you have a time billing rule at a \$250 per hour rate up to a cap, and a second billing rule with a discount rate for time which exceeds the cap.

- **Time period cap** — The time period cap limits the number of hours billed for the time period. Type the number of hours and select the time period from the list. Select "Apply the cap on a per employee basis" to apply the cap separately to each employee (for example, each employee has their own 40-hour cap), rather than one cap for all employees (for example, all employees combined time must be under 180 hours).

#### ■ Other Settings

- **Name** — You can give the billing rule a name. If this field is cleared, a default name will be assigned. The default name has the following format: "[type] billing rule [#]". For example, a new expense item billing rule's default name would be "Expense item billing rule 1".
- **Billing rule position** — With this option, set the order in which each rule will be applied when you run project billing.

For example, you may want a specific time billing rule to run first, then a second, more general time billing rule to any time entries not affected by the first rule.


 **Note:** The position of billing rules is important. If a general rule (for example, one which is simply "Bill expenses" or "Bill time at the employee(s)' billing rate") is positioned before a more specific rule, the specific rule will never process time entries picked up by the previous rule.

- **Charge description** — Enter a description of the billing rule, if desired. This description will be added to explanation of each billing rule in the "Rule" column of the "Billing rules" list for the project. It will also appear in the "Description/Notes" field of the item in the resulting invoice.
- **Charge stage** — If you want charges created by the billing rule to be assigned a specific charge stage, choose the stage from this list.
- **Agreement** — If you want charges created by the billing rule to be assigned to a specific agreement, choose the agreement from this list. The agreement must be associated with the project.
- **Customer PO** — If you want charges created by the billing rule to be assigned to a specific customer purchase order, choose the purchase order from this list. The customer PO must be associated with the project.
- **Service** — Associates a service to any charges created by the billing rule.
- **Use the selected service if the time entry does not have a service** — If a time entry does not have a service, use this option to assign this time entry to a service. Select the service from the "Service" list or lists.
- **Always use the selected service** — This option always assigns time entries to a service selected from the "Service" list or lists, overriding any other service choices.
- **Notes** — Add a description for the billing rule in this field. The description will appear in lists.
- **Exclude time from archived timesheets** — Select this option if you do not want time from archived timesheets to be included when running this billing rule.

- **Active billing rule** — Clearing this option deactivates the billing rule. It is selected by default.

## Expense Item Billing Rule Fields

- **Currency** — If your account uses multi-currency, use this list to select the currency you want the billing rule to be run with.
- **Date range** — If needed, enter a start and end date for the time when the billing rule will be in effect. If milestones have been created for the project, you can also select one of these milestones rather than a date.
- **Mark up/down** — Use this setting to create billing rules which mark up or mark down expense items in receipts associated with a project. Enter a markup or markdown as a percentage of the cost, or as a fixed monetary amount. The markdown is applied on a per-unit basis.

 **Note:** Enter a negative number for a markdown.

You can also select a Markup service. If you select a service in the list, the markup will create a separate flat rate charge assigned to that service.

- **Billing rule filters** — Use these filters to limit the billing rule to certain expense items. To create a filter for a particular item, click on its “>Create” button. In the popup window, select the items you want from the “Available items” list, click “Add Selected >”, and click OK.
- **Receipt maximums** — Set maximums on a per-expense item basis in each billing rule. When the billing rule is run for a particular project, receipts which exceed the maximum will be reduced to the maximum amount specified.
- **Cap** — Set a cap to limit the total amount billed by the billing rule. Expense billing rule caps are by money only.

You can also set whether a cap prompts you to adjust expenses to fit under the cap or prevent billing which exceed the cap:

- **Adjust receipts to fit under the cap** — If selected, when billings exceed the cap, the billing run will give you the option to create charges only up until the cap is reached, based on the dates or order of the expenses. If this option is not selected, and billings exceed the cap, no billing will be generated.

The cap limits the total amount billed by the rule. The next time you run billing, the cap will account for any existing charges created with this rule when it calculates whether receipts can be billed.

For example, if you set the cap to \$6,000 and select this option, and the first set of charges created in the rule total \$5,000, the next time you run project billing, you will only have the option to create charges for time entries or receipts up to a total of \$1,000. If billing is later run and the next set of charges add up to \$1,500, a total of \$1,000 would be billed.

If the option was not selected, nothing would be billed. In either case, any remaining receipts over the cap would not be billable.

When running billing with this option selected, the Description column will say “Adjusted for cap” for transactions which have not been fully billed.


- **Do not bill receipts that exceed the cap** — This rule affects billing when sequential billing rules exist. If selected, when the cap is reached, no further billing takes place. If this option is not selected, transactions exceeding the cap will pass to successive billing rules, if they exist, for further processing.

This option should not be used for situations when a certain amount of expenses are included in a fixed price billing and only expenses exceeding the cap are billed as incurred.

- **Other Settings**



- **Name** — You can give the billing rule a name. If this field is cleared, a default name will be assigned. The default name has the following format: “[type] billing rule [#]”. For example, a new expense item billing rule’s default name would be “Expense item billing rule 1”.
- **Billing rule position** — With this option, set the order in which each rule of a specific type (time or expense item) will be applied when you run project billing.

 **Note:** The position of billing rules is important. If a general rule (for example, one which is simply “Bill expenses” or “Bill time at the employee(s) billing rate”) is positioned before a more specific rule, the specific rule will never process time entries picked up by the previous rule.

- **Charge description** — Enter a description of the billing rule, if desired. This description will be added to explanation of each billing rule in the "Rule" column of the "Billing rules" list for the project. It will also appear in the "Description/Notes" field of the item in the resulting invoice.
- **Charge stage** — If you want charges created by the billing rule to be assigned a specific charge stage, choose the stage from this list.
- **Agreement** — If you want charges created by the billing rule to be assigned to a specific agreement, choose the agreement from this list. The agreement must be associated with the project.
- **Customer PO** — If you want charges created by the billing rule to be assigned to a specific customer purchase order, choose the purchase order from this list. The customer PO must be associated with the project.
- **Service** — Associates a service to any charges created by the billing rule.
- **Notes** — Add a description for the billing rule in this field. The description will appear in lists.
- **Subtract GST/HST from receipt** — If you are using the tax locations tax calculation method, select this option to subtract the GST and HST from the receipt total when the project billing is run.
- **Exclude non-reimbursable receipts** — Select this option to exclude non-reimbursable receipts from the billing rule.
- **Exclude non-billable receipts** — Select this option to exclude non-billable receipts from the billing rule. This option is selected by default.
- **Active billing rule** — Clearing this option deactivates the billing rule. It is selected by default.

## Fixed Fee on Date or Milestone Billing Rule Fields

- **Amount and Date or Milestone** — Enter the amount for the fixed fee, and the date on which it should be billed. If milestones have been created for the project, you will be able to select one of these milestones rather than a date, if desired.
- **Repeat billing rule** — You can create a rule with a repeating fixed fee.

For example, if you wanted to bill a customer a certain amount every month for work on a project, you could set up a fixed fee billing rule that will create a charge for the amount required every month. When you run project billing, the charges will be created with the dates specified by the billing rule and the intervals between any repeating fees - if the dates of the repeating fixed fees fall sometime in the future, they will not show up as billable items on the "Run billing" page until those dates are reached.

### To create a repeating fixed fee:

1. Click on the **>Create** link to create a repeating fixed fee. The “Repeat” dialog appears.
2. Select the frequency and the interval for the fee. The “Repeat Every” interval will change to reflect the frequency selected.

3. Select an end date for the repeat fee or designate a specific number of repetitions.
  4. Click **OK**.
- **Name** — You can give the billing rule a name. If this field is cleared, a default name will be assigned. The default name has the following format: “[type] billing rule [#]”. For example, a new expense item billing rule’s default name would be “Expense item billing rule 1”.
  - **Charge description** — Enter a description of the billing rule, if desired. This description will be added to explanation of each billing rule in the "Rule" column of the "Billing rules" list for the project. It will also appear in the "Description/Notes" field of the item in the resulting invoice.
  - **Charge stage** — If you want charges created by the billing rule to be assigned a specific charge stage, choose the stage from this list.
  - **Agreement** — If you want charges created by the billing rule to be assigned to a specific agreement, choose the agreement from this list. The agreement must be associated with the project.
  - **Customer PO** — If you want charges created by the billing rule to be assigned to a specific customer purchase order, choose the purchase order from this list. The customer PO must be associated with the project.
  - **Service** — Associates a service to any charges created by the billing rule.
  - **Employee** — To associate a charge to a specific employee, select the employee from this list.
  - **Cost center** — To associate a charge to a specific cost center, select the cost center from this list.
  - **Notes** — Add a description for the billing rule in this field. The description will appear in lists.
  - **Active billing rule** — Clearing this option deactivates the billing rule. It is selected by default.


## Fixed Fee on Percent Complete Fields

- **Amount, % complete, and % complete threshold** — Enter the amount for the fixed fee. If phases have been created for the project, you will be able to specify whether the % complete should be based on the project as a whole, or on a particular phase. Enter the % complete threshold. When the % complete of the project or phase is greater than the threshold entered, the amount of the billing rule will be created as a charge upon running of the billing rule.
- **Name** — You can give the billing rule a name. If this field is cleared, a default name will be assigned. The default name has the following format: “[type] billing rule [#]”. For example, a new expense item billing rule’s default name would be “Expense item billing rule 1”.
- **Charge description** — Enter a description of the billing rule, if desired. This description will be added to explanation of each billing rule in the "Rule" column of the "Billing rules" list for the project. It will also appear in the "Description/Notes" field of the item in the resulting invoice.
- **Charge stage** — If you want charges created by the billing rule to be assigned a specific charge stage, choose the stage from this list.
- **Agreement** — If you want charges created by the billing rule to be assigned to a specific agreement, choose the agreement from this list. The agreement must be associated with the project.
- **Customer PO** — If you want charges created by the billing rule to be assigned to a specific customer purchase order, choose the purchase order from this list. The customer PO must be associated with the project.
- **Service** — Associates a service to any charges created by the billing rule.
- **Employee** — To associate a charge to a specific employee, select the employee from this list.
- **Cost center** — To associate a charge to a specific cost center, select the cost center from this list. This option is controlled by a switch. Contact SuiteProjects Pro Support to discuss enabling this feature.
- **Notes** — Add a description for the billing rule in this field. The description will appear in lists.


- **Active billing rule** — Clearing this option deactivates the billing rule. It is selected by default.

## Purchase Item Billing Rule Fields

- **Currency** — If your account uses multi-currency, use this list to select the currency you want the billing rule to be run with.

 **Note:** When an expense billing rule generates a bill for a foreign currency expense in the same currency, the user-designated exchange rate will be used.

- **Date range** — If needed, enter a start and end date for the time when the billing rule will be in effect. If milestones have been created for the project, you can also select one of these milestones rather than a date.
- **Mark up/down** — Used with expense item billing rules and purchase item billing rules. Use this setting to create billing rules which mark up or mark down expense items in receipts or purchases associated with a project. Enter a markup or markdown as a percentage of the cost, or as a fixed monetary amount. The markdown is applied on a per-unit basis.

 **Note:** Enter a negative number for a markdown.

You can also select a Markup service. If you select a service in the list, the markup will create a separate flat rate charge assigned to that service.

- **Billing rule filters** — Use these filters to limit the billing rule to certain products. To create a filter for a particular item, click on its ">Create" button. In the popup window, select the items you want from the "Available items" list, click "Add Selected >", and click OK.
- **Cap** — Set a cap to limit the total amount billed by the billing rule. Purchase item billing rule caps are by money only.

You can also set whether a cap prompts you to adjust receipts to fit under the cap or prevent billing of receipts which exceed the cap:

- **Adjust purchase items to fit under the cap** — If selected, when billings by money exceed the cap, the billing run will give you the option to create charges only up until the cap is reached, based on the dates or order of the receipts or purchases. If this option is not selected, and billings exceed the cap, no billing will be generated.

The cap limits the total amount billed by the rule. The next time you run billing, the cap will account for any existing charges created with this rule when it calculates whether receipts or purchases can be billed.

For example, if you set the cap to \$6,000 and select this option, and the first set of charges created in the rule total \$5,000, the next time you run project billing, you will only have the option to create charges for time entries or receipts up to a total of \$1,000. If billing is later run and the next set of charges add up to \$1,500, a total of \$1,000 would be billed.


If the option was not selected, nothing would be billed. In either case, any remaining receipts or purchases over the cap would not be billable.

When running billing with this option selected, the Description column will say "Adjusted for cap" for transactions which have not been fully billed.


- **Do not bill purchase items that exceed the cap** — This rule affects billing when sequential billing rules exist. If selected, when the cap is reached, no further billing takes place. If this option is not selected, transactions exceeding the cap will pass to successive billing rules, if they exist, for further processing.

This rule should also not be used for situations when a certain amount of expenses are included in a fixed price billing and only expenses exceeding the cap are billed as incurred.

- **Name** — You can give the billing rule a name. If this field is cleared, a default name will be assigned. The default name has the following format: “[type] billing rule [#]”. For example, a new expense item billing rule’s default name would be “Expense item billing rule 1”.
- **Billing rule position** — Used with time and expense item billing rules. With this option, set the order in which each rule of a specific type (time or expense item) will be applied when you run project billing. For example, you may want a specific time billing rule to run first, then a second, more general time billing rule to any time entries not affected by the first rule.

 **Note:** The position of billing rules is important. If a general rule (for example, one which is simply “Bill expenses” or “Bill time at the employee(s) billing rate”) is positioned before a more specific rule, the specific rule will never process time entries picked up by the previous rule.

- **Charge description** — Enter a description of the billing rule, if desired. This description will be added to explanation of each billing rule in the “Rule” column of the “Billing rules” list for the project. It will also appear in the “Description/Notes” field of the item in the resulting invoice.
- **Charge stage** — If you want charges created by the billing rule to be assigned a specific charge stage, choose the stage from this list.
- **Customer PO** — If you want charges created by the billing rule to be assigned to a specific customer purchase order, choose the purchase order from this list. The customer PO must be associated with the project.
- **Service** — Associates a service to any charges created by the billing rule.
- **Notes** — Add a description for the billing rule in this field. The description will appear in lists.
- **Active billing rule** — Clearing this option deactivates the billing rule. It is selected by default.
- **Agreement** — If you want charges created by the billing rule to be assigned to a specific agreement, choose the agreement from this list. The agreement must be associated with the project.
- **Exclude non-reimbursable receipts** — Select this option to exclude non-reimbursable receipts from the billing rule.
- **Exclude non-billable receipts** — Select this option to exclude non-billable receipts from the billing rule. This option is selected by default.
- **Mark up/down** — Use this setting to create billing rules which mark up or mark down purchases associated with a project. Enter a markup or markdown as a percentage of the cost, or as a fixed monetary amount. The markdown is applied on a per-unit basis.

 **Note:** Enter a negative number for a markdown.

You can also select a Markup service. If you select a service in the list, the markup will create a separate flat rate charge assigned to that service.

## Creating, Editing, Copying, and Deleting Billing Rules

### To create a billing rule:

1. Go to Projects > Projects > [select a project] > Financials > Billing > Rules. A list of existing billing rules appears.
2. Click the Create button and click the type of billing rule you want to create under “Billing rule”. A form for the selected billing rule appears.
3. Set the parameters for the billing rule, and click **Save** or **Save & create another**.

### To edit a billing rule:


1. Go to Projects > Projects > [select a project] > Financials > Billing > Rules. A list of existing billing rules appears.
2. Click on the name of the billing rule that you want to edit. You can also click the **Edit** icon in the Action column of the list. The “Billing rule” form appears.
3. Make your changes to the rule’s form and click **Save**.

### To copy a billing rule:

1. Go to Projects > Projects > [select a project] > Financials > Billing > Rules. A list of existing billing rules appears.
2. Click the **Clone** button in the Action column for the rule you want to copy. The billing rule will be duplicated and the copy’s Billing Rule form will appear.


### To delete a billing rule:

1. Go to Projects > Projects > [select a project] > Financials > Billing > Rules. A list of existing billing rules appears.
2. Click on the name of the billing rule that you want to delete. The “Billing rule” form appears.
3. Click **Delete** at the top of the form.

 **Note:** You cannot delete a billing rule which has associated billing transactions or charges.


## Running Billing Rules and Project Billing Transactions

When you run billing, a list of all billable items will be generated based on the billing rules you have set up for the project. From this list, you can select the items you want to turn into charges. These charges can then be used in invoices. The Project Billing Transactions report will also list those items which have been billed. If you subsequently edit one of these charges so that its cost is different from the original billable item, the Project Billing Transactions report will display the original total, the charge total, and the difference between the two. If you delete a charge, the record will still remain in the project billing transactions list, and list the charge total as “0”.

 **Note:** You must create at least one billing rule for the project before you can run billing.

### To run a billing rule for one project:

1. Go to Projects > Projects > [select a project] > Financials > Billing and click the **Run** tab.
2. If desired, enter a Start date and End date for the billing run. Click **Next**.

 **Note:** The Start and End dates default to the values you entered when you last ran billing for the project.

3. The list of available billable items appears. If no items are billable, a “Nothing is currently billable for this project” message appears. To edit any items in the list, click the date of the billable item you want to change. Make any changes and click **Save**.
4. Select the items which you want to create charges for.
5. Click **Create project billing transactions and charges** at the bottom of the billable items list.

### To run billing for multiple projects:

1. Go to Reports > Advanced and click “Pending Billings” in the “Projects” section.
2. Enter the parameters for the report in the Pending billings form.
3. Click **Run the report**. The Pending Billings report appears, and shows all projects which have billings to run.
4. Click the **Tips** button.
5. Click the **Click here** link to create the billings for the projects in the report.

Click the **Transactions** link to see the items which have been billed. The charges which have been generated can also be found at Invoices > Charges. You can run billing again by clicking the **Click here** link to run billing again. You can enter a new set of dates if necessary.

## Deleting a Project Billing Transaction

To delete a project billing transaction, you must first delete the charges associated with it.

### To delete project billing transactions and their associated charges:

1. Go to Invoices > Charges > [Select a type of charge].
2. Select the charges which you want to delete by selecting their check boxes in the “Run an action” column. To select the entire list of transactions, check the box in the grey filter row.
3. Click the **Run an action** button at the top of the “Run an action” column. The Actions dialog appears.
4. Select “Delete the selected charges and associated project billing transactions” and click **OK**. The charges and their associated project billing transactions will be deleted.

## Auto-Billing


SuiteProjects Pro includes three options for auto-billing which allow you to simplify your billing workflow:

- **Do not auto-bill** — This is the default option. When selected, SuiteProjects Pro does not auto-bill.
- **Run a trial billing, do not create project billing transactions or charges** — This option lets you test a billing run without creating billing items.
- **Run billing and create project billing transactions and charges** — This option runs billing and creates billing items.

You can set default auto-billing options for project billing rules on an account-wide basis, eliminating a step for project managers when creating new projects.

### To configure auto-billing defaults:

1. Go to Administration > Application Settings > Projects > Project Billing Defaults.
2. Set the options for whether to use auto-billing, trial billing, or full billing, set the auto-bill schedule, and select the employees to receive email notifications for the billing results.
3. Click **Save**.

 **Note:** These options will apply only to new projects and will not change the auto-bill settings for any existing projects. Cloned projects will use the auto-billing settings of the original project from which the copy was made, and not the default auto-billing settings.

### To run a trial auto-billing:

1. Go to Projects > Projects > [select a project] > Financials > Billing > Auto-run.
2. Select the “ Run a trial billing, do not create project billing transactions or charges” option in the Auto-bill form.
3. In the “Email the results of the auto-bill run to:” section of the form, select the employees who should receive the results of the trial billing in an e-mail message by clicking on the **>Create** or **>Edit** links, selecting the employees from the "Available items" list, and clicking the **Add highlighted items >** button to move them to the "Selected items" list.
4. Select “Suppress the email if nothing is billable” to not send billing and recognition notification emails if no transactions are billable or recognizable.
5. In the “Run auto-bill on:” section of the form, select the day and the time of the week that the trial billing will run. The e-mail messages with the results will be sent as soon as the trial has been run.

**Note:** Times are in Eastern Time (UTC -5:00 during Standard Time and UTC -4:00 during Daylight Saving Time)

6. Click **Save**.

### To run auto-billing:

1. Go to Projects > Projects > [select a project] > Financials > Billing > Auto-run.
2. Select the “ Run billing and create project billing transactions and charges” option in the Auto-bill form.
3. In the “Email the results of the auto-bill run to:” section of the form, select the employees who should receive the results of the billing in an e-mail message by clicking on the **>Create** or **>Edit** links, selecting the employees from the "Available items" list, and clicking the **Add highlighted items >** button to move them to the "Selected items" list.
4. Select “Suppress the email if nothing is billable” to not send billing and recognition notification emails if no transactions are billable or recognizable.
5. In the “Run auto-bill on:” section of the form, select the day and the time of the week that the billing will run. The e-mail messages with the results will be sent as soon as billing has been run.

**Note:** Times are in Eastern Time (UTC -5:00 during Standard Time and UTC -4:00 during Daylight Saving Time)

6. Click **Save**.

## Revenue Recognition

The Revenue Recognition feature lets you set up revenue recognition rules for each project individually, and you can also recognize revenue using project billing rules. Each project can have multiple revenue recognition rules, providing flexibility to meet the needs of your company's current recognition structure. You can also create manual recognition transactions within a selected project, clicking the **Create** button, and selecting **Recognition transaction**.

**Note:** There are several switches which affect revenue recognition. See [Revenue Recognition Switches](#) for the complete list. To enable them, contact SuiteProjects Pro Support.

To create one of the following recognition rules, click **Create** and select Recognition > [Rule from list below]:

- % Complete

- As Billed
- Expenses
- Fixed amount on date or milestone
- Fixed amount on % complete
- Purchases
- Incurred vs. forecast
- Time project billing
- Balanced Incurred vs. Forecast

## Revenue Recognition Rules

### % Complete

This rule recognizes a fixed amount over time based on overall completion of the project. The total amount to recognize can be set in the **Amount** dropdown, and the calculation method can be set in **Calculate using**. You can select the following calculation methods:

- **% complete for the project** — calculated as the total amount set in the rule multiplied by the project's percent complete when the rule was run. For example, when recognizing \$50,000.00 for a project which is 11% complete when the recognition is run, a recognition transaction for \$5,500.00 is created.
- **Approved hours vs. planned hours for the project** — calculated as the approved hours divided by the planned hours.
- **Approved hours vs. budget hours for the project** — calculated as the approved hours divided by the budgeted hours.

You can apply rules to an entire project, or to elements of it, such as specific phases or tasks, by choosing them in the drop-down list boxes.

## As Billed

This rule creates recognition transactions when a charge is created or when a charge is invoiced. It also uses charges which were already created by project billing rules and charges which were already invoiced.

Limit the time period this rule is applied to by setting a Start and End date in the Date range section of the form, or leave these fields blank to include all dates in the recognition rule.

This recognition rule calculates the recognition amounts from already-created charges from billing rules, so you can set filters on the charge types using the **Charge types to exclude** section of the form. You can choose the following:

- Exclude hourly charges
- Exclude flat rate charges
- Exclude other rate charges
- Exclude expense item charges
- Exclude project charges

**Note:** Expense item charges are automatically excluded if you have created an **Expenses rule**, and product charges are automatically excluded if you have created a **Purchases rule**.

You can also apply filtering rules in the **Recognition rule filters** section of the As Billed form. Click the **> Create** link and select only the charges which you want to process when the recognition rule is run.

In the Other section of the form, if you select an agreement or customer PO, transactions will be set against that agreement or customer purchase order and the drawdown will be reported. Additionally, if you need to report hours recognized, select the **Populate hours in recognition transactions** checkbox.

## Expenses

This rule recognizes revenue from expenses, and offers more options than the As Billed rule. It recognizes receipts created in the Expenses module as revenue.

You can set one of several different scenarios to recognize revenue in the **Revenue to recognize** section of the Expenses rule form. The options are:

- **Mark up/down on billed expenses** — recognition on the mark up/down of the receipt when it is billed in the Invoices module.
- **All billed expenses** — recognition based on all receipts billed in the Invoices module.

- **All incurred expenses** — recognition based on all receipts which are currently assigned to the corresponding project.

You can limit the recognition rule to specific users and expense items in the **Recognition Rule Filters** section of the form. You can also restrict values based on associated tax location.

## Fixed amount on date or milestone / Fixed amount on % complete

These rules recognize a fixed amount on a set date or upon completion of a milestone/percent completed. Use the drop-down list box under User to select a user to associate the rule with. Enter the remaining information and click **Save**.

## Purchases

This rule recognizes revenue based on purchases created in the Purchases module. There are two scenarios to choose from:

- **Mark up/down on billed purchases** — recognition on the mark up/down of the purchase when it is billed in the Invoices module
- **All billed purchases** — recognition based on all purchases billed in the Invoices module.

## Incurred vs. forecast rule

This rule recognizes revenue based on how the project is tracking against the ongoing plan by dividing incurred costs by forecast costs and then multiplying by the amount of revenue to be recognized. Incurred and forecast costs can include any combination of labor, expenses, and purchases.

This rule is similar to the percent complete recognition rule; however, while the percent complete rule only uses hours, the incurred vs. forecast rule uses other inputs.

The Incurred portion of the percentage calculation is the numerator. The following items can be included in the Incurred portion:

- **Approved hours multiplied by employee/user cost** — hours approved from timesheets multiplied by the loaded cost
- **Approved receipts** — includes receipts from approved expense reports
- **Fulfilled purchase items** — includes fulfilled purchase amounts

The Forecast portion of the percentage calculation is the denominator. The following items can be included in the Forecast portion:

- **Estimated hours multiplied by user cost** — estimated hours from the project plan multiplied by the loaded cost
- **Approved and booked hours multiplied by the employee/user cost** — approved hours from timesheets and remaining booked hours within the period multiplied by the loaded cost. When you select this option and run the rule, it will find the end date of the last approved timesheet for the user and use that as the cut-off date. The forecast amount will be:

$$(\text{Approved time before the cut-off date} \times \text{Loaded cost}) + (\text{Booked time after the cut-off date} \times \text{Loaded cost})$$

- **Total planned receipts** — an estimate of the total receipt amount for the project

- **Total planned purchase items** — the same assumption as planned receipts, taking into account purchases instead of expenses



**Important:** Consider the following guidelines:

- The cut-off date used for **Approved and booked hours multiplied by the employee/user cost** is based on the latest approved timesheet for that user across all projects, and is not restricted to any one project.
- The loaded cost for the employee is set in Administration > Employees > [Select an Employee] > Cost. It includes the **Current hourly cost**, which specifies the hourly cost effective today, and any **Historical hourly costs**, which may specify both past and projected hourly cost values effective within a given date range.

- By default, the **Estimated hours multiplied by user cost** forecast is calculated using the **current hourly cost** for the employee. SuiteProjects Pro can be configured to calculate the **Estimated hours multiplied by user cost** forecast using the loaded cost effective on the day work is assigned, taking into account both current hourly cost and historical hourly costs.

To enable this feature, contact SuiteProjects Pro Support and request the following revenue recognition switch: For incurred vs. forecast recognition rules, use hours from assign by day table for the forecast, instead of planned hours, so that dated loaded cost can be used for the forecast instead of current loaded cost.

- The **Approved and booked hours multiplied by the employee/user cost** forecast calculation always uses the loaded cost effective on the day work is assigned, taking into account both **current hourly cost** and **historical hourly costs**



**Note:** When selecting any of the options which use hours multiplied by cost, you can select which cost level to use from the **User cost to use** drop-down list box in the **Other** section of the form. Additionally, you can tie agreements, customer purchase orders, and services to the rule like any of the other recognition rules.

## Incurring vs. Forecast Revenue Recognition Audit Custom Fields

Calculation details may be required to audit revenue recognition transactions that SuiteProjects Pro creates when an incurred versus forecast revenue recognition rule runs.

You can create custom fields to hold the various information that is used to calculate the amount for each revenue recognition transaction. These fields are populated automatically when SuiteProjects Pro creates each revenue recognition transaction.

The following tables list the name, suggested display name, type, and a description of the value recorded for each custom field you can create for auditing purposes.

When creating each custom field:

- Under **Add a custom field to**, select Recognition transaction.
- Under **Type of field to add**, select the type specified in the following tables.
- Enter the **Name** exactly as specified in the following tables.
- Enter a **Display name**. The display name may be different than the one suggested in the following tables.

For more information about creating custom fields, see [Creating and Modifying Custom Fields](#).

Like with all custom fields, unless hidden using the custom field properties or form permissions, custom fields for recognition transactions are available on the recognition transaction forms, the recognition transaction list (Projects > Projects > [Select a project] > Financials > Recognition > Transactions) and revenue recognition tabular (detail) reports.

Custom field values for recognition transactions [Revenue\_recognition\_transaction] can also be read or set using the SOAP API, XML API. See the help topic [Custom Fields](#).

## Time project billing rule

Recognizes revenue from charges that have been or would be created by selected time billing rules. This revenue recognition rule can only be created after at least one time billing rule has been created on a particular project. If you try to create the rule without a time billing rule, you will receive a "You must first create at least one Time billing rule" message.

When you've created one or more time billing rules for a project, you can select the billing rule or rules which will create recognition transactions when the recognition is run.

## Balanced Incurred vs. Forecast Rule

This rule uses true-up transactions to balance out previous accounting periods and adjust your projections to reflect project changes. It is particularly useful when your previously recognized income is more or less than the actual revenue as of the current date.

To use this rule, first enter the amount to recognize, and select whether the rule's calculations are based on bookings or assignments. The calculations are the same for both. Selecting bookings uses bookings for forecasts, while selecting assignments uses assignments for forecasting. Actual time entries are used in both scenarios:

- approved hours are used to calculate actual revenue recognition
- worked hours are used in revenue recognition projection calculations



**Note:** Whenever worked hours are entered, they are prioritized over booked or assigned hours to more accurately project what is occurring in SuiteProjects Pro.

It isn't possible to combine both booked AND assigned hours in the same rule.

For the Incurred section of the calculation, you may also plan for expenses and purchases to incorporate approved receipts or fulfilled purchase items, which makes it easier to transfer from the original Incurred versus Forecast rule.

In the Forecast section, define what type of hours (booked/assigned or logged timesheet hours) are used for revenue projection calculations. Two periods are considered in the forecast:

- the past up to and including a set pivot date
- all time after the pivot date

The forecast can use either time entries or booked/assigned hours. Time entries are preferred over bookings or assignments. You can also enter total planned receipts and purchase items into the forecast.

When the rule is run, true-up transactions are used to balance out previous accounting periods when there is more or less revenue to recognize as of today. They can be generated per project or per employee.

## Example of the Balanced Incurred vs. Forecast Rule

In December 2015, the following project data exists. The project will run from January 2016 to March 2016. Booked hours, projected cost, and projected revenue are the same for January 2016, February 2016, and March 2016. If there are no changes to Booked or Logged hours, the Actual revenue will match the Projected revenue for the duration of the project.

The following formulas are used to determine Projected cost and Projected revenue:

**Projected cost** = Booked hours x User cost

**Projected revenue** = (Projected cost / Total Projected cost) x Total project revenue

In February 2016, the Actual revenue for January 2016 has been recorded. In this example, the Actual hours were the same as the Booked hours, therefore the recorded Actual revenue was the same as the Projected revenue in January 2016.

In March 2016, the project is extended to April 2016, and 320 additional booked hours are added to April 2016. These additional booked hours increase the cost profile for the entire project. If the projected

revenue was recalculated in March 2016 with this new data, the projected revenue for each month would be lower for January, February, and March in 2016.

Because the January 2016 accounting period is already closed, the Actual revenue recognized for January 2016 cannot be changed. Therefore, the Balanced IVF rule creates a true-up transaction of (\$10,000) in February 2016 to balance the Actual revenue from January 2016.

In April 2016, income is recognized for March 2016. March 2016's booked hours were the same as its actual hours, so the Actual Revenue is the same as the Projected Revenue: \$15,000. The rule will not create a balancing transaction for this month.

In May 2016, it is determined that April 2016's Actual hours (200) were lower than the booked 320 hours. Therefore, the rule will need to create a true-up transaction in April 2016 which will take into account the true-up transaction made in February.

When the rule is run, it recalculates what the Actual revenue would have been if this new April 2016 data had been taken into account using the following multi-step calculation:

1. The rule creates a Revised Actual Revenue for each period it must account for. The formula is:  

$$(\text{Actual cost for period} / \text{Total Actual Cost}) \times \text{Total project revenue} = \text{Revised Actual Revenue for period}$$

- The rule subtracts each accounting period's original Actual revenue from the corresponding Revised Actual Revenue. The formula is:

Revised Actual Revenue for period — original Actual revenue for period = **Actual Revenue Difference** for period

- The Actual Revenue Differences for each previous period (January, February, and March 2016 in this example) are summed, and subtracts any previously-recorded true-up transactions, to give the true-up transaction for April 2016. In this example, the sum of (\$7,352.94), \$2,647.06, \$2,647.06, less (\$10,000) creates a true-up transaction of \$7,941.18 for April 2016.

The Balanced IvF rule can be limited to specific employees, expense items, time types, or tasks using a standard SuiteProjects Pro filter.

This rule can only be used with accounts using accounting periods. You can then define which accounting date to use with the rule. You should check the "Use the accounting period specified below" box and use the default accounting period.

The Balanced IvF rule includes a "Do not generate recognition projections for already recognized revenue" option, which functions in a similar manner to the original Incurred versus Forecast rule. If selected, the sum of all revenue recognition projections and actuals will always be equal to the revenue recognition amount defined on the rule.

With the Balanced IvF rule, you can also choose to include or exclude booked or assigned hours for users with missing time entries into recognition revenue projection calculations in periods before the pivot date.


**Note:** This rule also prioritizes using time entries over booked or assigned hours when generating recognition revenue projections. For example, if an employee logs time to a different project than they were originally booked to for a particular period, the calculation will use that employee's logged time rather than their booked time for the recognition calculation.

Finally, other settings allow you to add different "stamps" to generated transactions (for example, service X line, agreement, customer purchase order). You can also select which user loaded costs are used in calculations and define if the recognition rule is active or not.



## Running Revenue Recognition Manually

When a recognition is run, a list of potential recognition transactions based on the set recognition rules is displayed. You can select items which you want to turn into transactions. Then, you can click **Recognition transactions** to see a list of transactions.

 **Note:** You must have at least one recognition rule for a project before running the recognition.

### To manually run Recognition (after creating at least one recognition rule)

1. Select a project and click Financials > Recognition, then click the Run recognition sub-link.
  - Enter a **Start** and **End** date for the revenue recognition run, if applicable. By default, these dates are the values entered when the last revenue recognition was run.
2. Click **Next**. The list of available revenue items appears. If no revenue is available, you will receive a “No recognition transactions are pending for this project” message.
3. If necessary, edit any items in the list. Click on the date of the revenue item you want to change. After making your changes in the popup window, click **Save**.
4. Select the check boxes next to each item you want to include as revenue recognition transactions.
5. Click the **Create recognition transactions** link.

You can see and edit the items which have been recorded as revenue transactions by clicking the **Recognition transactions** link.

When you have created revenue transactions for a project, revenue information is displayed on the **Financial analysis** report for the project. If you want to re-run the recognition, click the **Click here** link at the bottom of the page. This will give you the option of entering a new set of dates.

## Running Revenue Recognition Automatically

SuiteProjects Pro has three options for automatically running revenue recognition on a timed basis. They are:

- **Do not auto-bill** — this is the default setting
- **Run recognition, do not create recognition transaction** — you can test the recognition run without creating revenue items
- **Run recognition and create recognition transaction** — runs recognition and creates recognition transactions

To find the auto-run options for each project, go to the project, click the **Recognition** link, and then click the **Auto-run** sub-link. A popup window containing the three auto-run options will open.

You can set up automatic revenue recognition runs without creating the corresponding revenue items:

### To set up a Trial Automatic Revenue Recognition Run

1. Click the **Run recognition, do not create recognition transaction** option in the **Auto-run** dialog.
2. To add users who should receive email messages of the trial run results, click the > Create or > Edit link, select users from **Available items**, and click **Add highlighted items** to move them to **Selected items**.
3. Select the day of the week and time when the trial recognition will run. Email messages with results of the run will be sent as soon as the trial has been run. All times are in U.S. Eastern Time.

4. If you don't want emails to be sent when no transactions are recognized, click **Suppress the email if there is nothing to recognize**.
5. Click **Save**.

You can set up automatic revenue recognition runs which create recognition transactions:

### To set up an Automatic Revenue Recognition Run

1. Click the **Run recognition and create recognition transaction** option in the **Auto-run** dialog.
2. To add users who should receive email messages of the trial run results, click the > Create or > Edit link, select users from **Available items**, and click **Add highlighted items** to move them to **Selected items**.
3. Select the day of the week and time when the trial recognition will run. Email messages with results of the run will be sent as soon as the trial has been run. All times are in U.S. Eastern Time.
4. If you don't want emails to be sent when no transactions are recognized, click **Suppress the email if there is nothing to recognize**.
5. Click **Save**.

## Revenue Reporting

The reporting values for recognized revenue can be used in reports. Commonly-used reports for reporting revenue based on the previous settings include the following:

- **Account-wide — Projects**
- **Account-wide — Company**
- **Account-wide — Customers**

To set up the captured time range, configure the **Period**, **# of periods**, and **Date** items. Then, choose corresponding fields which should be calculated in the resulting report. The following list are commonly-used Measures:

- **Projects — Actual revenue margin** — money from recognitions minus the cost of approved hours from time entries. Field type: money
- **Projects — Deferred Revenue** — money from all charges minus recognition transactions. Value will never be less than zero. Field type: money
- **Projects — Pending recognition transaction** — money from pending recognition transactions. Field type: money
- **Projects — Pending recognition transaction count** — number of pending recognition transactions. Field type: count
- **Projects — Pending recognition transaction time (Days)** — days from pending recognition transactions.
- **Projects — Pending recognition transaction time (Hours)** — hours from pending recognition transactions.
- **Projects — Projected deferred revenue [rules]** — the difference between money billed and money recognized from recognition projections. Field type: money
- **Projects — Projected revenue [rules]** — recognition projections which were generated using recognition rules. Field type: money
- **Projects — Projected revenue booking margin [rules]** — money from recognition projections which were generated using recognition rules minus the cost of the hours from the bookings. Field type: money

- **Projects — Projected revenue margin cost [corresponding cost][rules]** — revenue minus the cost. Field type: money
- **Projects — Recognition projection count** — number of recognition projections. Field type: count
- **Projects — Recognition projection time (Days)** — days from Recognition projections.
- **Projects — Recognition projection time (Hours)** — hours from Recognition projections.
- **Projects — Recognition transaction count** — number of recognition transactions. Field type: count
- **Projects — Recognition transaction time (Days)** — days from recognition transactions.
- **Projects — Recognition transaction time (Hours)** — hours from recognition transactions.
- **Projects — Recognition revenue** — money from recognitions. Field type: money
- **Projects — Recognized revenue from Expense item charges** — money from recognitions generated from Expense item charges. Field type: money
- **Projects — Work-in-Progress** — money from recognition transactions minus money from all charges. Value will never be less than zero. Field type: money

## Detailed Revenue Reports

Separate reports are available for reporting revenue recognition and corresponding values. These reports are:

- **Projects — Recognition rules**
- **Projects — Recognition transactions**
- **Projects — Pending recognition transactions**
- **Projects — Recognition projections**

### Projects — Recognition Rules

To view details about all currently created recognition rules, select Reports > Detail > [Projects] > Recognition rules in the old reporting system, or search for and select Projects — Recognition rules in the Next Generation Report Management interface. Set up the date filter for when the revenue recognition was created, either by selecting any predefined time range or using a custom date period.

### Projects — Recognition Transactions

To view details about recognition transactions, select Reports > Detail > [Projects] > Recognition transactions in the old reporting system, or search for and select Projects — Recognition Transactions in the Next Generation Report Management interface. Set up the date filter for when the revenue recognition was created, either by selecting any predefined time range or using a custom date period. For this type of report, you can also choose conversions on a different basis in Forex conversions and User loaded cost determination. Any report value which requires a foreign exchange conversion will use that date as the exchange rate date. The date will also dictate the date used for the currency conversion of user-loaded costs for any cost reporting value.

### Projects — Pending Recognition Transactions

To view details about pending recognition transactions, select Reports > Detail > [Projects] > Pending recognition transactions in the old reporting system, or search for and select Projects — Recognition Transactions in the Next Generation Report Management interface. Set up the date filter for when the

revenue recognition was created, either by selecting any predefined time range or using a custom date period. For this type of report, you can also choose conversions on a different basis in Forex conversions and User loaded cost determination. Any report value which requires a foreign exchange conversion will use that date as the exchange rate date. The date will also dictate the date used for the currency conversion of user-loaded costs for any cost reporting value.

## Projects — Recognition Projections

To view a complete overview of current recognition projections, go to Reports > Detail > [Projects] > Recognition projections in the old reporting system, or search for and select Projects — Recognition in the Next Generation Report Management interface. Set up the date filter for when the revenue recognition was created, either by selecting any predefined time range or using a custom date period. For this type of report, you can also choose conversions on a different basis in Forex conversions and User loaded cost determination. Any report value which requires a foreign exchange conversion will use that date as the exchange rate date. The date will also dictate the date used for the currency conversion of user-loaded costs for any cost reporting value.

## Specialized Revenue Reports

Two reports with pre-defined options are available in Reports > Advanced. These can be used to view pending recognitions and fixed fee projections. These reports are:

- **Pending recognition**
- **Fixed fee projections**

### Pending Recognition

This report shows what recognition transactions would be generated if the projection recognition rules were run. You can also recognize revenue on individual projects or across all projects. Included items can be included based on the following:

- **Time period** — choose a date range or start date for the data
- **Filters** — select which data to include or exclude by clicking **Create** or **Edit** and selecting items from the list or using the **Find** feature.
- **Other** — you can choose to **Hide projects with no pending recognition**, select a currency, or **Save this report as ...** to save it with a particular filename.

If there are pending recognition transactions, the project name is hyperlinked. Click this link to view and create recognition transactions for the project. You can also click a link in the Tips menu to create all revenue recognition transactions across all projects with one click.

### Fixed fee projections

This report shows total billings or revenue recognition anticipated under the fixed fee rules. It shows the total value of all rules: the amount used (where rules have already been run and transactions created), the percentage of the total used, and the amount remaining. This report can be customized with the following options:

- **Projections from** — select whether you want to run the report on billing or recognition rules. For recognition, both fixed fee on date or milestone and fixed fee on percent complete rules are considered.

- **Approval status** — apply filters as desired by clicking the checkboxes next to them.
- **Time periods** — Future billings or recognition can be broken out by period (specify the period, number of periods, and enter a date within the period where the report should start from).  
Click **Do not move late rules to the first period** to prevent a late rule from being moved to the first period. A late rule is a rule which should have run before the first period.

You can also subtotal information by customer and project.

## Merging Slip and Revenue Projection Deltas Using Automatic Backup Service (ABS)

By default, when SuiteProjects Pro runs slip and revenue projections, it fully generates the slip\_projection and revenue\_projection tables, with no indication of which records were changed against the previous run. You can use the **Merge Daily Changes Into Slip Projection and Revenue Projection Tables** feature to generate slip and revenue projections so that changes can be recognized using the standard “created”, “updated”, and “deleted” SuiteProjects Pro columns. To enable this feature, contact SuiteProjects Pro Support. Currently SuiteProjects Pro detects changes only in the following fields:

- transaction\_id
- acct\_date
- slip\_projection\_id (only available in the revenue\_recognition table)

If other fields are changed, the old row in the slip\_projection or revenue\_projection table will be flagged as “deleted” (the “deleted” field will change from null to “1”), and the new row will be added to the table.

You can also use the Create Virtual Slip and Revenue Projection Merge Tables feature to download deltas (all new, deleted, and modified transactions) for the slip\_projection and revenue\_projection tables using Automatic Backup Service. To enable this feature, contact SuiteProjects Pro Support.

When this feature is enabled, a **Virtual Projection Tables** option is added to the Automatic Backup Service. When this option is selected and ABS first runs, it will create the two virtual tables. ABS then copies the data directly from the slip\_projection and revenue\_projection tables to these virtual tables. For subsequent ABS runs, updates, additions, or deletions will be applied to these virtual tables. If the feature is disabled, the counter is reset, and when it is enabled again, ABS will recreate the two virtual tables.

You can also manually download these deltas for a selected period. Start and end dates for the deltas can be set in Administration > Global Settings > Account > Integration Import/Export > Export charge projections, Recognition projections deltas. The data file is saved in the same format as ABS MySQL export files, with SQL commands containing “update”, “delete”, and “insert SQL” statements.


## Revenue Recognition Switches

The following is a list of Internal Switches which affect the Revenue Recognition feature. To enable any of these switches, please contact SuiteProjects Pro Support and request the switch or switches you would like to activate.

- **Enable centralized recognition feature** — moves **Run Revenue** and the **Revenue Transaction List** to the Invoices module in their own tab. You should have SuiteProjects Pro Professional Services help to deploy this advanced feature.
- **Allow decentralized recognition transactions in conjunction with centralized recognition feature** — maintains a project-specific list of recognition transactions in individual projects. This should only be used with the **Centralized Revenue Recognition** feature.

- **For expenses recognition rules, do not include non-billable receipts when using the All Incurred Expenses option** — ensures that non-billable receipts are excluded when an Expense rule is used with the **All incurred expenses** setting.
- **Disable editing of TimeBills associated with recognition transactions** — TimeBills associated with recognition transactions cannot be modified.
- **Allow tasks as well as phases in % complete recognition rules** — allow tasks and phases to be chosen as options in percent complete recognition rules.
- **Require a service selection in recognition rules** — requires you to make a service selection for all revenue recognition rules. If you do not select a service, the form will produce an error when submitted.
- **Use the date filter end date as the recognition date stamp** — uses the date filter end date as the recognition date stamp. The default behavior uses [Today] as the date stamp.
- **Use only invoiced charges from approved, incremented and sent/viewed invoices for "As Billed" recognition** — only uses charges that are on Approved invoices, with an applied/incremented number that has also been marked "Sent" for "as billed" recognition. The default setting is to use ALL charges.
- **Use only invoiced charges from approved invoices for "As Billed" recognition** — ensures that only invoiced charges from Approved invoices are used in As Billed recognitions.
- **Use the invoice date for "As Billed" recognition transactions** — uses the Invoice Date for the date of "as billed" recognition transactions.
- **When TimeBill projections use booked hours, use approved and booked hours for incurred vs. forecast recognition rules** — activating this switch and using booked hours for slip projections causes incurred vs. forecast calculations to return the same values as if the "Approve and booked hours multiplied by user cost" was selected in the incurred vs. forecast rule.
- **Use the last day with approved time as the break date for Approved and booked in the Incurred vs. forecast recognition rule** — Incurred versus forecast recognition rules use a cut-off date to calculate incurred costs based on approved time entries and forecast costs based on approved time entries plus booked time after the cut-off date.  
By default, the cut-off date is the end date of the latest approved timesheet, where "latest approved timesheet" refers to the approved timesheet with the latest timesheet period end date.  
When this switch is enabled:
  - The break date is the latest date with an approved time entry in approved timesheets.
  - You can modify this behavior on a per-resource basis using the well-known custom field `use_timesheet_date_for_revrec` for employee records. If `use_timesheet_date_for_revrec` is checked for this user the break date is the end date of the latest approved timesheet when generating revenue recognition transactions based on approved time or booked time for this user.
- **Enable filtering by booking type in Incurred vs. forecast recognition rules** — permits a booking type filter in leveraging bookings in the forecasted cost calculation. This may be beneficial if the forecast option is configured to use the "Approve and booked hours multiplied by user cost" option and you would like to exclude bookings which have a "Tentative" booking type from the calculation.
- **Enable support to set dates or milestones on the Incurred vs. Forecast recognition rule** — enables support to set dates or milestones on the Incurred vs. Forecast recognition rule
- **Show phases in Task filter on the Incurred vs. forecast recognition rule** — the Projects > [select Project] > Financials > [create Incurred vs. forecast rule] form shows Phase/Task instead of Task in the **Recognition rule filters** section.
- **Disable editing of exported recognition transactions** — prohibits editing of exported recognition transactions.
- **Enable editing of revenue recognition hours** — exposes the "Hours" and "Minutes" fields on revenue recognition transactions from as billed (from time) and time recognition billing rules, as well as manually created revenue recognition transactions.

- **Allow billing rules and recognition rules to be copied when a task is copied** — Allow billing and recognition rules to be copied with tasks.
- **Delete the associated billing rules and recognition rules when a task is deleted** — Delete the associated billing and recognition rules when you delete a task.
- **Add Cost centers to Charges, Project billing transactions, and Recognition transactions** — adds cost centers to charges and revenue recognition transactions.
- **Require a cost center selection in recognition rules** — recognition rules require you to select a cost center. If a cost center isn't selected, the form will display an error when submitted or saved.
- **The user can un-export recognition transactions** — lets users un-export recognition transactions.
- **The user can mark recognition transactions exported** — lets users mark recognition transactions as exported.
- **Use approved hours instead assigned hours in the approved type percent complete revenue recognition projections** — use approved hours instead of assigned ones for approved type percent complete revenue recognition projections.
- **Respect the dates filtered on 'incurred vs. forecast' rule when generating revenue recognition transactions** — Include only the approved time entries, approved expenses and fulfilled purchase items for the specified date range when generating revenue recognition transactions using 'incurred vs. forecast' recognition rules.

 **Note:** Enable this switch, for example, if you run revenue recognitions for the previous month (for example November) a few days into the current month (for example December 6) and you only want to include approved time entries, approved expenses and fulfilled purchase items for the previous month (for example November 1–30) in revenue recognition transactions.

- With this switch enabled, only the approved time entries, approved expenses and fulfilled purchase items entries up to and including the specified end date (for example November 30) will be included in revenue recognition transactions.
  - If the switch is not enabled, revenue recognition transactions include all approved time entries, approved expenses and fulfilled purchase items up to and including the date you run the revenue recognition (for example December 6). This may include not only approved time entries, approved expenses and fulfilled purchase items for the previous month (for example November) but also for the current month up to the date you run the revenue recognition (for example December 6).
- **Use only bookings with the following approval statuses for % complete recognition projections** — only bookings with the selected approval statuses are used to calculate % complete revenue recognition projections.
  - **Enable Recognition transaction and Recognition projection date filters in summary reports** — shows an additional Date Filters section for Recognition and Recognition Projection Values in summary reports.
  - **Enable the feature to exclude specific projects from projections using custom field exclude\_from\_projections** — lets you create an “exclude\_from\_projections” custom field in a project's properties. You can check this field to disable projections built with this particular project.
  - **Show Billing Picklists on Revenue Recognition Transactions** — This feature allows you to choose which revenue recognition rule forms display a billing rule pick list. When you select a billing rule from this field, the billing rule is linked to the revenue recognition rule. This setting does not affect when billing or revenue recognition rules are run. Billing Rule IDs on revenue recognition rules can be accessed using the XML or SOAP APIs.

- **For incurred vs. forecast recognition rules, use hours from assign by day table for the forecast, instead of planned hours, so that dated loaded cost can be used for the forecast instead of current loaded cost** — By default, the **Estimated hours multiplied by user cost** forecast is calculated using the current employee hourly cost. With this optional feature enabled, the forecast is calculated using the loaded cost effective on the day work is assigned. The forecast calculation uses both the current hourly cost and the historical hourly costs set in Administration > Employees > [Select an Employee] > Cost.

## Issues

To use the issues feature, you must enable it.

To enable the Issues feature, go to Administration > Application Settings > Projects > Other settings and select the switch **Enable project issues**.

The Issue functionality provides you with the ability to maintain and manage issues encountered on projects. There are several components that are available for the configuration of an issue as well as the tracking needs defined by your business requirements.

Issues can only be created from within the project for which the issue is being entered. Issues may be updated, however, directly from the Issues tab of the Projects application. Action items can be reported upon directly in the application.

Display issues by selecting Issues > and select either pending, completed, or all. Issues are also displayed and linked to a project. Select Projects > Project > Issues.



There are several ways to define issues and they include categories, severities, sources, stages, and statuses.

### To create an Issue:

1. Go to Projects > Projects and select the specific project.
2. Select **Issue** from the **Create Button**.
3. Enter the New issue form information.
4. Click Save.

You can also quickly create new Issues using existing ones' information. While in the Issues list, click the **Duplicate** option next to the Issue you would like to duplicate.

### To view and update Issues:

1. Go to Projects > Projects and select the specific project.
2. Select the Issues tab.
3. Click the **Edit** or **Report** link for the issue.

## Issue Categories

Issue categories indicate the areas within a project that are impacted by the issue or the type of issue identified. The category may be at a high level such as Issue or Risk. They may also be at a more defined level such as Documentation, Product, Usability, and Training. You can also add notes describing the issue category. Issue categories, after they have been defined, may be inactivated and reactivated at any time.

### To create Issue categories:

1. Go to Administration > Application Settings > Projects > Issue categories. Select **New Issue category** from the **Create Button**.
2. Complete form information and click Save.

## Severities

Severities designate how serious or critical the issue is in terms of impacting a deliverable, the project plan or other key elements of the project. Possible values could be Low, Medium and High or use of a numeric scale (for example, 10 is severe impact and 1 is slight impact). You can also add notes describing the severity. Issue severities, after they have been defined, may be inactivated and reactivated at any time.

### To create severities:

1. Go to Administration > Application Settings > Projects > Severities.
2. Select **New Severity** from the **Create Button**.
3. Complete form information and click Save.

## Sources


Sources identify the person, team, or area that submitted the issue for the project. Examples are: Project Manager, Team Member, Customer Lead or Test Results. The issue source provides another filter and reporting option for classification of the issues reported. You can also add notes describing the issue source. sources, after they have been defined, may be inactivated and reactivated at any time.

### To create sources:

1. Go to Administration > Application Settings > Projects > Sources.
2. Select **New Source** from the **Create Button**.
3. Complete form information and click Save.

## Stages

Stages designate where the issue is in the process. Sample stage values could include: Open, Assigned, On Hold, In Work and Resolved. You can choose whether this stage is the default assigned to new issues and whether issues are considered closed when in this stage. Typically an Open stage is selected as the default for new issues and the Resolved stage is selected as the stage for issues to be considered closed. You also designate where the stage value displays in the list of issue stages. A notes field is available for issue descriptive material.

 **Note:** An issue stage may not be inactivated after it has been defined. It may be deleted altogether provided no issues are in the stage.

### To create stages:

1. Go to Administration > Application Settings > Projects > Stages.
2. Select **New Stage** from the **Create Button**.
3. Complete form information and click Save.

## Statuses

Statuses provide a means to identify the overall health of the issue. Sample statuses are: Red (critical), Amber (on watch list) and Green (no known problems). You can enter as many status values as are necessary for your company's needs. Using the sample values noted above, a Red status could mean that the issue will impact project timelines. An Amber status might mean the issue should be monitored to avoid impact to the project.

You can also add notes describing the status. Statuses, when defined, may be inactivated and reactivated at any time.

### To create a statuses component:

1. Go to Administration > Application Settings > Projects > Statuses.


2. Select **New Status** from the **Create Button**.
3. Complete form information and click Save.

## Downloading Issue Attachments in Lists and Bulk Actions

You can download issue attachments without having to open each issue to download files individually, and use bulk actions to download all attachments for multiple selected issues.


### To download issue attachments from a list:

1. Click the Download icon in the "Action" column of the Project Issues list.

 **Note:** If an issue contains multiple attachments, attachments are downloaded as one ZIP file.

### To download attachments from more than one project issue at one time:

1.
  1. Go to Projects > Issues> [select an issue].
  2. Add the "Run an action" column to the list.
  3. In the "Run an action" column, select the issues which you want to download attachments from.
  4. In the "Action" dropdown list, select "Download selected".

 **Note:** A ZIP file containing all attachments is generated.

## Pricing

Project pricing lets you create pricing estimates for specific projects based on different staffing, rate, and time required scenarios, and automatically view the key financial analysis for those scenarios.

The Pricing feature is displayed as a link within a project if pricing is enabled within the project stage. See [Project Stages](#). The options available are determined by the pricing scenarios that are set up within the project.

## Financials: Pricing: Scenario

Use the Pricing Scenario form to set up pricing scenarios for your project.

### Create a Pricing Scenario

1. Go to Projects > Projects > [select a project] > Financials > Pricing. The "Scenario" form opens.
2. In the Revenue section, select the rate cards you want to use to determine revenue based on standard and discounted rates. The analysis will show both the gross revenue (from the standard rate card) and the difference in the discounted rate card.
3. The "Get the revenue hours from" field determines the revenue portion of the analysis. Choose "Job code estimates" for a high-level, job-code-based labor revenue estimate, "Bookings" for a more detailed estimate, or Tasks for the most granular estimate. (If you want to split revenue over time, you must select "Bookings.")

4. Select "Calculate revenue to generate a margin of" if you would like to ignore revenue entries and instead calculate your scenario's revenue by a percent margin. Enter the percent margin you want generated in the text field (do not include the % sign).
5. The "Get the hours from billable resource costs from" field determines the labor cost portion of the analysis. Choose "Job code estimates" for a high-level, job-code-based labor cost estimate, "Bookings" for a more detailed estimate, or Tasks for the most granular estimate.
6. If you have enabled multi-currency functionality, select the currency for the scenario.
7. If desired, choose a percent probability of closing from the dropdown menu. This will be used when running the "Pricing analysis" Advanced project report.
8. Check the "Staffing approved" and "Finance approved" boxes to indicate if this scenario has been approved by Finance or Staffing functions. These check boxes will only be visible to users whose roles are set up to modify finance or staffing approval for project pricing.
9. Select "Use worked hours for prior months" to use worked hours to calculate the scenario instead of booked or assigned hours when worked hours are available.
10. Enter any desired notes, and click "Save".

Other gross revenue, investment absorptions, other billable costs, non-billable resource costs, and non-billable expense costs can all be individually spread out over time.

### Split Pricing Scenario Amounts Over Time

1. Go to Projects > Projects > [select a project] > Financials > Pricing > Scenario. The "Scenario" form opens.
2. Set up the Revenue section of the Pricing Scenario form as in [Create a Pricing Scenario](#).
3. In the Cost section of the Pricing Scenario form, click the "split" link next to either the "Billable expense or purchase cost (money)" or "Non-billable expense or purchase cost (money)" fields. The form will change to show "Date" and "Amount (money)" fields for each billable or non-billable expense or purchase cost.
4. For each section where you want to split the amounts over time, select the date and corresponding amount of money that you want to allocate for that time period. The first time period defaults to today's date. Note that for every date you choose, you must have a corresponding dollar amount or you will get an error message when you try to save the Scenario.
5. For any section whose amounts you do not want to split over time, either delete the initial date or click the "un-split" link for that section. The form will refresh without the Date and Amount fields for that section only.
6. You can add additional Date/Amount rows to any section from the "Add rows" dropdown box.

## Financials: Pricing: Job Code Estimates

Job code estimates enable you to specify the position levels or jobs required to complete the project, the number of individuals performing each job, and the average number of hours each of them will work. By combining this information with the rates and adjustments established in the Scenario section, you can run financial analyses on various estimate scenarios.

### Create a Job Code Estimate

1. Go to Projects > Projects > [select a project] > Financials > Pricing > Job code estimates. The "Job code estimate" form opens.
2. Select a job code from the "Job code" dropdown list.

3. Enter the number of employees who will be deployed on the project at that job level in the “# of employees” field.
4. Enter the average number of hours each of these individuals will work in the “Hours per employee” field.
5. Repeat steps 2 through 4 for each additional job code. If you need to add more rows to the grid, click the “[Add rows]” dropdown list and select the number of rows you would like to add. You can choose from “3 more”, “6 more”, or “9 more” rows.
6. Click “Save”.


## Financials: Pricing: Analysis

You can see a financial snap shot of your scenario by clicking on the "Analysis" link. The snap shot includes key revenue and cost parameters, discounts, profits and margins. By default, the analysis applies to the entire period of the project.

The weighted net revenue line represents net revenue weighted by the closing probability entered in the pricing scenario setup.

The snap shot dropdown menu lets you save a snap shot of the current analysis. You can also view previously created snap shots. To create a snap shot, select "> Create a snap shot" from the dropdown menu and enter a name in the window which opens. You can also select whether it is based on an approved budget. To view an existing snap shot, select the appropriate snap shot from the menu.

When viewing a snap shot, you can change the name of the snap shot or delete it by selecting "Edit this snap shot" from the dropdown menu and clicking the appropriate button on the window that pops up.

 **Note:** Note: If you are analyzing a "Bookings" Scenario, you can choose to split the analysis over time periods. To do so, click the "Analysis options" link, select a time period from the dropdown menu, and the start and end dates for the analysis. If you check the "Total by period" box, the report will show subtotals for each period, the total for the range specified and the total for the entire project.

- Click the “Analysis options” link to adjust the following settings:
  - Choose to use Total by period
  - Include hourly detail by employee
  - Define the period length and its start and end dates
  - Set the Loaded hourly cost using Primary loaded costs, Secondary loaded costs, or Tertiary loaded costs
- Click the “Print” link to open the Analysis in a more printer-friendly format.
- Click the “Print budget view” link to download PDF versions of your scenario’s summary or details with fields for Customer Approval.
- Click the “Download” link to download your analysis as a CSV-formatted or HTML-formatted file.

## Project Billing Defaults

Set the project billing default options for new projects. These options do not change the billing settings for any existing projects.

When using project billing rules, you may set a global project billing defaults option for running billing rules and sending results to a defined individual. The default settings for new projects include: Do not

auto-bill; Run a trial billing, do not create project billing transactions or charges; Run billing and create project billing transactions and charges. You can create a list of employees to email results of the auto-bill run to and you can schedule the billing option to run at a defined day and time. Optionally, you can suppress the email if results do not include billable items.

**Note:** Any project billing default options can be overridden within an individual project by using the auto-bill feature within the billing link of the project.

### To access and modify the Project billing defaults:

1. Go to Administration > Application Settings > Projects > Project billing defaults.

**Do not auto-bill** — This option does not run the billing rules automatically. This does not impact forecasting, which is handled by charge projections, nor invoicing, which can be done using a manual billing approach. For more information about charge projections, see [Charge Projections](#).

**Run a trial billing, do not create project billing transactions or charges** — This option does not run the billing rules automatically but does simulate running the rules to get an estimated billing value. No billing transactions or invoice charges are generated, only the trial billing value. An email is sent for each project that has a trial billing amount. This does not impact forecasting, which is handled by charge projections, nor invoicing, which can be done using a manual billing approach. For more information about charge projections, see [Charge Projections](#).

**Run billing and create project billing transactions and charges** — The billing rules are run automatically and generate billing transactions and invoice charges. This does not impact forecasting since it is handled by charge projections. For more information about charge projections, see [Charge Projections](#).

**Note:** All times set are US Eastern Time regardless of your employee specific preferred time zone. After Project billing options are set up, they become the default billing options for all new projects.

## Project Budget

The Project Budget feature lets you draw a detailed budget for labor, expenses, and purchases associated with your project and track expenditure at the task, phase, or project level.

The feature lets you:

- Create budgets based on cost or billing.
- Keep different versions of the same budget. Budgets are archived automatically as new budgets are approved.
- Get an overview of project expenses and profitability. View budgeted totals as well as monthly, quarterly, category-level, and task-level details.
- Submit multiple budgets for approval for the same project, compare up to five budgets side by side and approve the most realistic scenario.
- Compare your project expenditure (actuals) against planned budgets.
- Identify budget variances with customizable color coding for budget items that are on or off target, based on the percentage of planned versus actual expenditure.

To enable this feature, contact SuiteProjects Pro Support. SuiteProjects Pro Support can also enable related optional features and change related configuration settings.

- The Task on Purchase Request optional feature lets you add task-level granularity for purchase requests and items.
- An optional feature lets you add **Estimate to Complete (ETC)** and **Estimate at Completion (EAC)** columns to total columns in the budget, actuals, and compare views. The ETC and EAC values are calculated automatically when you save changes to your project budget.

- Your account can be configured to let you compare actual project costs against different project budget scenarios:
  - Normal, Optimistic, Pessimistic, Most Likely scenarios using a three point estimate (triangular or double-triangular distribution).
  - Normal, Optimistic, Pessimistic scenarios using a simplified contingency factor. The contingency factor setting lets you define optimistic and pessimistic scenarios for each project as a percentage of the planned costs. See [Creating a Project Budget or Modifying Project Budget Properties](#).

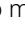

## Project Budget List

The project budget list lets you view the list of project budgets associated with the project. To view the project budget list, go to Projects > Projects > *[Select a project]* > Financials > Project Budget.

- Click the Edit icon  to modify the project budget properties.
- Click the Copy icon  to duplicate the project budget.
- Click the Delete icon  to delete the project budget.
- Click the Submit icon  to submit the project budget.
- Click the Pin icon  to mark the project budget as baseline. The baseline budget is used as the main reference for comparison against incurred project costs (actuals) and other budgets for the same project in reports. Only one budget with any approval status can be marked as baseline for each project. Baseline budgets are indicated with a green check mark under the Baseline project budget column in the list.

 **Note:** The baseline budget functionality requires the Estimate to Complete (ETC) and Estimate at Completion (EAC) in Project Budgets optional feature to be enabled for your account. Users must have the **Allow the user to set a project budget as a baseline** role permission to mark a budget as baseline.

- Click **Budget** to view and modify the project budget.

- Click **Actuals** to compare incurred project costs against the planned budget (for cost-based budgets), or actual values from charges and invoices against the planned budget (for billing-based budgets).

The project budget page includes the following elements:

- Summary grid — The left side of the budget grid shows the work breakdown structure for your project, the project costs under Expenses, Labor and Purchases categories, totals and other summary fields. You can add entries under all three categories directly from the grid and import labor entries from task assignments or bookings.
- Time grid — The right side of the budget grid shows a detailed breakdown of your budget per week, month or quarter over the span of the project.
- Toolbar — Switch between a view showing the budgeted costs, a view showing actual incurred costs, or a view comparing multiple budgets (see [Budget, Actuals and Compare Views](#)). Control view options such as the time granularity, the type of values shown (monetary or time and quantity, cost-based or billing-based), along with other list tools (See [Project Budget Toolbar](#)).
- Information and Settings panel — Vertical tabs include summary information related to your budget and additional settings and controls. See [Information and Settings Panel](#).



## Budget, Actuals and Compare Views

The project budget page lets you switch between a view showing the budgeted costs, a view showing actual incurred costs, or a view comparing multiple budgets.

- **Budget View** — Click **Budget** in the toolbar to show budgeted costs. You can add or modify budget items directly from the summary grid, and edit values for each item in the time grid.

## Information and Settings Panel

- The **Budget overview** tab lets you view the budget totals and remaining funds.
- The **Budget info & settings** tab lets you:
  - View basic budget information, including the budget name, created and modified dates, the parent budget it was created from, and its status.
  - Control view settings.
    - Check the **Rounded values** box to show monetary values rounded to the nearest integer value.

- Check the **Enable autosave** box to save changes to your budget automatically on a regular basis (Budget view online).
- Check the **Don't prefix task name with task ID** box to show task names only in the project budget grid and remove the task IDs.
- Check or clear a box under the View section to show or hide the corresponding project budget grid columns. On the Actuals view you can also:
  - Select to show actual costs at the task level or cumulatively at the phase or project level.
  - Select which loaded cost to show.
  - Choose which budget scenario (normal, pessimistic, optimistic, most likely) to compare actual project costs against.
- Perform certain actions, such as importing labor item information from task assignments or bookings.
- The **Agreements** tab lists the agreements and Customer POs associated with the project. The list shows summary information for each funding document, including the document name, total amount, total planned costs, and remaining funds. Billing budget entries are deducted from agreements and customer POs in chronological order.
- The **Compare** tab lets you select a base budget and other budgets you want to compare. To remove a budget from the compare view select **Select ...** from the corresponding dropdown field. You can compare up to 5 budgets at the same time.

## Project Budget Toolbar

The toolbar includes the following controls from left to right:

- Navigation: Budget | Actuals | Compare (selected) | Zibura budget v2
- Units: Money | Hours/Quantity | Show billing
- Time Period: Weeks | Months | Quarters
- Actions: Discard | Save | Settings (gear icon)
- Filter: Filter

The toolbar includes the following controls from left to right:

- Edit icon — Click the icon to edit the budget properties.

- Budget | Actuals | Compare — Choose **Budget** to show budgeted costs. Choose **Actuals** to show actual incurred costs. Choose **Compare** to show multiple budgets side by side on the same view.
- Budget dropdown — A dropdown field lets you select the budget you would like to view for the currently selected project.
- Money | Hours/Quantity — Choose **Money** to show only monetary values in the time grid. Choose **Hours/Quantity** to show time in hours and quantities instead of monetary values where relevant.
- Show billing — Check the **Show billing** box to view billing-based budget figures in the time grid. When checked, the values in the time grid. Clear **Show billing** to view the cost-based budget.
- Weeks | Months | Quarters — Choose the granularity for the time grid to show a detailed breakdown of your budget per week, month or quarter.
- Settings icon  — Click the icon to show a menu with additional options. You can download the project budget grid data as a CSV, HTML, or PDF file, enable column resize, or reset columns to their default width.
- Click the Expand All icon  or Collapse All icon  to expand or collapse all nodes in the project budget. Click the Expand Work Breakdown Structure icon  to expand all phase and task nodes but not the category and subcategory nodes.
- Filter — Enter the name of a cost category to show only matching cost items in the project budget grid.


## Sorting Options

You can sort the project budget data by column using the sort icons in the summary grid and time grid column headers.

This feature supports ascending and descending sort orders and multi-level sorting up to three levels. The arrows in the column header indicate the sort order and sorting levels:

- Sorting levels are color-coded:
  - White color arrow — Primary level
  - Yellow color arrow — Secondary level
  - Green color arrow— Tertiary level
- The colored arrow indicates the sort order for each sorting level:
  - Arrow pointing up — Ascending sort order
  - Arrow pointing down — Descending sort order

Click a column header to select that column as your primary sort field. Click the same column header again to change the sort order. If you click a different column header, this column becomes your primary sorting level, the previous primary level becomes the new secondary level and the previous secondary becomes the new tertiary level.


To reset the sort order to the default one, click the sort icon  in the toolbar.

## Creating a Project Budget or Modifying Project Budget Properties

You can create any number of budgets for your project using the Project Budget feature. You can also edit the properties of existing project budgets that are not submitted for approval or approved.


### To create a Project Budget or modifying project budget properties

1. Go to Projects > Projects > *[Select a project]*.
2. Do one of the following:

- To create a new project budget, click the Create button, then **Project budget**.
- To modify the properties of an existing project budget, click Financials > Project budget in the project record header, and click the Edit icon  under the Action column for the budget you want to modify.

The project budget properties form appears.

3. Enter all required information in the project budget properties form. The form includes the following information:
  - **Project budget name**
  - **Date**
  - **Budget level** — Choose whether to budget at the project, phase, or task level. The budget level cannot be changed for existing budgets.
  - Check **Enable creation of project budget entries not connected to particular tasks** box, if applicable. This lets you add budget entries at the project level when **Budget level** is task, for example.
  - **Planned budget** — Define the cost (for cost budgets) or cost and profitability (%) (for billing budgets).
    - **Cost** — Total project cost (used for all budgets, whether based on cost or profitability).
    - **Profitability (%)** — The target profitability percentage (used for budgets based on billing).
    - **Billing** — Read-only value used for budgets based on billing, and calculated automatically based on:
      - The sum of all agreements and customer purchase orders attached to the project, if the **Get planned billings from Agreements and Customer POs attached to the project** box is checked.

 **Note:** If the **Get planned billings from Agreements and Customer POs attached to the project** box is checked, changing either one of the **Cost** or **Profitability (%)** value, changes the value of the other based on the **Billing** value.

- The **Cost** and **Profitability (%)** values, otherwise.
- **Funding** — If the **Get planned billings from Agreements and Customer POs attached to the project** box is checked, the form shows the list of agreements and customer POs associated with the project including the following information: Document type, name, number, date, monetary **total**, total number of **hours**.
- **Currency** — The currency set on the project properties form.
- **Labor** — Set the labor subcategory and imported labor information settings
  - **Labor subcategory** — Budget entries for labor can be broken down either by Service or by Job code.
  - **Import labor based on** — Budget entries for labor can be imported from either task assignments or bookings.
- **Actuals vs planned color coding** — Add color coding for budget actuals in the Compare view to identify budget entries that are on or off target.
  - **Color coding** — Click **Create** to set ranges for color coding in the Compare view, based on the percentage of actual values compared to planned values.
  - **Use global color coding** — Check this box to use the color coding preferences set for your account.
  - **Actuals for color coding** — Select which actual values that will be color coded, based on item statuses (Approved, Submitted, or All).

- **Contingency factor** — Set **Optimistic (%)** and **Pessimistic (%)** scenarios for your project. Default values are 80% and 120%, respectively, and can be changed in Administration > Application Settings > Projects > Project Budget Options.

**Note:** The Contingency factor form section shows only if your account is configured to allow for a simplified contingency factor on project budgets. To change this configuration setting, contact SuiteProjects Pro Support.

## Approving and Unapproving a Budget

You can view all budget versions for approval, automatically reject submitted budgets and archive old approved budgets in the budget interface. To view the list of budgets, go to Projects > Project budgets and select a budget status (Open, Submitted, Approved, Rejected, Archived, or All).

Different versions of the same budget are assigned a version number which is visible in the Version column of the Project budgets lists. Approved budgets automatically cause other submitted budgets to be rejected. Previously approved budgets are archived, so only one approved budget exists at any particular time.

### To approve a submitted budget:

1. Go to Projects > Project budgets and select the Submitted budget list. You can also choose to show budgets which are "Waiting my approval" or "All".
2. Click the budget to approve. The budget properties form opens.
3. Click **Submit/Approve**.
4. On the Approval request form, choose **Approve**.
5. (Optional) Enter **Additional email addresses to CC** and add **notes or comments** for the approval.
6. Click **Save**.

Administrators can give selected users the permission to unapprove budgets. To enable this feature for a user, go to Administration > Global Settings > Users > Employees > [Select a user ID], scroll to Projects Options, check the **Allow the employee to unapprove a project budget box**, and click **Save**.

### To unapprove a budget:

1. Go to Projects > Projects > [Select a project] > Project budgets and select an approved project budget.
2. Click **Submit/Approve**.
3. In the Approval History page, click the **Click here** link in the unapprove message to unapprove the budget.

## Account-Wide Project Budget Preferences

You can set account-wide preferences for the Project Budget feature, including color coding for budget variances.

To set account-wide preferences for the Project Budget feature, go to Administration > Application Settings > Projects > Project Budget Options.

The form lets you set the following preferences:

- Number of week, month or quarter period visible before the start date and after the end date of the project.
- Data distribution — Choose to apply the cost on the first day of the period or to distribute evenly across the whole week, month or quarter period.
- Import cost priority — Choose to use employees cost only, service or job code cost only, or both with a preference for employees cost.
- Color coding — Set color coding to identify incurred costs that are on- or off-target, based on the percentage of planned versus actual expenditure. Click **Create**, then enter **Low** and **High** percentage values and select a color for each color coding category.

Budget color-coding accurately reflects overages when using optimistic or pessimistic contingencies. After you have set color-coding ranges for a budget, when you switch between Normal, Pessimistic, or Optimistic planned values in Actuals view, the color-coding automatically takes into account the new planned values when shading actual budget values.

**Note:** To set a maximum percentage (essentially “infinity”) enter 999 into a High field.

- Contingency factor — Set default values for **Optimistic (%)** and **Pessimistic (%)** scenarios for project across the account.

**Note:** The Contingency factor form section shows only if your account is configured to allow for a simplified contingency factor on project budgets. To change this configuration setting, contact SuiteProjects Pro Support.

- ETC & EAC — If the Estimate to Complete (ETC) and Estimate at Completion (EAC) in Project Budgets optional feature is enabled for your account, you can set the **Pivot date** used to calculate the ETC and EAC values:
  - The Estimate to Complete (ETC) is used for forecasting the funding needed to finish the project at any point. The calculated value includes all planned budget values from the pivot date until the last project budget entry.
  - The Estimate at Completion (EAC) is used for forecasting the overall cost of the project. The calculated value includes all actual budget values before the pivot date and Estimate to Complete values from the pivot date until the last project budget entry.

## Project Center Options

If the Project Center feature is enabled for your account, users with the “View Project Center” role permission can access the project center view when they go to a project record. For more information about the Project Center feature, see the help topic [Working with the Project Center View](#).

By default, the project center view shows a project outline on the left with the project sequence and resources booked to the project, and a booking grid on the right which can be used to view, add and modify hours each resource is booked to a project task at any point in the project time span.

If your company uses the project center only to create and manage project sequences but not to staff project and manage resource bookings, you can hide the resource booking information for all users. To do so, check the **Disable project center booking worksheet** box.

Resource availability indicators in the booking grid show the availability of the resource for each week as you add bookings or make changes to existing bookings for this resource. The availability indicator shows the number of hours available for booking based on the total number of hours across existing bookings for this resource that week, and the total number hours the resource is working that week (according to the employee work schedule). If the Overbooked resources warning indicators are enabled in the project center display options, the availability indicator always shows for a given resource in a given week when booked hours reach a utilization threshold.

Account administrators can configure which bookings are excluded from the available hours and booked hours calculation based on the **Booking type** and **Approval status**. They can also customize the resource availability indicator in the Project Center view, and set resource utilization ranges and color coding to suit the business requirements of your company.

To do so, go to Administration > Application Settings > Projects > Project Center Options.


Under the Resource availability calculation section of the form:

- Select the **Booking types excluded from resource availability calculation on the Project Center page** — All booking types are included by default.
- Select the **Booking approval statuses excluded from resource availability calculation on the Project Center page** — All approval statuses except “Rejected” are included by default. Rejected bookings cannot be included in the available hours calculation.

Under the Utilization color coding section of the form:

- Enter the utilization threshold for the **Overbooked warning indicator (%)**. The utilization threshold is given as a percentage of working hours in a given week. The value must be between 0 and 999.

The booking grid cell shows a warning indicator if the total number of hours the resource is booked for is greater than or equal to the specified percentage of working hours.

 **Note:** In this context, utilization is understood as the percentage of working hours the resource is currently booked for across all projects in a given week.

- Click > **Create** or > **Edit** under **Color coding** to create or modify a custom color code for the availability indicators.

The Color coding grid appears and lets you define up to 7 utilization ranges (one per row) and their corresponding colors to suit your business requirements.

For each utilization range:

- Enter the lower limit for the utilization range under **Low**.
- Enter the upper limit for the utilization range under **High**.
- Select the **Color** to be used for the availability indicator progress bar.

**Note:** Non-utilized working hours (the left portion of the progress bar if the utilization is under 100%) always shows in gray color. If there are no bookings for the resource or if the utilization is not within a defined range, the entire bar shows in gray color. This gray color cannot be customized.

## Transactional Budget

The Budget option lets you track project funding over time. Many projects require change orders or extensions to the existing project budget funding. When the budget functionality is enabled in your company's SuiteProjects Pro account, you are able to identify individual funding items that make up the total project budget, such as statements of work (SOW) or purchase orders (PO).

You must contact SuiteProjects Pro Support and request that the Budget feature be enabled. It is activated by an internal switch. When using the budget feature, you are not be able to enter a budget amount directly on the Edit project form. Instead, that files is read-only and contains the value and sum total of the budget line items. You enter the funding amounts using the Budget link for the appropriate project.

### To create a new budget:

1. Go to Projects > Projects.

2. Select the project.
3. Select **Budget** from the **Create Button**.

There are two data elements that can be defined within the budget option: [Budget Category](#) and [Budget Activity](#). These are described as follows.

## Budget Category

With Budget Category, you can specify what types of documents the funding is coming from such as a SOW, PO, or primary agreement. Another common definition of categories is the type of funding such as Fees, Expenses, and Maintenance. Enter a name for the category and any notes, if needed. The Budget category field on the Budget form displays a drop-down list of categories.

### To create a Budget Category:

1. Go to Administration > Application Settings > Projects > Budget categories.
2. Select **New Budget category** from the **Create Button**.
3. Enter a name for the category and any notes. The budget category drop-down list displays on the Edit the budget form.

## Budget Activity

Budget Activities are a way to identify various activities that are involved in obtaining the project funding. Examples include Initial Estimate, Proposal Provided, and Signed Contract. Individuals responsible for the activities can be defined on the Budget form along with the activity and the % allocation of funding to the type of activity completed. Allocation usage is typically for identification of commission payouts according to the compensation policy of your company. You are able to create as many activities as necessary.

### To create a Budget activity:

1. Go to Administration > Application Settings > Projects > Budget activities.
2. Select **New Budget activity** from the **Create Button**.
3. Enter a name for the activity and any notes, if needed. The budget activity drop-down list displays in the Edit the budget form.

## Gantt Display (without Outline, Gantt, and Task Views enabled)

The Project Gantt View displays as a link within a project if phases/tasks are enabled within the project stage. See [Project Stages](#). The layout form lets you select the fields you want to display and the order of those fields. This is a global setting that applies to all Gantt views for projects.

### To access and modify the Gantt display:

1. Go to Administration > Application Settings > Projects > Gantt display.

## Project Locations

Project Locations store location information within the project entity. This information is not used as part of any other functionality in SuiteProjects Pro but can be used for reporting purposes. It enables you to categorize your projects according to their location, if needed. Examples of project locations are state, city, country or any custom list of values.

### To create a Project location:

1. Go to Administration > Application Settings > Projects > Project locations.
2. Select **New Project location** from the **Create Button**.
3. Enter the Project Location name and any Notes about the location.
4. Check the **Active project location** box.
5. Type a Country code and State code as applicable.
6. Click Save.

## Project Stages

Project stages classify projects based on your business requirements. See [Creating a Project Stage](#).

After you create project stages, you can assign individual projects to the appropriate stage. See [Changing the Project Stage for a Project](#).

You can create Proposed, Active, Closed, Lost, and Internal stages to classify projects, for example, where:

- Proposed projects are projects which have not yet started and for which there are no signed contracts.
- Active projects are projects for which you have signed paperwork and which are being worked by your resources.
- Internal projects usually represents projects for which you want to track time and expenses, but are not customer related, such as training and documentation.

Project stages display as subtabs on the projects list. The **All** subtab lists projects in all project stages the user has access to. You can control the order in which the subtabs appear. See [Reordering Project Stage Subtabs on the Projects List](#).

## Creating a Project Stage

You can create project stages to classify projects based on your business requirements.

**Note:** When creating a project stage, you can enable access to the project record functionality that is required at this particular stage. For example, you may want to have Billing and Recognition options available for projects in the Active stage, but not for projects in the Internal stage. Options include:

- **Dashboard** — enables a project-specific message area and 1-click report location
- **Phases and Tasks** — exposes links related to task management
- **Worksheet** — provides ability to make updates across multiple tasks
- **Team** — displays all employees either booked or assigned to the project along with their booked or assigned dates
- **Issues** — enables issue tracking within the project
- **Budget** — provides ability to enter funding budgets including change orders or types of budget values
- **Utilization** — enables a graphical view of booked and assigned employee utilization for the project
- **Baseline** — provides for the storage of project snapshot baselines for variance reporting
- **Booking grid** — displays booking worksheet for entry of resource booking directly from the project
- **Pricing** — enables the estimation feature for displaying gross/net revenue and estimated margins
- **Billing** — provides ability to create and run billing rules for generating invoice charges and billing forecasts
- **Recognition** — provides ability to create and run recognition rules for generating revenue transactions and forecasting revenue
- **Analysis** — permits high level financial analysis of all costs and income
- **Overview** — displays a standard status report for the project

### To create a Project Stage:

1. Go to Administration > Application Settings > Projects > Project stages.
2. Click the Create button then **New project stage**.

The new project stage form appears.

3. Enter a name for the **Project stage**.
4. Check the **Make this the default project stage for new projects** box, if applicable. Only one project stage can be the default project stage. Checking this box will override any previous default project stage.
5. Under **Options**, check the boxes corresponding to the functionality and subtabs you want to make available on the project record when the project is in this project stage. A functionality or subtab will not be available to any users unless the corresponding box is checked.
6. Select the relative **Position** for the subtab corresponding to this stage. See also [Reordering Project Stage Subtabs on the Projects List](#).
7. Enter any **Notes** as required.
8. If standard email notifications controlled at the project stage level are enabled for your account, under **Notifications** check the boxes to control which events trigger notification email to be sent automatically and create a list of **Employees to notify**.
9. You can use filter sets to control access to projects at this stage. To do so, do the following:
  - a. Under the Filter sets form section, click **Create**.
  - b. Select the filter sets as appropriate. Employees who have this filter set as their active filter set cannot access projects in this stage.
  - c. Click **OK**.

**Note:** Project stages are one of the attributes you can use to control access using filter sets. Filter sets define what data the employee has permission to view or update. Depending on the filter set assigned to an employee, including any filter set applied when the employee views a particular SuiteProjects Pro module, the employee may not access all the project stages and all the projects at these stages. For more information about filter sets, see [Filter Sets Overview](#).

When you select filter sets on the project stage form, the selected filter sets do not allow the employee to view or modify information associated to projects in this project stage. For example, you should use filter sets to control who can access project records that are in a closed, cancelled or archived stage, both for performance reasons and to prevent employees from modifying these projects.

10. Click **Save**.

## Changing the Project Stage for a Project

After you create a project stage, employees with the appropriate permissions and access privileges can progress a project to this project stage.

### To change the project stage of a project:

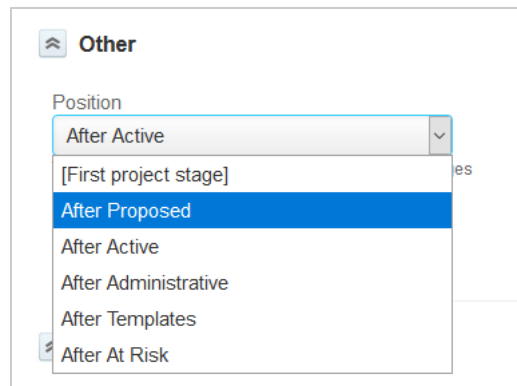
1. Go to Projects > Projects > *[Select a project]* > Properties.
2. Select a **Project stage** from the dropdown list.
3. Click **Save**.

## Reordering Project Stage Subtabs on the Projects List

Project stages display as subtabs on the projects list. You can change the order in which subtabs appear on the projects list at any time.

## To reorder project stage subtabs on the projects list:

1. Go to Administration > Application Settings > Projects > Project stages.
2. For each project stage, to move the corresponding subtab relative to others, do the following:
  - a. Select the project stage.
  - b. Select the relative **Position** for the subtab corresponding to this stage. The relative position can be set to first project stage or after any other existing project stage.



- c. Click **Save**.

## Project Stage Use Case: Project Templates

Templates are predefined project structures that you can use to simplify project creation. Employees can copy a template when creating a project to have project information and associated records prepopulated. You can create a **Templates** project stage to classify all project templates used in your company.

### To create a new project from a template:

1. Go to Projects.
2. Click the Create button then **New, from another project**.
3. Under **Duplicate phases and tasks from this project**, select the project template from the dropdown list.
4. Check the boxes for the elements of the project template you want to copy to the new project.
5. Enter any additional information as required.
6. Click **Save**.



**Note:** By default, all projects are available for copying. To limit the number of projects that can be duplicated, create a custom checkbox field and associate it with Projects. The field name must be `duplicate_from_project`. You can use `Use as project template` as display name. After you create the custom field, check the box on the properties form for each project which can be used as the base for duplicate project. Then, only projects with this box checked are available to be duplicated. See [Custom Fields](#) and [Custom Field Types](#).

**Tip:** To create a new project from an existing project, you can also go to the properties form of the project you want to copy and click the **Tips** button then **Clone this project**. Account administrators can control who can clone a project if the Clone Project Role Permission optional feature is enabled for your account.

## Worksheet Display

The Worksheet link displays within a project if phases/tasks are enabled in the project stage. See [Project Stages](#). The layout form lets you select the fields you want to display/modify and the order of those fields. This is a global setting that applies to all task worksheets within projects. The ability to modify specific fields within the worksheet display is controlled by edit permissions of the form or employee role.

### To access and modify the Worksheet Display:

1. Go to Administration > Application Settings > Projects > Worksheet display.

**Note:** When including assignments and predecessors in the task worksheet, you may display the current value of those fields as text below the create/edit options by selecting the desired option.

## Worksheet Display Pagination

The task worksheet can be separated into pages to increase performance and make large amounts of information more manageable.

### To set the number of tasks which appear in a Task Worksheet page:

1. Go to Administration > Application Settings > Projects > Worksheet Display.
2. In the "Number of paginated rows to display" field, enter the number of tasks you want to show on each page. Clear the field to disable this feature.
3. Select "Enable sorting on columns ID and Task name" to allow users to sort these columns alphanumerically in ascending or descending order.
4. Click **Save**.

## Task Types

Project task types are useful in task assignments, time entries, receipts, and charges. They are important in the calculation of utilization and also help filter hour-related data in reports. When time is recorded

against tasks with a defined task type, the task type is stored with the time entry record. You can display and filter the task and task assignment detail reports by project task type. You can also sub-total and filter Summary Reports and Advanced Resources reports by task type. The task type provides the ability to label individual tasks on a project. You can create as many types as you need to accommodate your company's specific time tracking requirements.

Utilization reports may use the value on the stored time entry or the current value on the task. See [Reporting Options](#). All other time based reports rely on the task type stored on the time entry record.

Some examples of typical task types include: Billable, Non-Billable, and Administration. Before you can use task types, you need to configure them in your account.



**Important:** Task types should be set to the correct value before time entries are stored on approved timesheets. Changes to task types throughout a project lifecycle may introduce conflicts in data reporting of what is stored on the time entry record versus what is set on the task type.

### To create a Task type:

1. Go to Administration > Application Settings > Projects > Task types.
2. Select **New Task type** from the **Create Button**.
3. Enter the Task type name and any notes, if desired.
4. Click Save.



**Note:** The value of the task type does not control whether the task is available for project time billing transactions to customers. This is managed by the Non-billable task box located near the bottom of the Properties form. As an account administrator, it may be helpful to run a detailed task report comparing the non-billable box value with the task type to verify the proper alignment.

### To use task types:

1. Go to Projects > Projects and select a project. Select a view under Phases/Tasks. Click on a task. On the New and Edit task forms, there is a drop-down list of Project task types.

## Alerts


You can configure Budget Alerts. Frequently, a 90% of Budget Alert is configured to run every day and sends an alert when approved hours read 90% of budget hours. This alert applies to all active projects and an email is usually sent to the project owner.

Alerts allow automated email reminders to be sent to ensure business needs are met. In the Projects application, a form is provided to help you create a new budget alert.

### To create a Budget alert:

1. Go to Administration > Application Settings > Projects > Alerts.
2. Select **New Budget alert** from the **Create Button**.
3. Name the alert.
4. Under Alert runs on, select the day and time when the Alert should run.

5. Under Rule, define the appropriate selection rules for why an alert is sent.
6. Under Charge types to exclude, select charge types.
7. Use the Email notification section to define who receives the email, the email sender, subject and text, and additional text.

 **Note:** Depending on account configuration, sending system-generated email from a custom address may not be permitted. When this is the case, a note under the text box advises you so, and email is sent from [www@openair.com](mailto:www@openair.com). See also [Email Settings](#).

8. Add notes, as desired. These notes do not appear anywhere in the alert. They are for informational purposes, such as remembering why the alert was created.
9. Check the Active alert box to make this alert active.
10. Click Save.

## Assignment Groups

An assignment group is a list of employees that are available from all the active employees. Assignment groups allow you to assign several employees to projects and project tasks quickly and share reports to multiple employees efficiently. The effect is the same as assigning the employees individually to projects and project tasks or sharing reports to individual employees.


Assignment groups are useful when you have tasks that need to be assigned to a large number of employees such as on internal or administrative projects. You can create an assignment group that contains all company employees and use this assignment group to assign all employees to tasks such as training, vacation, and holidays. The hours set on an assignment group on a task can either be split evenly among the group or kept the same across each employee in the assignment group. Another use is where you may have a group of resources with similar skills and can be interchangeable on a project task. To avoid having to set up each resource on the task when they begin work, the assignment group provides a simple solution.

## Assignment Groups Best Practice Guidelines

Assignment groups are a convenient way to manage assignments for sets of users. However, excessive usage of assignment groups will lead to performance issues.

Assignments are stored in the `project_task_assign` table, and SuiteProjects Pro uses this table heavily for various purposes. Excessive usage of assignment groups, especially if they contain many or all users, will lead to excessive growth of and updates to this table, which can cause performance issues. You should use other features instead of assignment groups where possible, depending on your requirements. You can use the following guidelines for best performance:

- **To grant access to all tasks in a project for a set of users**, contact SuiteProjects Pro Support and request the following feature: **Allow users to access all tasks, not only the ones they are assigned to**. After you enable this feature, you only need to use the assignment group on one task in the project, instead of all tasks.
- **To grant access to a specific task for all users:**
  1. Contact SuiteProjects Pro Support and request the following feature: **Allow all users to log time and expenses to a task**.
  2. On the task properties form, check the **Allow all users to log time for this task** box and click **Save**. All users will have access to this task

 **Note:** It is acceptable to use assignment groups heavily, depending on your business requirements. For best performance, where possible:


- Avoid overusing assignment groups with all or most users.
- Try to find alternative access control solutions, instead of creating many assignments to assignment groups contain hundreds or thousands of users.
- Ensure that the task start date and end or finish date are as close together as possible. Longer durations will result in larger project recalculations and will degrade performance.

## Creating an Assignment Group

SuiteProjects Pro lets you create assignment group and include any number of active employees to the assignment group.

### To create an assignment group:

1. Go to Administration > Application Settings > Projects > Assignment groups.
2. Click the Create button then **New Assignment group**.  
The new assignment group form appear.
3. Enter a **Name** for the assignment group.
4. Select the **Employees** to include from the Available list, and click **Add selected**.
5. Enter Notes describing the purpose and use of the assignment group.
6. Check the **Active assignment group** box to make this assignment group active.
7. Click **Save**.

 **Tip:** If you have an assignment group for all employees, you can reduce administrative maintenance by enabling the Automatically Add New Users to Assignment Groups optional feature. See the help topic [Automatically Add New Users to Assignment Groups](#).

## Adding an Assignment Group to a Task

After you have created assignment groups, you can assign them to a task in the same way you assign named or generic resources to a task.


### To add an assignment group to a task:

1. Go to Projects > Projects > *[Select a project]* > Phases/Tasks > List > *[Select a task]*
2. On the task properties form, scroll down to the Assignments form section.
3. Under the **Assigned to** column header, select the assignment group containing the resources you want to assign to the task from the dropdown list.
4. Click **Save**.

## Extended Category Feature: Service line <n>

Administrators now have the option of creating five new Service Lines <n>, where <n> is an integer from 1 to 5. These act in a similar manner to the default “service” feature and transactions in SuiteProjects Pro can be split across service lines for reporting purposes.

To use this feature, you must contact SuiteProjects Pro Support and request the extended category feature to be enabled. This lets you create the additional lines and adds service <n> as selectable fields on revenue recognition rules.

 **Note:** You may also want to enable a combination of the following switches. Each option below is independent for each extended service.

- Enable the feature to determine the service <n> line to be set in transactions by searching the task and phase work breakdown structure. This means that it looks at each task and uses what is selected on that task.
- Enable the feature to specify and require the top-level phase to be used to determine the service <n> line to be set in transactions generated by recognition rules and billing rules. Top-level is the highest parent phase of a task whether the task is part of a phase or the phase is part of another phase. While you can override these at the bill rule and recognition rule level, you can use them to automatically specify the activity for a service at the top-level phase.

The service value set on the top level task is stamped on all transactions associated with the phase including:

- tasks
- receipts
- project billing transactions
- charges (slips)
- charge projections (slip projections)
- revenue recognition transactions
- revenue projections
- purchase orders

### To create a New service <n> line:

1. Go to Administration > Application Settings > Projects > Service <n> lines.
2. Select **New Service <n> line** from the **Create Button**.
3. Name the Service <n> line.
4. Add notes to clarify the use of the service <n> line.
5. Click Save.

## Projects Best Practice Guidelines

Review the following best practice guidelines:

- SuiteProjects Pro has several features which let you optimize project recalculation when adding or modifying tasks to projects. The optimization improves loading time for task list, outline and Gantt

views after creating, duplicating, deleting, or modifying a task associated with the project you are viewing, or after moving or copying a task to another project. See [Project Recalculation Optimization](#).

- If your employees record internal time or PTO against one or more primary projects, the number of time entries and hours recorded against these projects grows large over the years. When the number of hours recorded against an Internal time or PTO project reaches 1 million hours, you should archive or deactivate the project, and create a new project to continue tracking internal time or PTO. See [Replace Internal or PTO Projects with Time Entries Totaling Over 1 Million Hours](#).

## Project Recalculation Optimization

SuiteProjects Pro has several features which let you optimize project recalculation when adding or modifying tasks to projects. The optimization improves loading time for the following views after creating, duplicating, deleting, or modifying a task associated with the project you are viewing, or after moving or copying a task to another project.

- Projects > [Select a project] > Phases/Tasks > List.
- Projects > [Select a project] > Phases/Tasks > Outline — Create, delete, duplicate, copy, move, repeat tasks.
- Projects > [Select a project] > Phases/Tasks > Gantt — Create, delete, duplicate, copy, move, repeat tasks.

By default, SuiteProjects Pro recalculates the project plan and reloads the view every time the user makes a change to the task, phase or milestone. The following features change this default behavior to optimize project recalculation. You can use any of these features in combination or independently.

- **Run the project recalculation manually** — This enables users to make any number of changes to the project plan first, and run the project recalculation manually at any time. See [Enabling Employees to Run the Project Recalculation Manually](#).
- **Restrict Project Recalculation to Tasks Impacted by the Changes on the Project Outline, Gantt and Task Detail View** — By default, the project recalculation includes all the tasks associated with the project. This feature restricts the recalculation to tasks that are impacted by the change instead of all tasks in the project. For example, if you change the planned hours for a resource assigned to a particular task, the recalculation will include only the specific task and any successor tasks. None of the other tasks are included in the recalculation. For more information, see the help topic [Restrict Project Recalculation to Tasks Impacted by the Changes on the Project Outline, Gantt and Task Detail View](#).
- By default, the project is recalculated automatically only after a field that requires recalculation was changed. Fields that require recalculation when changed include assignment hours/users, start/finish dates, predecessors, for example. Changes to task type, service, or custom fields, for example, do not trigger the recalculation. However, your company's SuiteProjects Pro account may be configured to trigger project recalculation always after editing a task on the project outline view. To review whether the internal configuration setting **Always trigger project recalculation always after editing a task on the project outline view** is enabled for account, contact SuiteProjects Pro Support.

## Enabling Employees to Run the Project Recalculation Manually

This feature can be enabled for any project on the project properties form. After you enable the features, employees can add tasks, delete tasks, modify the planned hours for any number of tasks, create repeat tasks or split tasks without having to wait for the project recalculation to complete between each change. Employees can then run the project recalculation manually.

- On the Phases/Tasks > List, Phases/Tasks > Worksheet or Phases/Tasks > Task Assignments views, a link is available at the top of the view. Click the link to recalculate the project.

- On the Phases/Tasks > Outline or Phases/Tasks > Gantt, a warning message appears when you go to the view. Click the link in the warning message to recalculate the project.

### To enable employees to run the project recalculation manually

- Go to Projects > Projects > [Select a project] > Properties.
- Under the General form section, check the **Allow the employee to initiate the project recalculation** box.

**Note:** If you cannot see the **Allow the user to initiate project recalculation** box on the project properties page, check the form permissions, or contact your account administrator.

- Click **Save**

## Replace Internal or PTO Projects with Time Entries Totaling Over 1 Million Hours

If your employees record internal time or PTO against one or more primary projects, the number of time entries and hours recorded against these projects grows large over the years. When the number

of hours recorded against an Internal time or PTO project reaches 1 million hours, you should archive or deactivate the project, and create a new project to continue tracking internal time or PTO.

When you access a projects list that includes hours columns such as **Hours – Approved**, **Hours – Worked**, for example, SuiteProjects Pro reads the database to retrieve time entries recorded against each project in the list and calculate the total number of hours. If the list data includes projects with hundreds of thousands time entries totaling millions of hours, it can lead to slow list loading time and other negative performance impacts.

When time entries recorded against a project reach 1 million, you should:

1. Clear the **Active** box on the project properties form, or change the **Project Stage** to Closed or Archived.
2. Create a new project to continue tracking time.



**Important:** Review the following guidelines:

- Use filter sets to control who can access project records that are in a closed or archived stage. Users should be restricted from accessing these project stages for performance reasons.
- Consider any impact replacing projects used to track internal time or PTO may have on reporting.
- Consider removing the ability to log time against the project for some time as an iteration step before you deactivate, close or archive the project. To do so, you can close the tasks on the project, or change the project stage to one that is not accessible to end users. Use filter sets to control who can access this project stage.

## Other Settings

The Projects application has many configurable parts. You can enable Earned Value Management (EVM) metrics; designate that EVM metrics employee costs are from primary loaded cost, secondary loaded cost, tertiary loaded cost, or job code; and enable different project pricing scenarios.

### To access the Projects Other settings:

1. Go to Administration > Application Settings > Projects Settings > Other settings.

**Enable transfers:** A cost transfer feature is available when this option is activated. Transfers are set up with a cost rate and bill rate function that permits the cost of an employee to be transferred to another cost center based on the projects worked. The use of the transfer feature is dependent on cost center setup including how cost center settings are inherited (that is, employee, project, or service) when an employee works on a particular project. When transfers are activated, it prevents the billing of resource project time using the invoice application for the employees and projects that have transfers set up. Projects not involved in transfer setups are not impacted.

**Enable task assignment at the project level: This option can only be enabled if you input planned hours at the task level rather than the assignment level. Send an email request to SuiteProjects Pro Support if you are not sure of your configuration.** This feature lets you assign a set of employees to tasks on tasks on the task form by checking the Use the project assignments box. Employees may



still be selectively assigned if the box is cleared on the task. This is typically determined during account configuration, but send an email request to SuiteProjects Pro Support if you want to change it.

**Use a scrolling picker to assign employees to tasks:** Employee selection by default is handled by a selection list with highlighting of desired employees on the left and adding them to the right for assignment. Assignments using a selection list do not have the ability to select individual employee planned hours nor other employee level value settings depending on internal switches activated in your account. Activating the scrolling picker gives you a row-by-row view of employees with each row allowing a drop-down list of employees to be assigned.

**Enable task cost and billing projections:** Activation of this option permits SuiteProjects Pro to compute and display forecasted costs at the task level in the project outline view (for employees based on their cost rates or cost overrides on the project or task, if those features are activated) using the task assigned hours. Financial projections for billing are performed and displayed based on the employee assigned hours. If this option is not activated, you are not able to view the forecasted employee cost or billing from the outline view of the project. This calculation is hard coded and cannot be changed. Use Reports to show a view of projections with more options for customization.

**Enable manual override of task cost and billing projections:** Activation of this option permits the computed value on each task to be overwritten manually. Use of this option is helpful in unit pricing or fixed fee pricing or cost (such as a subcontractor) at the task level.

**Enable project rate cards to be used in billing projections:** Activation of this option provides the ability to calculate projected billing forecasts based on rate card rates rather than employee hourly rates. This option requires the "Enable task cost and billing projections" feature to be switched on. To use this feature, select Rate card from the Projected Billing options for the project and the required rate card to base the calculation on. The job code is taken for the employee and can be overridden at the task assignment. If the job code is not found on the rate card then a warning is issued and the hourly rate is used in the calculation. See also the "Use zero rate for billing projections when no job code is available" feature.

**Use zero rate for billing projections when no job code is available:** This feature can be used when the "Enable project rate cards to be used in billing projections" feature is switched on. Activating this feature will result in a zero value being taken for employees that do not have a rate card rate defined for their job code on the rate card specified for the project.

**Make the task percent complete drop-down read-only:** Enable this setting to make the percent complete drop-down on tasks read-only for all users.



**Important:** You should check this box if SuiteProjects Pro calculates percent complete automatically, that is, if hours remaining or "Update percent complete as approved hours divided by planned hours" are enabled. If this drop-down is editable and SuiteProjects Pro is auto-calculating, a user can change the dropdown, but the selection will revert to the calculated value on subsequent updates of approved/planned/estimated hours.

**Require service in tasks:** If you have implemented services, this option lets you make this field required for all tasks when the form is created or modified. This requires you to define a complete set of services so that a valid value is always able to be selected for any type of task. Checking this option is particularly important if you have checked the timesheet option to retrieve the service from the task for timesheets if one is not entered or the option to always get the service from the task. The task level service setting may be passed to timesheet and included or overridden in billing rules and recognition rules based on service settings within the rules. Service settings are not kept historically on a task but are recorded historically on timesheet entries that pick up the service from the task level.

**Use only invoiced charges for WIP calculations:** WIP or Work-In-Process is an accounting computation regarding the state of revenue recognition based on revenue recognition and invoicing. This is only derived in reporting, no WIP transaction is generated with the application. Depending on your accounting practice and the setup of billing rules to drive your revenue recognition, charges may be created that are

used for revenue recognition but not invoicing. An example is a fixed price project which has an hours complete revenue recognition policy. If you are generating two sets of charges for this situation, one set of charges is used for invoicing (the fixed amounts) and the other is used to drive revenue recognition (as billed). WIP in this case should only be based on invoiced charges so this option would be checked. Likewise, any deferred billing charges would also not be included in WIP if they were not added to an invoice.

**Enable project-wide resource substitution:** Resource substitution can be done on the task level with or without this option by selecting the resource name and selecting a substitution candidate from the list provided by the search criteria option set (see below). The team link within a project also provides a list of employees which can be substituted by selecting their name within the team link. Activating this option permits a project wide substitution of a resource if selected within the team link. The employee does not get an option to pick which tasks should be substituted when this option is activated - all tasks have the resource substituted to which they are assigned.

**Search criteria for finding a resource to substitute for another on a task assignment:** The search criteria is a pattern match of the selected employee among all other employees and generics that are active for possible matches. The resource profile match depends on the skill database setup for your company's account. Depending on the complexity of the skill database, resource matching may become too unique and therefore limit or eliminate viable candidates due to a missing profile element. The job code value per employee is a one-to-one setting so a match is more likely due to the simplicity of data entries. If you have not set up a skill profile, then using this search criteria returns a list of all active employees/generics since an empty profile matches among all employees.


**Exclude project constraints from search criteria during resource substitution search by profile:** Activation of this option removes any availability of resource checks when performing a profile match against employee and generic candidates.

**Require a service selection in recognition rules:** Recognition rules inherit the service passed on billing transactions and charges, if you have set up services, unless it is overridden on the recognition rule. If your policy is to control the service settings to match your revenue recognition accounting policy (such as a specific account used to capture revenue in your accounting system), activate this option to require a setting of the service, which overrides any service setting from the billing transaction or charge. This requires you to define a complete set of services so that a valid value is always able to be selected for any type of revenue.

**Task percent complete interval choices:** You have the option to define how precise the % complete value is used. A 5% interval is a popular choice for ease of customer communication.

**Employees available for assignment to a project:** Options that make employees available for assignment provide control over which employees are viewable for project or task assignment by your project setup resources. The booked employees or all if none booked permits an open employee selection unless an employee has been booked to the project. After an employee is booked then only booked employees are displayed. If you use assignment groups, this option is viable provided no employees are booked. After an employee is booked, the ability to use assignment groups on the project is removed. Booked employees option displays only employees booked to the project. All employees always displays all employees, including assignment groups. This can be used for generics and regular users alike.

**Enable support for select resources to always be available for assignment to a project:** If checked, this trumps the "Users available for assignment" setting.

 **Important:** Requires a custom field named exactly "resource\_always\_assignable" to be created.

**Project pricing scenarios can get hours from:** The pricing feature within the project uses hours set up under scenarios to compute a project price. There are three possible ways to use hours for the scenario setup: Estimated hours, Booked hours, and Assigned hours. You may opt to allow all three scenarios during setup or identify a specific one which drives your employees to a standard for pricing. Estimated

hours are entered within the pricing feature as hours per job code which drives the scenario. Booked hours are the employee bookings entered using the project booking worksheet or resource booking tab. Assigned hours are those entered on tasks with employee assignments. Any resource type (regular or generic) may be used for the pricing scenarios. Booked hours and assigned hours for pricing may use Generics to earmark the type of resource needed if the project is a proposal or for the resource on the project if a contract extension is being forecasted.

**100% field for project pricing reports:** When setting up a pricing scenario, an analysis displays opportunity revenue, gross revenue, and net revenue. This option lets you define how the %'s are treated on the analysis report by selecting a revenue type as the base for 100%. For example: If gross revenue is selected, then the % of opportunity revenue and net revenue are computed against the gross revenue amount.

**Project pricing probability interval choices:** You have the option to define how precise the % probability value is used. A 5% or 10% interval are popular choices to use for a pipeline maturity process.

**Enable workspace member synchronization:** When creating a project, you may also create a workspace associated with the project. The workspace may pre-exist and be copied or be initially created when the project is created. Selecting this option permits all employees involved with the project (employees assigned to tasks) to be included automatically as members of the workspace with read/write capability. Clearing this option permits manual control of workspace membership by the project manager or project creator in the Workspaces application. If you do not create workspaces when creating a project, then this option has no system impact checked or unchecked.

**Inactivate project when all tasks are closed:** A project may have all tasks closed but still remain active for timesheet and expense report capturing provided tasks are not used on these items. Checking this option automatically inactivates (or clear the **Active** box) the project when all tasks are closed.

**Mark closed tasks 100% complete:** The % complete field may be manually set or computed automatically by SuiteProjects Pro. If this option is unchecked, then closing a task by checking the **Closed** box keeps the % complete as it was set when the task is closed. Checking this option changes the % complete field automatically to 100% if the task is closed. Use of this feature is both dependent on your project management methodology and possibly your customer billing if it is driven by a fixed fee on % complete of the project, phase, or task.

**Closing a phase will close all sub-phases and sub-tasks within that phase:** A time saving feature that permits a complete closure of a phase including sub phases and sub-tasks if the phase level is closed (checking the **Closed** box on the phase). If this option is not checked then the phase may be closed while leaving sub-phases and sub-tasks open.

**Disable "Pull SuiteProjects Pro resources" menu item in SuiteProjects Pro plugin for Microsoft Project:** This option involves the use of the SuiteProjects Pro Project Connector add-on service. When using the Project Connector to import a project, the resources identified within the Microsoft Project plan may be mapped to valid active resources in SuiteProjects Pro. Checking this option disables the resource mapping feature, which disables the import of employee assignments to tasks when the project plan is imported.

**Require a charge description on billing rules:** Billing rules define how customer invoicing is done and may drive revenue recognition. The charge description field is included on generated charges when the rule is executed. By default the field is left blank and may be entered optionally either within the rule which applies the entry to each generated charge or on individual charges when manually edited by an employee with the appropriate permissions. Charge descriptions may be displayed on an invoice. If you have defined an invoice format (layout) that displays the charge description, you may consider making the charge description field required to ensure information is available for invoices.

**Require a charge service on billing rules:** Time billing rules inherit the service passed from a timesheet, if you have set up service, or be blank unless it is overridden on the billing rule. If your policy is to control the service settings to match your customer invoicing accounts (such as a specific account used to capture receivables in your accounting system), activate this option to require a setting of the service,

which overrides any service setting from the timesheet. This requires you to define a complete set of services so that a valid value is always able to be selected for any type of billing. This forces a selection of a service on billing rules other than time billing if your business requires services on billing transactions.

**Enable project issues:** Issue tracking is an optional feature within the Project applications which permits employees to capture project issues, tracked due dates and close dates, assign issues to employees, and track general information such as the type of issue or state of the issue. When the feature is checked, a series of Issues configuration items are available including Issue Stages, Issue Categories, Issue Sources, and Issue Severities. See [Issues](#).

**Issue prefix:** By default issues have a prefix of IS- unless you choose to override the it. To reset the prefix, enter a new value in the text box next to the prefix pull down and save the form.

**Show totals for numeric, hours and days task custom fields on project outline:** By default, custom fields of numeric, hours, or days type do not automatically display total amounts when value on the tasks are rolled up to a project total. Checking this option permits the display of task custom fields of these types to appear at the project outline level. When this option is unchecked, the task level custom fields are not available for display in the project outline.

**Require unique project names by customer:** Many of the menu drop-down lists display customer: Project entries, which may make it difficult to select values unless they are unique. A project with the same name for the same customer may already exist but not be visible to some users depending on their access profiles. To ensure project names are unique for each customer, check this option.

**Enable task successor assignee notification custom field feature:** When you enable this feature, you create a Project checkbox custom field that you can select to notify task assignees when predecessor tasks are marked 100% complete or closed. This can be set as a default value for all projects, and when you create a project from another project, if you choose the option to Duplicate notification settings, you can copy the value of the custom field.

**Enable Earned Value Management (EVM) metrics:** Earned Value Management metrics allow companies to have increased visibility into project status and profitability. Using data from planned and completed work in SuiteProjects Pro, managers can readily assess the state of their projects. Schedule and cost metrics provide valuable understanding into the health of your projects. The EVM metrics include: Planned Value (PV), Actual Cost (AC), Earned Value (EV) as a monetary value, Earned Value (EV) as a percent complete value, Budget Variance (BV), Cost Variance (CV), Schedule Variance (SV), Cost Performance Index (CPI), Schedule Performance Index (SPI) and Critical Ratio (CR).

**Method to use when computing 'Earned Value Percent Complete' for projects and phases:** Two methods exist for the accounting of earned value. The weighted by cost method permits a cost tracking model of the hours worked. This means more expensive resources increases the earned value results. The unwatched method applies hourly cost values evenly among resources, which results in a strict hours worked earned value model.

**EVM metrics employee costs are from:** When using Earned Value Metrics, you have several selections you can use to specify where employee costs are determined. These are: Primary loaded cost, Secondary loaded cost, Tertiary loaded cost, and Job code. SuiteProjects Pro provides you with the ability to assign three levels of costs by employee. In addition, costs can be determined by the Job code. See [Job Codes](#) and [Cost](#) under Employees.

**Require a cost center selection in recognition rules:** Enable this setting to require a cost center selection in recognition rules. Forms will error on submission/save if a cost center has not been selected.

**Require a charge cost center on billing rules:** Enable this setting to require a cost center selection in billing rules. Forms will error on submission/save if a cost center has not been selected.

**Gantt chart reordering sorts task IDs:** Project plans may be complex and long. There may be a need for project managers to adjust tasks by moving them up or down in the timeline of a plan. The Gantt view provides visibility into the progress of a project, as well as the ability to easily re-order tasks and phases

leveraging up/down arrows. When you enable this feature, SuiteProjects Pro sorts the Gantt view by automatically re-ordering tasks in the Outline view based on the revised order in the Gantt view.

**Note:** There is an option located in the hints section of the Gantt view: Click here to re-order task IDs by current chart order. This option accounts for existing projects that have tasks that should be sorted based on the Gantt order.

**Default tab for projects:** Select the default tab to show when users go to Projects > Projects > [Select a project] unless a different default tab is set at the user level. If the user does not have access to the default tab, the first tab on the left is shown instead. You can select a specific tab or the metavalue [Company default] configured for your company's SuiteProjects Pro account. To change the Company default tab, contact SuiteProjects Pro Support.

**Note:** Users can set their default tab preference in Personal Settings.

**Enable prevent deletion of employee assignment with logged hours:** When this option is enabled a warning is displayed to prevent the deletion or substitution of a user from a project task when the user has already logged hours.

## Frequently Asked Questions

### How does the Split Task work in Projects?

The Split Task functionality lets you include breaks part way through a project task. You can split the task into periods when work will be done (hours are assigned to resources) and break periods when no work will be done (no hours are assigned to resources). The task duration or the percentage of assigned resources time is recalculated automatically in function of the break periods and the planned hours for the task.

The Split Task functionality is available on the task entity form whenever you create or modify a task.

### To split a task

1. Go to Projects > Tasks > [Select a task].
2. Click **Create** next to "Split the task" under the Other section of the task entity form.  
The Split the task popup appears.
3. Each row on the form corresponds to a break period. For each break period (blackout period):
  - a. Enter a **Start** and **End** time.
  - b. (Optional) Enter a **Reason** for the break.

**Note:** The Split the task form shows three rows by default. To add additional rows, click the **Add rows** dropdown field and select the number of rows to add.

4. Click **OK** to close the Split the task popup and return to the task entity form.
5. Click **Save**.

# Resources

The Resources application gives you the ability to set up an entire skills database called the Resource Profile, complete with attributes per entry. The elements included are Skills, Education, Locations, Job Roles, and Industry. You may expand the Resource Profile options for your company to include up to an additional 35 custom elements that you define based on your personnel requirements.

The default application terminology for the allocation of resources to projects is booking. The Resources application helps you collect and assign the resources your company has available for booking to specific projects, and even to tasks within those projects. The intention of the resource bookings is to properly assess a forecast of your company's resource needs. The Resources application lets you:


- List all resources for a particular time period and see what percentage of time they are booked.
- Display a worksheet for resources and a booking worksheet for a particular project as well as a chart that graphically shows metrics such as availability, booked time, time off, and holidays.

## Attribute Sets

Attribute sets allow you to designate a measurement of resources according to their skill set, education, or other custom characteristic.

### To create an Attribute set:

1. Go to Administration > Application Settings > Resources > Attribute sets.
2. Select **New Attribute set** from the **Create Button**.
3. Enter the Attribute set name and then list the values your company uses in the Attribute list. Defined Attribute sets are then available to associate with one or more tracking elements of the skill database. Attribute sets are only used on skill database tracking elements.
4. Add Notes, if desired.
5. Click Save.


## Tech Skills

Tech skills document the talents a resource has that are required by your organization. It is one of the standard Resource Profile elements predefined in SuiteProjects Pro. The tech skills link only displays in Resources Settings if you have activated this as a Resource profile option. See [Resource Profile](#).

You can define tech skills at a broad level, using terms such as Database or Functional, or you can use specific skills such as SQL Server database or Oracle EBS 11i. One or more skills may be assigned to an employee resource depending on the Resource Profile configuration. You use tech skills when you search for appropriate and available employees to assign to a project. Skills also provide reporting capability.

### To create Tech skills:

1. Go to Administration > Application Settings > Resources > Tech skills.
2. Select **New Tech skill** from the **Create Button**.
3. Type the Name of the Tech skill.
4. Add Description, if desired.
5. Check the **Active Tech skill** box.
6. Click Save.

 **Note:** Tech skill profiles may be disabled for your account. If you would like Tech skills to be available in, or removed from Administration > Application Settings > Resources > Industries, contact SuiteProjects Pro Support.


## Education

Education represents the level of education an employee resource has attained. It is one of the standard Resource Profile elements predefined in SuiteProjects Pro. The Education link only displays if you have activated this as a Resource profile option. See [Resource Profile](#).

You want to define Education entries in such a way that they can be tracked by your HR department or needs of your customers. Education entries provide an additional search and reporting capability.

### To create an Education record:

1. Go to Administration > Application Settings > Resources > Education.
2. Select **New Education** from the **Create Button**.
3. Type the Name of the Education record.
4. Add Description, if desired.
5. Select "Active Education". When "Active Education" is selected, the education will appear as a selectable option for users.
6. Click Save.

 **Note:** Education profiles may be disabled for your account. If you would like Education to be available in, or removed from Administration > Application Settings > Resources > Industries, contact SuiteProjects Pro Support.

## Locations


Locations specify where an employee resource lives or what office they are assigned to. It is one of the standard Resource Profile elements predefined in SuiteProjects Pro. The Locations link only displays if you have activated this as a Resource profile option. See [Resource Profile](#).

Many Customers require resources that are located near their project site to reduce expenses. Define the locations as is appropriate for your company and your resources. Locations can provide an additional search and reporting capability.



### To create Locations:

1. Go to Administration > Application Settings > Resources > Locations.
2. Select **New Location** from the **Create Button**.
3. Type the Name of the Location.
4. Add Description, if desired.
5. Select the check box for Location.
6. Click Save.

 **Note:** Location profiles may be disabled for your account. If you would like Locations to be available in, or removed from Administration > Application Settings > Resources > Industries, contact SuiteProjects Pro Support.


## Job Roles

Job roles provides an ability to track past job experience by role. It is one of the standard Resource Profile elements predefined in SuiteProjects Pro. The Job roles link only displays if you have activated this as a Resource profile option. See [Resource Profile](#).

The Job role can be a job title or can define job duties or responsibilities. Job role definitions are not related to [Job Codes](#) or roles as defined in the [Roles Overview](#).

### To create Job roles:

1. Go to Administration > Application Settings > Resources > Job roles.
2. Select **New Job role** from the **Create Button**.
3. Type the Name of the Job role.
4. Add Description, if desired.
5. Check the **Active Job role** box.
6. Click Save.

 **Note:** Job role profiles may be disabled for your account. If you would like Job roles to be available in, or removed from Administration > Application Settings > Resources > Industries, contact SuiteProjects Pro Support.

## Industries

Industries can provide you with a snapshot of which resources are suitable for a particular project. It is one of the standard Resource Profile elements predefined in SuiteProjects Pro. The Industries link only displays if you have activated this as a Resource profile option. See [Resource Profile](#).

An Industry may involve a direct relationship such as working for a firm within the specified industry, or it may be defined indirectly such as a consultant supporting various industries. Some customers may require a certain level of industry knowledge to have employees engaged on their projects. Industries provide an additional search and reporting capability.

## To create Industries:

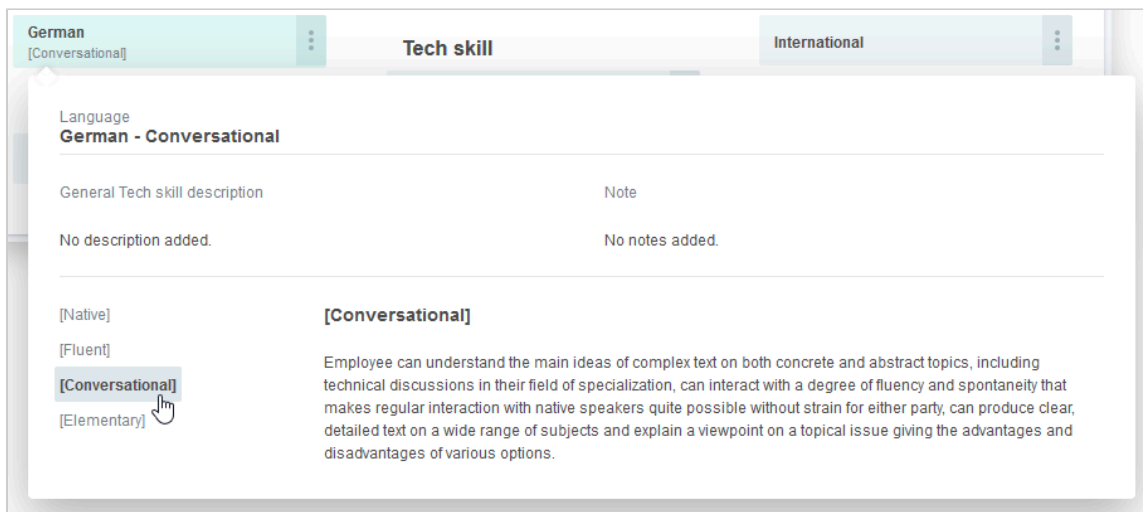
1. Go to Administration > Application Settings > Resources > Industries.
2. Select **New Industry** from the **Create Button**.
3. Type the Name of the Industry.
4. Add Description, if desired.
5. Check the Active Industry box.
6. Click Save.

**Note:** Industry profiles may be disabled for your account. If you would like Industries to be available in, or removed from Administration > Application Settings > Resources > Industries, contact SuiteProjects Pro Support.

## Customizable Skill Level Descriptions

Add descriptions to skill levels to help your resource managers assign the right competency level to each resource.

You can point to a skill on the consolidated resource profile, to view a skill description panel including a general description and a description of the competency level selected for that skill. To view the description for another competency level, point to that competency level on the skill description panel.



## To add descriptions for competency levels:

1. Go to Administration > Application Settings > Resources > [Select a category]. Select a category which contains skills and skill levels, such as "Education" or "Language".  
The list for the selected category appears.
2. Click a skill name. The skill entity form appears.
3. Under the Attribute descriptions section, enter a description for each competency level.
4. Click **Save**.

## Resource Booking Planner

The resource booking planner provides a global view of bookings and resource utilization calculated per day, week, or month. You can drag bookings from one resource to another to reassign them, and you can also change the bookings start date, end date and duration with a simple mouse interaction. The resource booking planner provides a visual overview of bookings and utilization, and lets you identify and resolve booking conflicts and resource overutilization.

**Note:** If the Resource Booking Approvals feature is enabled for your account, depending on your account configuration, bookings with the approval status "Submitted" or "Approved" cannot be modified. You cannot drag to change the start date, end date, duration or resource booked from the Resource Booking Planner view.

To enable the Resource Booking Planner feature, contact SuiteProjects Pro Support. When the feature is enabled, the following role permissions and application settings are available:

- Role permissions
  - View resource planner
  - Create and modify bookings in the resource planner
- Application settings ( Administration > Application Settings > Resources > Other Settings)
  - **Resource planner booking bar format - text options in drop down** — Select the default format for the text showing on booking bars.
  - **Disable daily option in resource planner** — Check this box to hide the Daily utilization calculation option for all resource booking planner users.
  - **Disable monthly option in resource planner** — Check this box to hide the Monthly utilization calculation option for all resource booking planner users.
  - **Disable weekly option in resource planner** — Check this box to hide the Weekly utilization calculation option for all resource booking planner users.

To access the resource booking planner, go to Resources > Bookings > Planner. If QuickViews are enabled for your account, you can also click **Booking Planner** from the QuickView window.

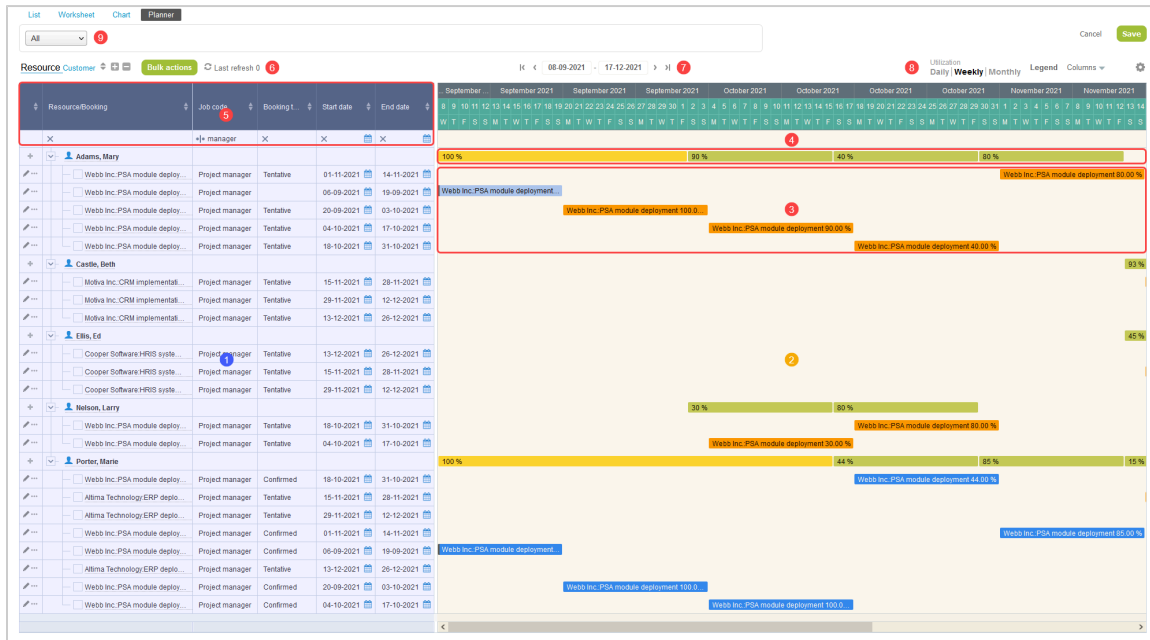

## Resource Utilization Overview in the Resource Booking Planner

The resource utilization overview is the default resource booking planner view. It shows a list of resources and bookings with a graphical overview of bookings and utilization for each resource over a period of time.


To access the resource utilization overview, go to Resources > Bookings > Planner and click **Resource** in the resource booking planner toolbar.





- Resources and Bookings List** — The left part of the resource booking planner shows a list of resources and bookings for each resource. You can select which columns are shown on the list using the **Columns** panel available from the toolbar.
  - Icons next to the resource name indicate the type and status of resource.
    - User, Jane** — Active resource currently assigned to the project.
    - User, Jane** — Inactive resource currently assigned to the project. Resources with an inactive employee record cannot sign in to SuiteProjects Pro, and cannot record time or expenses, for example.
    - Analyst [Generic]** — Active generic resource. Generic resources let you specify the kind of resource you want to book rather than a named individual. They can be useful as placeholders when planning a project if you do not know who will be conducting the work. Generic resources can only be used for forecasting — only named resources can record time and expenses.
    - Analyst [Generic]** — Inactive generic resource.
  - Click the arrow next to the resource name to expand or collapse the list of bookings for this resource.
  - Drag a booking vertically from one resource to another to reassign it.

**Note:** Bookings are grouped on one row and booking information is not shown if you choose the compact display option for Resources. To change the display options, click the settings icon

- Booking Grid** — The right part of the resource booking planner shows a graphical representation of bookings and resource utilization over the booking grid time span. Days, Weeks and Calendar Months are indicated at the top of the grid. You can control the time span using the time navigation panel in the toolbar.
- Booking bars** — Each booking is represented by a horizontal bar spanning the period the resource is booked for.
  - A black solid bar at the left or right extremity of the booking bar indicates that the booking extends beyond the start or the end of the time span displayed. Each bar is color-coded


depending on the booking type and includes a label with summary information, and an icon indicating the approval status of the booking. You can control the color code and the text format in the resource booking planner settings form available when you click the settings icon .

- Drag a booking bar horizontally to change the booking start date and keep the duration unchanged. You can drag the left or right edge of a booking bar to change both the booking start or end date and the booking duration.
- Click and drag outside existing bars in the booking grid to add a new booking. The new booking form appears in a popup window. The form is prepopulated with resource, project, task, start date, and end date information according to the grid locations you click and drag to.
- Click a booking bar to show a context menu with options to **Create** a new booking, **Edit** the booking, or **Duplicate** it. These actions are also available from the Actions column on the left.

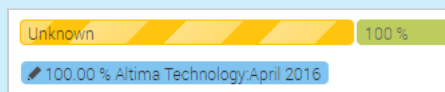
 **Note:** Booking bars are grouped on one row if you choose the compact display option for Resources and there is no period overlap between bookings. Overlapping bookings show on multiple rows. To change the display options, click the settings icon .


If the Resource Booking Approvals feature is enabled for your account, depending on your account configuration, bookings with the approval status "Submitted" or "Approved" cannot be modified. You cannot drag to change the start date, end date, duration or resource booked from the Resource Booking Planner view.


4. **Utilization bars** — The utilization of each resource is represented by horizontal bars on the same row as the resource name. The utilization is calculated as a percentage of hours booked compared to the employee's work schedule on a daily, weekly or monthly basis depending on the option selected in the toolbar. The utilization shows as a continuous bar if the utilization is the same across several time granularity units. Each bar is color-coded depending on the availability of the resource. You can control the color code using the Chart color keys section of the resource booking planner settings form.



 **Note:** The utilization information after the page is loaded or after you save changes.


- When the utilization is being calculated, the utilization shows as "Unknown".
- If you make changes to the bookings, such as changing the start or end date of a booking, for example, the impacted utilization bar shows as "Unknown" until you save the changes and the utilization is recalculated.

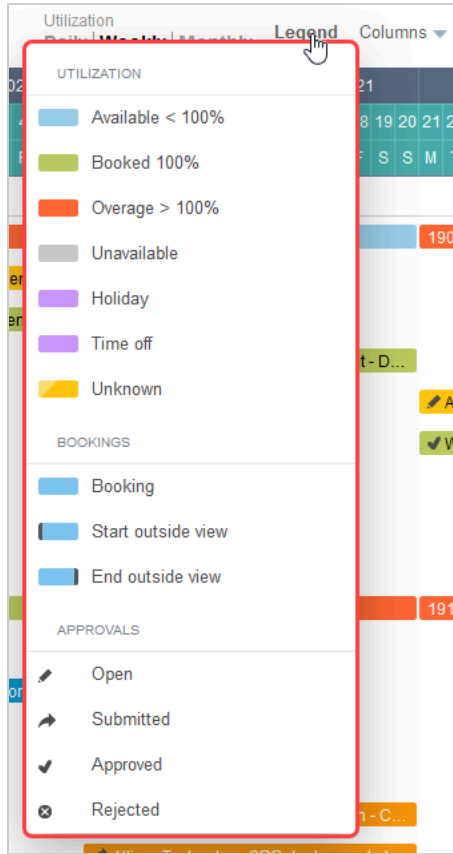


5. Resource and Bookings List **Column Headers** — The column headers include the following functionality:
  - **Sort Order** — Use the sort icons  to change the sort order using up to three sorting levels. See [Sorting Options](#).
  - **Column Filters** — Use column filters under the column headers to change the filter the list content. See [Filtering Data Using Column Filters](#).

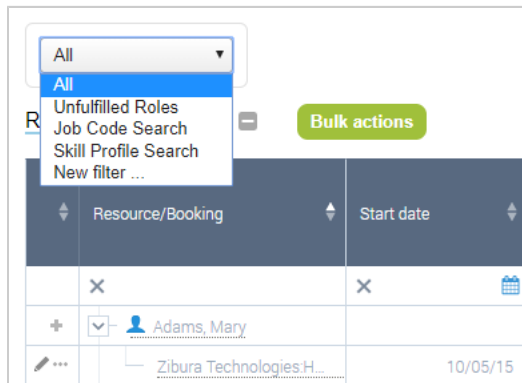
- **Column Position and Width** — Drag a column to change the column order. Drag the right edge of a column to change the column width.
6. **Toolbar (Left)** — The left part of the toolbar includes the following functionality:
- **View Selector** — The resource booking planner lets you view a breakdown of bookings by resource or by customer, project, and task.
    - Click **Resource** to get an overview of resource utilization as described in this help topic.
    - Click **Customer** to get an overview of bookings by customer, projects and tasks. See [Breakdown by Customer, Project and Task in the Resource Booking Planner](#).
  - **Sorting Reset** — Click the sorting icon  to reset the list to the default sort order.
  - **Expand All/ Collapse All** —
  - **Bulk Actions** — Check the box next to each booking you want to run the action on and click **Bulk Actions**. A window appears listing the available actions.

 **Note:** You can hide the bulk actions box in the display options. To do so, click the settings icon  then Disabled under Bulk actions.

- **Refresh View** — Click the refresh icon  to reload the page and view the latest data. The toolbar shows the time elapsed since the last refresh next to the refresh icon.
7. **Toolbar (Center) — Date Navigation** — Use the date navigation panel to control the booking grid time span. Click and select a start and end date. The maximum time span is 100 days. You can use the rewind, previous, next, and fast forward icons to move the time span backward or forward by 50% or 100% of the current time span.
8. **Toolbar (Right) — Utilization Calculation and Display Options** — The right part of the toolbar includes the following functionality:
- **Utilization Calculation Time Granularity** — Select the time granularity for the utilization granularity. The utilization is recalculated when you click a different granularity.
    - **Daily** — Utilization is calculated for each day. The share of each booking on each day is used for the calculation. The sum of booked hours per day is divided by the Day schedule.
    - **Weekly** — Utilization is calculated for each calendar week .
    - **Monthly** — Utilization is calculated for each calendar month.
  - **Legend** — Point to **Legend** to show a summary of the utilization color coding, and approval status icons.



- **Columns Selection** — Click **Columns** to display the List columns flyout panel. Select the columns you want to include and specify the column order. Click **Apply** to validate your changes and return to your list.
  - **Other Settings** — Click the settings icon to access the other resource booking planner settings. See [Other Settings](#).
9. **Advanced Filters** — Use advanced filters to show only the resources and bookings you want to see, or to manage the number of bookings displayed in the resource booking planner.



**Important:** The resource booking planner can display a maximum of 1,000 bookings. Use advanced filters to reduce the number of bookings displayed and show only the bookings you want to see. Reducing the number of bookings improves the performance and usability of the resource booking planner.

To review the number of bookings, resources and the time span shown on the resource booking planner, click the Tips button. The contextual tips include a summary such as "Showing 278 bookings and 89 resources in 91 days".

## Breakdown by Customer, Project and Task in the Resource Booking Planner

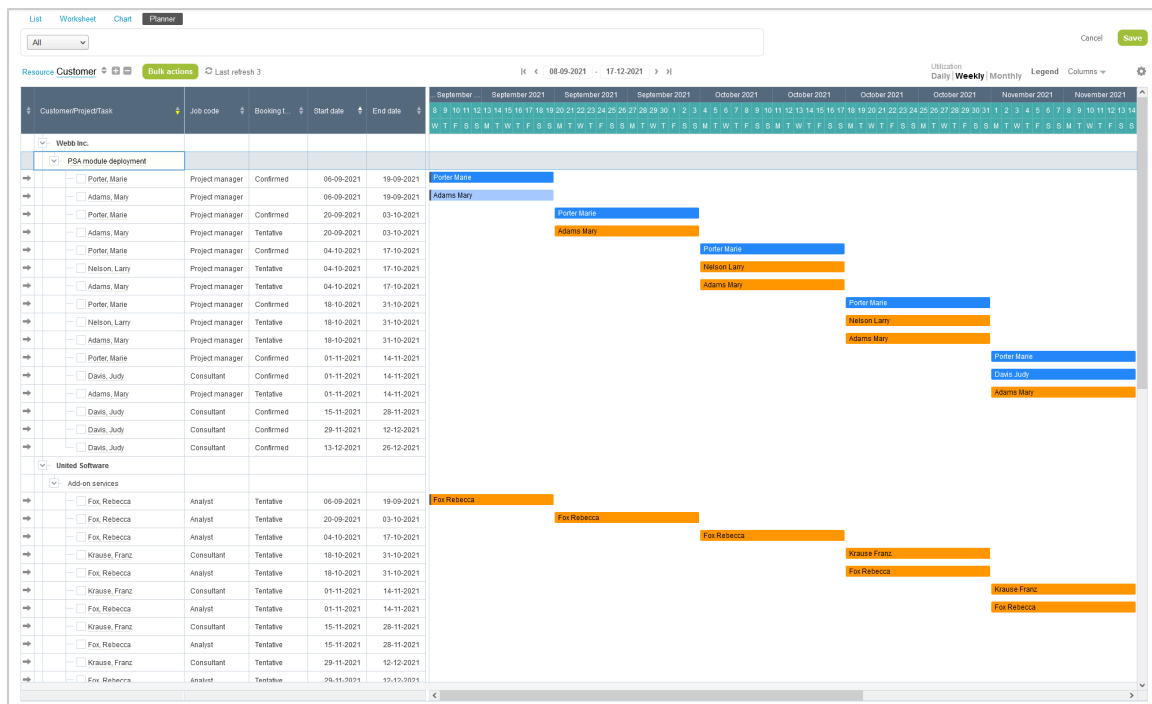
The resource booking planner lets you view a breakdown of bookings by customer, project and task with a graphical overview of bookings for each task over a period of time. It gives an overview of resources booked to each task and project, with indications of resource overutilization.

The functionality and information shown is similar to the resource utilization overview with the following differences:

- The list gives a breakdown by customer, project and task, instead of resource and bookings.
- Resource utilization information is not available.
- Overutilization (or Overage) is indicated with a red outline around the relevant booking bars.
- The Actions column includes a go to action only. Click the arrow icon to view the booking in the resource utilization overview. From there, you can identify what causes the overage and resolve it.

To access the bookings by customer, project and task overview, go to Resources > Bookings > Planner and click **Customer** in the resource booking planner toolbar.






# Creating, Editing, and Deleting Bookings in the Resource Booking Planner


You can create, edit and delete bookings from the resource booking planner.

## Creating Bookings


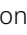
To create a new booking, do one of the following:

- From the resources and bookings list, click the add booking icon  next to the resource name. The New booking form appears with the **Resource** field prepopulated. Enter all required information and click **Save & Submit**, **Save**, or **Save & create another**. The utilization is recalculated automatically after you add the booking.
- From the booking grid, click and drag in the same row as an existing booking bar. The New booking form appears with prepopulated **Resource**, **Customer : Project**, **Task**, **Start** and **End Date**, and **Book by** information based on the existing booking on that row. Click **Save** in the resource booking planner to save the new booking and other changes made in the booking grid and trigger the utilization calculation.

## Editing and Deleting Bookings

 **Note:** If the Resource Booking Approvals feature is enabled for your account, depending on your account configuration, bookings with the approval status "Submitted" or "Approved" cannot be modified. You cannot drag to change the start date, end date, duration or resource booked from the Resource Booking Planner view.

To edit a booking, do one of the following:

- From the resources and bookings list, click the **edit** icon . The Edit booking form appears. Make changes as required and click **Save** or **Save & Submit**.
- You can edit the booking start date and end date inline in the resources and bookings list. You can also:
  - Drag a booking bar horizontally to change the booking start date and keep the duration unchanged.
  - Drag the left or right edge of a booking bar to change both the booking start or end date and the booking duration.
- To reassign a booking, drag this booking vertically from one resource to another in the resources and bookings list. Click **Save** in the resource booking planner to save all changes and recalculate the utilization.
- Point to a booking, task, or resource to show the QuickView for that item, then create a new booking, or edit, delete, or clone an existing booking from the QuickView.
- Click the more options icon  next to a resource name, then click **Create**, **Edit**, **Duplicate** or **Delete** the booking.
- If bulk actions are enabled, check the boxes next to each booking or task, then click **Bulk Actions** to make changes to all selected items at the same time. It is possible to select an item only if you have the appropriate role permissions.

You can choose **View the selected bookings in the bulk editor** on the bulk actions form. The Bulk Booking Editor feature lets you make changes to multiple fields for all selected bookings at the

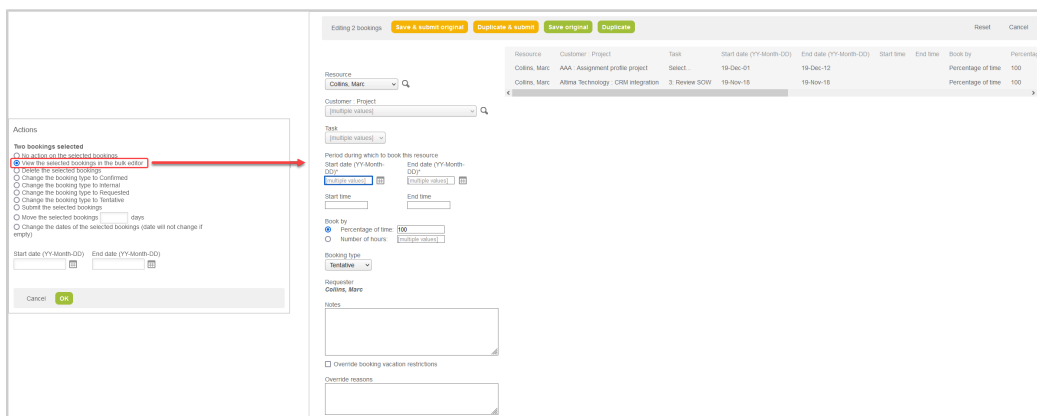
same time. You can then save or save and submit the modified bookings, or apply the changes to duplicate bookings and save, or save and submit the duplicate, if you want to keep the original bookings unchanged.

**Note:** To enable the Bulk Booking Editor feature, contact SuiteProjects Pro Support. SuiteProjects Pro Support can also configure the Booking Bulk Editor to prevent the following changes:

- Bookings for multiple resources reassigned to a single resource.
- Resource and customer both modified.

Account administrators control who can access the booking bulk editor by role permission:

- View and modify bookings in the bulk editor
- View, modify, and duplicate bookings in the bulk editor

### Sorting Options


You can sort the resource booking planner data by column using the sort icons in the column headers.

This feature supports ascending and descending sort orders and multi-level sorting up to three levels. The arrows in the column header indicate the sort order and sorting levels:

- Sorting levels are color-coded:

- White color arrow — Primary level
- Yellow color arrow — Secondary level
- Green color arrow— Tertiary level
- The colored arrow indicates the sort order for each sorting level:
  - Arrow pointing up — Ascending sort order
  - Arrow pointing down — Descending sort order

Click a column header to select that column as your primary sort field. Click the same column header again to change the sort order. If you click a different column header, this column becomes your primary sorting level, the previous primary level becomes the new secondary level and the previous secondary becomes the new tertiary level.

To reset the sort order to the default one, click the sort icon  in the toolbar.

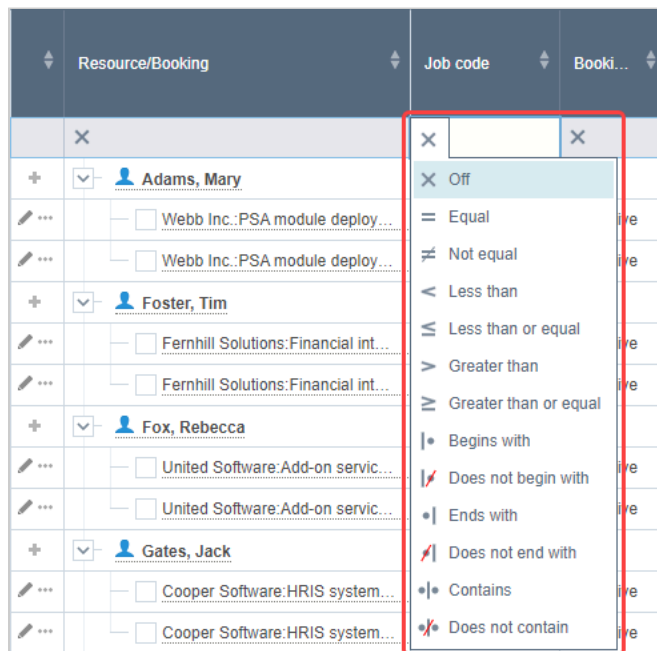
## Filtering Data Using Column Filters

You can use column filters to show only the resources and bookings you need. For each column filter, you can specify a criteria by selecting an operator and entering a value. After you set column filters, the resource booking planner shows only the matching information.

### To filter data using column filters:

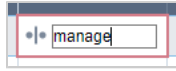
1. Click the icon in the filter cell under the column header. The icon may be different depending on the column filter currently applied.

The operator dropdown list appears. It includes the following options: Off, Equal, Not equal, Less than, Less than or equal, Greater than, Greater than or equal, Begins with, Does not begin with, Ends with, Does not end with, Contains, Does not contain.

## Column Width and List-Grid Divider

You can change the width of columns on the left part of the resource booking planner by dragging the right border of each column.

You can move the divider between the list on the left and the grid on the right by dragging it to the desired size.

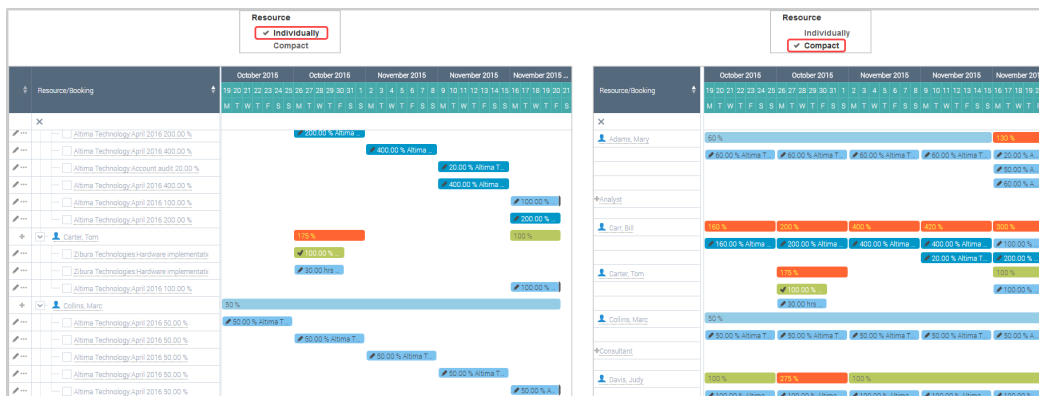
**Note:** For small date ranges, the width of the grid is set automatically and cannot be changed.

## Other Settings

Click the settings icon  to access the other resource booking planner settings.

- Customize list** — Select the columns to display on the left side of the resource booking planner view and specify the column order. The **Available** list shows all the columns you can add. The **Selected** list shows all the selected columns. Use the links to move items between the Available and Selected lists. Click a column in the **Selected** list and click the up and down arrow to change the position of this column.
- Settings** — The resource booking planner settings form lets you control the color-coding of booking bars by booking type, the information shown on the booking bar labels booking bar, and the color-coding of utilization bars depending on resource availability. You can also opt to **Include active resources without bookings** and **Include inactive resources with bookings**, which are excluded by default.
- Resources** — Click **Individually** to show each booking on a separate row. Click **Compact** to show all bookings on the same row.

If you choose the compact display option, the list on the left no longer shows booking information, and booking bars are grouped on one row except when there is a period overlap between bookings. Overlapping bookings show on multiple rows.



- Bulk actions** — Click **Enabled** to show the bulk actions check boxes for each booking row. Click **Disabled** to hide the bulk actions check boxes.

## Resource Compare View

The Resource Compare View allows you to compare resources at a glance and better manage large pools of resources. Add resources to the view, and then compare them side by side. You can select favorite skills and demographics, and create bookings from within the view.

### To enable the Resource Compare View


1. Ensure that your account has access to the Resources module.
2. If the user is not an administrator, ensure that the user's role has the "Enable Resource Compare View" role permission.
3. To add resources to compare from a resource QuickView, ensure that QuickViews are enabled for the user.

There are three ways to add resources to the Resource Compare View.

### To add resources to the Resource Compare View

- Point to any field which opens a resource QuickView, and click "Add to compare".
- In any list which shows resources, the Resource Request Queue "Search and Propose" page, or in Custom Search results, select the checkbox in the Bulk actions column next to each resource you want to compare, then click the "Bulk actions" or "Select..." dropdown list and click "Add to compare."

- In the Resource Compare View, click the "Add Resource" button.

As you add resources to compare, the counter on the left sidebar changes to indicate how many resources are in the Resource Compare View. Click this counter to open the "Resource Comparison" window, which shows the resources you will compare. To remove resources from this list (and from the Resource Compare View), click the  icon next to the resource's name.

**Note:** The Resource Compare View has a default limit of 50 resources which can be compared at one time. To increase this limit, go to Administration > Application Settings > Resources > Resource compare view options and enter a new maximum value in the "Maximum number of resources to display in Resource Compare View" text field. This text field accepts any number values up to 200.

## To open the Resource Compare View



There are two ways to go to the Resource Compare View:

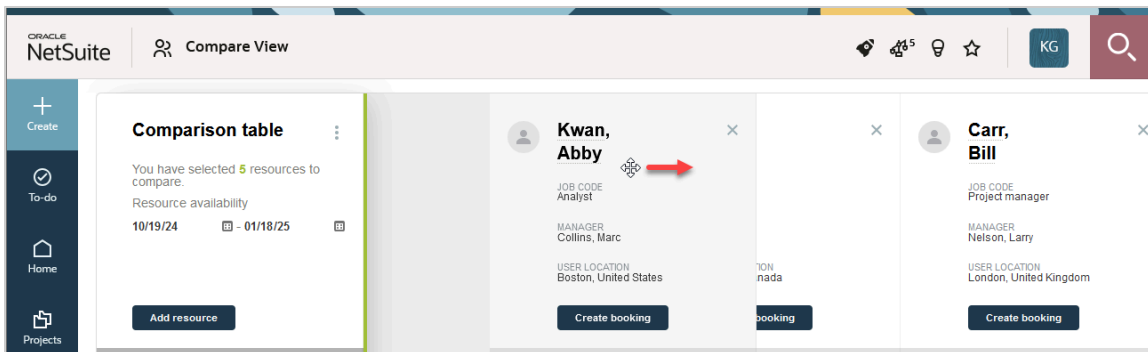
- Click the "Compare View" button in the "Resource comparison" window.
- Go to Resources > Compare view.

## Using the Resource Compare View

While in the Resource Compare View, add resources to compare by clicking the "Add Resource" button and selecting them from a multi-select list. Left click on an un-selected resource name in the list, and they will be added to the Comparison table. Left click a selected resource to remove it from the comparison.

To filter resources based on their availability, click the icon next to the "Resource availability" field and enter or select start and end dates.

Compared resources are shown side-by-side in the Comparison table. Rearrange the resources in the Comparison table by dragging them to new positions on the table. To remove a resource from the Comparison table, click the  icon in the top right corner of that resource's card. To remove all resource from the comparison, click the  icon and select "Remove all resources".



By default, resources' rates are hidden in the Resource Compare View. To display each resource's rates in the header of the resource cards, go to Administration > Application Settings > Resources > Resource compare view options and select the "Display employees' rate" option under Header settings.


You can also set which three fields appear under each resource's name in the Resource Compare View header. Any user demographic or custom fields can be selected to appear in the heading. See [Customizing Resource Compare View Headers](#).

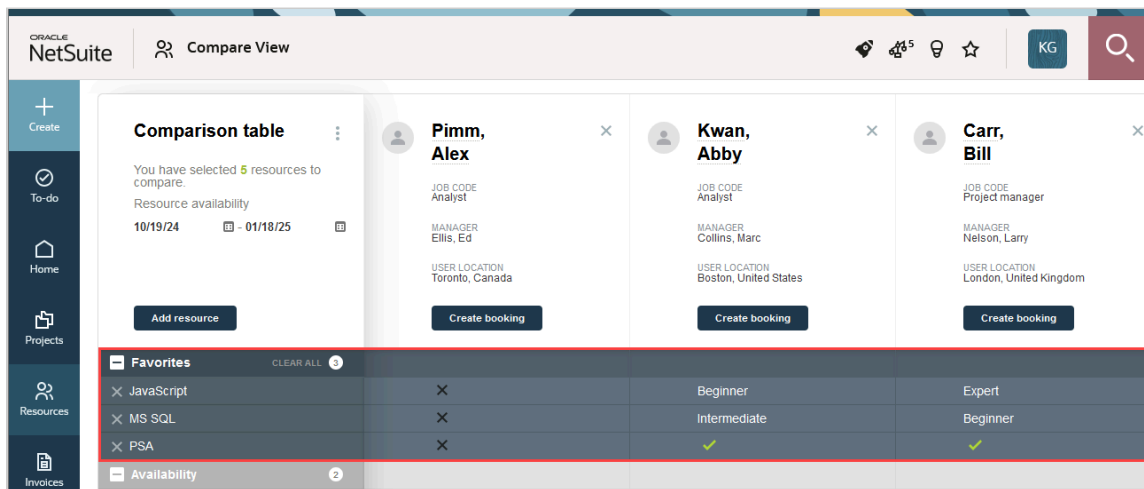
To hide skills categories such as Product knowledge or Tech skills, click the  icon near the category title. Click the  icon next to category title to expand that list of attributes. The numbers next to the category title indicate how many attributes are in that category.

Point to a Resource name in the header to open a QuickView window with details for the resource and links to perform resource-related actions.

As you scroll down the category skills category list, the resource name headers remain in view.

## Setting favorite skills or attributes in the Resource Compare View

You can select favorite categories which are moved to their own "Favorite parameters" row near the top of the Comparison table. This category remains visible even if you add or remove resources from the table. To set a favorite skill or attribute, click the  icon next to the skill or attribute.

## The Demographics category in the Resource Compare View

The Demographics category includes standard fields, and can be further customized in Administration > Application Settings > Resources > Resource compare view options. Here you can choose to include or exclude custom fields and some standard fields. To enable this feature, add the "Modify Resource Compare View options" role permission to all roles which you want to access it.

## Booking Resources from the Resource Compare View


### To book a resource from the resource compare view:

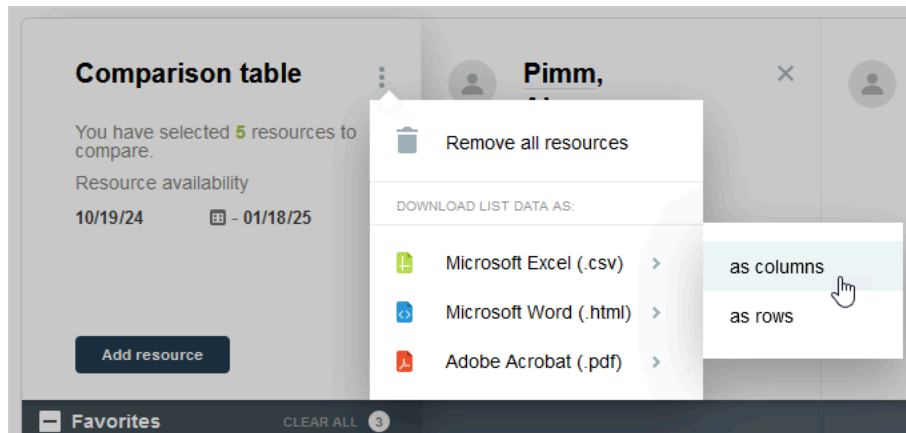
1. Click the "Create Booking" button in the Resource card header. A "New booking" form opens.
2. Enter the booking's details in the "New booking" form.

**Note:** When the New booking form first opens, the booking dates are based on the “Resource availability” dates set in the Comparison Tool, but can be changed when entering the booking information in the form.

## Downloading Resource Compare View Data

You can download resource compare view data in a variety of formats.

1. Go to the Resource Compare View's Comparison table.
2. Click the  icon. A window opens with options to download the Resource Compare View's list data.
3. Point to the file format you would like to save the data as. A window opens where you can select to save the data as columns or rows.



- Click “as columns” to save resource data vertically in your downloaded file. This format most closely replicates the data as it appears in the Resource Compare View's Comparison table, with each column representing a resource.
- Click “as rows” to save resource data horizontally in your downloaded file. In this format, each row represents one resource.

## Filtering or Removing Inactive Resources from the Resource Compare View

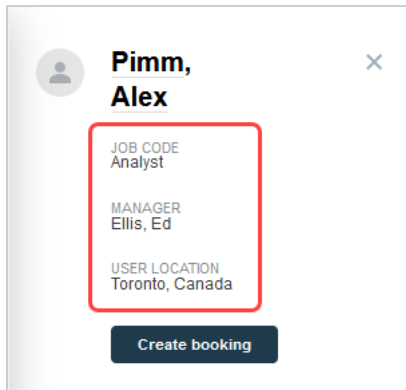
### To filter or remove Inactive resources from Resource Compare View selector:

1. Go to Administration > Application Settings > Resources > Resource Compare View Options and clear the **Include inactive resources** option.

## Customizing Resource Compare View Headers

Set which three fields appear under each resource's name in the Resource Compare View header. Any user demographic or custom fields can be selected to appear in the heading.





### To select which fields appear in the Resource Compare View headers

1. Go to Administration > Application Settings > Resources > Resource compare view options.
2. Select the fields to display in the "Header settings" section of the Resource Compare View Options form.

**Note:** If you try to set more than three fields in the header, you will receive an error message.

## Advanced Resource Search

With Advanced Resource Search, enter the parameters, skills, and demographics you're looking for, and SuiteProjects Pro does the rest. Search for availability, resource type, and entity tags. Mark parameters as "Required" and SuiteProjects Pro makes sure that the search results will only return candidates with those skills.

**Note:** This feature is enabled by default, and all users with access to the Resources module can use it. To control access to this feature, contact SuiteProjects Pro Support to enable the **View Advanced Resource Search** role permission, which can be used to limit access to specific roles.

### To search for a resource:

1. Go to Resources > Search > Advanced Resource Search.
2. Enter the General search parameters in the **General parameters** tab.

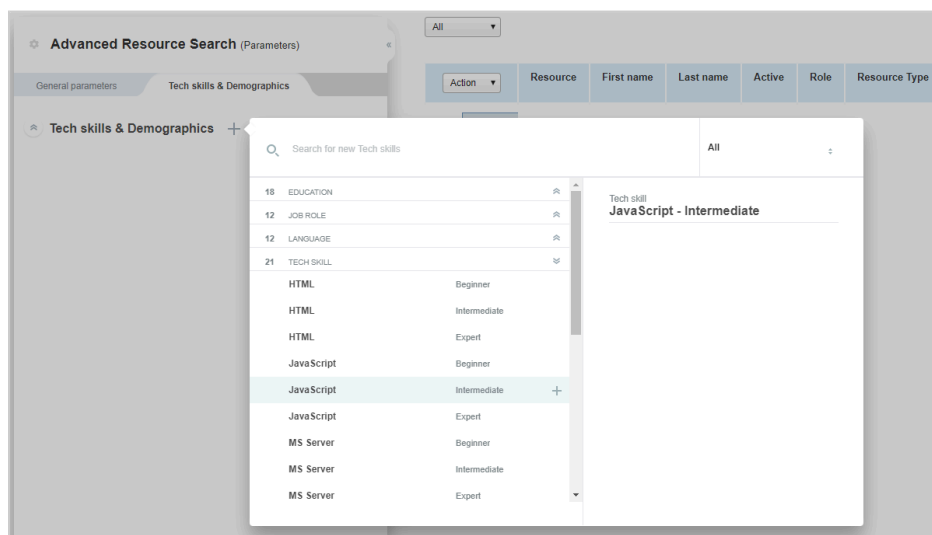

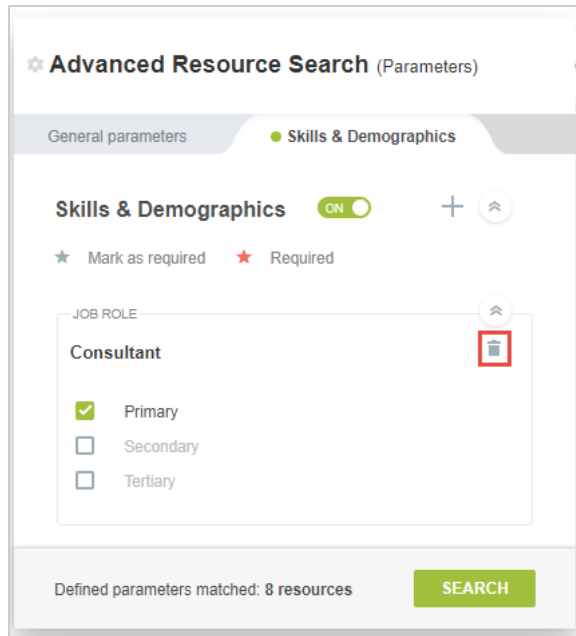
- **Resource type filter** – filter the types of resources which are included in the search. If no options are selected, Advanced Resource Search will search for all resource types. If you select an option (for example, “regular resources”), Advanced Resource Search will only search for the selected type of resource. Click the toggle button next to the **Resource type filter** heading to disable filtering by Resource type.
- **Hourly cost** – define the hourly cost range for the resources. Select a **Currency** and define a **Minimum** and **Maximum** hourly costs either by typing the figures in or using the sliders underneath. The hourly cost search parameters are empty by default. After the **Currency** is set, the **Minimum** and **Maximum** values are automatically set to the minimum and maximum hourly cost values in the account. The number of matches is recalculated automatically

whenever the range is changed. The hourly cost criterion is defined in terms of primary loaded cost. Only users with the **View primary loaded costs** role permission can view and use this search parameter. Click the toggle button next to the **Hourly cost** heading to disable searching by hourly cost.

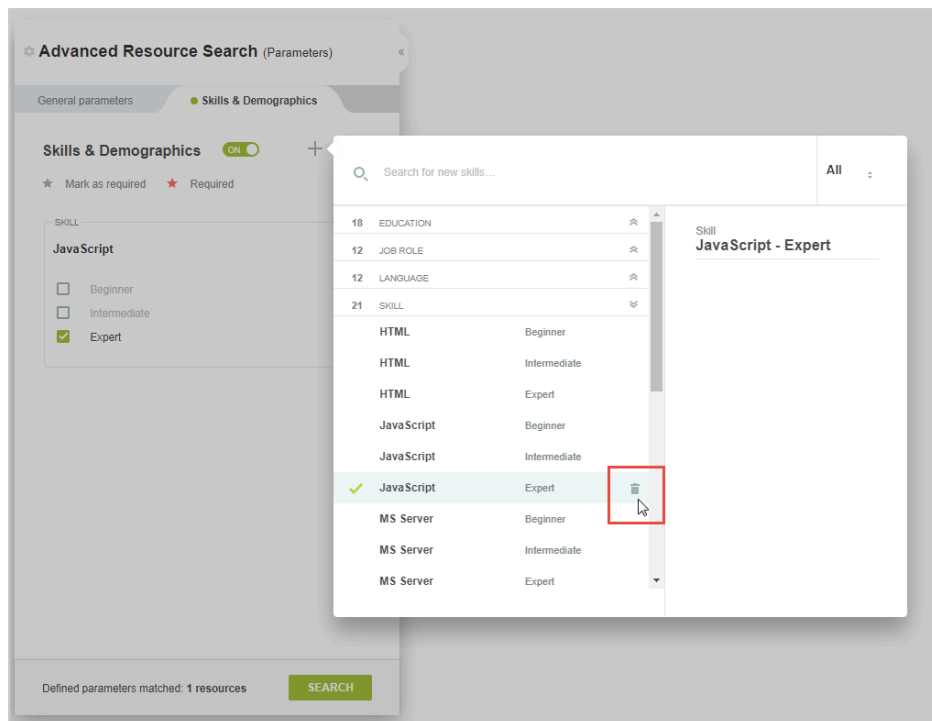
- **Availability** – you can set the **Date period** for when you will need the resources, their availability by percentage or hours, or limit their availability to specific booking types. Select the **Allow no intervening bookings when determining availability** option to prevent Advanced Resource Search from including resources with existing bookings which conflict with your search period from being included in the results. Click the toggle button next to the **Availability** heading to disable searching by ability.
  - **Entity tags** – set search criteria for Entity tags here. Click the toggle button next to the **Entity tags** heading to disable searching by Entity tags.
  - **Resource hierarchy filter** – Advanced Resource Search supports hierarchies when searching. Click the toggle button next to the **Resource hierarchy filter** heading to disable filtering by Resource type.
3. Enter the Skills you would like the resources to have in the **Skills & Demographics** tab.
- To add a skill to the search, first click the Add new **Skills / Demographics** **+** icon. Then select a skill category and click the **+** icon next to the skill you want to add to the search.



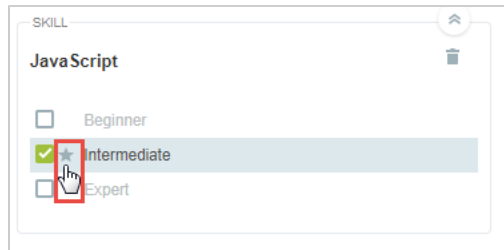
- To delete a skill from the search, click the **Delete** icon to the right of the skill name in the **Advanced Resource Search Parameters**.



Alternatively, you can delete a skill from the search by clicking the **Add new Skills / Demographics** icon selecting the skill category of the skill to delete, and clicking the **Remove Skill** icon next to the skill you want to remove from the search.



- To mark a skill as required, point to the skill and click the **Required** icon. The search will only return resources who have this skill.



**Note:** Some skills may have multiple levels of expertise or knowledge assigned to them (for example, JavaScript might have a Beginner, Intermediate, and Expert level of knowledge). Advanced Resource Search searches for each of these skill levels differently depending on how your skill profiles are set up.

For example, if you only allow a user to have only one level for JavaScript, and mark "Intermediate" JavaScript as required, Advanced Resource Search will return users with the "Intermediate" skill levels.

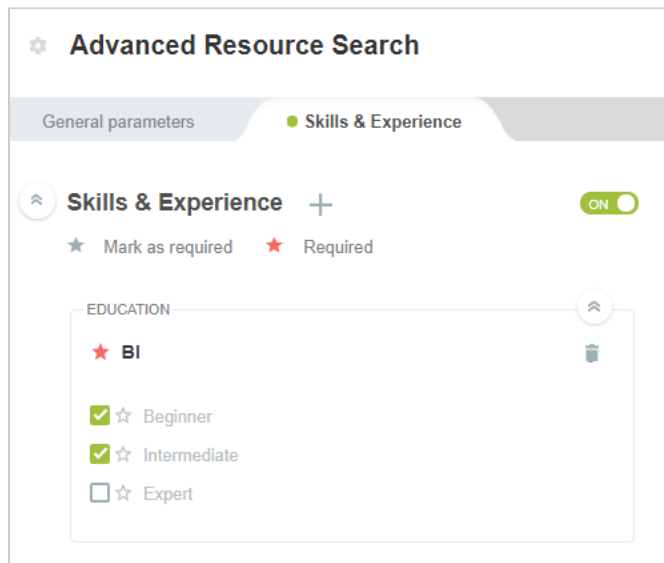
If no skills are marked as required, and you select "Intermediate" and "Advanced" JavaScript, Advanced Resource Search will return candidates with either of these skills. Resources without "Intermediate" or "Advanced" JavaScript will also appear, but will be ranked lower.

You can also search for resources with any level of required skills by marking a skill as required when looking for resources in Advanced Resource Search, and then selecting which skill levels

you want to search for. When a skill is marked as Required, Advanced Resource Search will return candidates who possess any of the levels for this skill which you selected.

### To set whether a skill or skill level is required or not in Advanced Resource Search:

1. Click the star icon next to the skill name. A red star icon indicates the skill is required, while a clear star icon indicates it is not required.
2. Select the skill levels you want to search for.



When you run the search, Advanced Resource Search will return resources who have either of the skill levels you selected. For example, if you select the BI skill, and also

select the Beginner and Intermediate levels for BI, Advanced Resource Search will return resources who have either Beginner BI experience or Intermediate BI experience.

- As you enter search criteria, the **Defined parameters matched** field updates to indicate how many resources your search will return.

You can also save searches in Advanced Resource Search.

#### To save a search in Advanced Resource Search:

- Click the **Menu** ☰ icon in the **General parameters** tab.
- Click **Save search settings**.
- Name the search (required) and provide a description for it (optional).
- Click **Save**.

#### To copy a search and save the copy in Advanced Resource Search:

- Click the **Menu** ☰ icon in the **General parameters** tab.
- Click **Copy and save**.
- Name the copy of the search (required) and provide a description for it (optional).
- Click **Save**.

#### To delete a saved search in Advanced Resource Search:

- Click the **Menu** ☰ icon in the **General parameters** tab.
- Click **Delete**.
- Click **OK** to confirm the deletion.

Users with the Modify Advanced Resource Search options role permission can customize the Advanced Resource Search form to show or hide any of the general search parameters.

## To show or hide sections in the general search parameters tab

1. Go to Administration > Application Settings > Resources > Advanced resource search options.
2. Select the section you want to show in the Advanced Resource search and leave the sections you want to hide unchecked.
3. Click **Save**.

**Note:** The Skills & Experience parameter section is always shown.

## Resource Demand Request (RDR)

The Resource Demand Request (RDR) optional feature lets you find and assign resources with specific sets of skills to your projects. To use the feature, first create a resource request, which acts as a folder for individual resource request queues. Resource request queues are searches for resources with specific characteristics, such as language proficiency, product knowledge, or job roles. You can then book resources from your resource requests, and download the information for later use. For more information, see the following help topics:

**Note:** Resource request records support custom fields — See [Custom Fields](#). Custom fields associated with resource requests are automatically visible in the resource request queues list and available for the resource request queues detail report.

## Creating a Resource Request

Resource requests act as a folder for detailed resource searches, or resource request queues. Every resource request queue must be in a resource request.

### To Create a resource request:

1. Go to Resources > Resource requests.
2. Click the Create button.  
The Create menu appears.



3. Under **Resource request**, do one of the following:

- To create a resource request only, click **New ...**


The New resource request form appears. After you enter all information and save the form, the Resource Request Queue appears.

- To create a resource request and add a resource request queue to the new resource request record, click **New, quick ...**

The New quick resource request form appears

4. Enter all required information (indicated by an asterisk). The fields included on the form depends on the option you chose in the previous step.

Both forms include the following fields:

- **Name** (Required) — Give the request a name.
- **Resource request number** — Automatically filled in with the next number in sequence, based on the last resource request. You can also enter your own resource request number.
- **Default Customer : Project** (Required)— Select the customer and project for which this request is used by default. If the customer and project you want are not present in the dropdown list, select **Find more...** or click the search icon  to search for a customer or project by name.
- **Expected start date** — Enter the expected start date for the resources to start work. Click the Calendar icon to open a calendar to choose the date.
- **Duration** — Enter the duration which the resource will work on the project. In the first dropdown, select a number between 1 and 31, and in the second dropdown, select either Days, Weeks, Months, Quarters, or Years.
- **Start date** — Enter the start date for the resource's assignment.
- **End date** — Enter the end date for the resource's assignment.



**Note:** You can specify either:

- The **Expected start date** and a **Duration**
- The **Start date** and a **End date**

Both field pairs are mutually exclusive. Entering the **Expected start date** and a **Duration** hides the **Start date** and a **End date** fields, and inversely.

- **Booking type** (Required) — Select either Confirmed, Open, Pending, Rejected, or Tentative. When this field is displayed in a resource request queue, its value is read-only and based on the setting from the associated resource request.
- **Notes** — Enter any notes for the resource request.
- **Attachments** — Add any file attachments here. Attachments can include documents such as résumés, statements of work, etc.

The New quick resource request form includes additional fields to create a resource request queue with the resource request. See [Creating and Editing a Resource Request Queue](#).

5. Click **Save**.


After you enter all information and save the New resource request form, the New resource request queue form appears. See [Creating and Editing a Resource Request Queue](#).

After you enter all information and save the New quick resource request form, the resource request record appears.

## Creating and Editing a Resource Request Queue

After you create a resource request, you can add resource request queues to your resource request. Resource request queues are searches for resources with specific characteristics, such as language proficiency, product knowledge, or job roles.

### To create and edit a resource request queue:


1. Go to Resources > Resource Requests > [Select a resource request] > resource request queues.
2. Do one of the following:
  - Click the Create button, then **New ...** under **Resource request queue**
  - Copy an existing resource request queue by clicking the copy icon  in the Action column on the resource request queue list.

The Resource request queue form appears.



**Note:** You can also:

- Create a resource request when creating a resource request queue. See [Creating a Resource Request](#).
- Select and duplicate multiple resource request queues using the list bulk actions functionality.

3. Enter all required information (indicated by an asterisk).
  - **Name** — Assign a name to the resource request queue.
  - **Resource request queue number** — Automatically filled in with the next number in sequence, based on the last resource request queue. You can also enter your own resource request queue number.
  - **Customer : Project** (Required)— Select the Customer and Project which this request queue is used for. If the customer and project you want are not present in the dropdown list, select **Find more...** or click the search icon  to search for a customer or project by name.
  - **Resource request queue status** — Select either Open, Partial, Complete, or Cancelled.
  - **Resource request requester** — This field is automatically populated with the person creating the request.
  - **Resource request queue quantity** — Enter how many resources you need who have the desired skills or experience.
  - Enter a **Start date** and **End date** for the bookings.
  - **Notes** — Enter any notes for the resource request queue.
  - **Select type of resources to include in search** — Select whether to include regular resources (which are active named employees), generics (which are placeholder roles), or inactive resources (which are people who aren't active and cannot enter time, etc. to any project). You can also select to allow no intervening bookings when determining availability.
  - **Availability** — Select whether the queue factors in percentage of time or number of hours when determining availability. Click > Create next to Limit availability search to specific booking types to limit the search to Confirmed, Open, Pending, Rejected, or Tentative availability.
  - **Base Criteria** — Select the criteria used in the resource request queue. There are four different categories to which you can assign searchable skills and experience. Click **Add new** in any of

the base criteria fields to open a window and select Job roles, Languages, Product knowledge, Tech skills, or Travel preferences.

- **Required** — A resource must have these features to be included in the resource request queue.
- **Desired** — A resource with these characteristics is ranked higher in the search results, but these characteristics are not required to be included in the queue.
- **Nice To Have** — A resource with these characteristics is ranked lower than those with desired characteristics, but higher than a resource without them. These characteristics aren't required to be included in the queue.
- **Excluding** — A resource with these characteristics will be excluded from the queue.

Check the **One matching attribute is enough** box to include resources who have any of the selected attributes, rather than all of the selected attributes. This feature is particularly useful when searching for employees with a minimum level of expertise or better.

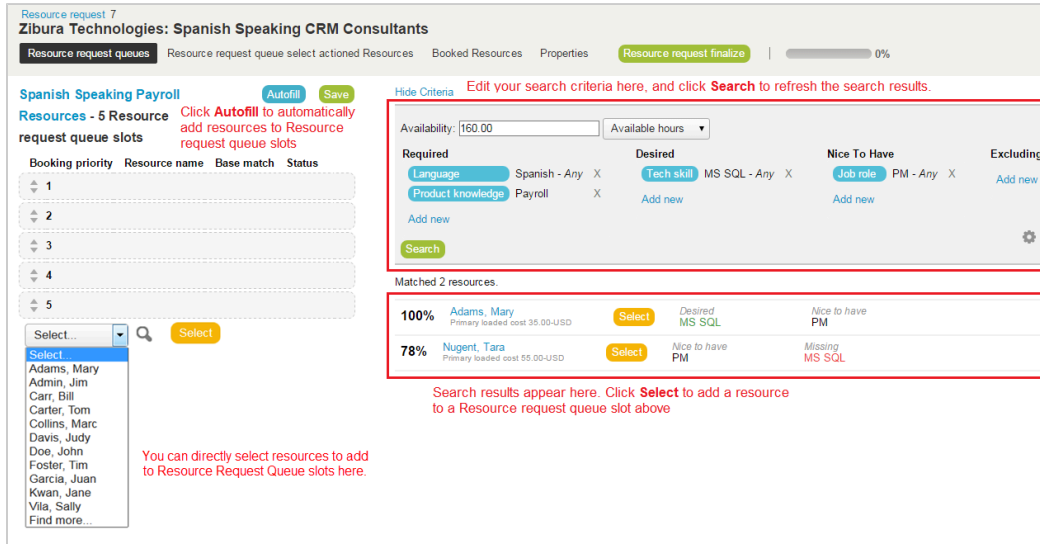
**Note:** When the **One matching attribute is enough** box is checked, employees with only one matching attribute are treated as a 100% match.

To use this feature, first go to Administration > Application Settings > Resources and clear the **Allow duplicates per resource** box for each profile type. The **One matching attribute is enough** box is not available on the resource request queues base criteria popup window if the **Allow duplicates per resource** box is checked for the profile type.

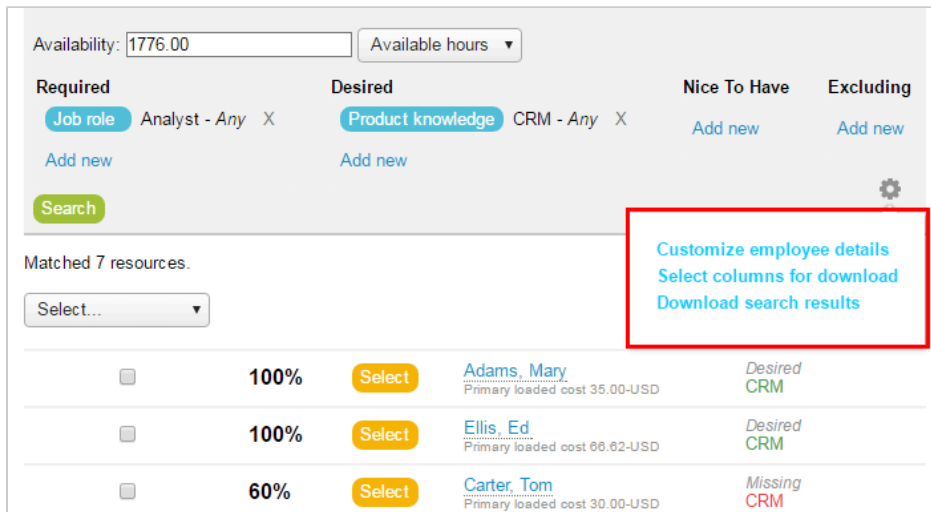

- **Attachments** — Add any file attachments here. Attachments can include documents such as résumés, statements of work, etc.
4. Click **Search and Resource request queue select action** to run the resource search and display the resource request queue.

The resource request queue record is saved and the Search and Propose page appears.



- Use the Search and Propose page to select resources and book them tentatively. The page shows the base criteria you selected previously and lists matching resources, with additional information such as a matching score, cost information and the search criteria they match.
  - Click the settings icon, then **Customize employee details** to customize the list and select the information shown on the list. You can also download the search results a HTML, CSV or PDF file, and select which information to include in the download file.



- Edit your search criteria, if required and click **Search** to find matching resources.
- Add matching resources to the Resource Comparison tool using the dropdown field above the matching resources list. See [Resource Compare View](#).
- Click **Select** in the matching resources list to add a resource to a resource request queue slot.
- Click **Autofill** to add matching resources to resource request queue slots automatically.
- Add any resources directly to resource request queue slots using the dropdown field under the resource request queue slots.
- Click the arrows  $\updownarrow$  under Booking priority to change the booking priority of the resource request queue slots.

**Note:** An optional feature replaces the booking priority ranking with a simpler method which lets you mark favorite resources without ranking them.

- If the feature is enabled for your account, click the star to mark or clear a resource as favorite in the resource request queue slots.

- To enable this optional feature, contact SuiteProjects Pro Support and request the following setting: **Use recommendations instead of ranking for resource request queue prioritization.**

6. Click **Save** to add the selected resources to the queue and return to the resource request queue properties form. The Resources section of the form shows the resource request queue slots you selected, with utilization forecast information. The selected resources are added to the **Resource request queue select actioned resources** sublist in the resource request record.
7. Click **Book** to book these resources tentatively to the project. A confirmation window will ask you to confirm the bookings. The bookings will be listed in the **Booked Resources** sublist after the bookings are confirmed.

**Note:** Booked resources still need to be approved. Click **Resource request finalize** in the resource request record header to close the resource request and approve all bookings.

You can use the Resource Request Queues Require Base Criteria and Availability feature to prevent resource request being finalized if the availability hours or percentage is set to 0. To enable this feature, contact SuiteProjects Pro Support.

Account administrators can control who can finalize resource requests by role permission. The **Resource request finalize** is not available for users with the role permission Disallow employee to finalize resource requests.

Users with the **Allow change of booking type on finalized Resource request** role permission can edit the booking type field in resource demand requests even after the resource request was submitted to a resource manager. This feature requires the **Enable a booking type to exist in all approval statuses** account setting. In addition, any bookings created after submission will retain the booking type which was set at the time the bookings were created, even if the booking type is later changed in the Resource Demand Request.

## Exporting Resource Demand Request (RDR) Search Results

Resource demand request queue search results can be exported as PDF, CSV, or HTML files.



### Export Resource Demand Request Search Results


1. Go to the resource request queue search results which you would like to export.
2. In the search results, click the settings icon. A dialog appears.
3. Click Download search results in the dialog.
4. Click the Click here link next to the file format you would like to export your results as. A dialog appears asking if you would like to open or save the file. You can choose the program to open the file, or download the file to a location of your choice.

## Deleting a Resource Request or Resource Request Queue

You can delete resource request queues and resources requests with no resource request queues.

### Delete a Resource Request or Resource Request Queue

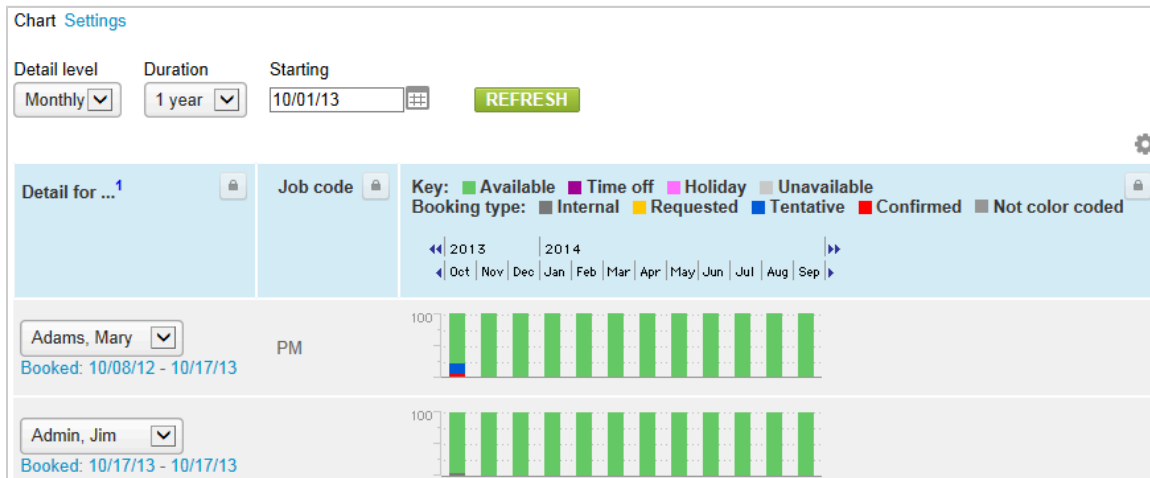
1. Go to Resources > Resource requests or Resources > Resource request queues to open the list for Resource Requests or Resource Request Queues.
2. Ensure that you have the **Run an action** column displayed on the list. If it isn't displayed, click the settings icon , click **Customize list**, click **Run an action** from the Available column in the List layout picker, and click **Add selected >**. Then click **OK**.
3. Check the Run an action box next to the resource request or resource request queue which you would like to delete.
4. Click the Run an action icon  at the top of the Run an action column.
5. Select **Delete the selected resource requests** or **Delete the selected resource request queues** and click **OK**.

 **Note:** You cannot delete a resource request that has any resource request queues within it.

## Booking Chart

The Booking chart lets you see booking data in a visual chart. You should use the booking chart to get an overview of bookings for one or more employees. This view can be customized to show booking data according to different attributes. To update a booking from the chart view, click on a day/bar on the chart and the booking is opened up in the List.

**Note:** Information about bookings displayed in this view can be added as hover over information. Contact SuiteProjects Pro Support for assistance.



## Booking Types

Booking Types provides you with the ability to group bookings or booking requests into distinct classifications. For example, a Hard booking type may indicate that the contract has been signed and a resource is needed for a specific time frame. While a Soft booking type can indicate that the contract has not been signed and the need is tentative. You can create booking types based on your company's needs and terminology. You should use booking types that align with a pipeline maturity or project lifecycle since updates are consistent with the state of the project or opportunity. For example, a proposed project with Soft bookings is signed and all bookings should be converted to Hard bookings. This requires a manual update. If you do not have the resources to maintain this data, then you may want to avoid using booking types.

### To create a Booking Type:

1. Go to Administration > Application Settings > Resources > Booking types.
2. Select **New Booking type** from the **Create Button**.
3. Enter the Booking type name and priority, if needed. Priority may be displayed on booking reports to identify a level of priority.
4. **Restrict booking editing by role** — To restrict the ability to edit or create bookings of this booking type, select the roles from the Available column and click **Add selected**. Users with the Selected roles will not be able to edit or create bookings of this booking type. Bookings of this booking type will not show in the Advanced Booking Worksheet for these users.
5. Add Notes to describe the use of booking types in your company's SuiteProjects Pro account. Booking types can be inactivated or reactivated at any time.
6. Click Save.

## Generics

Generic records are virtual or placeholder employee resources that represent a staffing need. Many times, generic resources align with job codes defined in the company since job codes tend to align with skills.

After you have defined generic records, you can use them in bookings or booking requests within the Resources application. A generic record can also be used for booked utilization forecasting or as assigned resources on projects and tasks for assigned utilization. If booking requests have been enabled in your environment, there is a switch that can be enabled to require a requestor to ask for a generic resource instead of a specifically named resource. See [Resources Other Settings](#).

If a project is being planned or has started, the project manager may need to assign a resource to project tasks to develop a full resource plan. Generics may be used if the project manager or requestor knows the type of resource but not the specific individual. Generic resources cannot record time or expenses and can only be used in a forecast capacity.

### To create a Generic resource:

1. Go to Administration > Application Settings > Resources > Generics.
2. Select **New Generic** from the **Create Button**.
3. Enter a name for the generic.
4. The drop-down list selection for **Week starts on** defaults to the day designated in [Resources Other Settings](#).
5. In the **Booking are approved by** drop-down list, choose the specific person or approval process (suggested) who can approve booking request assigned to generics. Generics can be inactivated or reactivated at any time.
6. Enter other employee-related information as needed.
7. Click Save.

After you save the Generic form definition, additional links display in a way that is similar to the employee definition process on the Employee Demographic form.

- A schedule link displays to allow association of the generic to a defined work schedule.
- Exceptions to the generics schedule may also be entered, although this is not used often for generics.
- The job code that aligns with the generic may also be defined. Since job codes may change in your company, SuiteProjects Pro provides a historical tracking feature if the generic should change to be associated with another job code. You can set the previous job code setting to a defined date range and set the new job code as the current value.
- The cost of the Generic may be defined. If the generic aligns with your job codes, the cost would be best set to the average cost of your employees with the same job code.
- If employee entity tags are activated and defined in your account for the employee record, the same tags are available for definition on the Generic record.

Generics are not real employees, and do not have sign-in credentials. As such, they cannot enter time or expenses and do not allow for Target Utilization, Filter Set, Proxy, or other typical employee configurations.

## Resource Profile

The Resource Profile Options form provides the foundation for relating all Resource Profile elements together to define a complete skill database. Each row controls a dimension of the resource profile.

### To access the Resource Profile Options form:

1. Go to Administration > Application Settings > Resources > Resource profiles.



- For each dimension or row, check the **Active** box to include the item as a dimension of the resource profile. When active, it displays in the Resources Settings list. You see the standard profile type names listed here such as Skill, Education, Location, Job role, and Industry. You may override the standard terminology or define a custom term for any of the other 35 custom profile elements.

**Note:** To create new profile types, go to Administration > Resources Settings and click on the profile type link. See [Tech Skills](#), [Education](#), [Locations](#), [Job Roles](#), and [Industries](#).

- Profile types become plural on forms by default unless you check the **Do not to pluralize** box.
- SuiteProjects Pro also converts two word combinations into a capitalized first word and lowercase second word unless you check the **Preserve case** box. The Terminology override displays exactly as you entered it in the Terminology text box.
- Optionally, you may associate Attribute Sets with individual Resource Profile elements by selecting the desired attribute set. Attribute sets only display if they are defined prior to accessing this form. See [Attribute Sets](#).
- If Resource Profile dimensions are related, identify the related profile element by selecting it from the Related Profile drop-down list. Related resource elements are only useful in reporting. Each resource profile element by default permits multiple selections by the employees in the category.
- You may choose to limit a resource profile element to only allow one entry. This is dependent on the definition of the resource profile element. An example would be identifying a highest education level entry by only allowing the employee to select one value. To all duplicates per resource, check the **Limit to one per resource** box.
- By default, SuiteProjects Pro lets employees select unique values from the available values of a resource profile. You may opt to allow employees to select duplicate values that are differentiated by an attribute set. If you do this, you must check the **Allow duplicates per resource** box.
- The last 2 boxes on the form ensure consistency of data and awareness:
  - Show only in use attributes** — ensures only active attribute set values display when information is entered in the Resource application.
  - Notify employees when new types created** — ensures employees are notified of a new Resource Profile value. This could be helpful if you open a new office location or create a new Skill profile.
- Click Save.

## Consolidated Resource Profiles

Use consolidated resource profiles to see what skills and experience your resources have at a glance. You can use it to update your resources' skills, which in turn helps you to assign the right resource to the right task and keeping them engaged, motivated, and increasing revenue.

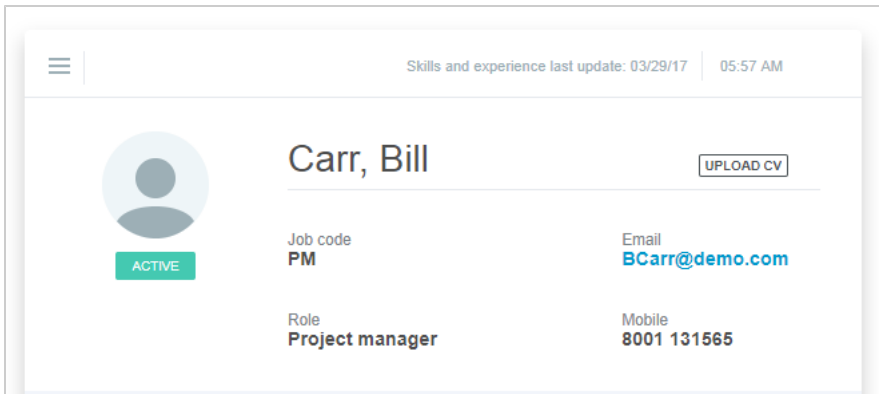
The consolidated resource profile contains a header, which you can customize with information such as the resource's email address, manager, location, or any user custom field arranged in four columns. There is no limit to the number of fields which can be shown in the header.

A table below the header lists the resource's skills and experience. Click each skill to see descriptions of each skill level.

To open a Consolidated Resource Profile, go to Resources > Resources > [choose a resource] > Profile.

**Note:** To enable this feature, contact SuiteProjects Pro Support and request the Consolidated Resource Profiles feature. Resources with the "View my own profile" role permission can see their information but cannot edit their demographics or custom fields. Resources with the "View and modify my own profile" role permission can also update their skills and experiences, but not the demographics. Users with either role will see a "My profile" link in the User Menu which opens the Consolidated Resource Profile.

**Warning:** Users will not be able to see information hidden by a switch or role permission, (for example, "Cost" or "Rate"). These fields will instead display an empty field. Custom fields and their data are always visible. Do not add custom fields to the Resource Profile which should remain hidden from some users.

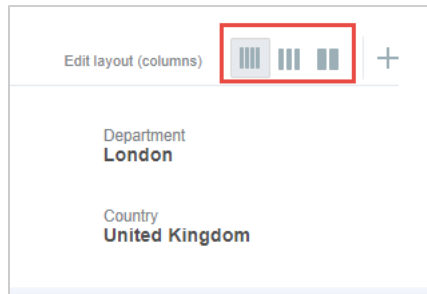

Account administrators and users with the "Edit Consolidated Resource Profile layout and settings" role permission can change the layout of the consolidated resource profile for your company's account. Select any resource's profile, edit and save the layout, and it is modified across the whole account.

**To edit which fields appear in the header:**

1. Click the menu icon and click **Edit layout**.
2. Click the Number of Columns icon for how many columns (2, 3, or 4) you would like to use.




3. Click the Add new item **+** icon. The Add new item menu opens.
4. Click on fields in the “All” list which you want to appear in the header. You can also click “Select All” to add all available fields to the header.
5. Click the X icon next to selected fields to remove them from the header individually. You can also click “Clear All” to remove all fields from the header.
6. Drag fields in the “Selected” list to arrange them in the order you would like.
7. Click **OK**.
8. Click **Save** to save the changes without leaving the Consolidated Resource Profile’s edit mode. This is useful if you want to make changes to other parts of the Consolidated Resource Profile.

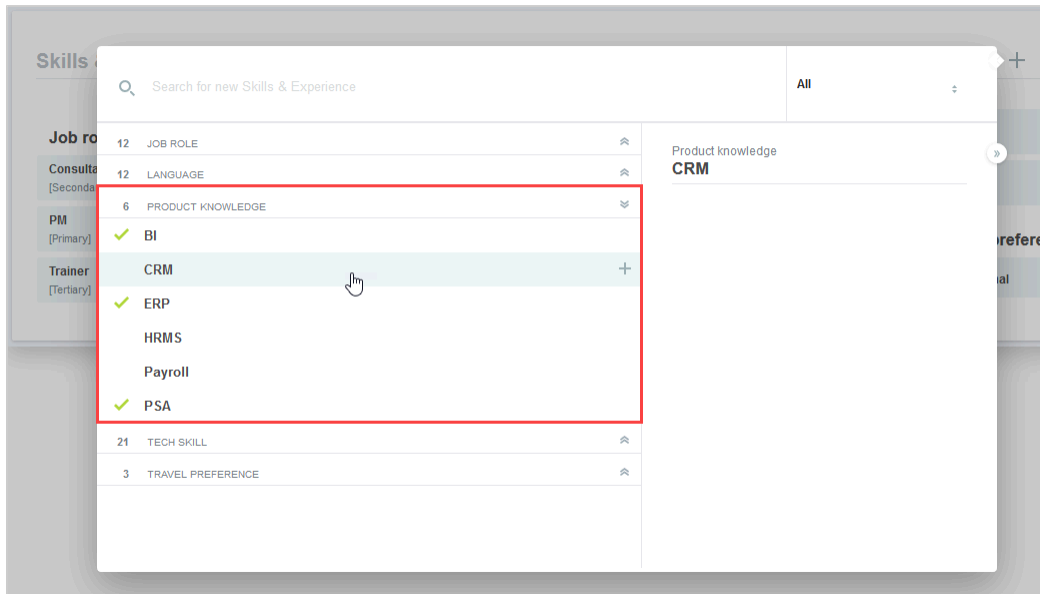
Click the  icon next to Save and click **Save & exit edit mode** to save your changes and exit the Consolidated Resource Profile’s edit mode.

Click **Discard** to exit edit mode without saving any changes.

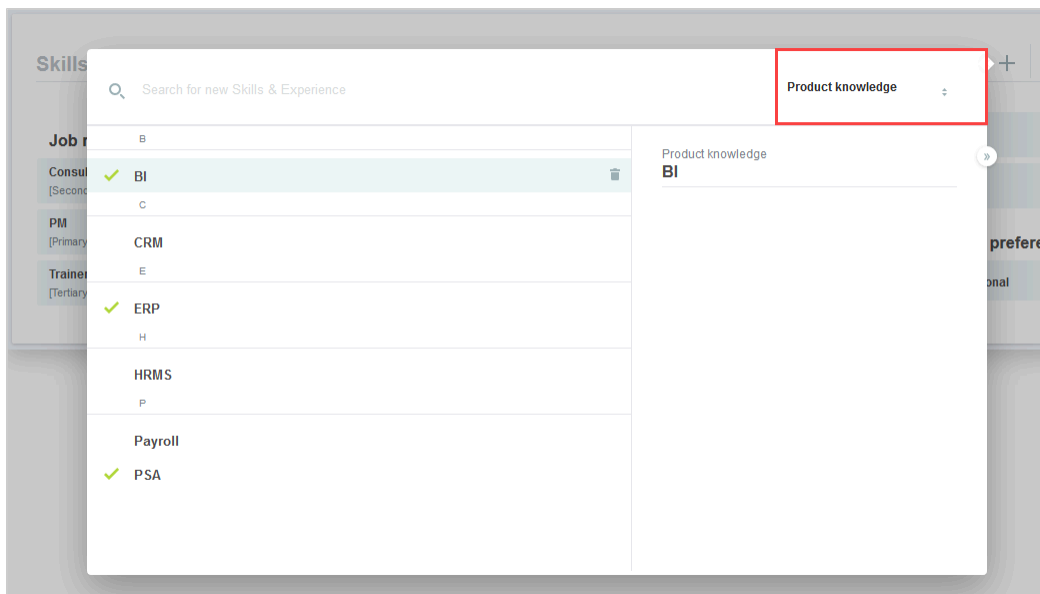
### To add skills in the Consolidated Resource Profile:



1. Click the “Edit skills”  icon.
2. Click the “Add Skills” **+** icon.
3. Click the Skill and Skill Level you would like to add from the list on the left side of the form. The skill will be added to the Consolidated Resource Profile when you click it. You can also search for a skill’s name using the “Search for new skills...” field at the top of the form.

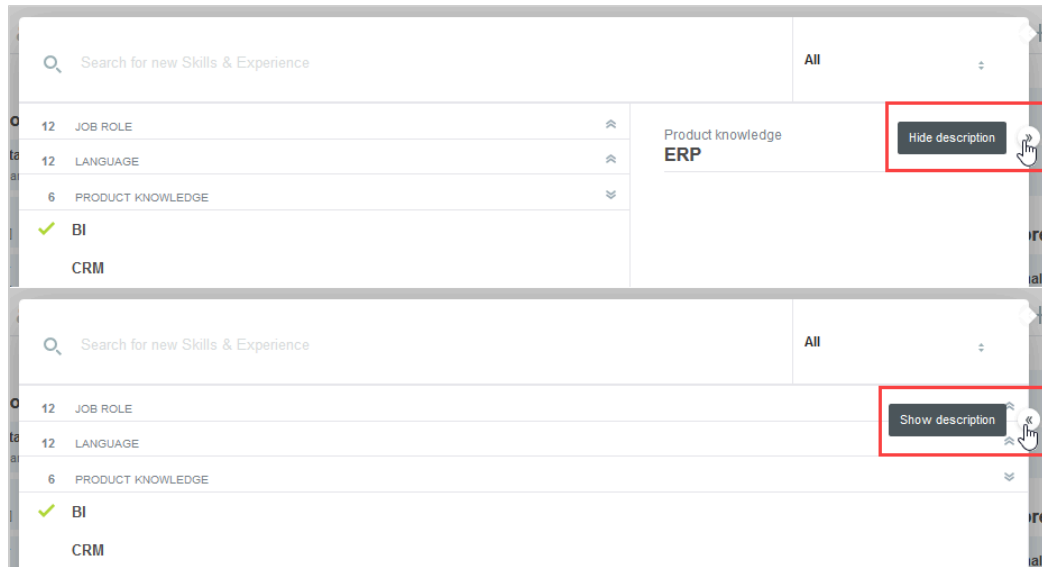
Skill levels roll up under categories which you can expand or collapse to see only the skills you want. Each category shows how many skills or skill levels are available for it.



The skills picker also contains a category filter. Use it to select a specific skill category, and the picker only displays skills which are available for that category. You can use the text search field to quickly find desired skills within this filtered list.



Use the icons on the right hand side of the skills picker to hide  or show  the skills description.





**Note:** You can use the keyboard arrow keys and search form to move through the new skills form without using a mouse.

4. Click anywhere outside of the form to close it and return to the Consolidated Resource Profile. The skill or skills which you added will be highlighted in blue.
5. Click **Save** or **Save & Submit** to save the new skills.

**Note:** If your company has the Skills Approval feature enabled, you can still save skills, however, they will not be permanently saved to your profile until approved by your designated approver.


### To edit skills in the Consolidated Resource Profile:


1. Click the “Edit Skills”  icon.
2. Click the  icon next to the skill you want to edit.
3. Click **Edit**.
4. Click the skill level in the Choose Skill Level header to change the skill level.
5. Enter a note for the skill and level (optional). Notes for skills appear when pointing to the skill in a resource’s Consolidated Resource Profile.
6. Click **OK**.

Newly added skills are highlighted in blue. No changes are saved until you click **Save**.

**Note:** If Skills Approvals are enabled, when you edit a skill, it will be marked as “Pending approval”. The resource profile approver can then approve the changes.

### To delete skills in the Consolidated Resource Profile:

1. Click the “Edit Skills”  icon.
2. Click the  icon next to the skill you want to edit.

3. Click **Delete** to remove the skill from the Skills & Experience table. If you delete a skill by mistake, click the  icon and click **Revert / Undo**.

**Note:** If Skills Approvals are enabled, when you delete a skill, it will be marked as "Pending approval". The resource profile approver can then approve the deletion.

Deleted skills are highlighted in red. No changes are saved until you click **Save**.

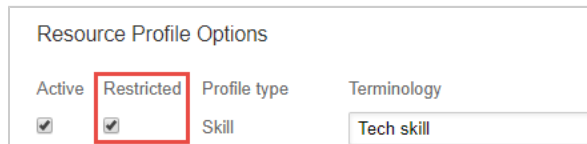
It is also possible to restrict skills which users can see based on their role permissions. To enable this feature, contact SuiteProjects Pro Support and request the **Restricted Skills in Consolidated Resource Profile** feature.

When a skill is restricted, only Administrators or users with one of two role permissions can see or edit it. Non-administrators who do not have one of these role permissions will also not see the restricted skills in dropdown lists or selectors. The role permissions are:

- **View restricted profiles** – User can see restricted skills in Consolidated Resource Profile, but cannot edit them
- **View and modify restricted profiles** - User can see and edit restricted skills in Consolidated Resource Profile

### To restrict skills by role permission in the Consolidated Resource Profile

1. Go to Administration > Application Settings > Resources > Resource Profiles.
2. Select the **Restricted** checkbox next to the skill you want to restrict.





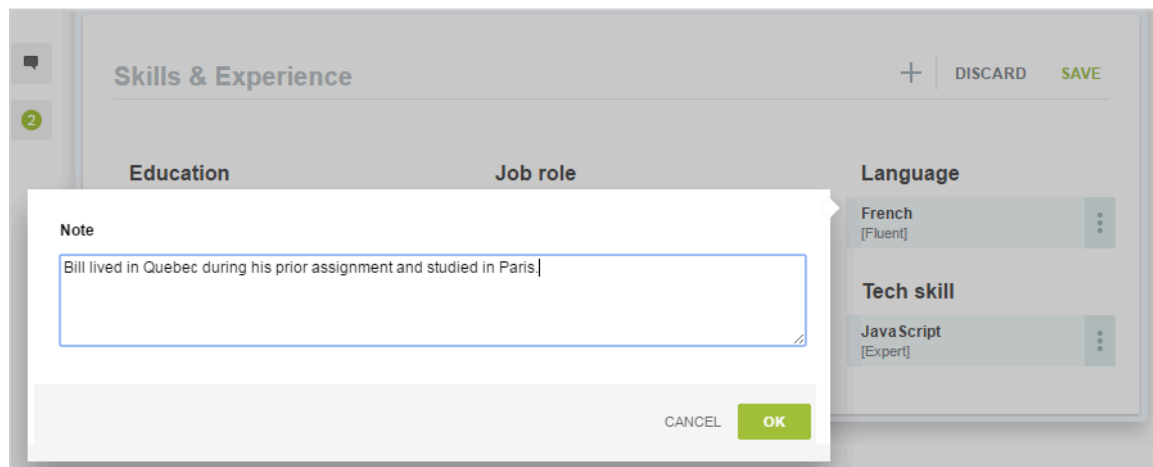

### To show Resource Profile comments in Resource Profile advanced reports:

1. Go to Reports > Advanced > Resources > Resource profiles.
2. In the "Filters and layout options" section of the Resource profiles form, click > **Edit** next to "Report layout".
3. Select the "Comment" field in the "Available" list and click **Add selected** >.
4. Click **OK**.
5. Click **Run the report** to create the populated report now or **Save** to save the report settings and run it later.

When the report is run, the "Comments" column will be added to the report and populated with comments entered in the consolidated resource profile.

## Customized User Avatars

Give your resource profiles personality with custom user avatars or profile pictures.

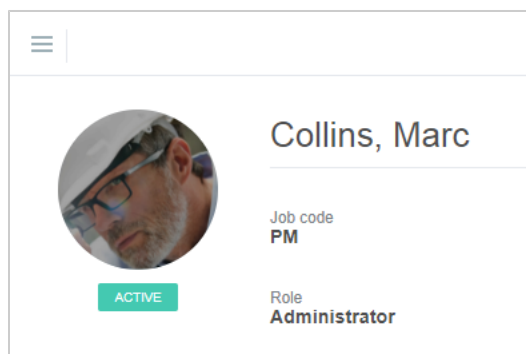
When this feature is enabled, you can upload avatars for users or give them the permission to replace the generic resource profile picture in their Resource Profile.

**Note:** To enable this feature, contact SuiteProjects Pro Support and request the Customized user avatars feature. The Consolidated resource profiles feature must also be enabled to show custom profile picture on the user interface. See the help topic [Consolidated Resource Profiles](#).

**Important:** If this feature is disabled, all uploaded avatar images are deleted.

The avatars appear in:

- Resource profiles.



- The top bar.

**Note:** If you proxy in as (sign in and perform tasks on behalf of) another user, the top bar shows the initials of that user on a red color background, even if the user has a profile picture.

- Resource compare view



The following image formats are supported: BMP, GIF, PNG, and JPG. The image file size cannot be larger than 1 MB. Uploaded avatar images do not count against your account storage.


Two role permissions can be assigned to users:

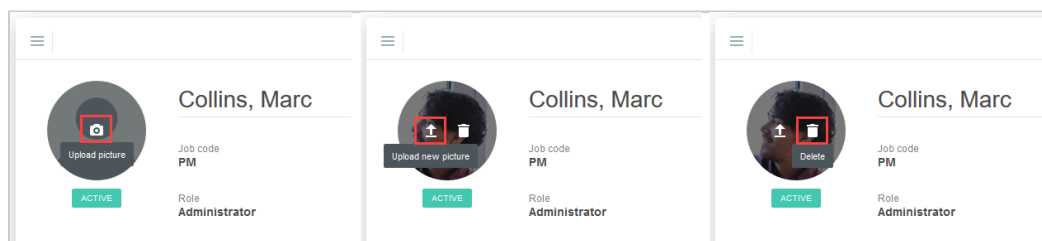
- **Modify own profile picture** allows users to modify their own profile picture.
- **Modify all profile pictures** allows a user to modify all pictures for all users they have access to.

**Note:** You need to have the **Modify own profile picture** role permission to upload or change your own profile picture. You need to have the **Modify all profile pictures** to upload or modify profile picture for any resource you have access to.

### To change a profile picture:

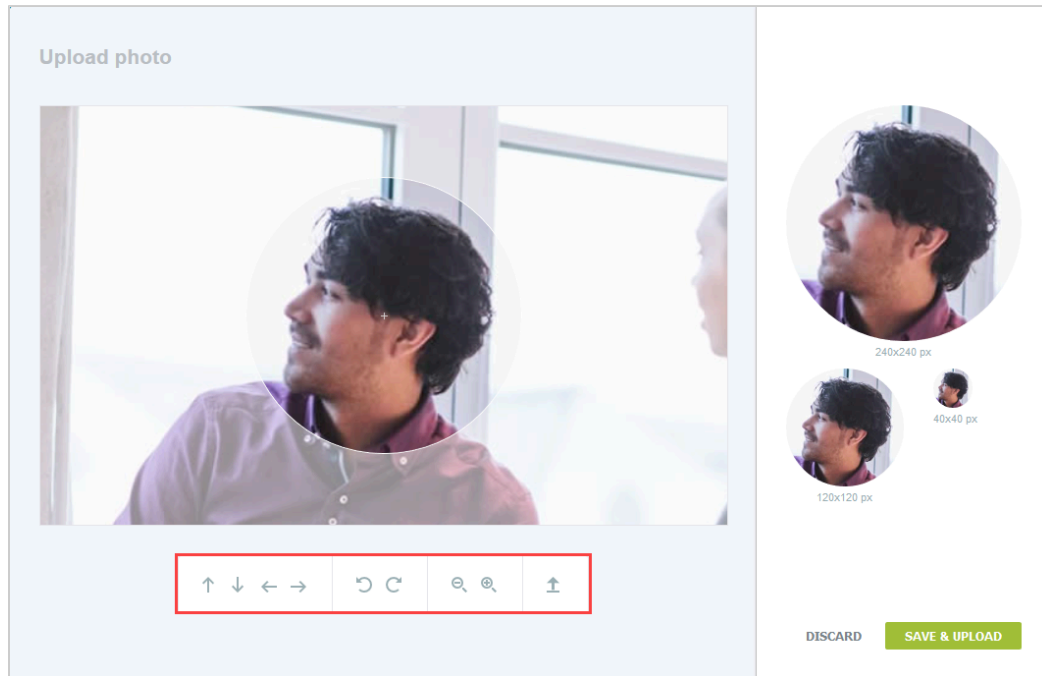
1. Go to Resources > Resources > [Select a resource] > Profile to open the consolidated resource profile for the resource whose profile picture you want to add or change. Go to User menu > My profile if you want to add or change your own profile picture.
2. Hover the mouse cursor over the profile picture and click the camera icon  to add a profile picture, or the upload icon  to replace the existing profile picture. A file selection dialog appears.

**Note:** You may also use the delete icon  to delete the profile picture.



3. Select an image file and click **Open**. The image file cannot be larger than 1MB and must be one of the supported formats (BMP, GIF, JPG, or PNG). The Upload photo window displays with your selected image file.
4. Select the part of the image you want to use for the profile picture. A preview of the profile picture displays in the right pane. Use the mouse to position the image or click the icons under the picture to position the picture, rotate it, zoom in/out or select a new image file.



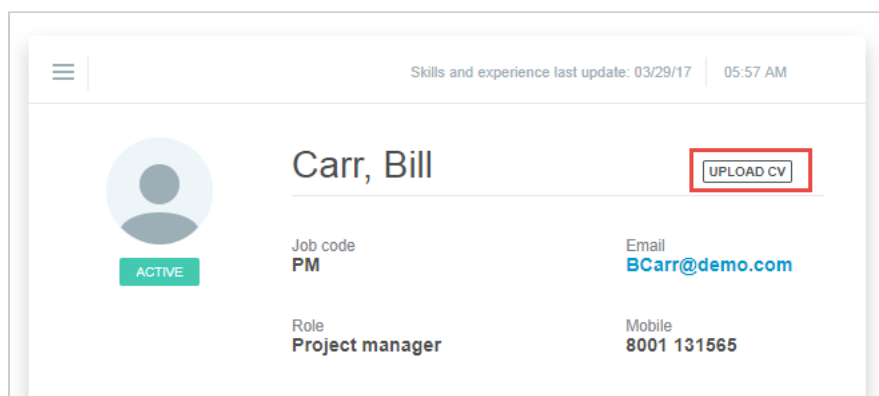


5. Click **Save & Upload**. The Consolidated Resource Profile displays with the new profile picture.

## Résumé and Curriculum Vitae (CV) Management in Consolidated Resource Profile

### To upload a resource's first résumé or CV to their profile using the Upload CV button:

1. Go to Resources > Resources > [Select a resource's Employee ID].
2. Click **Upload CV**.
3. Select the file to upload.



After a résumé or CV has been uploaded for a resource, the **Upload CV** button will become the **Download CV** button. To upload a new résumé or CV for a resource who already has one stored, use the **Upload CV** button in the Resource Profile Menu.

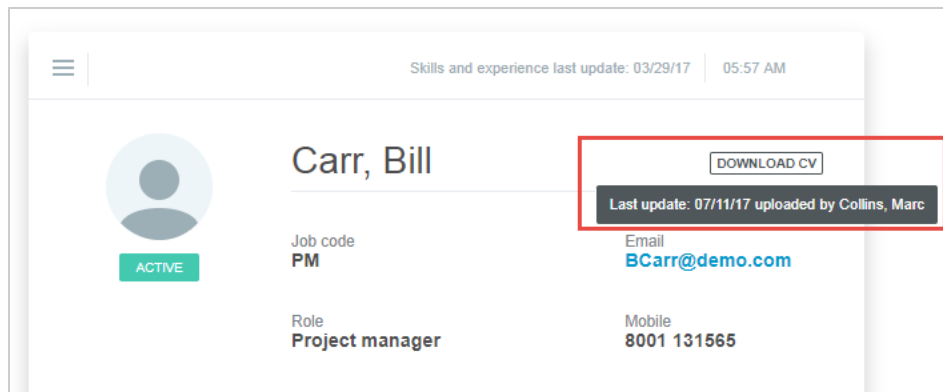
## To upload a résumé or CV to a resource's profile using the Resource Profile Menu:


1. Go to Resources > Resources > [Select a resource's Employee ID].
2. Click the **Resource Profile Menu** button and select **Upload CV**.
3. Select the file to upload.


**Note:** Uploading a new résumé or CV does not overwrite old résumés or CVs. All stored versions are available in the **Manage CVs** button in the Resource Profile Menu.

## To download a résumé or CV from a resource's profile using the Download CV button:

1. Go to Resources > Resources > [Select a resource's Employee ID].
2. Click **Download CV** to download the last résumé or CV which was uploaded for this resource.

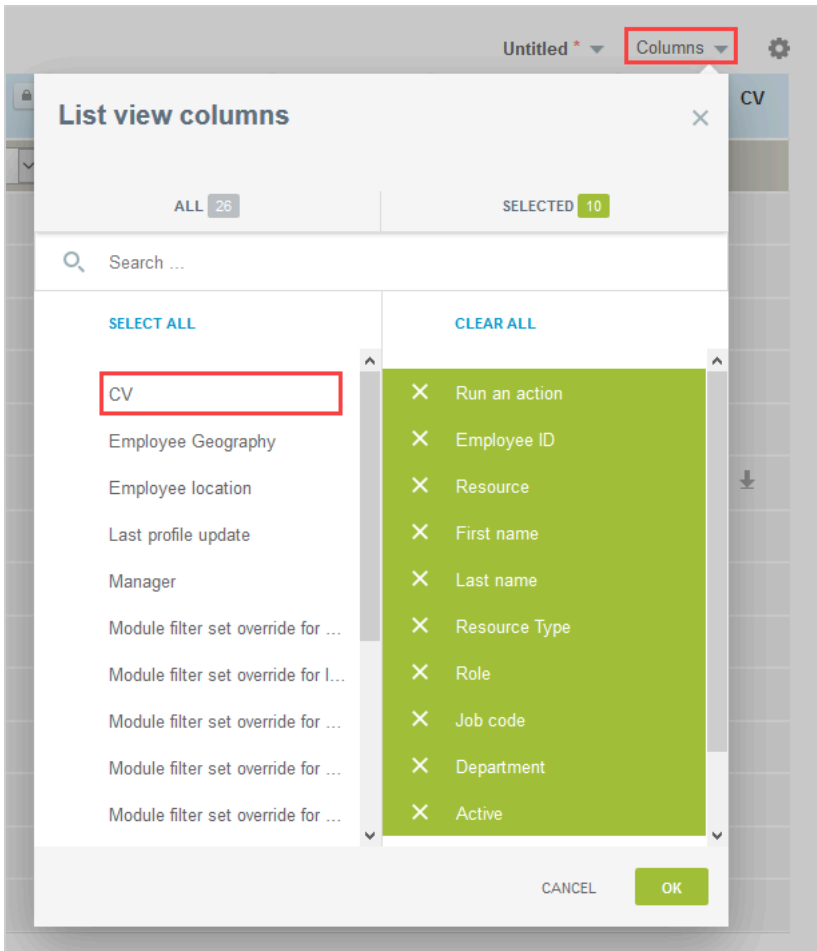

## Skills Approval

With this feature, you can delegate the responsibility of keeping your resources' profiles up-to-date. SuiteProjects Pro notifies you when your resources update their skills in the Resource Profile. With your approval, the skills are updated.

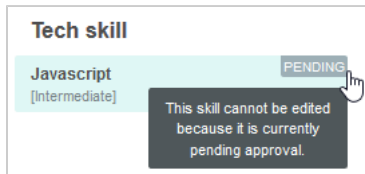


**Note:** To enable this feature, contact SuiteProjects Pro Support and request the Skills Approval feature.

Resources with either of the following role permissions can edit their own skills and experience in their profile:

- View and modify own resource profile
- View and modify profiles

When a resource makes a change to their resource profile and clicks Save & Submit, the change is marked with a "Pending" tag in their profile. Resources can make changes to skills that have been approved or rejected but not to those that have been changed and are still awaiting approval. When resources point to a skill that is pending approval, a tooltip is displayed to indicate that the skill cannot be edited.



You will also receive a notification that your resource has made a change to their resource profile. You can set these notifications in Administration > Application Settings > Resources > Notifications. Email notifications will be sent as with other types of approvals when changes are submitted. Reminders will also appear on the Dashboard.

### To approve or reject a resource's changes to their resource profile:

1. Go to Resources > Profile approval > [Select "All" or "Submitted"].
2. Click a change to approve. The "View profile approval lines" page appears.
3. Select the changes you want to approve in the "Run an Action" column.
4. To approve selected changes, click the "Run an Action" dropdown list and select the "Approve selected and reject all others" option. To reject selected changes, click the "Run an Action" dropdown list and select the "Reject selected" option.

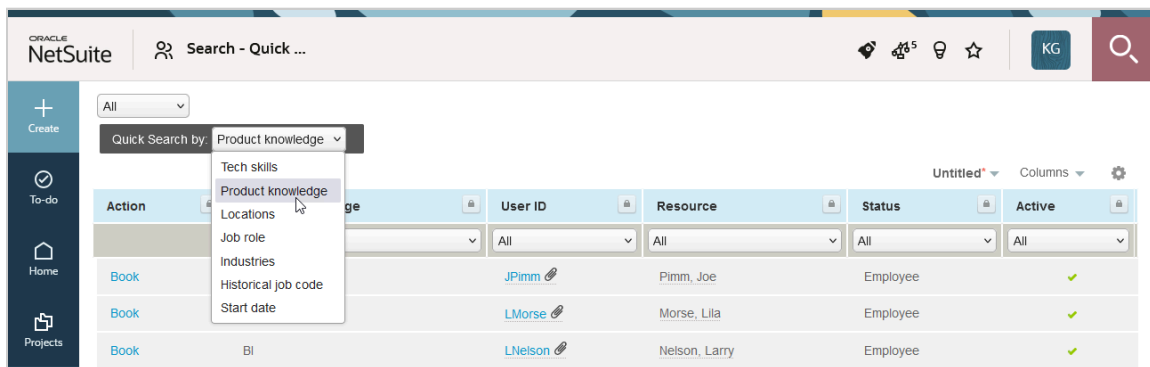
**Note:** Be sure to select all changes which you want to approve before clicking the "Approve selected and reject all others" option.

## Search - Resources Application

There are two types of searches you can perform in the Resources application. They are either a Quick Search or a Custom search. Each is described as follows.

### Quick Search

When you select the Quick link from the Search drop-down list, a text box displays with the list of Resource Profiles you specified in your account: [Tech Skills](#), [Education](#), [Locations](#), [Job Roles](#), and [Industries](#).



### To perform a Quick Search:

1. Go to Resources > Search and select Quick.

2. Select a search item from the drop-down list. The page refreshes and displays search results.

## Custom Search

When you select the Custom link from the Search drop-down list, a Search Criteria form displays and you can identify many different Resource Profile factors to search as well as tag groups and attributes. Remember, you must define profiles and attribute sets and tag groups must be established or they do not display as searchable items.

You can also search on availability that can include a specific time period as well as percentage of time or the number hours a resource is available. Search on experience, resource type, and detail fields. If you save your search and give it a name, it is stored under the Saved Searches link.

### To create a Custom search:

1. Go to Resources > Search and select Custom.
2. Click the Create links under Profile Filters to create filters for each profile. When you define entity tags and attributes for employees, an asterisk displays next to an item.
3. Select a Employee entity tag effective date.
4. Select Availability criteria including start and end dates and availability designations.
5. Check the **Filter resources using the following** box and use the drop-down list to identify a specific filter.
6. Check the **Filter customer experience based on** box and use the drop-down list to identify a specific filter. You can also add a filter for customer experience.
7. Select the type of resources to include in the search such as regular resources, generics, or inactive resources.
8. Create detail fields as needed.
9. To save the search for future use, check the **Save this search as ...** box and type a name for the search.
10. Type descriptive notes to help you remember the criteria you have specified in the search.
11. Click Search. Search results display the employees who match the Resource/Profile you searched on.

## Booking Request Layout

If you have enabled the switch for Enable booking requests, the Booking request layout link displays under Resources Settings. See [Resources Other Settings](#).

Use the Booking request layout form to set up a form that meets your company's needs and helps employees request resources they need.

### To access and modify the Booking request layout:

1. Go to Administration > Application Settings > Resources > Booking request layout.
2. Select the prefix and starting resource request number. "BR-" is the default prefix and starting number defaults to 1.
3. Select the **Grid style** format of the report and **Date format** from the drop-down lists.
4. As required, add additional notes in the header or footer.
5. Choose the particular fields that you would like to display on the booking request.

6. Choose the Adobe Acrobat PDF settings you would like to use in your environment.
7. Click Save.

## Alerts

You can configure a Daily utilization alert for Resources in your company's SuiteProjects Pro account. The alert runs every day and an email is sent when booked utilization threshold is exceeded.

Alerts allow automated email reminders to be sent to ensure business needs are met. In the Resources application, a form is provided to help you create a Daily utilization alert.

### To create a Daily utilization alert:

1. Go to Administration > Application Settings > Resources > Alerts.
2. Select **New Daily utilization alert** from the **Create Button**.
3. Type an Alert name.
4. Under **Alert runs on**, select the day and time when the Alert should run.
5. Under **Rule**, type the Daily utilization threshold percent. Exceeding this threshold generates the alert notification.
6. Use the Email notification section to define who receives the email, the email sender, subject, and email text.



**Note:** Depending on your account configuration, sending system-generated email from a custom address may not be permitted. When this is the case, a note under the text box advises you so, and email is sent from [www@openair.com](mailto:www@openair.com). See also [Email Settings](#).

7. Check the **Add information about employees exceeding the utilization threshold** box . This provides specific employee information.
8. Type notes, as desired. These notes do not appear anywhere in the alert; they are for informational purposes, such as remembering why the alert was created.
9. Check the **Active alert** box to make this alert active.
10. Click Save.

## Resources Other Settings

The Resources application lets you request, book and track resources (active employees) against one or several projects. There are several settings within the application that control the rights and permissions available to specific Roles. These options are indicated below.

In addition, the Resources application lets you enter particular skills, education, and industries to an employee's profile to create a skills-experience database for your resources that you can search. See [Search - Resources Application](#).

### To access the Resources Other settings:

1. Go to Administration > Application Settings > Resources > Other settings.

**Notify booked resource when a booking is added, modified, or deleted:** When you activate this option, SuiteProjects Pro creates email notifications and sends them to any resource who has a booking entry created, modified, or deleted for the resource.

**Note:** Notifications are sent for each booking entry. When using the booking worksheet, entries into each column creates individual booking entries, which causes an email notification to be sent for each booking.

**Prepend 'SuiteProjects Pro' on the subject line of booking notifications emails:** The email subject for booking notifications defaults to New Booking Created. Selecting this option appends 'SuiteProjects Pro' at the beginning of the subject line to make it clear to the employee that the email is coming from SuiteProjects Pro. You can customize the booking notification subject and email body per your company's needs.

**Notify manager of booked resource when a booking is added, modified, or deleted:** If you activate this option, SuiteProjects Pro creates email notifications to a resource's manager for each booking entry created, modified, and deleted.

**Note:** Notifications are sent for each booking entry. When using the booking worksheet, entries into each column creates individual booking entries, which causes an email notification to be sent for each booking. If an employee's Demographic form does not have a Manager identified, emails are not generated.

**Require booking type when booking resources:** If you have implemented booking types, this option lets you make this field required for all bookings created in your company's SuiteProjects Pro account. This requires you to define a complete set of booking types so that a valid value is always able to be selected for any type of booking entry. At least one booking type must be active for the option to be available. If there are no booking types active, then this feature does not have any impact.

**Always 'Book by' for bookings, booking requests, and deal booking requests:** By default, SuiteProjects Pro permits bookings to be entered by hours or by a percentage. Setting this option for strictly a percentage or strictly hours removes the ability to override the booking by the other option (for example, if set to Percentage, all bookings must be set in percentages and cannot be entered in hours).

**Default 'book by' value to use for new bookings when the default value is not otherwise implied:** This is a default setting for how an employee is booked to a project/task, by hours or by percentage. This can be overridden on the booking form or worksheet for each entry.

**Default 'book by' value to use for new booking requests when the default value is not otherwise implied:** If you have activated the use of booking requests within the resource application, this option sets a system default for how a booking request entry is created, by hours or by percentage. This can be overridden on the booking request form for each entry. If you do not have booking requests enabled, activation of this option does not have any impact.


**Enable customer experience in resource searches:** The Quick Search and Custom Search tabs within the Resource application by default do not include customer experience. Activating this option provides customer Experience as a search option allowing you to select specific customers in the search criteria. This allows to look up resources that have delivered work for specific customers.

**Note:** If you have set up a skill database and created a profile category to capture customer experience, this option should not be confused with skill database entries. Customer Experience is strictly based on Customer : Project association of the employee (that is, Timesheet entries).

**Allow searches for inactive resources:** Inactivating a resource removes the resource from various dropdowns and selection fields. Some forms allow the inclusion of inactive resources within a specific dropdown or selection list. By default, the search functionality within the Resources application does not include inactive resources. By activating this setting, an **Include inactive resources** box displays on the custom search field, which permits the inclusion of inactive resources in the search. If the Redesigned Advanced Filters feature is also enabled for your account, you can also search and select both active and inactive employees as values in your advanced filter conditions.



**Enable resource substitution searching on bookings:** Bookings created for employees may need to be changed due to resource conflicts or the replacement of a generic placeholder resource with an available employee. Activating this setting permits a substitution option to appear on booking lists and individual booking forms. How substitution candidates are identified is dependent on the criteria option listed below. The substitution feature saves data entry time should bookings require modification.

 **Note:** If you have email notifications activated for Bookings, the substitution of resources generates an email notification to both the original resource of the booking and the substituted resource of the booking. The only exception is when a generic resource is substituted as they do not have an email address.


**Criteria to use when searching for a resource to substitute for another a resource on a booking:** Searching the criteria for substitution candidates can be one of two types: by Profile or by Job code. The Job code is more of a one-to-one mapping that identifies resources with the same job code as the current resource in the booking. Profile uses the entries from the skills database to look for comparable matching resources. If your skill database is robust, the search may often times return few or no results. In these instances, the Job code substitution option would be best. The job code is derived from the **Job code** setting identified on the Employee Demographic form.

**Enable multiple booking resource substitutions in one action:** When enabled, resource managers have the ability to replace multiple resource bookings on the bookings list by selecting multiple resources and using the **Run an action** function.

**Show the related profile name on profile type drop-downs and pickers:** When configuring a skills database, several dimensions such as Skill, Industry, Location, and Education are defined. Each dimension may be associated with another dimension. When this is enabled, you may optionally choose to display the related profile dimension in the drop-down selection associated with another dimension. For example, you may want to relate a skill with a particular industry. In the drop-down list for the skill dimension, you see ABC Industrializes Skill.

#### Respect filter sets when generating availability reports


**Enable booking requests:** Bookings may be created/modified/deleted by employees with granted Role permissions. Depending on your business process, the resource who creates a booking may not know whether a specific resource is needed or what type of resource is required. Enabling Booking requests enables the booking request feature to be available to employees with the appropriate role permissions to submit booking requests (optionally through an approval process) for a particular employee or a generic resource for a particular duration and effort. Approved booking requests automatically create booking entries, either to the specified employee or to the generic resource.

 **Important:** To enable this setting the following internal switches must be disabled: **Enable approvals for bookings** and **Enable project booking automation**. Contact SuiteProjects Pro Support or SuiteProjects Pro Professional Services to discuss these options.

**Booking requests can only be created for generics:** By default when the Booking request feature is activated, any specific or generic resource may be entered on the request. Activating the Generic only feature supports a business process of having only a generic resource available to be chosen on the booking request. The resource reviewer/approver provides the named resource to be booked to the project. This would also require the option to **Edit a submitted booking request** to be enabled. When the generic resource request has been approved, another business process to book a named resource to the project is required. This would replace the generic booking with a named employee.

**Booking request approvals are for the requested resource:** This option directs how the Booking request is routed for approval. If this selection is enabled, the booking request is sent to the requested resource's approver. If left unchecked, the booking request is forwarded to the approver of the person making the request. To avoid confusion with approval routings, it is suggested that an Approval process is created to direct booking requests to the proper individuals. For more information, see the [Approval Routing](#).

**Enable additional required category in resource request queue for absolute requirements:** Use the “Required” category in resource requests to include only resources with the skills selected. The “Required” category works as a filter, and when a resource search is performed, only resources with the skills selected in this category will appear in results.

 **Note:** Available when the Resource Demand Request feature is enabled for your account.

**The booking type field on booking requests cannot be modified:** When a Booking request is initially created, the booking type field can be entered if you have configured Booking types and have at least one active entry. When the Booking request has been submitted, the booking type field cannot be modified if this option is activated.

**Copy the approved booking request notes to the automatically generated booking:** Notes may be entered on a Booking request. This information may be useful for reference in the Booking after the booking request has been approved. Activating this option permits the notes to be automatically copied to the booking. This is extremely useful to identify the appropriate named resource when generic resources are used on booking requests.

**Do not allow booking request submission if time is booked to an inactive option:** Employees entering booking requests against Customers : Project (or Customers, and possibly at the Task level) are provided a drop-down lists of these items. This option prevents the submission of a booking request if the employee is able to view a Customers : Project when the booking request is created but later the Customers : Project is inactivated before the booking request is completed and submitted. If this option is unchecked and the Customers : Project is inactivated during the booking request creation and submission process, the booking is allowed against an inactive project since the booking request was already in progress.

**Allow an approver to edit a submitted booking request:** When booking request approvals are used, booking requests are submitted for review by a defined employees who then approves or rejects the booking request. To avoid time delays introduced by having the reviewer reject a booking request and then the owner changing and resubmitting the request, activating this option gives the reviewer the ability to edit the booking request worksheet entries directly before continuing with an approval. This feature is useful to allow a booking request approver to substitute resources, if necessary, such as when a generic resource is selected in the request and a replacement of an available resource is required. This action is independent of any employee application role settings.

**Weekly booking worksheets start on:** The first day of the week for the booking worksheet can be set to any specific day of the week or to the first day of the week defined in the user demographics by selecting “From Employee demographics” in the dropdown. Selecting a day of the week for this option identifies the definition of a week in SuiteProjects Pro. SuiteProjects Pro permits weekly reporting and worksheet displays of weekly time periods. Each of these are dependent on what the specific week start setting that has been selected. This is most obvious in the Reports application under the Advanced tab for Timesheet and Expense status reports. Selecting several weeks to display show the defined employee week start values, which may not align with your particular employee week start setting. If this is the case, it may appear as if multiple timesheets have been submitted for a particular week, when in actuality it is the misalignment of the week start setting.

**Add booking custom fields to dynamic booking worksheet:** The dynamic booking worksheets are available in the Resources application under Booking requests and Bookings. By default, these worksheets do not include custom fields that may have been created for display and entry on the individual booking forms. Activating this feature includes the custom fields on the worksheet as well as the booking forms for proper data entry.

**Allow an approver to edit a submitted booking:** This option is mutually exclusive with the booking requests feature.

**Do not allow booking submission if time is booked to an inactive option:** This option is mutually exclusive with the booking requests feature. This option prevents the submission of a booking if any of the following properties are set to a record that is not marked as active: Customer, Project, Resource and

Booking Type. If an employee attempts to submit a booking associated with an inactive customer, project, resource or booking type using the Booking form, the dynamic booking worksheet, the advance booking worksheet, or actions in the Bookings list, an error message will be displayed and the booking will not be submitted. For example:

- An employee creates a new booking, selects a Customer:Project from the dropdown options and saves but does not submit the booking. The customer or project associated with this booking is inactivated before the booking is submitted. The employee will not be able to submit the booking and will be prompted to verify the customer or project associated with the booking.
- An employee navigates to the Advanced Booking Worksheet and copies an existing row to create a new booking. If the booking is associated with an inactive project or resource, on Save and submit, an error message will appear listing the inactive records preventing bookings from being submitted and the corresponding cells will be highlighted in the Advanced booking worksheet.


**Require a task selection on bookings:** This option requires specifying a Task when booking a resource to a project. If this is not selected, the task field does not display on the booking form. If tasks do not exist on the project to which the booking is being created, the booking does not save.

**Resource planner booking bar format - text options in drop down :** This sets the format of the text displayed on the booking bars in the resource booking planner.


**Disable daily option in resource planner :** This disables the daily utilization option in the resource booking planner, which calculates utilization for each day.

**Disable weekly option in resource planner :** This disables the weekly utilization option in the resource booking planner, which calculates utilization as the average of all bookings within a particular calendar week.


**Disable monthly option in resource planner :** This disables the monthly utilization option in the resource booking planner, which calculates utilization as the average of all bookings within a particular calendar month.

 **Note:** To enable the “Resource planner booking bar format” and “Disable daily/weekly/monthly option in resource planner” settings, the following internal switch must be enabled: **Enable resource planner**. Contact SuiteProjects Pro Support to request this feature.

**Preferred landing page for resources:** This sets the default landing page for all users opening resources, for example, Allocations Planner.

 **Note:** Administrators can also set a preferred landing page for individual users in the user demographic settings. Users can set their own preferred landing page from User Menu > Personal Settings > Resources Options.

**Hide inactive skills on resource profiles:** Check this box to hide inactive skills in consolidated resource profiles.

 **Note:** The option to hide inactive skills is available only if the consolidated resource profiles feature is enabled for your company's SuiteProjects Pro account.

## Frequently Asked Questions (FAQs)

### How to add start and end time to bookings?

By default, SuiteProjects Pro lets you add start and end dates for bookings but not start and end times. To show the start time and end time field on the booking entity form you need to enable work schedule time ranges and configure start times in the employee work schedule.

- To enable work schedule time ranges — Go to Administration > Global Settings > Account > Optional Features , check the **Enable work schedule time ranges** box and Save. See [Optional Features](#).
- Resources must have the relevant start times specified in their work schedule to be available for booking. For more information about configuring start times in work schedules, see [Work Schedules](#).

# Invoices

The Invoices application helps capture the time, expenses, and other charges accrued against a project. You can create charges in the Invoices application and include them in an invoice. You can also create charges when you run billing rules in the Projects application.

Primarily focused on invoicing your Customers, the Invoices application manages the results of running the billing rules which have been set up on projects. The charges created can then be placed on an invoice which is mailed or emailed to the customer. Manual charges may also be created at any time and thus the need to allow configuration items that may contribute to these charge items are available within the Invoice application (for example, Expense item, Flat rate, etc.).

The Invoices application includes:

**Charges** — Charges are in different states such as Open, Billed, Invoice Ready, Over Cap, and All. You create charges when you run billing for a project. Under charges, you can either edit charges or create them directly. Options include New hourly, New flat rate, New other rate, and New expense item, Mileage expense item, and New product. You can enter an individual charge to be included in a customer invoice or multiple instances of a charge on a scheduled frequency.

**Invoices** — All charges that are open and invoice ready display under the Invoices link. You can check all or clear all or select them individually. Click the button on the bottom right to Create the invoice.

**Retainers** — When a customer provides payment in advance, you create a retainer and apply some or all of the payment against an invoice. When you create a new invoice for this customer, the available retainer balance will display.

## Agreements

Agreements are contracts or SOWs that are used to track budget balances. Agreements may be associated with a project then assigned to the project billing rules for the tracking of balances. As such, agreements are created for a specific customer. An agreement may encompass multiple projects. An agreement can be used in conjunction with Customer POs, independent of Customer POs, or not at all. Agreements are standard reporting fields and can provide the remaining balance on the agreement and the charges to date. Agreements can be renamed to your company's terminology. See [Interface: Terminology](#).

### To create an Agreement:

1. Go to Administration > Application Settings > Invoices > Agreements.
2. Select **New Agreement** from the **Create Button**.
3. Enter the Agreement name and then select the Customer from the drop-down list.
4. Enter the customer's agreement Number specified on the document (if available) as well as the Date it was created.
5. In the Amount (money) field, enter the total value of the agreement and select the Currency if multi-currency has been enabled.
6. Input any Notes for this agreement, if appropriate.
7. Check the **Active agreement** box.
8. Click Save.

## Charge Stages

Charge stages separate time and expenses items into different phases or states within the Invoices application. There are two charge stages required in SuiteProjects Pro: Open and Billed. You may create

any number of charge stages in your environment based on your company's requirements. For example, you may create stages to indicate charges that are billable to the customer (for example, Billable or Chargeable) or not billable (for example, Administrative, Pending, or Overage.)

### To create a Charge stage:

1. Go to Administration > Application Settings > Invoices > Charge Stages.
2. Select **New Charge stage** from the **Create Button**.
3. Enter the Charge stage name.
4. Next, select the Options for this charge stage:
  - **Display charges in a separate tab** — checking this item displays the charge stage as a separate tab under the Invoices > Charges tab, which only displays the items under this stage
  - **Exclude charges from invoicing** — checking this item prevents charges under this stage from being selected in the invoicing process
  - **Exclude charges from project analysis** — choosing this item prevents charges in this stage from appearing under the Analysis link for projects.
5. Enter Position. Use the drop-down list to indicate the order in which the charge stage appears under the Charges tab.
6. Enter any Notes for further description of the charge stage, if desired.
7. Click Save.

## Customer POs

Customer POs are funding documents for projects or purchases. Customer POs may be associated with a project then assigned to the project billing rules for the tracking of balances. There may be one or more POs associated with a project. As such, customer POs are created for a specific customer. A customer PO may encompass multiple projects. A customer PO can be used in conjunction with Agreements, independent of agreements, or not at all. A customer PO can be set on a billing rule, so that charges are charged against a specific Customer PO. To set a Customer PO on the billing rule, you must first associate it with the project record on the project Properties form.

### To create a Customer PO:

1. Go to Administration > Application Settings > Invoices > Customer POs.
2. Select **New Customer PO** from the **Create Button**.
3. Enter the Name of the customer PO and then select the Customer from the drop-down list. Enter the customer's PO Number specified on the document (if available) as well as the Date it was created.
4. In the Amount (money) field, enter the total value of the customer PO and select the Currency if multi-currency has been enabled.
5. Input any Notes for this customer PO, if appropriate. Customer POs are a standard reporting field and can provide the remaining balance on the customer PO and the charges incurred to date.
6. Click Save.

Customer POs can be renamed to your company's terminology. See [Interface: Terminology](#).

## Expense Items

Expense Items are receipts, tickets, statements or other items that contain costs incurred by the employee and are entered as expense reports according to your company's policies and procedures.

The expense items are classifications or categories of these costs. Some examples are: Airfare, Lodging, Mileage, Business Meals, etc. Several common expense items are predefined in SuiteProjects Pro, but you can modify these and create new items per your company's needs.

Expenses incurred and related to customer projects are often billable to the customer. These expenses are available as charges in the Invoices application if expense receipts are processed by an expense billing rule on the project. Then they can be selected for inclusion on an invoice.

Expense charges are only created by the expense billing rule on the project if the Billable receipt box is checked on the individual receipts. However, you may override the billable receipt control on the Expense Billing rule directly by clearing the **Exclude non-billable receipts** box. This box is checked by default when you create a billing rule.

### To create a Expense item:

1. Go to Administration > Application Settings > Invoices > Expense items.
2. Select **New Expense item** from the **Create Button**.
3. Enter the Expense item name and select the Type of expense item (regular or mileage). A regular receipt is the default receipt form when a new expense report is created. A mileage receipt is a slightly modified receipt form allowing for mileage rates.

**Note:** Mileage expense items may also be set as a regular receipt type since the form provides the ability to enter a price per unit (in this case \$\$ per Mile, for example). If you are not using the Vehicle feature that requires the mileage receipt type, you may opt to set up all expense items to the regular receipt type and avoid end-employee confusion during expense entry.

4. Enter a Price for the item (this is generally left blank except for the cases of mileage or per diem), Currency if multi-currency is enabled and the default is not the desired value, a Unit measure (generally for mileage), and indicate whether this is a Per diem item.
5. The next section in the form relates to Receipt policy, which controls actions based on the individual receipt and expense item entered into an expense report. You are able to enter parameters for the receipt and select whether to require notes or approval based on the settings.
6. You can also set limits for allowing per diem expense item in expense reports.
7. Check the Taxable service box if tax may be charged to the customer for this expense item. The tax rate to be used is controlled through the Invoices application by using tax location values. If you would like the expense item price to be required on the receipt, check the box.

## Credit/Rebill

The invoicing functionality in SuiteProjects Pro enables companies to group multiple charges that should be billed and sent to a customer. Invoices can be sent through an approval process, sent to a customer and subsequently exported to an external accounting system. At times it is necessary to credit and potentially re-bill an invoice that has already been approved, sent to a customer, or has been exported. Currently, if an invoice and corresponding charges have been approved or exported, a credit would need to be applied manually creating negative offsetting charges. New charges would also need to be created manually if the invoice needed to be re-billed.




SuiteProjects Pro has streamlined the process of crediting an invoice and re-billing associated charges after a credit has been issued. A new Credit/Rebill link is available within an approved timesheet that enables users to either credit, or credit and rebill an invoice. If a user chooses to credit an invoice, a new invoice will be created that contains offsetting charges of the original invoice. If the user then chooses to re-bill, the charges from the original invoice will be available to be placed on a new invoice. Both credit and re-bill invoices will go through the same approval process as the original invoice. Additionally, the History link in the original invoice will indicate whether the invoice has been credited or re-billed, with the corresponding invoice numbers.

To enable the credit and re-bill functionality, contact SuiteProjects Pro Support.


### To Credit an Invoice:

1. Go to Invoices > Invoices > Approved > [select an approved invoice].
2. Click the "Credit/Rebill" link.
3. Enter any necessary notes and select the option for submission of the credit invoice to either "Yes" or "No."
4. After all options have been configured, click the "Credit" button. A new invoice will be created containing negative offsetting charges.

 **Note:** Credit invoice charges are designed to balance out the entire original invoice, and then new charges to be invoiced (or modified and then invoiced) are created by pressing **Rebill**.

### To Re-bill an Invoice:

1. Select the originally approved invoice that has already been credited.
2. From the "Credit/Rebill" link, click on the "Rebill" button. After the "Rebill" button has been selected, the charges on that invoice will appear in the "Open" charge stage.
3. Place these charges on a new invoice, if desired.

 **Important:** An invoice cannot be re-billed unless the invoice has been credited. After an invoice has been credited, a new re-bill option is now available.

After an invoice has been credited, users cannot edit the charge in the original invoice, and the **Charges** link won't be available. After the original invoice has been rebilled, users cannot delete the original invoice and the credit invoice in the UI. Users would need to set the field **credit\_rebill\_status** to C on the original invoice to be able to delete the credit invoice. This setting of the field can be done using the Integration Manager tool. After the credit invoice is deleted, users may now edit the original invoice.

### Edit or Delete an Invoice Where a Credit and Rebill Has Already Been Applied

1. Create a CSV file and add a column for **ID** and **credit\_rebill\_status**.
2. Indicate the **internal id** of the **original invoice** (not the credit invoice).
3. Indicate **C** under **credit\_rebill\_status** column.
4. Save it as **CSV**.
5. Open **Integration Manager**.
6. Map **ID** with **ID** and **credit\_rebill\_status** with **credit\_rebill\_status** for **CSV to Invoice**.
7. Run the **Integration Manager** tool.

After doing this, the original invoice's **credit\_rebill\_status** will become C (Credit Initiated) from R (Re-Bill). Moving it to a state that is not re-bill will allow users to delete the credit invoice. Users may do so by navigating to **[credit invoice] > Properties > click Delete**. After deleting the credit invoice, users may now edit the charges within the original invoice or delete the original invoice.

## Role Settings

There are two new role settings that allow specific roles to either Credit or Re-bill an invoice:

- Rebill invoices
- Credit invoices

## Charge Stages

A specific charge stage can be designated at the Administration > Application Settings > Invoices > Charge stages. Within the charge stage edit form, select the option "Set this as the primary stage for 'credits'". If designated, any charge created from the credit invoice will be displayed in this charge stage.

## Invoices List

In the Invoices list, a new subtab for "Credit/Rebill" is available. This subtab will hold any invoice that has been credited or re-billed. In addition, three columns can be added to the invoices list: "Credit/Rebill - Credit invoice number", "Credit/Rebill - Original invoice number", and "Credit/Rebill - Status".

## Reporting

Time entry related fields can now be reported on in a charge detail report. These fields can be leveraged to identify the original time entries hours from the resulting charge. To run a charges detail report, go to Reports > Detail > Invoices > Charges.

## Terminology

The terminology for "Rebill" can be changed. To modify the terminology, go to Administration > Global Settings > Display > Terminology.

## Invoice Layouts

The Invoice Layout sub-tab lets you create and maintain the various invoice formats you require to produce invoices capturing the information desired based on types of projects or customer preferences. You may have multiple invoice layouts and one of those layouts should be selected as your default layout.

The invoice layout is applied when the invoice is created based on the invoice layout setting on the project (Project Properties or Edit Project form). If a layout is not set, the default invoice layout is used. An invoice layout may be changed on a particular invoice by overriding the layout in the Edit Invoice form within the invoice. The layout form is structured into 7 basic parts: Invoice Columns, Invoice Groupings, Combine Charges, Other, Logo Settings, Footer Settings and Adobe Acrobat PDF Setting.

## Credit/Rebill Invoice Layout

A distinct invoice layout can be configured and designated as the default for credit invoices. To configure the layout, go to Administration > Application Settings > Invoices > Invoice layouts. Within the invoice layout edit form, check the option "Default credit invoice layout".

### To access, create and modify the Invoice layout:

1. Go to Administration > Application Settings > Invoices > Invoice layouts.
2. Select **New Invoice layout** from the **Create Button**.

The components of the Invoice Layout form follow.

## Invoice layout - Display, summary

In the top section of the form, you have the options to designate this layout as the default. Only one invoice layout can be considered the default. The display area enables the selection of specific information related to invoice charges and the order those fields are displayed in the invoice, one value per column.

If your account configuration enables separate layouts for expenses from other invoice charges such as time or flat rates, you are able to select the invoice layout that controls only the expense formatting of your invoice.

The Summary section enables a grouping of values to be performed when displaying the information. It is important to remember that the invoice layout and summary selected does not change any of the invoice charge values, the data is simply formatted according to your specifications. Selecting a group or groups of items enables a subtotaling display of information.

Expense items can be grouped together that are similar as can time entries. The way the information is grouped is based on the options by time period such as day or week, by rate such as combine only like rates, or by employee. You may select one or more of the combination options to produce the summarized group as expected.

Expense groups may also be created to group expenses together that are related in some way by your company. Select the create arrow to display the expense group form. You may define as many expense groups as required, however each group must have at least 2 expense items. Expense items not included in expense groups are not included on the invoice so it is advisable to set up an 'other' group to capture those expense items that are typically not passed to invoices but may occur in special circumstances.

## Invoice layout – Formatting override

A series of options exist to format the information displayed such as the location of project notes (if desired to be on the invoice) and invoice notes (if desired to be on the invoice). You may also select several other options such as the date format, number and hours formats, sorting order, additional text, etc.

If your account configuration allows terminology override on invoice layouts, you can override the names of all fields that could appear on the invoice including items such as Tax, Total, Hours, etc. If you choose not to enter any values, the default system value is used. If you choose to enter a value, then invoices using the layout will have the fields renamed. This option is helpful if you need to have invoices in another language or to show information using custom terminology instead of standard field labels. Example: redefine GST to Mwst Tax for country specific invoices. To activate the terminology override on invoice layouts option, [Creating a Support Case](#).

Two major sorting options are available to control the order in which charges are displayed, Primary charge sort order and Secondary charge sort order. Select the options that sort your invoices properly for each format.



**Important:** Not all sorting values are available for display on the invoice. This may lead to confusion regarding the sorting of data on the final invoice, so use the sorting options carefully.

## Invoice layout — Set the sender address (From)

By default, SuiteProjects Pro uses the email address of the employee sending the invoice in the From address of the invoice email. For example, if an employee goes to Invoices > [select an invoice] > Send tab and clicks **Send**, the invoice email will show as being sent from this employee's email address.

To override the sender email address for your invoice email, set **"From" email address for invoices** to any email address on the invoice layout. All invoice email with this layout will be sent using the sender address set for the layout.

You can use this together with **Do not set the From: address to the current employee's email address** option in Administration > Global Settings > Display > Email Settings to use only the sender email address set on the invoice layout for all invoice email. See [Email Settings](#).

## Invoice layout — margins, remit to

A remit to field lets you override the company address from which you are sending the invoice. This is helpful if you have more than one office invoicing customers and receiving payments. Since the office address is set in the invoice layout, you need to define invoice layouts per office and make sure they use only their layouts to get the appropriate remit to address displayed. There is no ability to restrict who can see what invoice layouts so training is key.

At the bottom of the invoice layout is a control of the invoice margins, both top and bottom. If you opted to allow the company logo to appear full size, the invoice top margin is ignored should your logo require more space. You have the option to load an override logo which is helpful in the case of invoicing by subsidiaries within your organization that may use unique logos when invoicing your customer base. The title of the invoice may also be overridden. This lets you specify a layout that renames the invoice to be 'Credit Memo' for example or any other terminology (in any language).


## Invoice Options

High level Invoice options exist that apply globally to all of your invoices. Setting the starting invoice # and the increment by # value should only be set one time in your account and not adjusted to maintain consistent invoice numbering.


### To access and modify the Invoice options:

1. Go to Administration > Application Settings > Invoices > Invoice options.
2. Set the Starting invoice # and the number invoices increment by. The starting number defaults to 100 and the incremental invoice # defaults by 1. You may change this as needed in your company. However, when set, you should not change it.
3. Check the **Include outstanding balances on the invoice** box if you would like to display any outstanding balances to your customers. This is controlled here and not with the invoice layout.

4. Check the **Show future charges when creating an invoice** box if you have set up invoice charges for future billing manually and want to include these in the invoice for advanced billing.
5. Check the **Show the employee name on the "Change charges" view** box if you allow employees to change the charges by removing or adding them and optionally editing the charge.
6. Check the **Show the task in the "Change charges" view** box if you want to display the task in the charges view.
7. Check the **Include PDF by default when sending an invoice** box if you want the **Include PDF invoice as attachment** option on the Invoice > Send form to be selected by default. Users will be able to clear this box if they do not want to include the invoice as a PDF attachment.

 **Note:** Attached PDF Invoice files are named 'invoice\_<invoice number>.pdf'. For example, Invoice number 1358 will be sent with the file 'invoice\_1358.pdf' in attachment.


8. Enter an email address in the **Invoice email Bcc** text box if you want to copy a recipient privately into all invoice email using Blind carbon copy. On the Invoice > Send form, the **Invoice email Bcc** is read-only and visible only if filled in the Invoice Options settings.
9. Enter an email address in the **Invoice email Cc** text box if you want to set a default recipient to be included into invoice email using Carbon copy. The **Invoice email Cc** can be overwritten by the user sending the invoice on the Invoice > Send form.
10. Click Save.

 **Tip:** You can set a sender address for your invoice email by using **"From" email address for invoices** on your invoice layouts. See [Invoice layout — Set the sender address \(From\)](#).

## Service

SuiteProjects Pro provides several methods you can use to charge or invoice a customer. One of these methods is Services. You use services when you would like to designate and bill for specific services offered to a customer.

A Service can be set up to bill at an hourly rate; a set amount per day, or week, or month; or may be set as a flat rate. Services are available in the Timesheets, Projects (tasks, billing rules, and recognition rules), Invoices, and Opportunity applications.

 **Note:** The name of this form is based on your company's terminology. Most companies use services or activities, but other terms are used. You can review and modify your company's terminology definitions in Global Settings. See [Interface: Terminology](#).


One example of a Service would be for monthly application support. You would charge a fixed fee amount per month to the customer regardless of the amount of time incurred by resources providing the support. Another example could be programming fees where the service is provided on an as needed basis. You would charge the customer at an hourly rate or on a per-day basis when assistance is required.

You are able to select the service as an option in the invoice layout. This defines the specific work provided to the customer.

### To create a Service:

1. Go to Administration > Application Settings > Invoices > Services.
2. Select **New Service** from the **Create Button**.

3. Enter the Service name. Type notes related to this service.
4. Under Billing rates, select the Currency if you are using multi-currency in your environment. Choose how you would like to charge for this service: Hourly rate, Other rate (specified amount per time period), or Flat rate (for the entire service-fixed fee).

 **Note:** You do not have to complete the billing rates section unless you have chosen to get billing rate from either Services or Services-Customer. See [Billing Rates](#).

5. Optionally, you may choose a cost center for the service if your company has enabled using Cost Centers and has chosen Services as a Selected Item. See [Cost Centers](#).
6. You may also enter text to be used on proposals in the Opportunities application, if desired.
7. Check the **Taxable service** box if tax may be charged to the customers for this service. The tax rate used is based on [Tax Options](#) as well as [Invoice layout - Display, summary](#).

## Frequently Asked Questions (FAQs)

### How would I know whether I should have Services set up for my company?

If your company provides standard types of services to customers, you may want to create services in your account. They can be used for providing a standard description of the work being performed and are useful for financial reporting, such as revenue by type of service delivered. Since services are carried onto invoice charges, they are available to display on invoices to identify the type of work completed for your customers. Services are “sticky” values that remain associated with time entries and can be used in billing/recognition rule setup. This can provide a wide variety of reporting options using timesheet hours and billing/revenue monetary values.

## Payment Terms

Payment Terms are the conditions, generally the timeframe, under which an invoice is expected to be paid by the purchaser of the goods or services. Common terms are: Upon Receipt, Net 30 days and Net 45 days. Any number of payment terms may be created per your company's policies. Generally these terms are specified in contracts or primary agreements between the provider and the customer.

### To create Payment terms:

1. Go to Administration > Application Settings > Invoices > Payment terms.
2. Select **New Payment terms** from the **Create Button**.
3. Enter the Payment terms name. SuiteProjects Pro provides a standard aging report. For the aging function to work properly, the payment terms must be input in the form of “Net#”.
4. Type any Notes, if desired.
5. If this payment term is the standard used for your company, check the **Default payment terms** box. You may also specify the payment terms on an individual customer basis.
6. Click Save.

After you have created payment terms, you can select them on the Customers form. Go to Customers and select a customer. Click the Billing information link. Select the Payment terms from the drop-down list. The payment terms for a customer override the default set in the payment terms form. See [Customer Billing Information](#).

## Other Settings

The Invoices application has many configurable parts including add-on functionality and interaction with how you are managing your projects.

### To access the Invoices Other settings:

1. Go to Administration > Application Settings > Invoices > Other settings.

**Disable editing of invoiced charges:** Charges may be edited within the Invoices application. This ability is controlled by application role settings. By default, a charge that has been included on an open invoice may also be edited directly within the invoice using the **Change charges** link. Activation of this feature disables the ability to edit charges within an invoice. Therefore, to edit charges on an invoice, all charges must be removed from the invoice first, modified, then reapplied to the invoice as appropriate using the **Change charges** link within the invoice.

**Disable editing of exported invoices:** Charges may be edited within the Invoices application. By default, a charge that is included in an invoice may also be edited directly within the invoice using the **Change charges** link. If you are exporting invoices for upload or integration with an accounting system, an export flag is set for invoices that have been exported. This is how SuiteProjects Pro tracks what new invoices must be exported each time the export is run. Activation of this feature disables the ability to edit charges on an invoice that has been exported.

To edit charges, the invoice must be unexported and then unapproved (if it has already been approved) to remove the desired charges from the invoice. Charges may be modified and reapplied to the invoice using the **Change charges** link within the invoice. The invoice can now be exported again whenever the next export is scheduled to be run.



**Important:** If you are interfacing invoices with another system, the invoice in the other system must be deleted if the invoice was unexported in SuiteProjects Pro. This is to avoid duplicate invoice creation in the other system when the SuiteProjects Pro invoices are exported again.

**Allow project over-ride of billing/shipping/sold to contact:** If this option is not selected, then the identified billing contacts for the customer are available to be set on the invoice itself. With this option checked, a field displays on the project form allowing a specific billing contact to be associated with the project. This option is useful if you are creating separate invoices per project.

**One project per invoice:** If this option is not selected, then invoices can be created at the customer level and include billing charges for multiple projects. When using the Create multiple invoices option in the Invoices application, you still have the option to check invoice creation by project or employee. If this option is selected, the system defaults to by project invoice creation for individual invoices as well as multiple invoice creation. You may still chose to create invoices by employee in the multiple invoice create option, but if the one project per invoice option is enabled, then the invoices are created per employee, per project.

**Enable shipping contacts:** By default, contacts created in SuiteProjects Pro can be associated with an employee as a general contact or identified as a billing contact. Enabling a shipping contact provides an associated field on the Create contact form to identify whether the contact can be used as a shipping contact.

**Require a description on charges:** When creating an invoice charge within the Invoices application, the description field is left blank by default. This option requires some type of entry into the description field, most likely due to the invoice layouts displaying the description field. If you create charges from Billing Rules on projects, the charge description can be set using the billing rule to ensure the value is always populated. Setting this option does not make the charge description field on billing rules a required field. Therefore, you still need to ensure the charge description field is entered properly.

**Require a service on charges:** When creating an invoice charge within the Invoices application, the Service field by default is left blank. This option requires a selection of a service value. Services may drive an integration with an accounting package within your environment, which makes setting the service field critical.

Other reasons why a service would be required include a display of the service on invoice layouts or the use of the service to capture project-related metrics and categories for reporting. If you are creating charges from billing rules on projects, the service drop-down list can be set in the billing rule to ensure the value is always populated. Enabling **Require a service on charges** does not make the service field on billing rules a required field. This is a separate setting within the project options area that you should also enable if you enable the **Require a service on charges** on charges for invoices.

**Sort numerically when sorting the invoice list by invoice number:** Invoices are assigned a number using the Invoice options form under Invoices Settings. Each customer, however, may have a specific invoice prefix and it could be alphabetic. Activating the sort numerically setting ignores the invoice prefix values and displays invoices in the order of the number assignment when you click on the Invoice # column header.

**Invoices tab defaults to a list of:** Sets the default landing page for the Invoices application to the Invoice tab rather than Charges tab.

## Frequently Asked Questions (FAQs)

I have entered charges for future billing manually but cannot create an invoice and include these charges.

The charges dates may be in the future and the Invoice options do not allow to include future charges when creating an invoice.

By default, if you entered charges manually, you can create an invoice and include open charges if the dates set for these charges are not in the future.

If you want users to create invoices for advanced billing and include charges with dates in the future, you need to select **Show future charges when creating an invoice** in the Invoices options. If this option is not enabled, users will need to wait until the date indicated on an open charge to create an invoice and include this charge. See [Invoice Options](#).



# Purchases

The Purchases application provides the ability to create a process flow from a purchase request to fulfillment and receipt, and enables the tracking of purchases made within your company.

- Employees with the proper permissions can create purchase requests for goods and services (that is, Products) which may then go through an approval process.
- Approved requests may then be turned into purchase orders (POs) by purchasers which are sent to vendors for fulfillment.

The Purchases application requires the following record types: Vendors, Products, and Purchasers (for PO creation). It also requires at least one of the following record types when using the full purchases functionality: Accounts payable locations, Carriers, F.O.B. locations, Receiving locations, and Shipping terms.

**Note:** Purchase items from purchase orders are associated to projects at the project level or the task level. They appear in the project budget under Purchases. Purchase items billing rules can be used to create charges and project billing transactions based on the purchase items. These charges can then be included when creating invoices. See [Billing](#) under [Projects](#).

The Purchases application is designed to facilitate the process flow from purchase requests to fulfillment and receipt. It does not support management of vendor records, bills, payments, records or credits. An external accounting system or the NetSuite integration may be used for this functionality.

## Accounts Payable Locations

Accounts payable locations are for your company's billing addresses. Your company may have multiple accounts payable addresses, which can be each location, a regional office, or a shared services facility. Accounts payable locations are only available in the Purchases application. When created, you can choose the appropriate accounts payable location when creating a PO so that the vendor is aware of the correct billing address when invoicing for this purchase.

### To create an Accounts payable location:

1. Go to Administration > Application Settings > Purchases > Accounts payable locations.
2. Select **New Accounts payable location** from the **Create Button**.
3. Enter the Accounts payable location name (required), the Demographic and Invoicing Address information (most critical).
4. Add Notes to include specific data regarding this location such as products and vendors to be used with this location.
5. Click Save.

## Carriers

Carriers are the organizations that transport the purchases you order from your vendors to your company locations. You may want to specify the carrier you would like your vendor to use when shipping your purchases. The preferred carrier can be entered when creating POs. Frequently, you may have special arrangements with certain carriers. The use of carriers is only available in the Purchases application.

### To create a Carrier:

1. Go to Administration > Application Settings > Purchases > Carriers.
2. Select **New Carrier** from the **Create Button**.
3. Enter the Carrier name and any relevant Notes regarding this carrier such as contact information and account number.
4. Click Save.

## F.O.B Locations

F.O.B. means Freight On Board. F.O.B. locations are an indication of which party, purchaser or vendor, is responsible for the shipping and loading costs. It may also refer to where the liability for damage goods resides.

In North America, the locations generally used are FOB Origin or FOB Destination.

**F.O.B. Origin** — means the purchaser pays for the shipping costs and takes responsibility (liability) for the purchase when it leaves the vendor's location.

**F.O.B. Destination** — is the opposite, where the vendor is responsible for costs and liability until the purchase reaches the purchaser's facility.

You may also create F.O.B. locations with specific locations (for example, F.O.B. London) or other conditions based on your company's needs. Ensure there is a clear definition on what each entry represents by entering notes as you set up the F.O.B. Location.

### To create a F.O.B. location:

1. Go to Administration > Application Settings > Purchases > F.O.B. locations.
2. Select **New F.O.B. location** from the **Create Button**.
3. Enter the F.O.B. location name and any Notes, if desired.
4. Click Save.

## Manufacturers

Establish manufacturers so that you can associate them with products to ensure the products are purchased from the manufacturers your company selects.

Manufacturers is a feature that is only available in the Purchases application, however, it is not a required record in the Purchases application.

### To create a Manufacturer:

1. Go to Administration > Application Settings > Purchases > Manufacturers.
2. Select **New Manufacturer** from the **Create Button**.
3. Enter the Manufacturer name and the Demographic Information.
4. The next section is for the Mailing Address and Notes. The demographic, mailing address information and notes are not required to use the manufacturers feature.
5. Click Save.

## Purchase Order Layout

You can tailor the Purchase orders to meet your company's needs. Since this report may be emailed or mailed to vendors outside of SuiteProjects Pro, the Purchase order layout should clearly communicate your purchasing requirements. You are able to select the prefix and starting PO number, Grid style, and Date format. These settings determine the numbering of the created POs and the basic style of the PO report.

### To access and modify the Purchase order layout:

1. Go to Administration > Application Settings > Purchases > Purchase order layout.
2. You may choose to include project information such as the Project name or the Customer : Project, if desired, by selecting from the drop-down list.
3. Check the **Include description on PO** and **Include signature on PO** boxes if required.
4. Type information in the "**From**" email address for POs if you would like that added.
5. A Notes field is available to be displayed on the PO and may be positioned in the header or footer of the form. The notes displayed are a combination of notes entered directly on the PO and static text that may be entered into the Additional notes field in the PO layout. An example of static text may be: All inquiries should be directed to the Accounts Payable Department at xxx-xxx-xxxx.
6. Select the **Columns to display for each purchase item on the PO** from the Available Columns and move them to the Selected Columns.
7. Choose the Adobe Acrobat PDF settings you would like to use in your environment. You should print a sample Purchase Request when the PDF settings are in place to ensure the page layout and margins are set correctly.
8. Click Save.

## Products

Products are items you purchase from vendors. A product must exist to use the Purchase request or PO functionality within the Purchases application. Products may also be rebilled or invoiced to your customer and therefore need to be available as a type of billing rule on projects and also as a revenue recognition rule in the Projects application. They also may be used as a invoice charges in the Invoices application.


When you set up products in SuiteProjects Pro, consider your company's requirements to distinguish between specific products. You may choose to set up generic products like cell phones, travel, or computer. Or, you may choose to be more specific on the type of products you allow to be purchased for your company such as Blackberry 8830 or Dell Inspiron E1705. To allow more flexibility and less maintenance, setting up products that are more generic enables accurate data capture while not restricting the company from evolving as new products are approved and old products are retired.

If you are using the Purchases application to also procure vendor services, you also need to set up products related to services provided such as Consulting, Programming, and Web Design.

### To set up a product:

1. Go to Administration > Application Settings > Purchases > Products.
2. Select **New Product** from the **Create Button**.
3. Enter the Product name. You can choose a Manufacturer from the drop-down list and identify the Manufacture's part number in the fields provided.
4. Choose the Preferred vendor (if available), the Preferred vendor's SKU number, Standard price, Currency if using multi-currency, and Unit measure.

5. Check the **Taxable product** box if applicable.
6. Check the **Active product** box.
7. Add any Notes on this product, if desired. Click Save.

 **Note:** Only the name is required to create a product. Any other fields entered on the product record auto-populate related fields on a purchase request or purchase order in the Purchases application.

## Purchase request layout

You can use the Purchase Request layout form to set up purchase requests that are specific to your company's needs. Since this report form may be routed for review and approval internally, the layout should clearly communicate your purchasing needs. You are able to select the prefix and starting Purchase Request number, Grid style, and Date format. These settings determine the numbering sequence of created Purchase requests and the basic style of the report.

### To access and modify the Purchase request layout:

1. Go to Administration > Application Settings > Purchases > Purchase request layout.
2. A series of data inclusion options are available:
  - Include customer:project information on purchase request
  - Include description on purchase request
  - Include signature line on purchase request
  - Show the approval history
3. The Header or Footer of the Purchase Request may display purchase request notes and the customer purchase request notes. You can also add additional notes.
4. Select Columns to display for each request item on the purchase request. Move items from the Available list and move them to the Selected list.
5. Choose the Adobe Acrobat PDF settings you would like to use in your environment. You should print a sample Purchase Request when the PDF settings are in place to ensure the page layout and margins are set correctly.
6. Click Save.

## Purchasers

You must set up a Purchaser record to be able to use the Purchases application to create POs. The purchaser record stores the default purchasing preferences of each employee. For example, an employee who is in charge of creating POs and delivering them to vendors for a particular office often uses the same accounts payable and receiving information for each PO. By creating the purchaser and associating it with an employee, you set the purchasing preferences beforehand so the employees do not have to enter this information each time they create a PO.

A employee cannot create POs or POs by vendor unless the employee has an associated Purchaser record. Depending on role permissions, an employee can create Short Order POs without being designated as a Purchaser.

### To create a Purchaser:

1. Go to Administration > Application Settings > Purchases > Purchasers.
2. Select **New Purchaser** from the **Create Button**.
3. Select the Associated employee from the drop-down list of account employees.
4. Enter a name for the Purchaser.
5. Choose the **Default Accounts payable location** and the **Default Receiving location** for this employee from the drop-down lists.
6. Complete shipping information. Check the **Default for 'Only ship complete order'** box. Otherwise, you allow for multiple shipments.
7. If you would like to select a default carrier for this purchaser, select a carrier from the **Default for 'Ship via'** from the drop-down list.
8. Notes may be added, if desired.
9. Click Save.


## Vendors

Vendors play an important role if you use the Purchases application. A vendor is someone from which you purchase services or products. Purchase orders (POs) issued in SuiteProjects Pro can be sent to vendors automatically provided the necessary information has been entered on the vendor record.

Vendors are an optional feature in the Expenses application and can be entered on receipts, if your company's SuiteProjects Pro account is configured to use vendors on receipts. The entry of Vendors is separate from customers. So if you provide services to a company but also purchase services/products from them, then you must create both a customer and a vendor record. See [Customers](#).

### To create a Vendor:

1. Go to Administration > Application Settings > Purchases > Vendors.
2. Select **New Vendor** from the **Create Button**.
3. Enter the Vendor name and check the **Active vendor** box.
4. Enter Demographic Information as completely as possible.
5. Under the Purchasing Address, enter the full address of the vendor and person/department to be notified. This information is necessary when sending POs that have been created in the Purchases application to the vendor.
6. Enter the additional Purchasing Information. This includes Payment terms (see [Payment Terms](#) under Invoices Settings), Currency if using multi-currency, a PO note that is displayed on every PO for this vendor, Email PO text to be used on POs sent by email, and any notes if required.

 **Note:** The purchasing address and other information are optional if you are not using the Purchases application.

7. Click Save.

## Receiving Locations

Receiving locations are for your company's shipping addresses. Your company may have multiple addresses it ships to, which could be each location/plant, a regional distribution center, or possibly a third party facility such as a manufacturing plant receiving parts.

Receiving locations are distinct from accounts payable locations since the purchase may be shipped to a plant location while the invoice should be sent to the regional office for accounts payable processing. Receiving locations are only available in the Purchases application. When created, you can choose the appropriate receiving location when creating the PO so that the vendor can ship the purchase to the correct shipping address.

### To create a Receiving location:

1. Go to Administration > Application Settings > Purchases > Receiving locations.
2. Select **New Receiving location** from the **Create Button**.
3. Enter the Receiving location name (required), the Demographic Information and Receiving Address information (most critical).
4. Add Notes, if desired.
5. Click Save.

## Shipping Terms

You can enter shipping terms on a PO to provide information for your purchases with a vendor. Shipping terms are only available in the Purchases application and are generally determined by the contract between your company and the vendor. Shipping terms could include who is responsible for expenses involved in shipment, who owns goods at a particular point, and who is responsible for paying damage to goods. Examples are Paid by Vendor and Collect on Delivery or C.O.D.

### To set up Shipping terms:

1. Go to Administration > Application Settings > Purchases > Shipping terms.
2. Select **New Shipping terms** from the **Create Button**.
3. Enter the Shipping terms name. This displays on the PO.
4. Type any additional information in Notes.
5. Click Save.

## Other Settings

There are several other settings available in the Purchases application.

### To access the Purchases Other settings:

1. Go to Administration > Application Settings > Purchases > Other settings.

**Allow an approver to edit a submitted purchase request:** When purchase requests approvals are used, purchase requests are submitted for review by a defined employee who then approves or rejects the purchase request. To avoid time delays introduced by having the reviewer reject a purchase request then having the owner fix and resubmit the purchase request, activating this option gives the reviewer the ability to edit the purchase request directly before continuing with an approval.

**Allow an approver to edit a submitted PO:** When PO approvals are used, POs are submitted for review by a defined employee who then approves or rejects the PO. To avoid time delays introduced by having the reviewer reject a PO then having the owner fix and resubmit the PO, activating this option gives the reviewer the ability to edit the PO directly before continuing with an approval.

**On purchase requests, show only Customers and projects with open tasks assigned to the employee:** This option only permits employees that have been assigned to open tasks on active Customer : Project to create a purchase request.

**Enable by default the "Automatically track payability with fulfillment" option for new POs:** If you select this option, any PO item is indicated as payable when the item has been fulfilled. You may override the setting on a specific PO when editing a PO.

**Allow modification of the notes field on an approved PO:** When a PO has been approved, all fields are locked from changes. By enabling this option, the Notes field can be modified after the PO has been approved.

**Allow PO submission even if there are purchase items with no costs assigned:** This option enables a PO to be submitted for approval without having a defined cost indicated on the purchase item. Normally, purchase items and products entered on purchase requests have a standard price or cost assigned to them.



**Do not auto-populate description field on request items:** The description field is automatically populated from the description on the products. Selecting this option does not use the item description and requires the description to be entered on all purchase items.

**Duplicate request item attachments to their respective purchase items when creating POs:**

Attachments to purchase items are automatically duplicated when creating new POs when this option is selected.

**Enable the ability to create quick PO items. These are purchase items for purchases made without a PO:** This feature lets you create PO items when purchases have been made without using purchase requests or POs. Generally you would create purchase requests or POs from products that have already been defined in SuiteProjects Pro. Quick POs are technically purchase items, and are not the standard purchase order record.


# Reports

The Reports application provides you with a way to download and report on information stored in SuiteProjects Pro. It consists of five main tabs and each has its own set of configuration options. The types of [Reports](#) are listed below:

- Summary
- Detail
- Advanced
- Drill Down
- Saved reports

To manage reports, see [Reports Status](#).

To view company report-related switches in Global Settings, see [Reporting Options](#).

The Report Management and Editor optional feature changes the user interface for all except advanced reports and streamlines the way you work with reports. For information about the Report Management and Editor Interface features, see  [User Guide](#).

**Note:** To enable the Report Management and Editor feature, contact SuiteProjects Pro Support. After the feature is enabled, account administrators can give individual employees access to the report management and editor interface.

To give an employee access to the report management and editor interface:

1. Go to Administration > Global Settings > Users > Employees > [Select an employee] > Demographics
2. Check the **Enable the report management and editor interface** box under the Reporting Options form section.

You can use the Bulk employee change wizard to give multiple employees access to the report management and editor interface at the same time.

## Reports

The Reports application provides employees who have the appropriate privileges the ability to create and run a wide variety of reports based on your company's configuration. SuiteProjects Pro provides a robust and flexible reporting environment. You are able to choose the fields you want to see and the order in which they are displayed, along with the ability to filter the data.

There are four general types of reports: Summary, Detail, Advanced and Drill Down (optional). These four report types and their uses are described as follows.

## Summary Reports

Summary reports give you access to report information across SuiteProjects Pro such as reporting Timesheet entries along with Invoice information and Project revenue recognition. Reports are created by selecting a base report then completing the report form to configure the options for report generation. Selecting a base entity under the application specific context, rather than Account-wide, will limit the available values to only those in that application. Summary reports provide subtotal capability and flexible data filtering as well as inclusion of custom calculations in your company's SuiteProjects Pro account. See [Custom Calculations Overview](#).



**Tip:** Columns can be locked in Summary Reports which do not contain a subtotal.

If the option to lock columns isn't available, go to User Center > Personal Settings and make sure that the following settings are enabled: **Anchor column titles at top of page when scrolling vertically** and **Enable anchoring of left columns when scrolling horizontally**. Then, go to Administration > Global Settings > Display > Interface: Display and make sure that the setting **Enable dynamically collapsible sections in hierarchy lists** is disabled.

If column locking is not available in Summary Reports because they contain a subtotal, you can add at least one detail field to the Report and run it. This will make anchoring available even in Summary Reports with subtotals.

## Detail Reports

Detail reports give you access to report information within specific applications or tables such as Employee information. Some information may be rolled-up for a basic sub-total function, but in general, reports in the Detail tab are used to report specific fields for a single object. Calculations are not performed in detail reports and the intended use of these reports is to provide list values of data.

## Advanced Reports

Advanced reports provide preconfigured reports that have specific functionality and formatting built in. The options for report configuration are generally limited. Key reports in this area include: Pending billings and Pending recognition reports, Timesheet status, Accounts receivable, and a variety of resources utilization reports.

## Drill Down Reports

Drill down reports are useful if you are using Hierarchies with multiple levels in your company's environment. You can create reports by selecting the specific Hierarchy and Level within the hierarchy. You will also need to provide a Time period-Dates, the Application for which the hierarchy is associated, Data values and Other options. See [Hierarchy](#).

**Note:** The Drill Down tab is an optional feature that is enabled unless you select the **Hide the 'Drill down' reports tab** available in Reporting Options. See [Reporting Options](#).

## Reports Status

The Reports status page provides you with an overview of report statuses and details. This is a report management tool that lets you monitor the status of reports and take action on long running reports impacting performance, stale reports, etc.

It consists of three views.

- All
- Running
- Maintenance

### All

From the **All** view you can see details on how reports are being used in your account.

You can also select one or more reports and run a bulk action to:

- **Delete the selected report**
- **Remove the selected report from schedule**
- **Change the report owner**

You can also change the report owner from the **Report owner** section on each saved report.

### Running

From the **Running** view you can see all the details for the reports that are currently running.

You can also select one or more reports and run a bulk action to **Stop the selected report**.

## Maintenance

From the **Maintenance** view you can see all the active scheduled reports with inactive owners. This tab is available for administrators to clean their active scheduled reports.

## Reporting Options

Reporting Options settings provide system-wide controls on the appearance of reports and functions available in within the Reports application. In the following steps, we address the Options tab, which lets you configure the Global report options form. These Global report options affect the appearance of reports.

To view company report-related switches in Global Settings, see [Reporting Options](#).

### To set Global Report options:

1. Go to Reports > Options.
2. Select the Weekly and Bi-weekly report columns starts on. The default is Monday.
3. Select the Date to use in column titles: Use starting date or Employee ending date.
4. Designate how to handle settings when a value is not applicable in the report context.
5. Enter Display settings to wrap multi-line text fields at. The default is 50.
6. Select Adobe Acrobat PDF settings and identify other page display properties.
7. Enter Font size and select Grid style
8. Identify Multiple currencies you want to report on.
9. Click Save.

## Frequently Asked Questions (FAQs)

What are the differences between the types of reports and how would I use them?

Refer to the following descriptions:

- **Summary reports** (also called **Crosstabbed reports** in the Report Management and Editor tools) provide a great deal of flexibility in reporting. You are able to subtotal on many fields and incorporate fields from different applications into the reports.
- **Detail reports** (also called **Tabular reports** in the Report Management and Editor tools) concentrate on specific entities within the applications and you can customize the reports to your needs. For example, you can create a report on project details or invoice details based on the information available within the entity you select.
- **Advanced reports** are standard reports provided by SuiteProjects Pro. You have the option to modify some parameters within the report.
- **Drill Down reports** are used to provide specialized reporting on hierarchies set up in your company's SuiteProjects Pro account such as employee country, state, and project regions. The Drill Down tab is an optional feature that is enabled unless you check the **Hide the 'Drill down' reports tab** option under the Reporting Options. See [Reporting Options](#).
- The **Saved Reports** tab shows customized reports that you or others have created in your company's SuiteProjects Pro account. These are used in the charts and graphs you display in the Home application.

# Workspaces

The Workspaces application provides employees with an area to store project-related documents and share them with other team members. The workspace owner control who can access the workspace area by granting workspace membership to individual employees, assignment groups, or all employees. The workspace owner can control members access rights as read-only, read/write, or administrator.

After you create a workspace, you can add a discussion thread. The discussion could be about anything related to the workspace such as a project, for example. You can also add documents, and edit the properties of the workspace. You can search workspace documents and discussions using keywords.

You can manage alerts for documents and discussions by selecting the events that trigger an alert and designate members who receive the alert. You can check the **"Exclude alerts" on by default** box to disable alerts by default for all documents and discussions in a workspace.

You can set up an Account storage alert that will notify you when a certain percentage of your account storage capacity is used.

## Document Categories

Within the Workspaces application you are able to define specific Document Categories to use. You can apply these categories to your documents when loading them into the workspace or folders within a workspace. Identifying documents by category enables you to easily track and maintain documents.

### To create Document categories:

1. Go to Administration > Application Settings > Workspaces > Document categories.
2. Select **New Document category** from the **Create Button**.
3. Enter the Document category name and Notes, if desired.
4. Check the **Active document category** box.
5. You may optionally select one of the document categories to be the default category by checking the **Default document category** box.
6. Click Save.

## Searching Workspaces, Documents or Discussions

You can search workspaces, documents or discussions for specific keywords.

By default, the search functionality include document names only. You can extend the document search to the documents content as well as document names. To do so, go to Administration > Application Settings > Workspaces > Other Settings and check the **Enable document content searching** box. See [Other Settings](#).

The Search feature is available in the following locations:


- Workspaces > Workspaces > Search
- Workspaces > Documents > Search
- Workspaces > Discussions > Search
- Workspaces > Workspaces > [Select a workspace] > Search

- Workspaces > Workspaces > [Select a workspace] > Documents > Search
- Workspaces > Workspaces > [Select a workspace] > Discussions > Search

### To search workspaces, documents or discussions:

1. Go to one of the locations above.
2. Enter one or more **Keywords**.
3. Choose which workspaces you want to include in your search. You can include:
  - **All** workspaces
  - **Open** workspaces only
  - **Selected** workspaces only

If you choose to include selected workspaces only, click **Create** and select the workspaces to include in your search.

 **Note:** You cannot select the workspaces you want to include in the search if you are viewing a workspace, or a document or discussion sublist within a workspace.  
The **Selected** option is available only in Workspaces > Workspaces > Search.

4. Select all the record types you want to include in your search:
  - **Workspaces** — Available only Workspaces > Workspaces > Search
  - **Documents** — Available only Workspaces > Workspaces > Search and Workspaces > Workspaces > [Select a workspace] > Search
  - **Discussions** — Available only Workspaces > Workspaces > Search and Workspaces > Workspaces > [Select a workspace] > Search
5. Click **Search**.  
A list appears showing the search results.

  - Go to Workspaces > Documents.
  - Go to Workspaces > [*Select a workspace*] > Documents.
  - Search for a document. See [Searching Workspaces, Documents or Discussions](#).
2. Locate the document you want to download.
3. Click the download icon in the actions column.

Depending on your browser settings, the file download starts automatically or a window appear prompting you to choose a download location.

 **Tip:** Use the Column selection panel in the list toolbar to add the Commands column to your list.

## Downloading Multiple Documents at the Same Time

You can download multiple documents as a ZIP archive from the documents list or the documents search results.

### To download multiple documents at the same time:

1. Do one of the following:
  - Go to Workspaces > Documents.
  - Go to Workspaces > [*Select a workspace*] > Documents.
  - Go to Workspaces > Search, and search documents for one or more keywords.
  - Go to Workspaces > [*Select a workspace*] > Search, and search documents for one or more keywords.
2. Check the box in the bulk action column for all the documents you want to download. Check the box or click **Select All** in column header to select all documents in the list page.
3. Click **Bulk actions** then **Download selected**.



Depending on your browser settings, a file download starts automatically or a window appear prompting you to choose a download location.

## Downloading All Documents from a Workspace

You can download all documents from a workspace as a ZIP archive.


### To download all documents from a workspace:

1. Go to Workspaces > [Select a workspace].
2. Click **Download all documents**.  
The Download all documents form appears.
3. (Optional) Check the **Include folders** box if you want the content of the ZIP archive to preserve the folder structure of your workspace documents.
4. (Optional) Check the **Include document revisions** box if you want to download all previous revisions of each document. Revisions for each document will be placed in a subfolder.
5. (Optional) Check the **Delete all documents** box to delete the documents from SuiteProjects Pro after downloading them.

 **Note:** This option is available only if the Documents Bulk Deletion on Download optional feature is enabled for your account. See  [Optional Features](#).


6. Click **Download**.

## Downloading All Documents from All Workspaces

You can download all documents from all workspaces at the same time if the Download All Documents Across All Workspaces optional feature is enabled for your account. See  [Optional Features](#).

### To download all documents from all workspaces:

1. Go to Administration > Application Settings > Workspaces > Download all documents.
2. Click **Download**.  
Depending on your browser settings, a file download starts automatically or a window appear prompting you to choose a download location. The ZIP archive default filename is "Workspace\_Documents\_YYYY-MM-DD.zip". The Zip archive contains all documents and all revisions for each document, and preserves the folder and document structure.

 **Important:** If you have a large volume of workspace documents stored in your company's SuiteProjects Pro Account, generating a large ZIP archive for download may take a long time and your browser may time out.

## Account Storage

When using the Workspaces application to store your company's documents, you can monitor the amount of storage space currently used and the total amount of storage space available on your account. The default storage space available is 5MB. To increase the storage capacity for your account, contact your SuiteProjects Pro account manager.

To view the account storage capacity and space used, go to Administration > Application Settings > Workspaces > Account storage.

You can set up an Account storage alert that will notify you when a certain percentage of your account storage capacity is used. See [Creating an Account Storage Alert](#).

You can use the following features to take a copy of the documents stored in SuiteProjects Pro and delete documents at any time to manage your account storage.


- You can use the Automatic Backup Service to schedule the regular delivery of your company's SuiteProjects Pro account data including documents and attachments. See [Automatic Backup Service](#).
- You can download and delete workspace documents. See [Downloading Documents from a Workspace](#).
- You can delete reimbursed or approved expense attachments for a specified date range. See [Expense Attachment Deletion Wizard](#).

## Creating an Account Storage Alert

You can configure SuiteProjects Pro to check the amount of storage space currently used on your account at regular interval and notify you when the storage space used reaches a percentage of the capacity allowance for your account.

### To create an account storage alert:

1. Go to Administration > Application Settings > Workspaces > Alerts.
2. Click the Create button then **New account storage alert**.
3. Enter an **Alert name**.
4. **Alert runs on** — Select the Day and Time you want to schedule the alert to run.
5. **Rule** — Enter the percentage of storage capacity above which notification email should be sent.
6. Enter the following **Email notification** information:
  - **The email is from** — Sender email address.

 **Note:** Depending on your account configuration, sending system-generated email from a custom address may not be permitted. When this is the case, a note under the text box advises you so, and email is sent from `www@openair.com`. See also [Email Settings](#).

- **The email will be sent to** — Recipient email address.
  - **Subject** line.
  - **Additional text to include** in the body of the email.
7. Check the **Active alert** box.
  8. Click **Save**.

## Other Settings

There are several other settings you can select related to Workspaces.

### To access the Workspaces Other settings:

1. Go to Administration > Application Settings > Workspaces > Other Settings.

**Require a document category when checking in documents:** Document categories are configured to group documents by type for reference. If this option is checked, ensure you have set up all necessary document categories so a valid value is always available. If this option is unchecked, employees may optionally choose a document category provided values exist. If values do not exist, the field does not display when creating or loading a document.

**Require a comment when checking in document revisions:** The comment field is optional unless this option has been selected. Requiring a comment on document revisions helps enforce policies such as including a summary of changes on the document history.

**Require a message body when creating a new message or replying:** The Workspaces application enables discussions to be entered and tracked. Checking this option prevents empty messages from being created, which may also trigger notifications to employees involved in the discussion depending on the alert settings within the workspace.

**Add the customer name in auto-created project workspaces:** When creating a project, the project creator is given the option to create an associated workspace. By default, the name of the workspace includes the project name and the base workspace name, if one was copied. Selecting this switch also includes the client name in the name of the workspace. This is helpful if you have projects with similar or the same name to ensure you have unique workspace names.

**Enable document content searching:** Check this box to extend workspace document search to the content of documents in addition to the document names. See also [Searching Workspaces, Documents or Discussions](#).

After you enable this feature, go to Administration > Global Settings > Account > Maintenance Settings, choose **Build document content search indexes** and click **OK**. This indexes all workspace documents to support the search functionality.



**Important:** Enabling document content search reduces the amount of storage space available on your account as storage space is required for content indexing.

The Home application gives account users an overview of their and the company's business performance, what they need to know and what they can or need to do.

For a general description of the classic homepage and dashboards, see the help topic [Homepage and Dashboards](#) under the [User Guide](#).

**Note:** When enabled for your company's account, the next-generation homepage is currently available in addition to the classic homepage because it does not yet offer a new solution for all the classic homepage functionality. There are two Home items in the main navigation menu:

- Home – Classic homepage.
- Home (new) – Next-generation homepage.

## Message Board

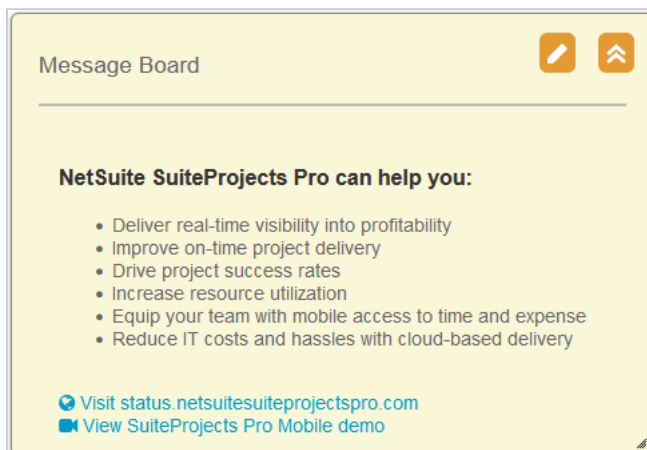
You can use the message board on the homepage to post information for all account users or for all employees in a department. For example, you can use the message board to post instructions and general information about using SuiteProjects Pro, or reminder about your company policies and processes.

To edit the default message board content for all users, go to Home > Home and click the Edit icon.

To edit the message board content for all employees in a department, go to Department > *[Select a department]* > Message.

In both cases, a form appears. Enter the message board content in the text box.

**Note:** Depending on your account configuration, the message board content text box supports HTML syntax.



## My Status and Company Status

The status portlets include information about open objects (objects that are not yet resolved or completed), such as expense reports, timesheets, and many other key object types. The My status portlet shows only objects owned or assigned to the authenticated user, and the Company status portlet gives a company-wide view.

The status portlets can include the number of open or incomplete tasks and issues as an optional feature. This includes all tasks and issues. If you use projects such as general overhead or administrative projects to capture non-billable time, for example, these projects would typically include tasks that always remain open and will be included in the number of incomplete tasks. Depending on your implementation and use of SuiteProjects Pro, you may not need the status portlets to show the number of incomplete tasks, and in some cases, excluding this information may improve loading time for the homepage. See the help topic [Display Incomplete Tasks on Dashboard](#).

**Note:** The to-do list introduced in SuiteProjects Pro 2024.2 includes all workflow tasks from the Reminders portlet on the classic homepage, and some workflow tasks from the My status portlet. Workflow tasks in the My status portlet for which you cannot take direct action are not included in the to-do list. For more information about the to-do list, see the help topic [To-do list](#).

## Report Portlets

By default, each report portlet can show a maximum of 2,000 rows of data by default. To increase this limit, contact SuiteProjects Pro Support.

**Note:** Increasing the maximum number of rows may impact performance. You should use filters to reduce the report size so all data shows on the portlet.

## Dashboard Tabs and Chart Portlets

Account administrators and user with the relevant role permission can use the bulk employee change wizard to copy the dashboard tabs and charts from one employee to other employees, or to all employees in one department. This enables you to create a dashboard template and use this template as the default dashboard for other employees. See [Making Changes to Multiple Employee Records at the Same Time](#).

Two options are available in the bulk employee change wizard under **Information to copy**:

- Dashboard charts (Copy) – This option creates the dashboard tabs and chart portlets in addition to existing dashboards that the destination employees may have.
- Dashboard charts (Replace) – This option replaces any existing dashboard tabs and chart portlets that the destination employees may have.

After the dashboard tabs and chart portlets are copied to an employee's dashboard, this employee can make changes to these dashboard tabs and chart portlets and personalize them.

**Note:** Only charts and dashboard tabs containing chart portlets are copied. Report portlets and dashboard tabs that do not contain any chart portlets are not copied.

## Wizards

Wizards are tools available for maintenance tasks on the homepage. Account administrators and users with the relevant role permissions can use wizards to copy information or complete an action such as

attachment deletion across multiple items at the same time. The wizards are useful when you want to update a large number of employee records with the same information, or remove expense attachments in bulk across a large number of expense reports based on your parameters, for example.

There are four wizards available:

- **Bulk employee change wizard** – The bulk employee change wizard enables you to copy field values and settings from one active employee record to multiple active or inactive employee records. See [Making Changes to Multiple Employee Records at the Same Time](#).
- **Expense report attachment deletion wizard** – The expense report attachment deletion wizard enables you to free up some of your account storage space by deleting attachments associated for older expense reports that have been reimbursed or approved.

To do so, go to Home and click **Expense report attachment deletion wizard**, enter a date range, choose between the reimbursed and approved expense report statuses. After you click **Delete the attachments**, all the attachments for expense reports with a date within the specified range and the chosen status are deleted. This action can not be undone.

- **Bulk task change wizard** – The bulk task change wizard enables you to copy field values and settings from one task across multiple tasks within a single project. This is helpful for maintaining larger projects.

To do so, go to Home and click **Bulk task change wizard**. Step 1 of the wizard displays. Identify the customer and project. Select the task to copy from. Select the information to copy to another task. Click Next. Step 2 of the wizard displays. Select the task to copy to. Click Run.

- **American Express receipt import wizard** – The American Express receipt import wizard enables you to connect to an American Express online statement and download your receipts into a preexisting expense report.

## Making Changes to Multiple Employee Records at the Same Time

The bulk employee change wizard enables account administrators and user with the Bulk employee change wizard role permission to copy information from one active employee record to multiple active or inactive employee records.

Examples of use cases and information you can change using the bulk employee change wizard include:

- Module access privileges – You can give several employees access to the Account, Timesheets and Expenses modules only so that they take up one Timesheets and Expenses (T&E) only user license instead of a Full user license. See [Licenses](#).
- Exchange access privileges – You can give or remove several employees access to the SuiteProjects Pro Mobile app or other add-on services.
- Role, assigned filter sets, filter set module overrides – You can change access control settings as you introduce new roles and filter sets. See the help topic [The Security Model](#).
- Individual user settings and options on the employee demographic form – You can change some of the standard user settings and options and all custom fields available on the demographic form. This can be useful if you want to introduce a feature that requires additional set up at the user level, such as SAML SSO or two-factor authentication, for example.
- Schedule, Cost, Proxy or Leave Accrual settings – You can change all settings on the tab for several employees.
- Dashboards and chart portlets – You can create dashboard tabs for one employee with chart portlets already set up and copy the dashboard tabs and chart portlets to other employees.



You can copy the information to named employees or to all employees in a department.

**Note:** Review the following guidelines:

- Not all the information can be changed using the bulk employee change wizard. You cannot copy the password or primary filter set, for example. If the information you want to change is not available in the bulk employee change wizard, update employee records one by one or consider using SuiteProjects Pro Integration Manager to update employee records in bulk. For more information about SuiteProjects Pro Integration Manager, see the help topic [Integration Manager Overview](#).
- The employee you copy the information from must be an active employee. However, you can copy the information to both active and inactive employees.

### To make changes to multiple employee records at the same time:

- Make the changes to one employee record. To do so, go to Administration > Users > Employees > [Select an employee], make the changes, and click **Save**. For more information about employee records, see [Employees Overview](#).
- Go to Home > Home.
- Click **Bulk employee change wizard** in the Wizards portlet.

4. Select the **Employee to copy from**. Only active employees are available in the dropdown list.
5. Under **Information to copy**, select the information you want to copy from the list in the **Available** box.
6. Click **Add selected**.
7. Under **Copy to**, choose **Employees** to copy the information to selected employees or **Departments** to all employees in selected departments.
8. Check the **Include inactive employees** box if you want to copy the information to inactive employees.
9. Click **Next**.

The Bulk User Wizard – Step 2 form appears.

10. Select the **Employees to copy to** or **Departments to copy to**, select the employees or departments you want to copy the information to from the list in the **Available** box.
11. Click **Add selected**.
12. Click **Run**.

**Important:** Verify the information, and users or departments you selected before you click run. The changes cannot be undone automatically.

A confirmation message appears when the operation completes.

13. Click **OK**.

A page summarizing the changes made appears.

## Next-Generation Homepage Setup

An early version of the next-generation homepage was introduced in SuiteProjects Pro 2024.2. When enabled for your company's SuiteProjects Pro account, the next-generation homepage is available in

addition to (and not in replacement of) the classic homepage because it does not currently offer a new solution for all the homepage functionality. However, employees can start personalizing their homepage and include lists and reports to show the information that is relevant to them. For more information about the next-generation homepage, see the help topic [Getting Started with the Next-Generation Homepage](#).

Account administrators and user with the relevant role permission can use the Bulk employee change wizard to copy the next-generation homepage setup from one employee to other employees, or to all employees in one department. This enables you to create a homepage template and use this template as the default homepage setup for other employees. See [Making Changes to Multiple Employee Records at the Same Time](#).

In the bulk employee change wizard, select Home (new) personalization under **Information to copy**. This option replaces all personalization and content set up for the next-generation homepage that the destination employees may have. This action cannot be undone.

After the setup is copied to an employee's homepage, this employee can make changes to homepage and personalize it.

## Homepage Setup Sharing Best Practice

The homepage setup can contain list or report content configuration parameters that are not available to some target users.

Review the following best practice guidelines:

- For list content:
  - Make sure target users have access to the application (module) containing the list and to the object list.
  - Use a public list layout. If the selected list layout is no longer public or no longer exists after the homepage was copied to other users, the homepage for these other users shows the list with the standard layout instead of the custom layout selected in the list portlet setup.
  - Remember that saved filters are available on a per-user basis only. The selected list filter is ignored if it is not available for the target user.
- For report content, share reports used in the homepage with target users before copying the homepage setup.

## Calendar Customization

Calendars show a schedule overview of bookings, task assignments, time off requests, and work schedule, for the authenticated user and other employees this user has access to.

This topic describes the elements of the calendars that can be configured and controlled by account administrators.

For a general description of the calendars, see the help topic [Calendars](#) under the [User Guide](#).

## Access Control

By default, the type of items a user can see in the calendar depends on which modules this user can access. The [All Item Types in Calendar](#) optional feature lets users see their bookings and task assignments even if they do not have access to the Resources and Projects modules.

## Configuration Settings

To customize calendars, go to Administration > Global Settings > Display > Interface: Display. The following settings are available:

- **Hide the 'My Calendar' tab** — Check this box to hide My calendar menu option in all modules for all users .
- **Maximum number of rows to display per day in 'My Calendar' monthly view** — Select the number of calendar items that can be shown for each day in the month calendar view. The default (and minimum) is 4 calendar items, and can be increased up to 10. The option to display all rows regardless of number is also available.
- **Show My Calendar tab in all modules** — Check this box to show the My Calendar menu option for each application (module). This setting is also available in users' personal settings. When checked, My calendar is the first option in the menu for each application. This setting has no effect if the **Hide the 'My Calendar' tab** box is checked.
- The following settings modify the information shown for each calendar item. The summary information is shown in all three calendar views (month, week and day). The detail information is shown in the day calendar view only.
  - Show booking type for bookings as summary on the calendar
  - Show custom fields for bookings as summary on the calendar
  - Show custom fields for bookings as detail on the calendar
  - Show custom fields for task assignments as summary on the calendar
  - Show custom fields for task assignments as detail on the calendar

# Opportunities

The Opportunities application lets you capture prospect information about a potential customer and an existing customer. You can add contact information, deal information, an estimate, a proposal, proposal templates, and business types, customer sizes, customer sources, and territories.



**Important:** Access to the Opportunities application is restricted. As communicated in the SuiteProjects Pro 2023.2 release notes, enabling the Opportunities application is no longer permitted. You can continue using the Opportunities if it is currently enabled in your account.

As an alternative to using the Opportunities module, consider using project stages to track projects through the sales cycle. For more information about project stages, see [Project Stages](#).

The same approval process may be used for different transaction types across different SuiteProjects Pro modules.

## Deal Stages

Deals are the primary object in tracking pipeline opportunities in SuiteProjects Pro when using the Opportunities application. Deals, when created, may be matured to include estimates and can result in a proposal in the Opportunities application or project in the Projects application.

When creating a deal, a standard field on the deal form is the Deal Stage. Deal stages can be defined per your established sales process to track maturity of an opportunity in the pipeline.

### To define a Deal stage:

- Go to Administration > Application Settings > Opportunities > Deal stages.
- Select **New Deal stage** from the **Create Button**.
- Enter the Deal stage name and a representative Percentage to be used for weighted pipeline reporting. As deal stages are entered, you also can indicate the order in which the deal stages are presented to the employee in the drop-down field option on the deal form.

4. Add Notes about the deal stage, if desired.
5. Click Save.

## Proposal Layout

Proposals generated in SuiteProjects Pro are built by adding various proposal components such as text items, hourly items, and fixed fee items. Together these components make the proposal a report that can be mailed directly to customers for review and acceptance.

The proposal report that the customer sees using the proposal link in the email is controlled by the Proposal Layout option. Here you may identify which columns are displayed to the customer and in what order. You can identify the layout of the paper, the type of lines to display such as a grid or none, the format of dates, and the top margin to accommodate your company logo, unless you've chosen to override margin control in the logo settings. See [Logos: UI, documents](#). The proposal layout form also doubles as a configuration for the starting number for proposals. The default starting number is 1 and proposals are incremented by default by 1.

### To define a Proposal layout:

1. Go to Administration > Application Settings > Opportunities > Proposal layout.

## Templates

You can generate proposals using standard text and estimates including hours and rate, fixed fee values, and expense costs. Text items added to a proposal may reference defined Templates to ensure standard wording is used on all proposals. A typical example of this would be disclaimer text or copyright text.

When a template exists and a proposal is being created, you can create text items for the proposal and either enter custom text or select a defined template that uses the text defined in the template. If a template does not exist, the option to select a template does not display when you are creating text items for the proposal.

### To create a Template:

1. Go to Administration > Application Settings > Opportunities > Templates.
2. Select **New Template** from the **Create Button**.
3. Enter the Template name and the standard wording for the template in the Content text area.
4. Click Save.

## Territories

You can assign Territories to customers, prospects, and deals. These are an arbitrary geographical designation that you name. When you create them, you can include territory information when you create customer records. This field is visible in the customers list and in reports. Definition of territories is related to Opportunities when there is an organizational structure defining regions of customer aligning with the sales organization. Examples are: East, West, US, and EMEA. If territories are not defined, then the field does not display on the Customer form. See [Customers](#).

Territories may be created or inactivated at any time. Inactive territories do not appear as a valid selection on Customer forms. Due to the general nature of the Territory form, you may choose to use this field for another purpose and rename Territory. See [Interface: Terminology](#).

## Business Types

You can create Business Types to capture business type information for customers and prospects. This field is visible in the customers list and in reports. Definition of business types is related to how your company groups types of Customers. Examples are by vertical such as Healthcare and Education, or by industry such as Energy and Transportation. If business types are not defined, then the field does not display on the Customer form. Business types may be created or inactivated at any time. Inactive business types do not appear as a valid selection on Customer forms. See [Customers](#).

## Customer Sizes

You can create Customer Sizes records to capture customer size information for customers and prospects. This field is visible in the customers list and in reports. Definition of customer sizes is generally interpreted in terms of employees or revenue. Examples are less than 100, 101-500, 501-1000 if employee based, or less than \$500K, \$1M-\$5M if revenue based. If customer sizes are not defined, then the field does not display on the Customer form. Customer sizes may be created or inactivated at any time. Inactive customer sizes do not appear as a valid selection on Customer forms. See [Customers](#).

## Customer Sources

You can create Customer Sources to capture customer source information for customers and prospects. This field is visible in the customers list and in reports. Definition of customer sources is generally interpreted as how the customer was obtained. Examples are referral, marketing campaign, trade show, cold call, etc. If customer sources are not defined, then the field does not display on the Customer form. Customer sources may be created or inactivated at any time. Inactive customer sources do not appear as a valid selection on Customer forms. See [Customers](#).

### To define Territories, Business Types, Customer Sources or Customer Sizes:

1. Go to Administration > Application Settings > Opportunities and select either Territories, Business types, Customer sizes, or Customer sources.
2. Select the New entity you want to create from the **Create Button**.
3. Enter the name of the particular entity value.
4. Add Notes for the value, if desired.
5. Click Save.

## Other Settings

There are several other settings available in the Opportunities application.

### To access the Opportunities Other settings:

1. Go to Administration > Application Settings > Opportunities > Other settings.

**Allow an approver to edit a submitted proposal:** This feature, when selected, permits an approver to make adjustments to a Proposal after it has been submitted.

**Allow a proposal to be associated with a deal:** Enabling this feature lets you associate a proposal with a Deal. You first must have a Customer or Prospect set up. Then a Deal has to be created in the Opportunities application. You can then create a Proposal and tie it to the specific deal.

**Disable editing of sent proposals:** If the Proposal has been marked as Sent to the Customer or Prospect, this feature prevents editing the proposal in SuiteProjects Pro.
